(1) Purposes of the survey

The purposes of this survey are to collect information on activities related to peace building through sports, sports promotion and participation ii Olympic games in South Sudan and to examine possible JICA assistance to promote sports for peace building. The following are the major activities of this survey.

- Collect and analyse information/data of sports related organisations in South Susan
- Conduct invitation programme in Japan for South Sudanese stakeholders to deepen their understandings on importance of sports promotion
- Support to conduct the first National Unity Day to examine the implementation capacity of sports related organisations (e.g., MoCYS, athletic federation, and football federation)
- Support to prepare and implement the second National Unity Day to improve the implementation capacity of MoCYS
- Conduct invitation programme in Uganda to exchange views on sports promotion and peace building through sports with sports related organisation in Uganda

(2) Processes of the survey

Seven (7) field surveys and one (1) invitation programme in Japan were conducted. The schedule and survey contents of each survey are shown in the following table.

(3) Important findings

1) Capacity of MoCYS

Regarding the capacity of MoCYS, the following were identified through this survey.

- Financial capacity of MoCYS was extremely low even before the conflict in Juba in July 2016. Budget allocation of MoCYS has been the most less among all the ministries of South Sudan National Government.
- Although human resources are quite limited, MoCYS has implemented the first and second National Unity Day successfully. This is because the administrators (i.e. Undersecretary and Director General) and staffs who have been assigned to the National Unity Day task team have committed seriously to implement the event. Implementation capacity of sports promotion activities by MoCYS improved drastically through the implementation of the National Unity Day.

2) Implementation process of the National Unity Day

Preparation of the second National Unity Day was smoothly done compared to the one of the first event since the necessary processes were clarified based on the experiences of the first National Unity Day and important tasks were discussed among the staff of MoCYS (please see

ANNEX 1). Then a proposal of the second National Unity Day from MoCYS was discussed among state stakeholders to reach the consensus, which was stipulated in the minutes signed by the all stakeholders such as MoCYS, state governments and JICA (ANNEX 2).

Abovementioned processes have worked very effectively to maintain transparency on the decision making process and to have consensus among the stakeholders before staring the event. Preparation meetings and an evaluation meeting for the event were well organised.

3) Important aspects of the National Unity Day for peace building

Through the implementation of the National Unity Day, the following important points were identified.

- Messages for peace and unity of the nation were emphasised throughout the events of National Unity Day not only for players but also for spectators through speeches before and during games/matches and TV and radio programmes. It seems that many public people were aware of purposes of the events and the importance of peace and unity.
- Sensitisation on peace and unity, fair-play sprit, HIV/AIDS and gender was made for the players before starting games/matches. This made players understand the importance of those aspects.
- Players from different towns stayed in a same room at an accommodation to foster friendship among different tribes. Similar arrangements were made for organising the teams for peace games. These kinds of arrangements were effective for uniting the players from different areas/tribes.
- Due to deteriorated security conditions in the nation, appropriate transport modalities from twelve towns to Juba were examined seriously.
- Rules and regulations were clearly stipulated before staring games/matches during the second National Unity Day based on the experiences of the first event. This arrangement was very important to reduce disputes concerning results of games/matches.
- A frame work of dispute resolution was prepared before the second event. This also contributed to avoiding serious disputes during the second event.
- Numbers of security police and national security officers were deployed at playgrounds to maintain security conditions during games/matches. However, a serious incident happened during the football match held at the Maric playground. Some spectators started fighting each other so that national security officers fired some blank shots to stop fighting. To avoid such situations, the football matches were not made at the Maric playground since the playground was located in the city centre where many spectators could come to watch the matches.

4) Possible technical cooperation of JICA

Since JICA received an official request of the JICA's technical cooperation from MoCYS on peace building activities through sports, JICA sent a mission team for detailed planning of the proposed project.

The project would be composed of three aspects; 1) Capacity development of MoCYS through actual implementation of sports promotion activities (e.g., implementation of the National Unity Day and formulation of sports policy), 2) Capacity development of coaches and referees for top

class athletes for successful implementation of the National Unity Day, and 3) Capacity development of coaches and referees for promotion of grassroots sports activities.

The detailed of the project contents and modalities of cooperation will be discussed during the project formulation process based on the present security conditions in South Sudan.

- 5. Contents of discussion
- 5-1. Evaluation of the first National Unity Day
 - Many people recognized the importance of a sports event for peace building and unity
 for the nation. Also cabinet members recognized the importance and positive impact of
 the event for peace and unity.
 - Participants could meet with players of other states and could make new friends during the event. Almost all participants expressed positive comments on the event.
 - Since radio broadcasting was made widely, many citizens could enjoy the football matches.
 - Some stakeholders would like to know reasons why some states could not participate in the National Unity Day. MoCYS explained some causes like insecurity of travel by car/bus in particular areas, and not enough financial capacities to provide transportation from states to Juba by some State Governments.
 - Particularly for football, issues of over age players and not registered players were very serious. Some manipulations were made by some teams, so these issues should be addressed for the next event.
 - MoCYS needs more close communications with Ministry of Education, South Sudan Football Association, and South Sudan Athletics Association for the next event.
- 5-2. Arrangements of the State Coordinating Meeting
- (1) Schedule and programme for the State Coordinating Meeting
 - The State Coordinating Meeting will be held from November 21st to 23rd at the Fairway hotel in Kampala, Uganda.
 - Draft programme of the State Coordinating Meeting is attached as Annex 2.

(2) Logistics for the State Coordinating Meeting

- Target towns for the State Coordinating Meeting are twelve major towns, such as Juba Wau, Yambio, Torit, Aweil, Bor, Pibor, Malakal, Bentiu, Kwajok, Abyei, and Rumbek.
- From each major town one Director General and one Director of sports related State Ministry, one coach of athletics, one coach of football will be invited for the State Coordinating Meeting. In addition one expert representing Jubek State Athletic Association and one expert representing Juba Local Football Association will be invited. From MoCYS, two Director Generals and members of the project team will be invited.
- Regarding the logistical demarcation, JICA is responsible for the arrangements of transportation for participants from Juba to Kampala and their accommodation in Kampala. MoCYS is responsible for the arrangements of transportation for participants from respective towns to Juba, their accommodation in Juba, and obtaining Ugandan VISA.
- MoCYS has responsibilities to accomplish the following logistical arrangements for the State Coordinating Meeting by October 14^h, 2016.
 - ✓ Preparation of the list of state convention participants
 - ✓ Collection of necessary documents of participants (i.e. passport copies/travel document copies, office ID card copies, two passport photos for visa application, and information on Yellow Fever)
 - ✓ Confirmation of schedule for private flights.
- JICA will confirm the schedule of UNHAS flights and procedure.
- Each participant needs to have a vaccination card of Yellow Fever. The cost of vaccination is 210 SSP and will be shouldered by the participant. A participant who does not have a passport should obtain a travel document for foreign travel. The cost for obtaining the travel document is 70 SSP and will be shouldered by the participant. JICA will shoulder the cost of Ugandan VISA.
- JICA will also provide cost of transportation to the nearby airports in each town (only when travel over 30km), accommodation on the way to the nearby airport (1 night maximum for each participant), and daily allowance of 10 USD for travel inside the country. The expense for both ways will be reimbursed upon presenting the receipts in Juba after the workshop in Kampala.
- JICA will provide for participants the cost of flights or buses between each town and Juba, accommodation in Juba with the maximum 65 USD, flight between Juba and Kampala, and accommodation in Kampala with three meals.

(3) Necessary presentation materials and documents for the State Coordinating Meeting

- One representative of each town prepares a presentation material on evaluation of the first Unity Day and activities done after the Unity Day. Each presenter has 10 minutes for presentation and 5 minutes for Q&A.
- MoCYS will prepare draft rules and regulations of athletics and football for discussion.
- MoCYS will also prepare a list of necessary tasks to be done until the National Unity Day and an action plan format with support from the JICA consultant.

5-3. Arrangements of sports events for the second National Unity Day: technical aspects

(1) Selection processes of players

- The target sports for the second National Unity Day are men's and women's athletics and men's football. Age limit of players for both athletics and football is under 20 years old, so that new young stars can obtain more chances to participate in the national sports events.
- Track events of athletics for both men and women are 100M, 200M, 400M, 800M, 1,500M, 100Mx4, and 400Mx4. An event of 3,000M is only for men. Filed events for both men and women are shot put, discus, javelin, and long jump.

- One player of athletics can register for two track events excluding relay events and one field event OR one track event excluding the relay and two field events.
- State ministry and local association of each town will decide selection methods under their circumstances (e.g. limited financial and human resources, insecurity, and inaccessibility).
- Due to insecurity and inaccessibility, selection processes of players (e.g. preliminary games/matches) might be conducted near or inside big towns. However, fairness of selection should be maintained throughout the processes. This should be emphasised during the State Coordinating Meeting.
- To avoid overage players, preparation of identification (ID) cards with photos is very crucial. Secretariat of MoCYS will prepare ID cards with photos for players, coaches and administrators.
- Definition of origin of players is that players stay in a place at least three months.
 Internally Displaced Persons (IDPs) should be given special considerations. If state ministries and local associations would like to register players who are IDPs and live in different towns, they need to communicate with secretariat of MoCYS during a preregistration period.

(2) Registration of players and control of participants to games/matches

- MoCYS will work for pre-registration before the Unity Day (might be in December 2016 and early January 2017). MoCYS will collect necessary documents such as lists of registered players, their official certificates to prove ages (e.g. birth certificate or assessment of age issued by Ministry of Health), and their pictures.
- During the registration at the Rombur TTI, the MoCYS secretariat should confirm age and origin of players with birth certificate or assessment of age issued by Ministry of Health.
- Based on the information of the official documents, ID cards with photos will be issued by the MoCYS secretariat.
- Before games/matches, referees will check records of registration and players' IDs to avoid involving players not registered.

(3) Rules and regulations of games/matches for athletics and football

- Athletics will hold two heats for each track event. The first-three in each heat and the fastest two losers can forward to the final. If there are more than sixteen registered players for one event, three heats will be held and the sixteen will be chosen based on the time records and forward to the semi-final (two heats). For the field events each players will be allowed three trials. Twenty players (10 males and 10 females) per each town will be invited to the National Unity Day.
- Regarding football the teams will play in a group stage. Three groups will be formed. A winner of the each group and one best team among losers will forward to the semi-final. The best team among losers will be determined as follows:
 - ✓ Greatest number of points obtained in all group matches
 - ✓ If points are same, goal difference in all group matches
 - ✓ If goal difference is same, greatest number of goals scored in all group matches
 - ✓ If number of goals scored is same, drawing of lots by the organizing committee
- Generally, FIFA rules are applied. Twenty-two players will be invited. Up to maximum of five substitutes can be played during a match.
- Draft rules and regulations were prepared. Some modifications will be made by the staff of MoCYS based on the discussion during this meeting. Final version of these documents will be presented during the State Coordinating Meeting. Please see the details of rules and regulations in Annex 3 and 4.

(4) Resolution of disputes

• The highest body of disputes resolution is the organizing committee. Under the organizing committee, sub-committees for athletics and football are formed. The expected members are shown in the following table.

- Dispute resolution will be made by referees of a game/match, the head of referees, the subcommittees and the organizing committee. Proposed processes of dispute resolution are shown in the following table.
- MoCYS raised an issue of allowances for the committee members from other organizations.
 JICA recommends that effort is made by MoCYS to communicate with other support
 organizations (e.g. donors, NGOs, and private companies, and past funders for the South
 Sudanese delegate to the Olympics) to obtain funds for allowances.

(5) Qualification of referees

 Referees of athletics will be selected by the South Sudan Athletic Association and Some referees do not have official licences, so MoCYS needs to have close coordination or support with the athletic associations to maintain the quality of referees. • Referees of football will be selected by the South Sudan Football Association and Juba Local Football Association. Since the referees of the first National Unity Day had international referee licences, there was no problem on the quality of referring in the last events.

(6) Facilities for games/matches

- The Bulk paly ground is used for the athletic event. Construction of fence will be made by
 using funds from Japanese Embassy in South Sudan and might be completed before the event.
 If the construction delays until the events (late January 2017), JICA South Sudan office needs
 to coordinate with Japanese Embassy in South Sudan to stop construction temporarily during
 the event.
- For football the National Football Stadium will be used for only opening, the final match of football, and closing. The Bulk, Zhara, Spiri, and Juba 1 playgrounds will be used for other matches.
- If conditions of surfaces of these football playgrounds are not good, MoCYS will coordinate with Ministry of Physical Infrastructure to repair the surfaces. Necessary cost (i.e. fuel of heavy duty equipment) will be provided by JICA.

(7) Sports gears

- For athletics some gears such as stop watches and javelins are necessary for the event. These gears shall be provided by South Sudan Athletic Association which obtained grassroots grant aid from the Japanese Government.
- For football enough number of balls and pumps, two sets of corner flags, two goal nets, and twenty sets of uniforms for referees should be purchased for the event.

(8) Medical support

- Medical support by the Red Cross for games/matches during the last event was good. The number of medical staff for games/matches might be increased to provide more effective medical support in the next event.
- Medical support at the Rombur TTI (accommodation of coaches and players) was very poor during the last event, since no doctor or nurse was assigned there. Thus, a doctor or nurse should be assigned at the accommodation during the next event.
- Also necessary medicines will be kept at the playgrounds and accommodation.

(9) Security of playgrounds and accommodation

- Security conditions of playgrounds were relatively OK during the last event, so MoCYS will continue making same arrangements for the next event.
- Security arrangements for the Rombur TTI were not satisfactory. MoCYS and JICA may consider hiring some security guards from a private security company, or to add such entrance management to the police mandate to strengthen functions of a reception at a main gate, since many strangers came into the TTI and ate some meals prepared for players during the last event. This caused shortage of meal amount for players.

5-4. Arrangements of sports events for the second National Unity Day: logistical aspects

(1) Accommodations

- A hotel for administrators was fair. JICA may provide the same level of accommodation for administrators in the next event.
- Facilities of the Robur TTI were relatively OK. Some repairs might be needed especially for electrical pumps for a water system. Necessary items, such as mattress, bed sheets, mosquito screens for windows and fire extinguishers, have to be procured.

(2) Food and drinks

- Quantity of food for players was diminishing day by day during the last event, since some
 people from outside ate meals of players. To prevent such situations, a function of reception to
 check strangers at the main gate should be strengthened.
- To avoid meal shortage of players, amount of food stuff for meals should be procured with a certain level of contingencies (maybe 5% or 10%).
- At least six litters of water per day per player should be provided in the next event. In addition some water servers will be set at the TTI especially at the each floor of accommodation building.

(3) Transport from accommodations to playgrounds

- Some players failed to take a bus to go back to the TTI, so MoCYS staff hired a car to send them to the TTI. At least one car should be kept for MoCYS staff to address such issues.
- Communications on transport arrangements should be made very closely between MoCYS and a local consultant for overall management.

(4) Local consultants

- Mandate of consultants, list of procurement items, and the shortlist for candidate companies shall be listed by Oct. 14th.
- Staff of MoCYS feels the need for closer coordination with local consultants to be hired.
 Communication methods, a chain of command, and roles and responsibilities among MoCYS, local consultants, and JICA should be discussed and stipulated in a document upon contracting for smooth coordination during the event.

(5) Resource mobilization

MoCYS should make serious efforts for obtaining additional financial and in-kind resources
form donors, NGOs, and private companies to avoid relying on JICA support only. UNESCO
and some telecommunication companies could be high potential partners. MoCYS will
communicate these stakeholders to check the possibility of obtaining additional resources.

5-5. Maintenance of functions of the project office

 Necessary support to maintain office functions (e.g. provision of fuel for a generator and office supplies) will be listed up by MoCYS and be submitted to JICA. JICA will examine the contents of the list and decide items of necessary support.

The National Ministry of Culture, Youth and Sports (hereinafter referred to as "MoCYS"), State Ministry of Information, Culture, Youth and Sports (hereinafter referred to as "MoICYS") and Japan International Cooperation Agency (hereinafter referred to as "JICA") made discussions on the contents and the arrangements for the "State Convention on the 2nd National Unity Day" (hereinafter referred to as the "Convention"),

I. Demarcation and responsibility

1.1 Responsibility of MoCYS

- 1.1.1 MoCYS shall take initiative in the preparation and implementation of the 2nd National Unity Day to be held in Juba, from January 28th to February 4th, 2017 by providing necessary instruction and coordination with MoCYS, MoICYS, and National Sports Association, and coaches.
- 1.1.2 The MoCYS and MoICYS observes the precautions regarding security situation in Juba, and proposes appropriate prevention measures as follows.

1.2 MoICYS responsibility

MoICYS shall be responsible for the transportation (including accommodation in the process) of players, Director General, Director of Sports, and 2 head of coach each for soccer / athletics, and one reporter from each city to Juba. Furthermore, each MoICYS shall prepare uniforms and shoes for the players and coaches.

1.3 JICA responsibility

In consideration of the financial difficulty of Government of South Sudan, JICA will support initiatives of the MoCYS to prepare for the 2nd National Unity Day by financing and supporting following facilities until the completion of the event.

- Player, coaches and reporter accommodation
- Food
- Sports equipment
- Player and official's transportation during event in Juba
- Officials accommodation
- Security related cost
- PR related cost
- Medication
- Ceremony arrangement

II. Security Issues

2.1 Juba-based Sports Matches and Opening/Closing Ceremony

2.1.1 The MoCYS and MoICYS observe the precautions regarding security situation in Juba, and proposes appropriate prevention measures as follows.

2.1.2 MoCYS shall submit final security arrangement plan in Juba, including police deployment layout and schedule, with cost estimation to JICA by 1st week of December.

2.3 JICA arrangement and MoCYS arrangement for the National Unity Day

2.3.1 The MoCYS and MoICYS have agreed to make efforts for the necessary arrangements to take the security precaution measures in the 2.1 and 2.2.

2.4 Dispute resolution for general matters

The MoCYS and MoICYS agreed that the Organizing committee in Table 1 shall be responsible for resolution of general disputes during the usage of accommodation in Rombur TTI, and non-technical disputes regarding matches, and that all parties shall follow the resolution announced by the Organizing Committee.

III. Arrangements of Selection and Registration

3.1 Age and number of Participants

MoCYS, MoICYS and JICA agreed that age limit for both athletics and football shall be under 20 years old (born on and after 1st January 1998) and the number of participants as follows;

- ➤ 10 males and 10 females, 2 coach for athletics / 1 female and 1 male
- ➤ 21 players, 2 coach for football

3.2 Process of Player selection process

- 3.2.1 MoCYS and MoICYS agreed that all players' age must be verified by either passport / national ID / birth certificate, or assessment of age issued by the Ministry of Health (1 of the 4), and photo data.
- 3.2.2 MoCYS and MoICYS agreed that State players must have stayed in the State of participation for longer than 3 months. Furthermore, both sides agreed that Internally Displaced Persons, if included in a team, need to communicate with secretariat.

3.2.3 State ministry and local association of each town shall decide selection methods under their circumstances.

3.3 Registration procedure

- 3.3.1 MoCYS shall prepare official National Unity Day Participants ID (hereinafter referred to as "official ID") with photos for all players, coaches and administrators. MoICYS agreed that participants without the official ID published by the MoCYS are not eligible for the National Unity Day.
- 3.3.2 MoCYS secretariat shall finally verify photos and birth certificate or assessment of age issued by Ministry of Health upon arrival in Rombur TTI. MoICYS have agreed that only players who have been registered and given IDs in the Rombur TTI reception are allowed entry into the facility.
- 3.3.3 MoICYS have agreed that players are eligible for matches only after referees check records of registration and players' IDs.

IV. Arrangements of Athletics

4.1 Athletics event and rules

4.1.1 MoCYS, MoICYS and JICA agreed to hold following events during the National Unity Day.
