Project for Capacity Development of the Office of the National Assembly of Vietnam – Phase II

3. Duration of the Project

Planned: From 1st October 2017 to 30th September 2021 (Four years)

4. Background

In the 13th term, the National Assembly (hereinafter referred to as NA) approved and promulgated the 2013 Constitution, and made amendments to codes and laws in synchronization with the new Constitution. NA, the Government, and other agencies in the political system have disseminated the substantive message of the Constitution and shown their strict compliance with the Constitution. In two years since the Constitution was promulgated, nearly 70 laws and codes were made for the enforcement.

Accordingly, the legislative process has been streamlined and it has promoted people's participation. For the amendment of laws, drafting and verification have been more efficient and transparent, reflecting the peoples' voice. As a result, the debate and ratification of laws in the NA sessions have been implemented more consistently with the regulated procedures and improved the quality.

Many Vietnamese and Japanese experts understand that the capacity development of the Office of the National Assembly (hereinafter referred to as "ONA") is the crucial point to improve and strengthen the function of NA further. Following the successful result of the Project for Capacity Development of ONA of Vietnam from January 2014 to September 2017, based on the request of the Government of Vietnam, Japan International Cooperation Agency (hereinafter referred to as "JICA") has implemented the Project for Capacity Development of ONA of Vietnam – Phase II (hereinafter referred to as "the Project") to enhance the capacity of the office.

The Project has focused on the capacity development to support three functions of NA, i.e., representative, legislative and oversight functions, in response to diversified activities of NA under the 2013 Constitution. Related to the three functions, ONA is responsible for

smooth and efficient implementation of various tasks such as assisting in drafting and updating the NA agenda, supporting effective discussions in the NA committees, and public relations. In order to respond to those needs, it is indispensable to improve the capacity of the individual ONA staff and ONA as a whole simultaneously.

III. Achievements of the Project

The Project conducted the baseline survey in 2017 and, based on the gathered data as a benchmark, conducted the monitoring survey in 2019 and 2020. The survey work has been implemented by the same local consultant³ who is familiar with the activities of NA. The consultant updated the data, collected new information through questionnaire answers and complementary interviews with the active and former NA deputies⁴ and ONA's officials as shown in table 2-1 below. The consultant analysed the result qualitatively, quantitatively compared to the baseline data, which shows the Project's achievement as follows.

The Project selected the Management Consulting and Development (MCaD SJC) with the team leader, Dr. Nguyen Khac Hung, CEO of MCsD SJC, who received a Ph.D. in Public Administration and Management, University of Manchester, the UK as the consultant. The MCaD SJC has much knowledge about the public administration system in Vietnam, especially NA, and full experience in training work skills and leadership/ management skills for ONA.

The interviewed NA deputies and experts above mostly appreciated ONA for its support to the NA deputies and the management of NA and endorsed the achievement of the Project's purpose⁶.

1-1. Comments by the NA deputies and experts

- (1) Unlike the Parliament of many other countries, NA of Vietnam does not have its assisting apparatus (the individual deputies of NA of Vietnam do not have their own assisting staff). Therefore, the ONA's units' work is vital.
- (2) The assisting role mainly reflected in two domains. These are: ① providing relevant information and documents (including the provision through the Digital Library) and arranging logistics conditions (accommodation, transportation, etc.) for the NA deputies (See table 3-2 below) and ② Advising on substantive contents such as thematic research results to NA and the NA deputies (including the NA provincial groups) to perform their functions and duties.
- (3) ONA achieved timely and adequate information sharing and provided substantive advice to promote the significant discussion by the NA deputies and improve the NA's legislative function.
- (4) ONA has significantly achieved the logistic support and information dissemination and public relations for the NA deputies to reach their stakeholders, hear from them and

- (5) Positive public relations activities, including the NA visiting tours and experiential education programs, have been effectively achieved.

- 1-2. Overall analysis of the achievements of the Project's purpose
- (1) The indicator ("Satisfaction rate of NA deputies on the supporting services of the ONA in terms of legislative function increases") reached the target.
- (2) As for the other two indicators, "Satisfaction rate of NA deputies on the supporting services of the ONA in terms of representative function increases" and "Satisfaction rate of NA deputies on the overall supporting services of the ONA increases", even though it could not reach the target (90.0% and 95.0%, respectively), they showed satisfactory performance when the results of 82.2% and 87.2% in the 2017th baseline survey increased to 87.0% and 91.4%, and the interviewees commented on the positive performance of ONA in the 2020th monitoring survey.
- (3) The achievement of the three indicators and the interview result above are regarded as steady progress in the Project's activities and other efforts by ONA, which brought a good result for the Project's purpose. It also suggests adequacy of the Project's design seeing the achievements of the output below.

2. Achievement of Project Output⁷

The interviewed NA deputies and experts mostly appreciated ONA for its support to the NA deputies and the management of NA as shown in Table 3-2 above. They endorsed the achievement of the Project's output. Furthermore, the interviewed ONA's officials above showed their confidence in the improved capacity with the Project's support and their efforts.

- 2-1-1 Comments by the ONA's officials for Output 1-1~3 and the NA deputies for Output 1-4
- (1) The leaders of the Law Department: The Law Department played a focal point role for the quality inputs and outputs of NA and the NA Standing Committee's legislative activities and completed the task of serving NA's legislative and oversight activities in the last Legislature.
- (2) The Law Department's leaders: Before, in the verification work of new laws, they studied the laws themselves in-depth but paid little attention to the viewpoint and purpose of its enactment and feasibility for the enforcement. After participating in the OJT training in Japan, they changed their focus to its necessity and goals of new laws,

- the settlement solution, and the policy viewpoints of the Party and State.
- (3) Director of the Law Department: The Project counterparts' units participated in the workflow development supported by the Project in 2018. As a result, the ONA's officials have a better view of better work handling via the "new workflow" developed by themselves which helps maximize their support to legislative activities.
- (4) The NA deputies: The NA Library of Vietnam was scaled up to a department of ONA in 2014 and started the Digital Library in 2015. Since then, its activities have flourished, as shown in Table 3-3 below. It is appreciated that digitization of the reference materials has progressed, as Table 3-4 and the service could make their work faster.

2-1-2 Overall analysis of the achievements of the Project's output

- (1) Two of the four indicators related to Output 1 have been achieved (Output 1-3 and Output 1-4). For Output 1-3, the number of materials sent by the NA Library to the NA deputies increased in the 14th Legislature compared to the 13th Legislature, mainly in terms of electronic information, which is recognized as a remarkable improvement in managing the Digital Library. During the session, the NA Library also provides information at unique information booths in the NA building and online tools in response to requests from the NA deputies.
- (2) Although the indicator of Output 1-1 did not reach the target (90.0%), it has improved from 83.0% in 2017's baseline survey to 88.0% in 2020th monitoring survey, and the ONA's officials are aware of the improvement with the support by the Project.
- (3) As for the indicator of Output 1-2, while the quality and efficiency of the work of the Law Department have improved with the new workflow, the ONA's officials recognize room for improvement in the process of coordinating opinions among different ONA's units for advisory works.
- (4) The achievement of the four indicators and the interview result above are regarded as showing steady progress in the Project's activities and other efforts by ONA, which brought good result for the Project's output.

2-2-1 Comments by the NA deputies, experts and ONA's officials

- (1) The NA deputies and experts: It was acknowledged that the volume and frequency of media reports and publications have been increased and diversified public opinions have been quoted. The major online presses for the NA activities such as the "Peoples-Representative-Newspaper" and "Deputies Voters" daily inform the detailed discussion in NA and the NA Standing Committee to the public and the NA television disseminate information on new laws, politics and voters' opinions on NA.
- (2) The officials of the Information Department: The Information Department proactively carried out a public opinion survey¹¹ of students and teachers at Hanoi and analyzed

The public opinion survey planned in 2020 to measure the satisfaction rate could not be conducted because of the COVID-19 epidemic.

representative organ of the people and the highest organ of State power of the Socialist Republic of Vietnam ". The 76.2% chose the right answer "NA is the legislative organ", the 60.8% chose the right answer "NA is the organ making decisions significant national affairs" and the 48.9% chose the right answer "NA exercises the supreme control over all activities of State".

For the question on the organ making decisions significant national affairs, the percentage of correct respondents "NA is the highest representative organ of the people and the highest organ of State power of the Socialist Republic of Vietnam" under 15 years old is 73.9%, 15 years old to 18 years old is 53.7%, and 55.5% for 18 years old or older. 61.6%. Regarding the correct answer for "Who is the NA Chairperson?", the percentage of respondents choosing under 15 years old is 94.9%, 15 to 18 years old is 89.7%, and 99.3% for 18 years old or older.

The program of the NA visiting tour started on 14 March 2015, the experiential education program was introduced in 2017, and the E-portal site was in 2015.

The survey was implemented from December 2019 to January 2020 for 460 students in Hanoi. The main targets were students of junior high school (under 15 years old, 139 students), high school (15-18 years old, 92 students), and college/university or over (18 years old or older, 125 students). A part of students of the two junior high schools participated in the NA experiential education program. The survey results show that the majority (61.6%) correctly chose the answer, "NA is the highest

the questionnaire answers on the linkage between the participation of the NA visiting tours and experiential education programs and the percentage of right answers on the NA activities. The survey results show students and teachers with the participation, especially junior high school students, the leading target group of the NA experiential education program, answered more correctly.

2-2-2 Overall analysis of the achievements of the Project's output

- (1) For the indicator of Output 2-1, the number of visitors increased rapidly in 2017 but decreased after because participants have been reasonably limited for more effective operation and stopped during the NA sessions when ONA introduced and prioritized the NA experiential education program in 2017. The program, together with the E-portal started in 2015¹², have shown a notable achievement, of which the E-portal continued to be a significant channel for the public to access the NA's information after the temporary suspension of the NA visiting tour and experiential education program due to the COVID-19 epidemic since early 2020.
- (2) For the indicators of Output 2-2, 2-4 and 2-5, 2020th monitoring survey did not include a questionnaire to the participants of the NA visiting tour because the tour was canceled due to COVID-19 epidemic. But the achievement of the indicators of Output 2-2 and 2-4 has already improved to a high level in 2019 monitoring survey. Furthermore, for the indicator of Output 2-2, the Information Department proactively carried out a public opinion survey in early 2020, the results of which indicated 86.5% of participants of the NA experiential education program evaluated the program as "Very useful" and the NA visiting tour as "Very good".
- (3) As for the indicator of Output 2-5, the five ONA counterparts' units for the Project claimed that the scope of NA's representative function was too broad and exceeded the jurisdiction of the five units. However, according to the self-assessment on their capacity and interviewed results of the ONA's officials, the ONA's officials were confident in their capacity building progressed in the support to the NA deputies for effective reach to the stakeholders, the NA visiting tour and experiential education program, and public relations.
- (4) The achievement of the five indicators and the interview result above are regarded as showing steady progress in the Project's activities and other efforts by ONA, which brought good result for the Project's output.

2-3. Achievement of Output 3

_

Indicators of Output 3 have not to be quantified, but the significant cases of the research activities, drafting resolutions, formation of the standing orders, and collection of the precedents are regarded as the achievement of the Project's output.

The E-portal site managed by Vietnam Television officially started in 2015. Because it was assumed to transfer to the Information Department of ONA as the responsible unit, at the start of the Project, the activity related to the E-portal site was described on the R/D. However, under the COVID-19 epidemic, the transfer became less prioritized on the Viennese side, and Vietnam Television still has managed the E-portal site.

Output 3. The capacity of ONA for the efficient operation of NA is enhanced

(i) Research activities for the efficient operation of NA and ONA are conducted.

: "Theoretical and Practical Basis for Further Improvement of Activities of NA at its Plenary Sessions in the Current Context" was submitted to the NA deputies and ONA managements in April 2021.

(ii) Resolutions are drafted.

: "The Law Revising a Number of Articles of the 2015 Law on Promulgation of Legal Documents, 2020" and" The Law Revising a Number of Articles of the 2014 Law on Organization of the National Assembly, 2020" became effective in Jan. 2021.

(iii)The standing orders of the secretariat of the NA Secretary-General are formulated.

: The secretariat of NA established in 2014, has assisted the Secretary-General of NA in proposing many amendments and supplements (or standing orders) related to NA's operational processes and procedures and contributed significantly to improving the schedule management for speeches, questions, and explanations at the Hall.

(iv) Precedents for NA are collected.

: In the legislative process, ONA is used to gather reference information, including domestic and foreign precedents, and submitted to the NA deputies for their deliberation. Following the instruction of the Secretary-General, the NA library has gathered the foreign precedents for new law projects.

2-3-1 Comments by the NA deputies, experts, and ONA's officials

- (1) The experts: A research, "Theoretical and practical basis for further improvement of activities of NA at its meeting sessions in the current context" (here-in-after is called as the "2021 Research" 13) is regarded as a significant proposal for the efficient operation of NA and ONA. This research was chaired by Mr. Le Bo Linh, former deputy Secretary-General of NA and former vice chairman of ONA, and Mr. Hoang Minh Hieu, Director of the Information Department of ONA, acted as his secretary, finalized in April 2021 and submitted to the NA Standing Committee and others. The "2021 Research" focuses on the improving the sessions' management and proposes specific measures as necessary and immediate actions and assumed as feasible contents.
- (2) The experts: Critical contributions ¹⁴ of ONA was the adaption of ① "The Law Revising a Number of Articles of the 2015 Law on Promulgation of Legal Documents, 2020" (here-in-after is called as the "2015 revised law") and ② "The Law Revising a Number of Articles of the 2014 Law on Organization of the National Assembly, 2020" (here-in-after is called as the "2014 revised law"), which are regarded as two significant steps to improve the operation of NA¹⁵. The "2015 revised law" includes five provisions defining the responsibilities of the Ethnic Council and other Committees of NA in their verification activities, and the duties of the concerned agencies, and coordination

mechanisms for receiving and rationalizing law projects. The "2014 revised law" includes a provision to increase the proportion of the full-time NA deputies from 35% to 40%; a provision on working principles of NA Standing Committee (working on a collective basis and making the decision by the majority); a provision on quorums, as well as voting procedures in the Ethnic Council and other committees of NA.

- (3) Director of the General Affairs Department: In recent years, much effort has been sustained, leading to a high rate of completion of advisory and assisting services to NA and the NA Standing Committees and leaders of ONA. The evidences to this include:
 - ① advice and support to drafting meeting agenda of the NA sessions, with improved efficiency and closeness to reality.
 - ② advices and proposals for improvement and innovation of the NA's activities, support to more rational and efficient NA plenary sessions, advices on drafting of the NA plenary session resolutions with higher quality, gathering, and synthetization of NA deputies' opinions on time.
 - ③ increasing proactivity and professionalism in advisory and supporting service in general, and specifically in advice for more systematic, reasonable, and efficient working regulations of ONA.
- (4) The ONA's officials: The establishment of the Secretariat of NA to assist the Secretary-General of NA in the performance of his duties and the development of its operating rules have contributed significantly to the efficient operation of the NA sessions.
- (5) Director of the NA library: In the legislative process, ONA gathers reference information, including domestic and foreign precedents, and submitted to the NA deputies for their deliberation. The NA Library of Vietnam and the National Diet Library of Japan have repeated exchanges and the NA library has gathered the Japanese precedents for new law projects.

2-3-2 Overall analysis of the achievements of the Project's output

- (1) All four indicators related to Output 3 have achieved notable performances with the significant cases of researches, resolutions for the adaption of the draft laws, the establishment of the Secretariat of NA and the related standing orders, and precedents.
- (2) To proceed with the legislation process for the individual laws and regulations effective for the efficient operation of NA and ONA, the ONA's units have conducted various kinds of research submitted to the NA deputies as reference information. Besides the aforementioned works, the "2021 Research" is regarded as a more comprehensive and upstream plan for improvement. The members who conducted the "2021 Research"

- included the Project's counterparts familiar to the present challenges of NA and ONA and supposed to be in enough influential position for the operation of NA and ONA.
- (3) In the Secretariat of NA, which consists of some ONA's units, the General Affairs Department plays a focal role in the management and operation. From the second half of 2020 to the first half of 2021, the Project intensively supported strengthening the IT system for the efficient operation of the plenary sessions of NA.
- (4) The "2021 Research" noted that from the 13th to the 14th Legislature, the procedures for setting the session agenda (which includes all agenda items to be considered, deliberated, and voted on during a session, as well as matters related to events such as the opening and closing of the session) were improved with the standing orders and through the other institutional capacity development of the Secretariat, the preparatory work was manualized in consideration of the short term of the session in Vietnam, and the information provided to the NA deputies was digitalized. In addition, the "2021 Research" mentions the evaluation of the current session agenda by the NA deputies, explaining that 99.3% of the surveyed deputies have a favorable view of the agenda (see Table 3-8 below).

- (5) In 2020, the Secretary-General of NA instructed ONA to gather the foreign cases for the efficient operation of NA and precedents in various areas. The instruction has become a strong incentive to enhance exchanges with their counterpart's organizations of Japan and other countries and make the gathering a routine, especially for the legislation process of new laws.
- (6) The achievement of the four indicators and the interview result above are regarded as showing steady progress in the Project's activities and other efforts by ONA, which brought good result for the Project's output.

IV. Results of Joint Review

(Evaluation on the achievements of the project purpose and output)

1. Results of Review based on DAC Evaluation Criteria

As mentioned above, at the beginning of the Project's implementation in 2017, a survey was conducted to set the baseline for each indicator, and based on the survey, a monitoring survey was performed in 2019 and 2020. Based on the survey results, the Project has been submitting a monitoring report to JICA every six months. On the other hand, in April 2021, the "2021 Research" focuses on the crucial activities that take place during the NA session, refers to overseas cases, scrutinizes the current situation and actual conditions, clarifies the issues, and then summarizes the recommendations that contribute to the efficient operation of NA during the session.

The following is an evaluation with the DAC five perspectives of "appropriateness," "effectiveness," "efficiency," "impact," and "sustainability," based mainly on the results of the aforementioned monitoring surveys and the "2021 Research".

The "2021 Research": In April 2021, under the leadership of Mr. Le Bo Linh, former deputy Secretary-General of NA and former vice chairman of ONA, Mr. Hoang Minh Hieu, Director of the Information Department of ONA, and other officials of NA wrote the "Research Report on the Theory and Practice of Improving the Management of NA in Session".

1-1. Relevance

Relevance of the Project is high.

The 12th National Congress of the Communist Party in 2016 decided on the policy of continuing to reform the State's institutional organization and consolidated the system of the socialist rule of law. In the Resolution of the Congress, it was stated that "it is necessary to continue to renew the organizational structure and operation of the National Assembly and to establish the National Assembly as the truly supreme representative body of the people and the highest organ of State power. The National Assembly will properly perform the functions of legislation, decision-making on important national issues, and supreme supervision - in particular, supreme supervision over the management and use of the country's various resources".

The content of this Resolution was embodied in the Resolution on some issues of reformation and arrangement of the political system towards streamlining and effectiveness issued in the 12th Party Central Committee's 6th plenum of 2017. The Resolution included: (1) Increasing the proportion of professional and full-time NA members and considering an appropriate reduction in the number of members who hold concurrent posts; (2) Reducing the number of vice-chairmen and standing members of the Ethnic Councils and of each Committee of NA, and stipulating an appropriate proportion of chairperson and full-time members; and (3) Improving the efficiency and reorganizing the internal organization of ONA.

The role of ONA is becoming more important than ever from the perspective of realizing the above-mentioned reform of the organizational structure and operation of NA, and capacity building is required. Therefore, JICA's support for capacity building of ONA is considered to be in line with the policy of the State of Vietnam.

On the other hand, Japan's policy on development cooperation for Vietnam is one of the priority areas or the goals that it aims to "support efforts to streamline and improve the efficiency of administrative organizations (including administrative reform) through human resource development and other measures. Therefore, the Project is positioned as an effort to contribute to the achievement of this goal.

In light of the above, the Project is in line with the critical policies and goals of both Japan and Vietnam, and the approach to achieving the Project's overall goal is appropriate. Therefore, its relevance is highly evaluated.

1-2. Effectiveness

Effectiveness of the Project is generally high.

As stated in III. Achievement of the Project above, the degree of achievement of the most indicators for the Project's purpose and output are regarded high. And the other indicators which have not yet reached the target values have improved in general compared to when the Project started. Furthermore, the results of interviews with the NA deputies, experts, and ONA's officials conducted during the monitoring survey confirm this outcome and the Project's contribution to the achievement (see Table 1-2 below). The surveys and analysis done in "2021 Research" also support the result. Therefore, the effectiveness of the Project is generally high.

1-3. Efficiency

Efficiency of the Project is high.

1-3-1. Basic evidence of the evaluation

(1) The project cost on the Japanese side was within the planned amount as below.

(3) Besides the result mentioned in the above (1) and (2), the NA deputies, experts, and

ONA confirmed the causal relationship between the Project's inputs and achievements, the summary mentioned in Table 1-2 above. They together could be evidence for the adequate size and timely inputs of the Project. Furthermore, the Project's support to the NA visiting tour and experiential education programs is a significant example of efficient inputs and its immediate good achievement, shown in 1-3-2. Concrete examples are shown in Table 1-3 below.

1-3-2. Concrete examples

From the beginning of 2020 to 2021, it became difficult to hold seminars with participation of experts from Japan and to conduct training programs in Japan due to the COVID-19 epidemic. However, the training by local experts and the input of equipment contributed to the efficiency of operations, including the equipment for the E-parliament (See 1-5. Sustainability), the content, and scale of inputs that met the needs of ONA provided timely. The results are shown in III.3-1 Achievement of the Project and III.3-2 Achievement of Project Output (See II.2 Result of the inputs and Annex 1 for the contents of inputs by the Project.)

One of the activities that are considered to be particularly efficient is the "The NA visiting tour and experiential education program" led by the Information Department. Initially, the department was not a counterpart of the Project, but in October 2015, the department was added to the counterpart of the Project as a department in response to Output 2: "The capacity of ONA to support the representative function of NA is enhanced".

In February 2016, a training delegation to Japan including Mr. Hoang Minh Hieu, Director of the Information Department, was organized by the JICA office. By that time, from March 2015, the Information Department has taken the lead in organizing the NA visiting tours. After learning about the "Children's Diet" and the "Special Experience Program" implemented by the House of Councillors in Japan, Director Hieu began to consider combining the existing NA visiting tour with a "Vietnamese version of the Special Experience Program" that would make use of the knowledge gained in Japan.

In July 2017, the previous phase of the Project conducted a training in Japan on the theme of "the NA education activities for Vietnamese Youth" for the officials of the Information Department, to learn and share of the experience of the Children's Diet and the Special Experience Program in the House of Councillors. They had an opportunity to learn about "Education of the Diet in Local Communities" in Saitama Prefecture. Based on

the findings mentioned above, in September 2017, the Information Department piloted the "Vietnam NA experiential education program" for junior high schools in Hanoi has since been working to enhance the content and expand the scale of the program. The Project has progressively supported the procurement of equipment and software for the NA visiting tour and experiential education program¹⁷.

In October last year, with the aim of further improving the program, the Information Department and the House of Councillors in Japan held an online seminar. It also provided an opportunity to hear the opinions of Vietnamese teachers and the media, as well as the experience of the Japanese parliamentary secretariat in running a similar program (1-2. Incountry Training/Seminar of Annex 1). The number of participants in the NA experiential education program has steadily increased from 70 at the start of the program in 2017 to 1,272 in 2018 and 2,195 in 2019. The number of participants in the NA visiting tour alone has decreased from 24,580 in 2017 to 18,648 in 2018 and 17,276 in 2019, but this is due to the fact that the number of tours is limited to ensure quality by avoiding tour during the NA session, and because the experiential education program mentioned above is given priority.

(The NA visiting tour and experiential education program have been temporarily suspended since the beginning of 2020 due to COVID-19 epidemic.)

1-4. Impact

Impact of the Project is generally high.

Vietnam's NA is the highest representative organ of the people and the highest organ of State power of the Socialist Republic of Vietnam. NA exercises constitutional and

legislative powers, decides significant national affairs, and exercises the supreme control over all activities of State¹⁸. Of these, the Project focused on the representative, legislative, and oversight functions of NA and set the following three indicators as those related to the Project's overall goal, "Functions to be performed by NA are strengthened". Based on the performance of each indicator shown below¹⁹, the Project is recognized as contributing to the achievement of the overall goal orchestrated with own various efforts by the Vietnamese side.

1-4-1. Indicator: The public assess representative function to be performed by NA is strengthened.

In order to promote debates that appropriately reflect the opinions of the public in NA, ONA provides logistical support for the NA deputies' communication with their local voters, public relations activities that promote stakeholders' understanding of the NA activities, information on public opinion to the NA deputies, and the management of sessions that contribute to smooth deliberations. The NA deputies, who are representatives of the people, give high marks to the ONA's support in the areas, as shown in the achievement of the related Indicator of the Project's purpose.

Besides, in the "2021 Research", it is suggested that the decision-making system based on majority rule was thoroughly implemented in accordance with the principle of collective leadership in the operation of each session, and as a result of the exchange of numerous opinions, the wisdom and sense of responsibility of the NA deputies were demonstrated, and a more dynamic and democratic atmosphere was created. In the 14th Legislature, digitalized materials became one of the primary resources for providing information to the NA deputies, and online deliberations were used in the NA plenary sessions and meetings in the NA Standing Committee and the NA committees. This is becoming a new form of legislative activity.

As data to support the above, the "2021 Research" asked the NA deputies to self-evaluate the management of deliberations in the NA plenary sessions, and the results showed that deliberations on socioeconomic conditions received the highest rating (65.1% rated it as "very appropriate"), followed by question-and-answer sessions (61.4% rated it as "very appropriate"). The question-and-answer session was rated highly (61.4% "very

appropriate"). When the percentage of those who rated the question-and-answer session as "somewhat appropriate" is added to the percentage of those who rated it as "very appropriate", the total percentage exceeds 95%, indicating that the question-and-answer session was highly rated in general.

1-4-2. Indicator: The public assess legislative function to be performed by the NA is strengthened.

In order to accelerate legislation that contributes to solving pressing problems of the people and the country, this indicator emphasizes the development of ONA's capacity to operate NA sessions according to proper procedures, the improvement of the expertise for the scrutiny of bills, and the provision of sufficient information to the NA deputies for the deliberation of bills, including the Digital Library.

Besides, in the "2021 Research", the following are the recent achievements of ONA in developing a system for enacting high-quality laws.

- (1) The "2015 revised law" clearly states that the organization or individual who submitted the bill can provide an explanation of the bill's content at the request of the Chairperson of NA or the NA deputies during the deliberation of the bill in plenary session. Accordingly, it was confirmed that administrative officials can also give their opinions on areas of jurisdiction at the request of the NA deputies.
- (2) It has been institutionalized in the rules of the NA session that the Chairperson of NA may instruct the Secretary-General of NA to prepare a form for hearing the opinions of the NA deputies if there is a difference of opinion among them during the deliberation of a bill.
- (3) In accordance with the "2015 revised law", the NA Standing Committee is held accountable for the results of the review of bills and for the opinions that were not reflected in the review. Based on this, the left explanation is shared in advance when the bill is reviewed and adopted by NA, which contributes to the smooth implementation of the review and adoption by NA.
- (4) The following efforts have been institutionalized in the procedures for the enactment

of laws and regulations: ①Setting a deadline for the submission of proposals for the enactment of laws and regulations, and rigorously carrying out preparatory work for such proposals; ②Strengthen cooperation with various organizations in the process of preparing proposals for the enactment of laws and regulations; and, ③After the enactment of the law, a comprehensive review will be conducted to assess the impact of the policy and hear the opinions of various ministries and agencies.

(5) Each NA regional group plays a role in incorporating the opinions of local organizations and individuals, and each NA deputy conducts research and opinions with the support of ONA and other organizations. In the case of bills where there are still different opinions, it becomes a common practice for the NA Standing Committee to hear opinions from the full-time NA deputies with knowledge.

1-4-3. Indicator: The public assessment oversight function to be performed by NA is strengthened.

Project Purpose does not have an objectively verifiable Indicator that explicitly presupposes efforts in this area. However, many of the ONA's efforts to strengthen the representative and legislative functions of NA have contributed to strengthening the oversight function of NA. Those efforts include the "2015 revised law" that makes it possible to invite the government agencies to explain on their activities in NA, and the provision of information to the NA deputies when questioning the government ministers.

Besides, the "2021 Research" pointed out that ONA has supported various legislations and NA's activities in the area such as the enactment of the "Law on Oversight Activities by NA and the People's Councils (2015)" which has contributed to the establishment of a system for managing the executive branch by holding question and answer sessions and votes of confidence in the sessions and dispatching inspection teams.

In the 6th session of the 14th Legislature (October-November 2018), a vote of confidence was held for 48 public officials elected or approved by NA, showing their achievements from the beginning of the term to the 14th Legislature (2016-2018), as well as an objective assessment of their abilities and personalities.

In the 6th session (October-November 2018) and 10th session (October-November 2020) of the 14th Legislature, focused on topics of public interest or controversial issues, NA invited and questioned the heads of State institutions that have jurisdiction over these matters, including the Minister of Construction, the Minister of Natural Resources and

Environment, the Minister of Labor, Wounded Warriors and Social Affairs, and the Minister of Information and Communications.

During the 14th Legislature, NA selected topics for audit activities, focusing on issues that are likely to cause public dissatisfaction and are essential, such as food safety, organizational reform of the state administrative structure, privatization of State enterprises, urban land use planning and management, fire prevention, and child abuse prevention.

1-5. Sustainability

Sustainability of the Project is generally high.

Improvement and given conditions in the following five areas are considered to contribute to the sustainability of the achievements by continuing the Project's activities.

1-5-1. Progress in building ONA's organizational and individual capacity

ONA has established workflows for each department and is building the capacity to carry out work in line with the workflows through training in soft skills such as administrative processing, leadership, communication, and coaching by local experts, and the introduction of IT equipment and software to improve work efficiency. The NA deputies have given a high evaluation to ONA's management of NA and support system for the NA deputies, and the internal review of the ONA's officials has shown the same recognition (see III. Achievement of the Project). Regarding the professional advice to the NA committees provided by the ONA's units in charge of the drafting process, through the

PDCA cycle, the Law Department recognizes room for improvement in the workflow about the cooperation and division of roles across multiple ONA's units and the Law Department.

1-5-2. Maintaining communication channels between Japanese and Vietnamese related organizations

Regular communication channels have been established between ONA in Vietnam and each supporting organization in Japan, including the exchange between the Japan-Vietnam National Assembly Library (see Good Practice Case below).

(Good Practice: Information exchanges between Japan and Vietnam National Diet Library)

■ 33 Japanese laws and regulations provided by the National Diet Library of Japan In March 2020, the NA Library sent a request email to the National Diet Library of Japan to collect Japanese laws and regulations related to 19 draft laws to be considered in 2020.

The NA Library translated the 33 corresponding Japanese laws and regulations provided by the National Diet Library of Japan into Vietnamese. The NA deputies received the information and utilized it as a reference for deliberative discussion during the NA session. The List of draft laws requested by the NA Library is as seen the Table1-6.

Sessions records since 1947 provided by the National Diet Library of Japan

As a project in 2021, the NA Library is creating a reference material on the activities of the foreign parliaments. In March 2021, the NA Library sent a request email to the National Diet Library of Japan to collect the session records of the Japanese National Diet. The

National Diet Library prepared the related information since 1947 with its statistical database and shared it with the NA Library.

1-5-3. Strengthening of the IT system in NA

For COVID-19 epidemic prevention, NA has accelerated the E-parliament project, strengthened the IT system in ONA, and proceeded with the digitalization, which enhanced robustness of the results of the capacity building of ONA and increased the sustainability.

(1) Promoting the implementation of online session management

NA approved the "Policy on investment and construction of the E-parliament project in the period of 2019-2026" (hereafter, the E-parliament project) at the regular meeting of the NA Standing Committee held in July 2019. As a COVID-19 epidemic prevention measure, the 9th session of May-June 2020 was partially held online. The session was divided into two periods, with the first period held online and the second period held in regular format.

As a result, the resilience to external shocks in the operation of NA has been strengthened, and at the same time, agenda-setting in more consideration of priorities, highly specialized discussions based on the materials prepared by ONA and securing contact with the people involved in the elected bodies before and after the first and second sessions and discussions reflecting their opinions have been encouraged.

(2) Continuation and promoting efficiency of the ONA's operations

During the expansion of COVID-19 infection from the beginning of 2020 onwards, ONA procured IT software and equipment to improve the efficiency of its daily works and for remote communication. The infrastructure could secure the continuity of work necessary for the operation of NA, assist the NA deputies, and hold international conferences chaired by Vietnamese NA.

The Project has supported the effort, and for example, the simultaneous interpretation set procured with the support from the Project was used at the IPU's online conference, "Young Parliamentarians' Conference," held on April 28-29 (attended by about 200 IPU members) and contributed to the success of the conference.

1-5-4. Prospects for budgetary support to sustain the result of the Project

The Project has supported capacity building within the ONA's existing organization and personnel and the development of rules and regulations that will contribute to efficient workflows for better session management. The additional investment for organizational and individual capacity building in the future may not be much, but own budgetary arrangement for internalization of the officials' training supported by the Project will be necessary to apply it to the broader officials of the ONA's units.

Among the new initiatives, the NA visiting tour and the experiential education program introduced in the previous phase have already been continuously budgeted as activities of the Information Department. In addition, the E-parliament project has been approved by the NA Standing Committee and positioned as a priority initiative of NA. As the IT center, which is responsible for the operation and maintenance of IT equipment at ONA, has been strengthened under the E-parliament project, we believe that there will be no major obstacles to the operation and maintenance of the IT equipment supported by the Project. However, it is considered necessary to pay attention to the financial resources for the renewal of equipment supported by the Project and/or the E-parliament project, and additional investment that may occur around and after 2026.

1-5-5. The NA deputies who were former ONA's officials and their expected role in the future

Among the officials of the Project counterpart units who participated in the Project activities, four directors were elected as the NA deputies in the election held in May 2021. In the future, it is expected that these four members, who are familiar with the purposes and activities of the Project, will maintain close cooperation with the ONA and participate in the NA activities as a full-time deputy, who will be the core of the activities of each NA committees. In addition to the four directors above, the following officials related to the Project, especially those who participated in training in Japan, have been elected as members of NA.

- 2. Outstanding achievements with the Project activities
- (1) The training/seminars in Japan²⁰ and Vietnam, sharing Japanese experience such as the Diet reform and deliberation on bills contributed to strengthening the ONA officials' capacity, paying more attention to the overall workflow for the legislative process, stakeholder relations, and feasibility of new laws, which are critical for the efficient management of NA and creating quality laws.
- (2) The Information Dept. started the NA visiting tours in 2015 and the experiential education programs in 2017 to make NA more proximate to the people. The tours and programs showed good performance in a short period and followed the PDCA cycle with a public opinion survey and symposium to hear opinions from major stakeholders, which are regarded as highly effective, efficient, and sustainable.
- (3) The NA Library of Vietnam was scaled up to a department of ONA in 2014 and started the Digital Library in 2015. Since then, its activities have been flourished as shown in Table 3-3 of III. Achievement of Project. The interviewed NA deputies emphasized the effectiveness and efficiency of the service in PMS.
- (4) The NA Library of Vietnam and the National Diet Library of Japan exchanged information as a routine practice that supports the Vietnamese legislative process. Accordingly, the NA deputies received reference information for the making of quality laws that contributed to the sustainable achievements of the Project in strengthening the NA's legislative function (See Good Practice Case of 1-5. Sustainability).
- (5) In July 2019, NA approved the "Policy on investment and development of the E-parliament project in the period of 2019-2026" (hereafter, the E-parliament project). Aiming for contribution to the policy, the Project assisted ONA in strengthening ONA's IT system. The ONA appreciated the Project for their efficient support with the new IT systems for the ONA counterpart units, which regards that will lead to the operation of NA improving effectively. The support for IT infrastructure of the ONA is even more necessary in the context that modalities for remote meetings and conferences in NA are introduced, which contributed to the robust operation in the context of COVID-19 epidemic.

3. Key Factors Affecting the Implementation and Outputs

- (1) At the initial stage of the Project, ONA's personnel changed due to the new term of NA (the 15th Legislature). Accordingly, the names and job titles of managements described in the Project Implement Structure of R/D were adjusted to the new personnel, including the Secretary-General of NA.
- (2) Due to the COVID-19 epidemic and according to travel restrictions and bans, the training in Japan and the dispatch of experts from Japan could not be carried out. Some activities were forced to postpone or change the implementation methods, which have not much affected the outputs of the Project.

4. Evaluation of the results of the Project Risk Management

- (1) Due to the COVID-19 epidemic, the initially planned seminars by Japanese short-term experts and JCC meetings face-to-face with all Vietnamese and Japanese members were held online. As a result, despite above 3. (2), the Project could implement most of the activities and accomplished the expected achievements above.
- (2) The Project assisted in strengthening the IT system in the ONA under the E-parliament project on the Vietnamese side, which contributed to the sustainable achievements of the Project activities.
- (3) To respond to the risks and critical issues for the Project implementation, the PMU held meetings regularly between the counterpart units and the Project involving the JICA office as an observer.
- (4) Due to the restriction of the face-to-face meetings under the COVID-19 epidemic, the Project prioritize frequent meetings with the Protocol Department that played a representative role well and coordinated the opinions of the other counterparts' units. Accordingly, the counterparts and the Project understand that there was no critical risk during the implementation of the Project.

5. Lessons Learnt from the Project

- (1) The flexible addition of the Information Department to the counterpart to strengthen the efforts in the area of public relations of NA contributed to the achievement of the Project.
- (2) In the political system of developing countries, there are many cases of promotion from officials to parliamentarians or from ministry officials to ministers and vice-ministers, as in the case of ONA in Vietnam, which also affects the sustainable realization of project goals positively. Therefore, from the abovementioned viewpoint, it was reaffirmed that the selecting counterparts at the time of project formation is important.
- (3) Seeing the experience of ONA effectively responded to the external shock of the COVID-19 disaster with the new IT system as a part of its efforts to improve operational efficiency and the introduction of the E-parliament, it was confirmed that the digitalization of the work could be an important initiative not only for improving efficiency but also for strengthening resistance to external shocks.
- (4) For the COVID-19 epidemic prevention, it had been difficult to hold face-to-face meetings for a long time in the Project implementation. However, the coordination of the Protocol Department, which is the counterpart contact point, functioned effectively and contributed to the smooth implementation of the Project by accurately absorbing the needs of the related units. From the abovementioned viewpoint, for the effective implementation of the Project, we reconfirmed the importance of hearing the voice of the coordination body of the counterparts and establishing a reliable relationship with them.

6. Room for further efforts

(1) The activities that will contribute to the realization of Overall Goal, "Functions to be performed by the National Assembly are strengthened", will vary depending on the public needs, and activities will need to be tailored to the development stage and government policy. It is also necessary to pay attention to the need for support of the 15th National Assembly members as well as their orientation for the ONA's organizational renovations, which may be revealed in the future. The contents of the activities may include efforts by units other than the current Project counterpart unit.

- (2) When the ONA's organizational capacity building for the legislative process progressed much, and the expected role has enlarged, the Law Dept. officials recognized room for revising the division of roles and promoting collaboration among the different ONA's units in substantive advisory works.
- (3) For IT systems and other equipment introduced under the Project, it is necessary to continue proper operation and maintenance of those items and sustain the result.

V. For the Achievement of Overall Goals after the Project Completion

1. Prospects to achieve Overall Goal

In the evaluation of the Impact above, the results obtained through the Project are considered to have contributed to the achievement of Overall Goal, "Strengthening the functions to be performed by NA (focusing on representative, legislative, and oversight functions)". On the other hand, the activities that will contribute to the achievement will vary depending on the public needs, and activities will need to be tailored to the development stage and government policy. It will be necessary to continue the Project activities and improve and expand the contents of the activities, including efforts by units other than the Project counterpart, within the PDCA cycle.

In the evaluation of the sustainability above, improvement and conditions in the following five areas are considered to contribute to the sustainability of the achievements by continuing the Project activities: (1) progress in building ONA's organizational and individual capacity, (2) promotion of IT system in parliamentary operations and ONA's daily work, (3) prospects for sustainable budgetary measures, (4) maintenance of communication channels between Japan and Vietnam related organizations, and (5) the election of ONA's graduates to NA and their expected roles in the future.

However, it might be necessary for ONA to make more efforts in the following areas: (1) the internalization of training programs that contribute to the organizational and individual capacity development and their implementation in a wide range of ONA's units; (2) the solid organization of communication channels between Japan and Vietnam-related organizations; and (3) the establishment of communication channels with similar foreign organizations besides Japan, and (4) sharing the Project experience from the NA deputies who were former ONA's officials to the other NA deputies.

2. Plan of Operation and Implementation Structure of Vietnamese side to achieve Overall Goal

2-1. Plan of Operation

In the description of Prospects to achieve the overall goal above, we mentioned the necessary efforts according to the different development stages and government policy. When considering the Vietnam's plan of operation to achieve the overall goal, it is

necessary to keep in mind the national goals, the goals for establishing a Rule of Law State, the goals of NA, and the planned deadlines for achieving goals.

The resolution of the 13th National Congress of the Communist Party in January 2021 stated, (1)To become a developing country with modern industry beyond the lower-middle-income level by 2025, the 50th anniversary of the complete liberation of the South and the national reunification, (2)To become a developing country with modern industry at the upper-middle-income level by 2030, the centenary of the Party's establishment, (3)To become a developed country at the high-income level by 2045, when the Socialist Republic of Vietnam celebrates its 100th anniversary. Under the target above, Vietnam is necessary to develop the legal system required for a developed country by 2045.

Furthermore, after the start of the 13th term of the Communist Party, the Committee on building a Rule-of-Law State, headed by the President of the State, was established and held its first meeting in July this year. The meeting decided to launch a project to realize the "Policy for Building and Completing a Socialist Rule-of-Law State by 2030 with Vision to 2045". This policy and vision are considered consistent with and complementary to the above Party's Resolution as the national goal.

From 2021 to 2045, five Legislatures with a term of five years are scheduled, and the above legislation will be implemented during those Legislatures. At the same time, the policy of "The organizational structure and operation of NA must be continuously reformed" has been carried over to the 15th Legislature and subsequent Legislature. The recommendations in the "2021 Research" submitted to the NA leaders for the continuous reform of the organizational structure and operation of NA suggest the most efforts to support the realization of the resolution above of the 13th Party Congress and the policy and vision of the Committee on building a Rule-of-Law State.

In light of the above, it is considered that the environment and systems are being developed to achieve the Project's overall goal: "Functions to be performed by the National Assembly are strengthened".

2-2. Implementation Structure

The current Implementation Structure for implementing the policy of "Continuously renewing the organizational structure and operation of the National Assembly" in order to achieve the Project's overall goal "The functions to be fulfilled by the National Assembly

will be strengthened" is as follows from (1) to (4), and the relationship between the various actors is expected to be maintained in the future.

- (1) The highest decision-making organ for the NA to fulfill its functions is its Standing Committee as a leadership body.
- (2) From time to time, the NA deputies who represent the people, and experts such as former NA deputies and former ONA's officials offer their opinions and suggestions for improving the operation of NA.
- (3) The foreign organizations will provide advice and suggestions based on their own experience and knowledge related to the policy.
- (4) ONA assists NA, the NA Standing Committee, and the NA deputies in fulfilling its necessary functions and takes various measures based on the instructions of (1), opinions and suggestions of (2), and consultations and advice of (3).
