1. BACKGROUND

Recognizing that the establishment of systematic family planning extension activities which are most suited to the actual life of Indonesian people is one of the most important tasks for the improvement of people's life, the Government of Japan and the Government of the Republic of Indonesia will jointly carry out a technical cooperation project in the field of information, education, and communication for family planning.

2. THE OUTLINE OF THE PROJECT

The Project intends to improve the audio-visual software materials for information, education and communication for family planning both in quality and quantity, and includes the following activities.

- (1) Training of Indonesian Staff in Japan
- (2) Improvement of facilities for software prototype production and training.
- (3) Services of Japanese Experts in Indonesia.

3. MEASURES TO BE TAKEN BY THE GOVERNMENT OF JAPAN

(1) In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to provide at its own expense, upon the request of the Government of the Republic of Indonesia through the normal procedure under the Colombo Plan Technical Co-operation Scheme, (Application Form A 1), the requisite services of Japanese experts including those for installation of equipment as listed in APPENDIX I.

(2) In accordance with laws and regulations in force in Japan, the Government of Japan will take the necessary measures through JICA to provide, at its own expense, upon the request of the Government of the Republic of Indonesia, through the normal procedure under the Colombo Plan Technical Co-operation Scheme, (Application Form A 4), such equipment and materials necessary for the implementation of the Project as listed in APPENDIX II.

a) The equipment and materials referred to above will become the property of the Government of Indonesia upon being delivered c.i.f. at the port of disembarkation to the Indonesian authorities concerned.

b) The equipment and materials referred to above will be utilized exclusively for the implementation of the Project in close consultation with the Japanese experts.

(3) In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to receive, at its own expense, upon the request of the Government of the Republic of Indonesia, through the normal procedure under the Colombo Plan Technical Co-operation Scheme, (Application Form A2, A3), Indonesian staff associated with the Project for such technical training in Japan as listed in APPENDIX III.

4. THE MEASURES TO BE TAKEN BY THE GOVERNMENT OF THE REPUBLIC OF INDONESIA

(1) In accordance with laws and regulations in force in Indonesia, the Government of the Republic of Indonesia will take necessary measures to ensure the provision and/or recruitment of Indonesian counterpart personnels as listed in APPENDIX IV and to provide, at its own expense, the services of such personnels.

(2) In accordance with laws and regulations in force in Indonesia, the Government of the Republic of Indonesia will take necessary measures to provide :

a) Space for software prototype development or space which is suitable to the purpose;

b) The supply or replacement of equipment and other materials for appropriate running of the Project, other than those provided by the Government of Japan under Paragraph 3. (2);

c) The expenses necessary for the domestic transportation of the goods referred to in Paragraph 3. (2), as well as for their installation, operation, maintenance and repair;

d) All running expenses necessary for the effective implementation of the Project.

(3) In accordance with laws and regulations in force in Indonesia, the Government of the Republic of Indonesia will take necessary measures to provide for the exemption of customs duties, internal taxes and other similar charges, if any, imposed in Indonesia in respect to the goods referred to in Paragraph 3. (2).

(4) The Indonesian authorities concerned will take the necessary measures to ensure that the knowledge and experience acquired by the Indonesian staff through the technical training in Japan under paragraph 1. (3), will be utilized effectively for the implementation of the Project.

5. PRIVILEGES, EXEMPTIONS AND BENEFITS

(1) The Japanese experts mentioned in Paragraph 3. (1) and their families will be granted privileges, exemptions and benefits in Indonesia, no less favourable than those granted to experts of any other countries working in Indonesia under the Technical Co-operation Scheme as well as those of the United Nations.

(2) The Government of the Republic of Indonesia will exempt the Japanese experts under the terms of this Record of Discussions from all taxes and other similar charges in connection with all remunerations remitted to them by the Government of Japan or JICA.

(3) In accordance with laws and regulations in force in Indonesia, the Government of the Republic of Indonesia will take necessary measures to meet:

a) The expenses for chauffeured vehicles for the Japanese experts during working hours;

b) The expenses for the internal travel in Indonesia of the Japanese experts on duty;

c) Free medical service and facilities for the Japanese experts and their families.

d) Expenses for fully furnished appropriate housing for the Japanese experts and their families.

6. CLAIMS AGAINST THE JAPANESE EXPERTS

In accordance with laws and regulations in force in Indonesia, the Government of the Republic of Indonesia undertakes to bear claims, if any arises, against the Japanese experts resulting from, occurring in the course of, or otherwise connected with the discharge of their official functions in Indonesia, except for those claims arising from the wilful misconduct or gross negligence of the Japanese experts.

7. Japanese experts will primarily give technical guidance and advice to the Indonesian staff associated with the Project pertaining to its implementation and Indonesian authorities concerned will be responsible for the administrative and managerial matters pertaining to the Project.

(It) is advisable to establish a Joint Committee under the Chairmanship of the Chairman of National Family Planning Coordinating Board (BKKBN-NFPCB), which consists of the representatives of both Indonesian experts, and the Japanese resident experts for the successful and smooth implementation of the Project.

8. Both Governments will consult with each other when necessary in respect to any matter that may arise from or in connection with this Record of Discussions.

9. The duration of the Japanese cooperation for "the Project" will be commencing from July 21st, 1977 to March 31st, 1980.

The Japanese Implementation Survey Team (hereinafter referred to as "the Team") organized by the Japan International Cooperation Agency (hereinafter referred to as JICA) and headed by Dr. Kunihiro Suetake, Professor of the Tokyo Institute of Technology, visited the Republic of Indonesia from 12, March to 23, March 1980 for the purpose of working out the details of the technical cooperation program concerning the Family Planning Project in the Republic of Indonesia.

During its stay in the Republic of Indonesia, the Team exchanged views and had a series of discussions with the Indonesian authorities concerned in respect of the desirable measures to be taken by both Governments for the successful implementation of the above-mentioned Project.

As a result of the discussions, the Team and the Indonesian authorities concerned agreed to recommend to their respective Governments the matters





THE ATTACHED DOCUMENT

I. COOPERATION BETWEEN BOTH GOVERNMENTS

1. The Government of Japan and the Government of the Republic of Indonesia will cooperate with each other in implementing... the Family Planning Project (hereinafter referred to as "the Project") for the purpose of developing the family planning programmes, and thus contributing to the advancement of welfare of the people in Indonesia.
2. The Project will be implemented in accordance with the Master Plan which is given in Annex 1.

II. DISPATCH OF JAPANESE EXPERTS

1. In accordance with the laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to provide at its own expense services of the Japanese experts as listed in Annex II through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
2. The Japanese experts referred to in 1 above and their families will be granted in the Republic of Indonesian the privileges, exemptions and benefits no less favourable than those accorded to experts of third countries working in the Republic of Indonesia under the Colombo Plan Technical Cooperation Scheme.

III. PROVISION OF MACHINERY AND EQUIPMENT

1. In accordance with the laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to provide at its own expense such machinery, equipment and materials necessary for the implementation of the Project as listed in Annex III, through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
2. The articles referred to in 1 above will become the property of the Government of the Republic of Indonesia upon being delivered c.i.f. to the Indonesian authorities concerned at the ports and/or airports of disembarkation, and will be utilized exclusively for the implementation of the Project in consultation with the Japanese experts referred to in Annex II.

IV. TRAINING OF INDONESIAN PERSONNEL IN JAPAN

1. In accordance with the laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to receive at its own expense the Indonesian personnel connected with the Project for technical training in Japan through the normal procedures under the Colombo Plan Technical Cooperation Scheme .

2. The Government of the Republic of Indonesia will take necessary measures to ensure that the knowledge and experience acquired by the Indonesian personnel from technical training in Japan will be utilized effectively for the implementation of the Project.

V. MEASURES TO BE TAKEN BY THE GOVERNMENT OF THE REPUBLIC OF INDONESIA

1. In accordance with the laws and regulations in force in the Republic of Indonesia, the Government of the Republic of Indonesia will take necessary measures to provide at its own expense:
 - (1) Services of the Indonesian counterpart personnel and administrative personnel as listed in Annex IV ;
 - (2) Land, buildings and facilities as listed in Annex V;
 - (3) Supply or replacement of machinery, equipment, instrument, vehicles, tools, spare parts and materials necessary for the implementation of the Project other than those provided through JICA under III above;
 - (4) Transportation facilities and travel allowance for the Japanese experts for the official travel within the Republic of Indonesia;
 - (5) Suitably furnished accommodation for the Japanese experts and their families.

2. In accordance with the laws and regulations in force in the Republic of Indonesia, the Government of the Republic of Indonesia will take necessary measures to meet :

- (1) Expenses necessary for the transportation within the Republic of Indonesia of the articles referred to in III above as well as for the installation, operation and maintenance thereof;
- (2) Customs duties, internal taxes and any other charges, imposed in the Republic of Indonesia on the articles referred to in III above.
- (3) All running expenses necessary for the implementation of the Project.

VI. ADMINISTRATION OF THE PROJECT

1. The Japanese experts will give necessary technical guidance and advice to the Indonesian staff associated with the Project pertaining to the implementation of the Project, and the Indonesian authorities concerned will be responsible for the administrative and managerial matters pertaining to the Project.
2. For the successful implementation of the Project, the Coordinating Committee will be established with the members as listed in Annex VI.

The Committee will meet at least once a year.

The functions of the Committee are;

- (1) To give guidance of the annual plan of action for the Project,
- (2) To review the implementation of the Project,
- (3) To advise the Indonesian authorities concerned about the implementation of the Project at all stages and at all levels.

The Government of the Republic of Indonesia undertakes to bear claims, if any arises, against the Japanese experts engaged in the Project resulting from, occurring in the course of, or otherwise connected with the discharge of their official functions in the Republic of Indonesia except for those arising from the willful misconduct or gross negligence of the Japanese experts.

VIII. MUTUAL CONSULTATION

There will be mutual consultation between the two Governments on any major issues arising from, or in connection with this Attached Document.

IX. TERM OF COOPERATION

The duration of the technical cooperation for the Project under this Attached Document will be three years from the date of signature.

1. The outline of the Project.

The Project aims to improve the activities of information and education, and other related activities for family planning, with special emphasis on the activities in the Media Production Center (MPC).

2. Implementation

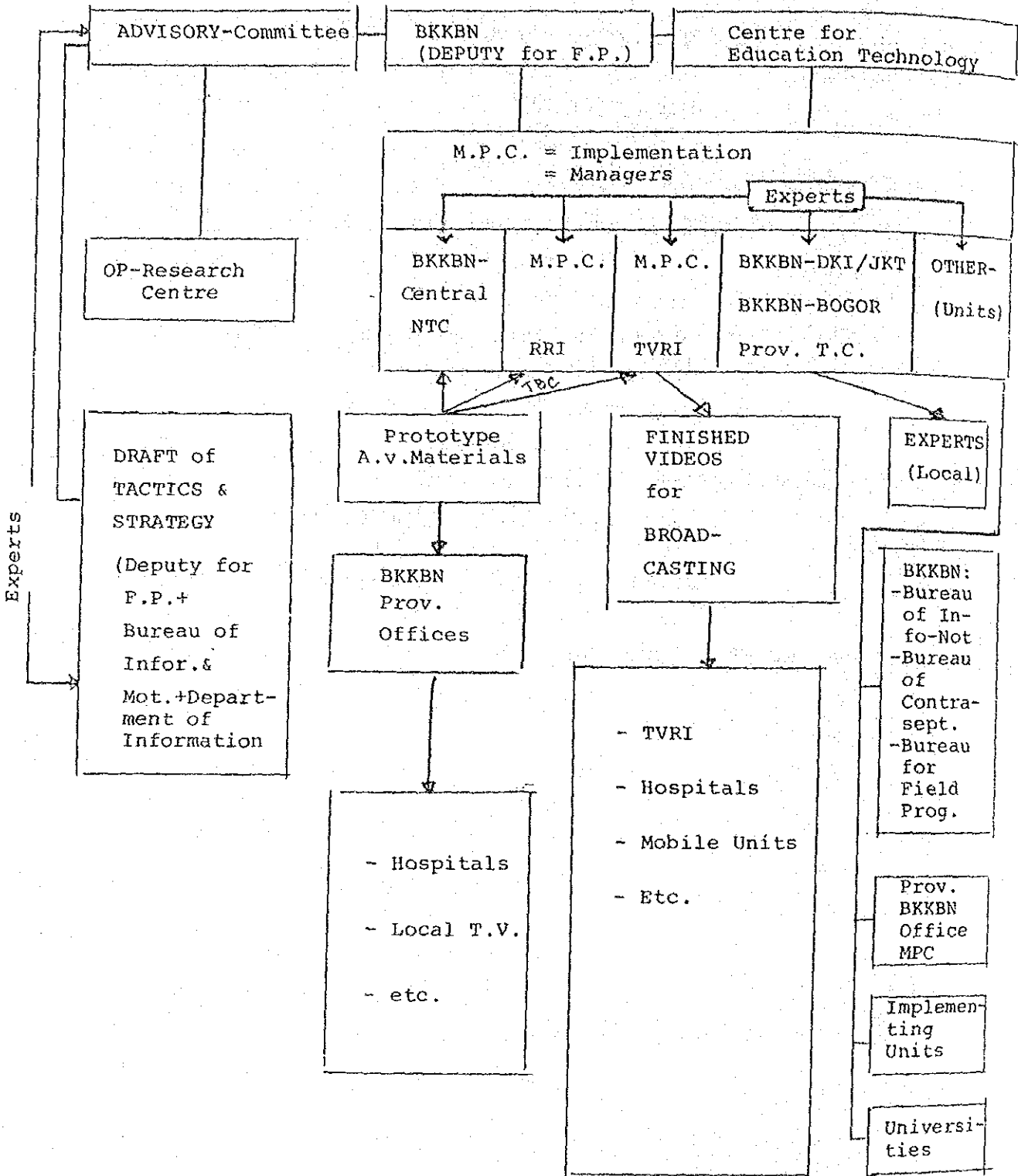

MECHANISM OF M.P.C.- ACTIVITIES




Record of Discussions between the Japanese






The Japanese Implementation Survey Team (hereinafter referred to as "the Team") organized by the Japan International Cooperation Agency (hereinafter referred to as JICA) and headed by Mr. Tameyoshi Katagiri, Director, Japanese Organization for International in Family Planning, INC, Tokyo, visited the Republic of Indonesia from January 22, 1982 to January 29, 1982 for the purpose of working out the details of the technical cooperation program concerning the Family Planning Project in the Republic of Indonesia.

During its stay in the Republic of Indonesia, the Team exchanged views and had a series of discussions with the Indonesian authorities concerned in respect of the desirable measures to be taken by both Governments for the successful implementation of the above-mentioned Project.


As a result of the discussions the Team and the Indonesian authorities concerned agreed to recommend to their respective Governments that the on going technical cooperation Project based on the Record of Discussion signed at Jakarta on March 18, 1980 be developed into a new form as provided for in the document attached hereto.

THE ATTACHED DOCUMENT

I. COOPERATION BETWEEN BOTH GOVERNMENT.

1. The Government of Japan and the Government of the Republic of Indonesia will cooperate with each other in implementing the Jakarta Urban Family Planning Project (hereinafter referred to as "the Project") for the purpose of improving and strengthening Information, Education and Communication (IEC), training in the field of the family planning in the Jakarta urban area, the activities of family planning service points, integrated family planning program with health^{care}, and thus contributing to the advancement of the welfare of the individuals there.
2. The Project will be implemented in accordance with the Master Plan which is given in Annex I.

II. DISPATCH OF JAPANESE EXPERTS.

1. In accordance with the laws and regulation in force in Japan, the Government of Japan will take necessary measures through JICA to provide at its own expense services of the Japanese experts as listed in Annex II through normal procedures under the Colombo Plan Technical Cooperation Scheme.
2. The Japanese experts referred to in 1 above and their families will be granted in the Republic of Indonesia the privileges, exemptions and benefits no less favourable than those accorded to experts of third countries working in the Republic of Indonesia under the Colombo Plan Technical Cooperation Scheme.

III. PROVISION OF MACHINERY AND EQUIPMENT.

1. In accordance with the laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to provide at its own expense such machinery, equipment and materials necessary for the implementation of the Project as listed in Annex III, through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
2. The articles referred to in 1 above will become the property of the Government of the Republic of Indonesia upon being delivered c.i.f. to Indonesian authorities concerned at the port and/or airports of disembarkation, and will be utilized exclusively for the implementation of the

Project in consultation with the Japanese experts referred to in Annex II.

IV. TRAINING OF INDONESIAN PERSONNEL IN JAPAN

1. In accordance with the laws and regulations in force in Japan, the Government of Japan will take necessary measures through JICA to receive at its own expense the Indonesian personnel connected with the Project for technical training in Japan through the normal procedures under the Colombo Plan Technical Scheme.
2. The Government of the Republic of Indonesia will take necessary measures to ensure that the knowledge and experience acquired by the Indonesian personnel from technical training in Japan will be utilized effectively for the implementation of the Project.

V. SERVICES OF INDONESIAN COUNTERPART PERSONNEL AND ADMINISTRATIVE PERSONNEL.

1. In accordance with the laws and regulations in force in the Republic of Indonesia, the Government of the Republic of Indonesia will take necessary measures to secure at its own expense necessary services of Indonesian counterpart personnel and administrative personnel as listed in Annex IV.
2. As to the Indonesian counterpart personnel, the Government of the Republic of Indonesia will allocate the necessary number of suitably qualified personnel corresponding to each Japanese expert to be dispatched by the Government of Japan as specified in Annex II, to fulfill the effective and successful transfer of technology under the Project.

VI. MEASURES TO BE TAKEN BY THE GOVERNMENT OF THE REPUBLIC OF INDONESIA.

1. In accordance with the laws and regulations in force in the Republic of Indonesia, the Government of Republic of Indonesia will take necessary measures to provide at its own expense:
(1) Land, buildings and facilities as listed in Annex V ;

- (2) Supply or replacement of machinery, equipment, instrument, vehicles, tools, spare parts and any materials necessary for the implementation of the Project other than those provided through JICA under III above ;
 - (3) Transportation facilities and travel allowance for the Japanese experts for the official travel within the Republic of Indonesia;
 - (4) Furnished accommodations for the Japanese experts and their families.
2. In accordance with the laws and regulations in force in the Republic of Indonesia, the Government of the Republic Indonesia will take necessary measures to meet :
- (1) Expenses necessary for the transportation within the Republic of Indonesia of the articles referred to in III above as well as for the installation, operation and maintenance thereof ;
 - (2) Customs duties, internal taxes and any other charges, imposed in the Republic of Indonesia on the articles referred to in III above;
 - (3) All running expenses necessary for the implementation of the Project.

VII. ADMINISTRATION OF THE PROJECT.

- 1/ The Project Manager appointed by the National Family Planning Coordinating Board will be responsible for the administration, management and implementation of the Project, and the Japanese expert will provide necessary technical guidance and advice for the implementation of the Project.
2. For the effective implementation of the Project, the Working Committee consisting of the members as listed in Annex VI, will meet at least once a month. The functions of this Working Committee are :
 - (1) To review the implementation of the Project;
 - (2) To discuss and take ^{necessary measures} to solve problems arising during the implementation of the Project; and
 - (3) To develop the annual plan of action for the Project.

VIII. CLAIMS AGAINST JAPANESE EXPERTS

The Government of the Republic of Indonesia undertakes to bear claims, if any arises, against the Japanese Experts engaged in the Project

resulting from, occurring in the course of, or otherwise connected with the discharge of their official functions in the Republic of Indonesia except for those arising from the willful misconduct or gross negligence of the Japanese experts.

IX. MUTUAL CONSULTATION.

There will be mutual consultation between the two Governments on any major issues arising from, or in connection with this Attached Document.

X. TERM OF COOPERATION

The duration of the technical cooperation for the Project under this Attached Document will be three (3) years from January 28, 1982 to March 31, 1985.

ANNEX I. MASTER PLAN.

1. Objectives

The objectives of this Project is to support the implementation of the Jakarta Urban Family Planning program in the following specific area :

- (a) ^{To} Develop and strengthen production of IEC materials and IEC activities through the MPC;
- (b) ^{To} Increase knowledge and skills of service providers through local training;
- (c) ^{To} Strengthen and develop family planning service points;
- (d) ^{To} Strengthen and develop integrated family planning program with health care.

2. Implementation

The National Family Planning Coordinating Board of the Government of the Republic of Indonesia (BKKEN) has responsibility for the implementation of the Project, with the assistance of the Working Committee consisting of the members as listed in Annex VI. The overall responsibility will rest with the Government of the Republic of Indonesia. The Government of Japan will cooperate with the Government of the Republic of Indonesia in carrying out the Project through dispatch of Japanese Experts, acceptance of Indonesian personnel for training in Japan and provision of equipment.

3. Activities

The Project will consist of the following activities :

- A. ^{To} Develop and strengthen production of IEC materials and IEC activities through the MPC :
 - (1) At Technical Production Unit, development and improvement of video family planning program for use mainly in the training of family planning service providers, such as medical doctors at health centers as well as private clinics, midwives, and other paramedics, communication providers and management personnel in the Jakarta urban area.
 - (2) At Motivational Production Unit for Radio, development and improvement of audio family planning program for use in motivating the general public for family planning in the Jakarta urban area, and training family planning workers, through radio and so on.

- (3) At Motivational Production Unit for Video, development and improvement of video family planning program for use in motivating the general public for family planning, and training family planning workers, in the Jakarta urban area through TVRI, monitors and VTRs, mobile vans and so on.
- (4) With the use of motivational and teaching materials produced in the three Units mentioned above, IEC and training activities for the promotion of family planning in the Jakarta urban area will be conducted for the target audiences described above.

B.^{To} Increase knowledge and skills of Indonesian personnel through local training :

- (1) a. Provide local training for family planning service providers, in both private and government sector. This training would be carried out in Indonesia.
- b. Provide local training for medical and paramedical personnel from government service points involved in integrated family planning with health, especially for phase III area (area with current user level more than 35 %). This training would be carried out in Indonesia.
- (2) Provide training for counterparts personnel to be carried out in Japan.
- (3) Training of Indonesian staff assigned to the Project.

C.^{To} Develop and strengthen family planning service points :

Provide IEC materials and equipment as well as equipment for government family planning clinics, private and industrial clinics including multinational companies, private doctors and midwives, and other related personnel.

D.^{To} Develop and strengthen integrated family planning program with health :

- (1) Provide necessary facilities to serve integrated family planning program with health for government service facilities in phase III area.
- (2) Provide all needs for the integrated family planning program with health.

E. Other related activities mutually agreed upon as necessary.

ON THE RECORD OF DISCUSSIONS BETWEEN THE JAPANESE
IMPLEMENTATION SURVEY MISSION AND THE AUTHORITIES
CONCERNED OF THE REPUBLIC OF THE PHILIPPINES ON THE
TECHNICAL COOPERATION IN THE FIELD OF FAMILY PLANNING

The Overseas Technical Cooperation Agency (OTCA), entrusted with execution of technical cooperation by the Government of Japan, organized an Implementation Survey Mission (hereinafter referred to as the Mission), headed by Mr. Tameyoshi Katagiri, Director of the Family Planning Federation of Japan, which visited the Republic of the Philippines from July 8 to July 18, 1974 for the purpose of working out the details of a cooperation project in the field of Family and Population Planning in the Philippines.

The Mission exchanged views and had a series of discussions with the Commission on Population (hereinafter referred to as the POPCOM) of the Government of the Republic of the Philippines concerning the necessary and mutually acceptable measures to be undertaken by the two Governments to realize the said Project. As a result of the survey and discussions, the two parties agreed to recommend to their respective Governments to carry out the matters referred to in the attached Record of Discussions including its Annexes concerning the technical cooperation project in the field of Family and Population Planning in the Philippines.

RECORD OF DISCUSSIONS

Recognizing that to find solution to population problem is one of the important tasks for improving the welfare of people and for achieving greater social stability, the Government of Japan and the Government of the Republic of the Philippines will jointly endeavor to carry out the Family Planning Cooperation Project in the Philippines (hereinafter referred to as the Project) by further strengthening and expanding the Education, Information and Communication (EIC) and Training components and other related activities of the Program in the Philippines.

1. (1) In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures to provide at its own expense the requisite services of Japanese experts in the field of Family and Population Planning, upon request of the Government of the Philippines, through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
(2) The Japanese experts mentioned above and their Families will be granted in the Republic of the Philippines privileges, exemptions and benefits no less favorable than those granted to experts of third countries or of international organizations such as the United Nations performing similar missions.
2. (1) In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures to provide at its own expense the equipment listed in Annex I, including the corresponding spare parts of asterisked items through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
(2) The goods referred to above will become the property of the Government of the Republic of the Philippines upon being delivered c.i.f. at the port of disembarkation to the POPCOM.
(3) The Government of Japan will provide POPCOM with the necessary spare parts for a period of two (2) years upon the arrival of the requested equipment covered by the Project.
3. In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures to receive at its own expense Philippine staff engaged in the Project for the existing group training courses listed in Annex II, as well as for individual training courses in Japan through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
4. The Government of the Republic of the Philippines will undertake to bear claims, if any arises, against the Japanese

experts resulting from, occurring in the course of, or otherwise connected with the discharge of their official functions covered by this Record of Discussions, except for those claims arising from the willful misconduct or gross negligence of the Japanese experts.

5. The Government of the Republic of the Philippines will undertake to meet:

(1) expenses for medical treatment of the Japanese experts and for their approved official travel within the Republic of the Philippines, as programmed by POPCOM, in accordance with laws and regulations in force in the Philippines,

(2) expenses necessary for the transportation of the goods listed in Annex I within the Republic of the Philippines as well as for their installation, operation, maintenance and other running expenses necessary for the implementation of the Project,

(3) customs duties and any other charges, if any, as may be imposed by the Republic of the Philippines on the goods listed in Annex I.

6. The Government of the Philippines wishes to forward to the Government of Japan, through normal channels, request for equipment programmed for the succeeding years of Assistance in the areas of Training, Information, Education, and Communication.

7. The two (2) Governments will consult with each other from time to time to ensure the successful implementation of the Project.

8. The duration of the Japanese cooperation for the Project will be five (5) years commencing from 1974 Japanese Fiscal Year.


EXTENSION NOTE FOR THE RECORD OF DISCUSSIONS CONCERNING
TECHNICAL COOPERATION FOR THE FAMILY PLANNING PROJECT


The Japanese Implementation Survey Team (hereinafter referred to as the Team) organized by the Japan International Cooperation Agency had a series of talks with the authorities concerned of the Government of the Republic of the Philippines on the extension of the on-going technical cooperation for the Family Planning Project based on the Record of Discussions signed at Manila on 17 July 1974.

As a result of the talks, the Team and the Philippine Authorities concerned agreed to recommend to their respective Governments the following understanding reached between them.

The period of technical cooperation based on the above-mentioned Record of Discussions will be extended until 31 March 1981, during which period both Governments will study the establishment of a Model Area in a certain province within the scope of activities of the Project, and with regards to the question on the indemnification clause on Japanese experts assigned to the Philippines, it is understood that the recent understanding reached between the Japanese Government and the Philippine Government shall be applied: The Government of the Philippines shall be responsible for dealing with claims which may be brought by third parties against Japanese experts, and shall hold them harmless in respect of claims or liabilities arising in the course of, or otherwise connected with the discharge of their official duties in the implementation of the Project, except when such claim or liability arises from gross negligence or wilful misconduct of the above-mentioned individuals. Should any question arise in connection with the foregoing, both Governments shall immediately consult with each other.




EXTENSION NOTE FOR THE RECORD OF DISCUSSIONS CONCERNING
TECHNICAL COOPERATION FOR THE FAMILY PLANNING PROJECT


The Japanese Implementation Survey Team (hereinafter referred to as the Team) organized by the Japan International Cooperation Agency had a series of talks with the authorities concerned of the Government of the Republic of the Philippines on the extension of the on-going technical cooperation for the Family Planning Project based on the Record of Discussions signed at Manila on 17 July 1974.

As a result of the talks, the Team and the Philippine Authorities concerned agreed to recommend to their respective Governments the following understanding reached between them.

The period of technical cooperation based on the above-mentioned Record of Discussions will be extended until 31 March 1981, during which period both Governments will study the establishment of a Model Area in a certain province within the scope of activities of the Project, and with regards to the question on the indemnification clause on Japanese experts assigned to the Philippines, it is understood that the recent understanding reached between the Japanese Government and the Philippine Government shall be applied: The Government of the Philippines shall be responsible for dealing with claims which may be brought by third parties against Japanese experts, and shall hold them harmless in respect of claims or liabilities arising in the course of, or otherwise connected with the discharge of their official duties in the implementation of the project, except when such claim or liability arises from gross negligence or wilful misconduct of the above-mentioned individuals. Should any question arise in connection with the foregoing, both Governments shall immediately consult with each other.

RECORD OF DISCUSSIONS

Recognizing that to find solution to population problem is one of the important tasks for improving the welfare of people and for achieving greater social stability, the Government of Japan and the Government of Thailand will jointly endeavor to carry out the Family Planning Cooperation Project in Thailand (hereinafter referred to as the Project) by further strengthening and expanding the Education, Information and Communication (ETC) and Training Components and other related activities of the Project in Thailand.

(2) The Japanese experts mentioned above and their families will be granted, in Thailand, privileges, exemptions and benefits accorded to experts under the Colombo Plan.
2. (1) In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures to provide at its own expenses, upon the request to be made by the Government of Thailand, the necessary and relevant equipment, vehicles and materials for the fruitful implementation of the Project as listed in Annex I, which is an indicative requirement of the Ministry of Public Health.
(2) The equipment, vehicles and materials referred to above will become the property of the Government of Thailand upon being delivered c.i.f. at the port of disembarkation to the Department of Technical and Economic Cooperation (DTEC).
3. In accordance with laws and regulations in force in Japan, the Government of Japan will take necessary measures to receive at its own expenses Thai staff engaged in the Project for the seminars and training courses in Japan as listed in Annex II through the normal procedures under the Colombo Plan Technical Cooperation Scheme.
4. The Government of Thailand will undertake to meet:
 - (1) expenses necessary for the transportation of the equipment, vehicles and materials within Thailand as well as for their installation, operation, maintenance and other running expenses necessary for the implementation for the Project.

(2) customs duties and any other charges, if any, as may be imposed in Thailand in respect of the above equipment, vehicles and materials as listed in Annex I.

5. The two (2) Governments will consult with each other from time to time to ensure the successful implementation of the Project.

6. The duration of the Japanese cooperation for the Project will be five (5) years commencing from 1974 Japanese Fiscal Year.
