January 13 (Friday)

Leaves Tokyo at 12:40 (AF 269 via Moscow).

Arrives at Paris at 20:10.

January 14 (Saturday)

Leaves Paris at 11:40 (UT 787)

Arrives at Lagos at 17:40.

January 15 (Sunday)

Discusses the survey schedule at the Japanese Embassy in the afternoon.

January 16 (Monday)

Pays a courtesy call on Mr. B.M. Tukur, General Manager, the Nigerian Ports Authority (NPA) at 09:00.

Adjusts and confirms the Scope of Work with Mr. D.P. Opara and discusses the schedule at 10:00.

Pays a courtesy call on Japanese Ambassador Tanaka at the Japanese Embassy in the afternoon.

#### January 17 (Tuesday)

Yokota, Takayama and Komori carry out a survey on the Victoria beach of the east coast of Lagos Port in the morning.

Maeda calls on Mr. Adeusi, Deputy Secretary for Ports, at the Federal

Ministry of Transport and briefs him on the purpose of the survey.

In the afternoon, Ishiwata, Yokota, Takayama, Inamura and Komori carry out a survey on the vicinity of Lagos, the town of Epe, and Badagri Creek,

## January 19 (Thursday)

All members of the team are briefed on Tin Can Island Port by Mr. A. Ogunaike, manager of Tin Can Island Port, and make a fact-finding tour of Tin Can Island Port.

# January 20 (Friday)

Maeda, Ishiwata and Inamura call at the Central Planning Office, the Federal Ministry of Economic Development, at 10:00 to be briefed by the Director, Mr. T. Ilugbuhi, and experts in various fields, on the progress of the Third National Development Plan, population, progress of major industrial development projects and preparations for the Fourth National Development Plan. Yokota, Takayama and Komori call on Mr. Abayomi, director of the Meteorological Agency, and Assistant Chief, Mr. G.I. Ewalu, to ask questions about the meteorological and maritime conditions of Nigeria. In the afternoon, Maeda, Ishiwata and Takayama consult with Mr. Sharma of NPA on the following week's schedule. They later brief Secretary Takita and JICA Resident Representative Tomita on the following week's schedule at the Japanese Embassy.

## January 21 (Saturday)

At the Japanese Embassy, the team is briefed by Mr. Mitarai of Kawasaki Kisen and Mr. Tsurusaki of Mitsui O.S.K. Lines on the present conditions, traffic and loading and unloading in respect of Lagos Port.

Ishiwata and Inamura leave for Tin Can Island Port at 10:00. Questions are put to Mr. A.T. Muluey on the width of the apron and the depth of channel. Questions are also put to Mr. Lipede, Chief Engineer, on the

width of the apron, depth of channel and the reason for availability of few sheds. Visit Mr. Osoba, Deputy Controller of Engineering at Apapa. Maeda, Yokota, Takayama and Komori visit the University of Lagos.

January 24 (Tuesday)

Takayama, Yokota and Komori go to bookstores in downtown Lagos to buy maps.

In the afternoon, Komori goes to the Federal Survey to purchase maps. Maeda, Ishiwata, Yokota and Inamura coordinate the following week's schedule with Mr. Sharma of NPA.

In the afternoon, Maeda pays a courtesy visit to Mr. T. Usman, Permanent Secretary of the Federal Ministry of Works.
