


Figure N-1-1 Organization Chart of the System for Usage and Distribution of Water and Irrigation Facilities in Bulgaria

Figure N-1-3 Organization Chart of 'Napoitelni Sistemi' EAD (Irrigation Systems Co.)








Figure N-1-5 Organization Chart of the Vodproect EAD


Figure N-1-7 Organization Chart of Vodno Stopanstvo, Public Limited Company

I. Introduction

In response to the request of the Government of the Republic of Bulgaria (hereinafter referred to as "Bulgaria"), the Government of Japan decided to conduct the Feasibility Study on the Project for Agricultural Reform in Bulgaria (hereinafter referred to as "the Study") in accordance with the relevant laws and regulation in force in Japan.

Accordingly, the Japan International Cooperation Agency (hereinafter referred to as "JICA"), the official agency responsible for the implementation of technical cooperation programs of the Government of Japan, will undertake the Study in close cooperation with the authorities concerned of the Government of Bulgaria.

Ministry of Agriculture and Food Industry (herinafter referred to as "MAFI") is the implementing agency of the Study in cooperation with the Irrigation Systems Company.

The present document sets forth the scope of work with regard to the Study.

II. Objectives of the Study

The objectives of the Study are:

- 1.To formulate the agricultural development plan in the selected area to be adapted to the market-oriented economy in order to support the restoration of Bulgarian agriculture.
- 2.To transfer relevant technologies to Bulgarian counterpart personnel in the course of the Study.

III. Study area

The Study shall cover three areas located in Petrich, Rositza and Sredna Tunja, approximately 11,000ha, 50,700 ha and 97,000 ha respectively.

IV. Scope of the Study

To achieve the objectives mentioned above, the Study shall cover the following items:

1. Review and Analysis of Economic and Agricultural Reform Situation/

- (4) to exempt the members of the Japanese study team from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Japanese study team for their services in connection with the implementation of the Study:
- (5) to provide necessary facilities to the Japanese study team for remittance as well as utilization of the funds introduced into the Republic of Bulgaria from Japan in connection with the implementation of the Study;

- 3. MAFI shall act as a counterpart agency to the Japanese Study team and also as a coordinating body in relation with other governmental and

Meeting Minutes

I. In accordance with the Scope of Work for the Study on the Project for Agricultural Reform in Bulgaria (herein referred to as the Study) agreed upon between Japan International Cooperation Agency (JICA) and the Ministry of Agriculture and Food Industry (MAFI), the JICA Study Team submitted 20 copies of the Inception Report on 12 June 1996 to the MAFI Working Group. The Working Group, as ordered in MAFI Order No. 1-507, is defined as the counterpart for the JICA Study Team.

- II. Meetings to review the Inception Report were held in MAFI offices on 12, 13, and 14 June. The attendants of the meeting are listed in the attached. The meeting was lead by Mr. Georgi Spiridonov, Chairman of the MAFI Study Working Group. Members of the JICA Study Team, lead by Mr. T. Kobayashi, explained the contents of the report, and the MAFI Working Group accepted the Inception Report as written.
- III. English language versions of the Inception Report and these Minutes of Meeting are adopted as the official working documents.
- IV. The following points were reviewed in the course of the discussion on 13 June, and consensus was made between the MAFI Working Group and the Study Team.
- A. The Japanese side submitted a request to MAFI to provide the Study Team with an office in the MAFI building. The Working Group promised to investigate the possibility of the provision of this office for the Study Team. The Working Group will also arrange to issue passes for the Study Team to facilitate routine entry and exit from the MAFI offices.
- B.. The Bulgarian side offered comments on the Inception Report, and the Japanese side agreed to consider the comments as the Team begins the field assignment. Summary of the key issues raised by the Bulgarian side and discussed with the Study Team includes:
 - 1. The definition of hectares for the three targeted regions was clarified to mean the potential irrigation system areas, not a definition of the regions by municipal or administrative boundaries.
 - 2. Description of 3 issues or categories of agricultural management in the γ Inception Report were recognized as only an initial method of describing Bulgarian agriculture. The members agreed that definition by export-oriented production and domestic market-production and a distinction grain and vegetable production will be a better means of defining basic categories.
 - 3. Description of marketing systems, and study of distribution networks, will include both domestic and export marketing issues within scope of the study.

- 4. Organizational issues will include cooperative and associations as part of the study.
- 5. Among the criteria for selection of the pilot area, the issue of development potential is of the utmost importance. Land reform and land restitution may not be the most important issues since land reform is an evolving process, and significant changes are anticipated over the next 1-2 years.
- 6. Procedures for the selection of the pilot area will require further definition, and the process of narrowing the focus to an area less than 30,000 ha will require further description and discussion.
- 7. Livestock production is an important issue, and a systems approach to analyzing the agricultural sector is encouraged. The Study Team confirmed the importance of livestock production, and will address the Issue in the field work with particular emphasis on feed and fodder production from an agricultural crop production and marketing perspective. Detailed review of meat processing, marketing and distribution will not be possible within the established Scope of the project as agreed by both Governments in the S/W.
- 8. Study and research of marketing issues will include not only the EC/PHARE and EBRD activities, but also the activities of other international donors and private investors.
- 9. Study objectives as written are vague and require further definition to ensure a successful project. The S/W defines the Objectives and these objectives are agreed. Objective (1) now requires further definition including contents of major reports submitted, and clarification of the outputs of the overall study. Further definition will ensure development of concrete recommendations. Objective (2) requires further clarification and an operational plan to understand the activities covered under technology transfer and training.
- 10. As discussed with the S/W mission, participation of Bulgarian experts as part of the Study Team is encouraged, similar to the activities of other international donors. Such participation will be efficient, and facilitate local understanding.
- 11. Plans for a seminar or series of seminars at the regional level, and/or a project campaign for the pilot project area will be discussed in more detail as the study progresses. In principal, this activity may encourage participation of local residents in the development process, though care will be taken to not raise expectations to an unrealistic level.

- Item 1. Mr Spiridonov thanked the team for their work and the Progress Report (I)
- Item 2. Mr Kobayashi reviewed Chapter 4-3, a comparison of the 3 study areas, in terms of their suitability for agricultural production, the type and condition of their infrastructure, the progress of land restitution in the area, the availability of water, the farming systems in each area, etc.
- Item 3. Mr Kobayashi indicated that although the final selection of the site for the pilot project was contingent on further analysis in Japan, the high potential areas at this time appeared to be:

Rositza

- The Main Left Nikyupsky canal

Sredna Tunja

Binkos Marash

- Nova Zagora

- Item 4. The Working Group agreed that these were the high potential areas.
- Item 5. The Working Group stressed the importance of the attitude of the producers in the selected pilot area towards a project, especially their willingness to assume operations and maintenance costs.
- Item 6. The Working Group agreed to make the final selection when they had received the results of the further analysis, and looked forward to receiving the Interim Report.
- Item 7. The Working Group said that MAFI could only guarantee MAFI & ISC statistics and pointed out the importance of ensuring that the team was using the best available data, as the conclusions depend on the data.
- Item 8. Mr Spiridonov officially accepted twenty (20) copies of the Progress Report (I) on behalf of the Working Group.
- Item 9. The meeting ended with expressions of mutual gratitude, with both parties looking forward to continuing their collaborative work in November, and the Study Team hoped that MAFI would be able to provide office space for them during Phase II,

Meeting Minutes

I. In accordance with the Scope of Work for the Feasibility Study on the Project for Agricultural Reform in Bulgaria (herein referred to as the Study) agreed upon between Japan International Cooperation Agency (JICA) and the Ministry of Agriculture and Food Industry of Bulgaria (MAFI), the JICA Study Team submitted 20 copies of the Interim Report on 4 November, 1996 to representatives of the MAFI Working Group. The Working Group, as ordered in MAFI Order No. 1-507, is defined as the counterpart for the JICA Study Team.

- II. The meetings to review the Interim Report were held in MAFI offices on 4 & 5 November. The attendants of the meeting on 5 November are listed on the attached sheet. This meeting was opened by Mr. Dimo Uznov, First Deputy Minister, MAFI, and addressed by Mr. Emil Betzinsky, Head of the International Cooperation Department, MAFI, Mr. Osamu Koyama, Chief, Project Advisory Committee, JICA and Mr. Noboru Saito, Director Planning Division, Agriculture, Forestry and Fisheries Development Study Department, JICA. The MAFI Study Working Group, lead by Mr. Georgi Spiridonov, and the JICA Study Team, lead by Mr. T. Kobayashi, discussed the contents of the report, and the MAFI Working Group accepted the Interim Report as written.
- III. The following points were discussed in the course of the meeting on 5 November, 1996. Both the Bulgarian and Japanese sides were complimentary of the cooperation and assistance rendered to each side during the Phase I study, and hopes for the continuance of this collaboration were widely expressed as the Study Team begins Phase II.
- A. The JICA Study Team Leader provided an overview of the Phase I study process. The Study Team Leader highlighted the selection criteria applied for identifying the one pilot area. The Bulgarian side agreed with the process and the results of Phase I. The Bulgarian Working Group offered comments on the Interim Report, and the Japanese side clarified the technical points raised by the Bulgarian side. Key issues raised by the Bulgarian side and discussed with the Study Team include:
 - 1. Selection of the pilot area was carried out in accordance with the criteria given in the interim report. Nomination of Nova Zagora M3 Canal Block as the pilot area was confirmed as an appropriate selection, and both sides expressed interest in proceeding with further study of this pilot area in Phase II.
 - 2. Further review of the legislative environment now in place in Bulgaria was encouraged as work proceeds into Phase II. Special attention was suggested for the "Law on the Protection of Agricultural Producers", the "Cooperatives Act", and the "Land Lease Act". Detailed review of these laws was not required in the Phase I Study, though further consideration of the prevailing legal framework will

be important in preparing components of the pilot project in Phase II.

- 3. The Interim Report was noted as being comprehensive and the Report offers insight in study methodology for the Bulgarian Working Group.
- B. The Japanese side commented that the Phase II study would have to cover a wide range of topics linked to agricultural reform, such as water user associations, agricultural support services, cooperatives, credit, farm management, marketing, food industry privatization and irrigation. The Bulgarian side agreed. Both sides confirmed a willingness to work closely together in Phase II to address these issues in planning for a pilot project.
- C. The Japanese side provided an overview of the Phase II schedule. The JICA Study Team will begin field work immediately and conclude on 14 December. A meeting of the MAFI Working Group and the JICA Study Team to review the Progress Report (2) was suggested on or about 10 December. Draft Final Report preparation will begin in Japan in mid-December and continue during the month of January. Presentation and explanation of the Draft Final Report will be made in Bulgaria during early March 1997. The Final Report will be completed in April.
- D. The Japanese side submitted a request to MAFI to provide staff to facilitate a close working relationship during the field work. MAFI confirmed that their Working Group seeks close collaboration, and will ensure MAFI staff and ISC staff are available to work with the JICA Team. The Japanese side again suggested the need to provide the Study Team with an office in the MAFI building. The Chairman of the Working Group noted their past best efforts and promised to further investigate the possibility of the provision of office space for the Study Team.
- E. In closing the meeting to review the Interim Report, both the Bulgarian and Japanese sides expressed satisfaction for the past collaboration in this Study process, and confirmed a commitment to expanded cooperation in the coming months.

Meeting Minutes

I. In accordance with the Scope of Work for the Feasibility Study on the Project for Agricultural Reform in Bulgaria (herein referred to as the Study) agreed upon between Japan International Cooperation Agency (JICA) and the Ministry of Agriculture and Food Industry (MAFI), the JICA Study Team submitted 20 copies of the Progress Report II on 10 December 1996 to representatives of the MAFI Working Group. The Working Group, as ordered in MAFI Order No. 1-507, is defined as the counterpart for the JICA Study Team.

II. The meetings to review the Progress Report II were held in MAFI offices on 10 & 11 December. The attendants of the meeting on 11 December are listed in the attached. The meeting was lead by Mr. Georgi Spiridonov, Chairman of the MAFI Study Working Group, and joined by Mr. Evgeni Kizilov, Member of Parliament from Nova Zagora, Mr. Emil Betzinsky, Head of the International Cooperation Department, MAFI. Members of the JICA Study Team, lead by Mr. T. Kobayashi, explained the summary contents and project components, and the MAFI Working Group accepted the Progress Report II as written.

III. English language versions of the Progress Report II and the Minutes of Meeting are adopted as the official working documents. A Bulgarian language translation of the English version of the "Summary" was distributed, and this Summary was the basis for discussion during the 11 December meeting.

IV. The following points were discussed in the course of the meeting on 11 December 1996. Both the Bulgarian and Japanese sides opened with expressions of gratitude for the cooperation and assistance rendered to each side during the Phase II field assignment, and expressed hope for fulfillment of the project.

A. The JICA Study Team Leader provided an overview of the Key Assumptions guiding the Study Team, and the proposed Project Components. The Bulgarian Working Group offered comments on the Project Components, and the Japanese side commented on the technical points raised by the Bulgarian side. Summary of the key issues raised by the Bulgarian side and discussed with the Study Team includes:

1. The Bulgarian side agreed and commented that irrigation improvements were noted as necessary but not sufficient conditions for agricultural growth and development. Other important topics have vital links to irrigated agricultural reforms, such as water user associations, agricultural support services, cooperatives, credit and farm management, marketing, and food industry privatization. The Stredna Tundja irrigation system is blessed with underutilized water supplied through gravitational irrigation. This system is noted as a system poised to take advantage of the project interventions and serve as a model for

the country. Clarification of the main canal rehabilitation is requested, and the on-farm irrigation system improvements will need to closely match farm size.

- 2. The size and purpose of the village-level farm demonstration plots proposed will need to be further explained in the Draft Final Report. The role of emerging Extension "local advisory offices" and the former Experiment Stations, and the Research Institute structure requires rationalization in developing the village-level demonstration plots. Potential benefits of bringing the demonstration plot to the farmer, rather than the farmer to the demonstration plot, are new models and require further discussion and definition.
- 3. For the project, the responsibilities of ISC and the role and definition of Water User Associations (WUAs) in relation to the components should be clarified.
- 4. The proposed establishment of the Agribusiness Center (ABC) is a good proposal in support of the Municipality of Nova Zagora. Suggested links between the ABC and the potential MAFI Extension service office (also in the Municipality) require further elaboration to ensure roles and services are supportive and not duplicated. A division of responsibility between information duties and technical advisory services is outlined, and will be expanded upon with further study.
- 5. ISC / Sliven, as the field level office working closest with the JICA Study Team, is committed to support the proposed activities and hopes to encourage full implementation of the project. In this regard, the base cost assumptions applied in calculating inputs and construction works are important to ensuring project success. Significant inflationary pressures and exchange rate movements have occurred during the period of the JICA Study Team's work, (e.g. the price of PVC pipes have risen 4 times from July to November, and exchange rates have changed significantly). Both inflation rates and the exchange rates movements will need to be forecast in the cost estimation.
- 6. The role of WUAs and a potential coordinating body for WUAs is important but still unclear in the Bulgarian context. The Working Group called attention to the complexity of relations between the users and the supplier of irrigation water. Care will need to be taken to fully account for Bulgarian traditions in water syndicates, prevailing management structures and emerging legislative changes while defining and proposing progressive water management strategies.

- 7. Privatization of the agro-processing industries in the Nova Zagora area is recognized to have an impact on agricultural efficiency and farm income levels. MAFI and the Parliament have discussed possible models to encourage farmer participation in the privatization, and the potential for a level of ownership and operation of processing companies. Ideas and potential strategies for encouraging closer farmer and processing company links are solicited from the JICA Study Team.
- B. The Japanese side provided an overview of the remaining work schedule. The Draft Final Report preparation will be begin in Japan in mid-December and continue during the month of January. Presentation and explanation of the Draft Final Report will be made in early March 1997. The Final Report will be completed in April.
- C. In closing the meeting to review the Progress Report II, the Bulgarian side confirmed agreement with the Project Components as outlined. Both the Bulgarian and Japanese sides were pleased with the study progress to date, and confirmed a commitment to joint project cooperation in the coming months.
