



1 - Introduction

In response to the request of the Government of Federative Republic of Brazil (hereinafter reffered to as " the Government of Brazil"), the Government of Japan decided to conduct the Integrated Development Master Plan Study for Agriculture and Livestock of the State of Tocantins (hereinafter referred to as "the Study") together with the Government of Brazil, in accordance with the Basic Agreement on Technical Cooperation between the Government of Japan and the Government of Brazil, signed in Brasilia on September 22, 1970, (hereinafter referred to as "the Basic Agreement").

Accordingly, the Japan International Cooperation Agency, (hereinafter referred to as " JICA"), the official agency responsible for the official implementation of technical cooperation programs of the Government of Japan, Agencia Brasileira de Cooperação (hereinafter referred to as "ABC") as legal intervenient agency on behalf of the Government of Brazil and the Secretaria de Estado da Agricultura (hereinafter referred to as "SAG-TO"), lhe executive agency responsible for the implementation of the technical cooperation for the Study, will undertake the Study in close cooperation with

The present document sets forth the scope of work with regard to the Study.

II. Objectives of the Study

The objectives of the Study are as follows:

- To prepare an Integrated Development Master Plan for Agriculture and Livestock with the target year of 2015 for the Study area defined hereunder, out of which projects and programs with high priority shall be
 - (a) improvement of small scale farming
 - (b) environmental conservation
 - (c) diversification of agriculture
 - (d) coordination with other sector development plan
- To carry out technology transfer to the Brazilian counterpart personnel through on-the-job training in the course of the Study

III. Study area

The Study area covers the entire of the Tocantins State. The Tocantins State will be classified into several development zones based on various factors including agro-ecology. In making the Study, the emphasis will be put on the typical areas and/or

projects/programs where are derived from each development zone.

IV. Scope of the Study

In order to achieve the objectives mentioned above, the Study shall cover the <Phase 1>

1. Analysis of present situation in the Study area

The present situation in the Study area will be analysed on the basis of all available data, maps and reports relevant to the area by way of field survey, covering such fields as follows;

 - 1)topography
 - 2)meteorology and hydrology
 - 3)geology
 - 4)pedology
 - 5)vegetation
 - 6)natural environment and ecology
 - 7)others
- (2) socio-economic conditions
 - 1)demography

 - 6)education
 - 7)vocational training system
 - 8) public health
 - 9)social environment

10)others

(3)land use

- (4)status of agriculture
 - 1)agricultural structure

 - supporting system(government institutions, organizations, supporting organizations and extension organizations) service
 - 5)agricultural infrastructure
 - 6)others
- (5)development status in each sector
 - 1)transportation

- (1) The role of the Study area in the regional (north region) and national economic setting will be defined.
- (2) Goals and objectives for development, together with strategies to achieve them will be defined.
- (3) Socio-economic and Spatial development framework, together with identification to target beneficiaries will be prepared.
- (4) Development scenario will be formulated through the comparison of attractive scenarios.

VII. Undertakings of the Brazilian side

- 1. The Government of Federative Republic of Brazil shall accord privileges, immunities and other benefits to the Japanese study team (hereinafter referred to as "the Team") in accordance with the Basic Agreement, as follows:
- (1) to secure the safety of the team,
- (2) to permit the members of the Team to enter, leave and stay in the Federative Republic of Brazil for the duration of their assignment therein, and exempt them from foreign registration requirements and consular fees,
- (3) to exempt the members of the Team from taxes, dulies and other charges on equipment, machinery and other materials brought into the Federative Republic of Brazil for the conduct of the Study,
- (4) to exempt the members of the Team from income tax and other charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Team for their services in connection with the implementation of the Study,

A

- (5) to provide necessary facilities to the Team for the remittance as well as utilisation of the funs introduced into the Federative Republic of Brazil from Japan in connection with the implementation of the Study.
- (6) to secure permission for entry into relevant areas for the implementation of the Study,
- (7) to secure permission for the Team to take all data and documents out of the Federative Republic of Brazil to Japan, in accordance with laws and regulations in force in Brazil , for analysis during the implementation of the Study, and
- (8) to provide medical services as needed. Its expenses will be chargeable on the members of the Team.
- 2. The Brazilian side shall bear claims, if any arises, against the members of the Team resulting from, occurring in the course of, or otherwise connected with, the discharge of their duties in the implementation of the Study, except when such claims arise from gross negligence or wilful misconduct on the part of the members of the Team.
- 3. SAG-TO shall act as the counterpart agency to the Team and also as coordinating body in relation with other governmental and non-governmental organizations concerned for the smooth implementation of the Study.
- 4. SAG-TO shall, at its own expense, provide the Team with the following, in cooperation with other relevant organizations concerned;
- (1) available data and information related to the Study,
- (2) full-time counterpart personnel, technical supporting staff, clerical staff, etc.
- (3) suitable office space with necessary equipment in Palmas,
- (4) adequate means of transport for the Team, and

(5) credentials or identification cards.

VIII. Undertaking of the Japanese side

For the implementation of the Study, the Japanese side shall take the following measures:

- (1) to dispatch, at its own expense, the Team to the Federative Republic of Brazil, and



Mr. Satoshi Yoshida JICA Brazil Office In accordance with the Scope of the Work for the Study on the Integrated Development Master Plan for Agriculture and Livestock in Tocantins State (hereinafter referred to as "the Study"), the Government of Japan through Japan International Cooperation Agency (JICA) dispatched the Study Team headed by Mr. Satoru Kido for the implementation of the Study in the State of Tocantins in the Federative Republic of Brazil.

As a result of an explanation and exchange of opinions on the Report, the following has been agreed upon by both Tocantins State and Japanese sides.

- 1. The Tocantins State side agreed with the contents of the Report had been prepared in due compliance with the conditions set forth in the Scope of the Work for the Study.
- 2. Programs/Projects proposed in the Report have generally good correlation with the result of the diagnosis and analysis of the prevailing potentials and constraints in the Study Area. The detailed review on the Report will be made by the Tocantins State side and the comments will be sent to the Study Team by March 12, 1998 through the JICA Brazil office, Brasília, if any.
- 3. The Study Team will modify and/or correct the Report based on the above comments, if necessaary and send the Final Report to the Tocantins State through the Headquarter of JICA, Tokyo within two months after receiving the said comments from the Tocantins State side.
- 4. Tocantins State side has no objection to the Final Report being open to the public immediately after the Final Report is received by the Tocantins State.
- 5. Both sides agreed to have a Seminar regarding the Study in Brasilia.

This minutes of meeting is prepared in English and in Portuguese. In case that any discrepancy may arise between these two versions, the English version shall prevail.
