

I. INTRODUCTION

In response to the request of the Government of the Republic of Kenya (hereinafter referred to as "the Government of Kenya"), the Government of Japan decided to conduct the Study on the Strengthening District Health System in the western part of Kenya (hereinafter referred to as "the Study") in accordance with the relevant laws and regulations in force in Japan.

Accordingly, the Japan International Cooperation Agency (hereinafter referred to as "JICA"), the official agency responsible for the implementation of the technical cooperation programmes of the Government of Japan, will undertake the Study in close cooperation with the authorities concerned of the Government of Kenya.

The present document sets forth the scope of the works with regard to the Study.

II. OBJECTIVES OF THE STUDY

The overall objective of the Study is to strengthen the District Health System in the western part of Kenya in accordance with the Kenya's Health Policy Framework.

The specific objectives are;

- (1) to make specific recommendations on what concrete steps are needed to restore a comprehensive referral system in the study area,
- (2) to specify those action plans for the components/regions identified to be necessary for the District Health System, which aim to attempt an overall implementation in order to strengthen referral network in intensified areas through the Study, including institutional and capacity building in the Ministry of Health (hereinafter referred to as "MOH"), and
- (3) to conduct technical transfer to the Kenyan counterpart personnel throughout the Study.

III. STUDY AREA

The Study area will cover the following four(4) districts in the western part of Kenya.
Bomet, Kericho, Kisii, and Nyamira.

IV. SCOPE OF THE STUDY

In order to achieve the objectives mentioned above, the Study will cover the following items.

Phase I : Baseline Study




Issues to be assessed horizontally are as follows;

- (5) logistics for medical supplies and equipment,

- (8) other sectors related to health.

Issues to be assessed vertically are as follows;

- (1) reproductive health,
- (2) infectious diseases of endemic importance,
- (3) other infectious diseases including EPI related diseases and HIV infection

6. Setting goals and targets for the strengthening of District Health System and preparation of basic strategies;

- (1) population,
- (2) society and economic, and
- (3) disease and mortality structure.

Phase II : Formulation of basic strategies for the strengthening of District Health System (implementation plan), and of priority programme

The Government of Kenya will submit their comments to JICA within one (1) month after the receipt of the Draft Final Report.
6. Final Report:
Fifty (50) copies within one (1) month after JICA's receipt of the said comments on the Draft Final Report.

VII. UNDERTAKINGS OF THE GOVERNMENT OF KENYA

1. To facilitate smooth conduct of the Study, the Government of Kenya shall take necessary measures;
 - (1) to secure the safety of the Japanese Study Team (hereinafter referred as "the Team"),
 - (2) to permit the members of the Team to enter, leave and sojourn in Kenya for the duration of their assignment therein, and exempt them from foreign registration requirements and consular fees,
 - (3) to exempt the members of the Team from taxes, duties and any other charges on equipment, machinery and other materials brought into and out of Kenya for the conduct of the Study,
 - (4) to exempt the members of the Team from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Team for their services in connection with the implementation of the Study,
 - (5) to provide necessary facilities to the Team for remittance as well as utilization of funds introduced into Kenya from Japan in connection with the implementation of the Study,
 - (6) to secure permission for entry into private properties or restricted areas for the implementation of the Study,
 - (7) to secure permission for the Team to take all data and documents (including maps and photographs) related to the Study out of Kenya to Japan, and
 - (8) to provide medical services as needed. Its expenses will be chargeable on members of the Team.
2. The Government of Kenya shall bear claims, if any arises, against the members of the Team resulting from, occurring in the course of, or otherwise connected with, the discharge of their duties in the implementation of the Study, except when such claims arise from gross negligence or willful misconduct on the part of the members of the Team.
3. The MOH shall act as a counterpart agency to the Team and also as a coordinating body in relation with other governmental and non-governmental organizations concerned for the smooth and effective implementation of the Study.





Based on the official request of the Government of the Republic of Kenya, the Japan International Cooperation Agency (hereinafter referred to as "JICA") dispatched to Kenya the preparatory Study Team (hereinafter referred to as "the Preparatory Team"), headed by Prof. Takatoshi KOBAYAKAWA to Kenya from 6th to 19th April, 1997. And the Preparatory Team had a series of meetings with officials of the Ministry of Health (MOH), and some of District Hospitals, Health Centres, and Dispensaries in the visited area by the Preparatory Team. A list of the officials of the Ministries and other organizations is hereto attached in Annex-I.

Through the exchange of opinions and discussions, the Preparatory Team and the MOH reached an agreement on the Scope of Work.

Items discussed in the series of meetings are summarized in the followings:

1. Title of the Study

Originally the Government of Kenya requested the Government of Japan to conduct a development study entitled "the Study on Strengthening the Regional Health System in Western Kenya".

Kenyan side further proposed the Preparatory Team to revise the title of the study as "the Study on Strengthening District Health System in the western part of Kenya", in order to avoid confusion between area-wide health system and Regions as governmental unit and also to avoid misunderstanding of the inclusion of Western Province in the Study area.

2. The Objectives of the Study

The both side agreed to add an underlined phrase described below to the objectives of the Study, in order to clarify the concrete target of realization of the strengthening of the District Health System after completion of the Study.

Item 2) of Objectives of the Study in the Scope of Work:

"to specify the action plans for the components/regions identified to be necessary for the District Health System, which aims to attempt an overall implementation in order to strengthen referral network in intensified areas through the Study, including institutional and capacity building in the Ministry of Health (hereinafter referred to as "MOH"),"

3. The Committees to be organized for the Study

The both side agreed that, for the smooth implementation of the Study, Kenyan side will organize a Steering Committee at central headquarters level and a Technical Committee at district level composed of the Kenyan members listed in the Annex-II.

4. The Study Area

Kenyan side requested the Preparatory Team to include the boundary areas in the proximity districts of Nandi District, Uasin Gishu District and Kisumu District into the Study area.


The request has been taken note for further consideration by Japanese side.

5. The Inception of the Study

(1) The both side agreed the year of 2005 as the target year of the implementation plan.

(2) The both sides agreed upon the following principal items to be assumed in the Study;

- (1) Rehabilitation of District Hospital(s) extended under the Grant Aid, with the consideration of necessity of assistance, strengthening, and effectiveness of the implementation.




- 2) Project for improvement of the referral network, including facilities for public health laboratory and mobile clinic, extended under the Technical Cooperation in the selected area based on the result of the Study, and
- 3) Human resource development which might be included in the implementation programme such as provision of practical training with the trainees in Medical Training College at Kisii, and in the Rural Health Training Centre in Rift Valley Province.

6. Undertakings of the Government of Kenya

- (1) As to the provision of the office space to the Team, the MOH notified the Preparatory Team that office space shall be arranged for the use of the Study Team.
- (2) As to the counterpart personnel to the Study, the Preparatory Team pointed out that health personnel in the fields of health policy and planning, health administration, health education, economic/financial analysis, human resources development etc., should be assigned by the MOH and, if necessary, other personnel from other ministries, for the purposes of smooth and effective implementation of the Study.
- (3) As to the provision of vehicles to the Study Team, MOH requested that JICA should provide the Study Team with transportation since the present conditions would not allow the Ministry to do so in terms of the number of the vehicles and funds available.

7. Others

- (1) As to the timing of initiation of the Study, the Preparatory Team suggested that it would be August 1997, with a duration of thirteen (13) to fifteen (15) months.
- (2) MOH requested the Preparatory Team the provision of various data processed by computer to assure the further continuity of consequent updating in the Ministry even after the completion of the Study. The Preparatory Team replied that the data processing would be computerized owing to its variety and quantity as well.
- (3) MOH requested the Preparatory Team the provision of the Kenyan counterpart personnel with an opportunity to have training in Japan through the Study.
The request shall be conveyed to JICA Headquarters by the Preparatory Team.



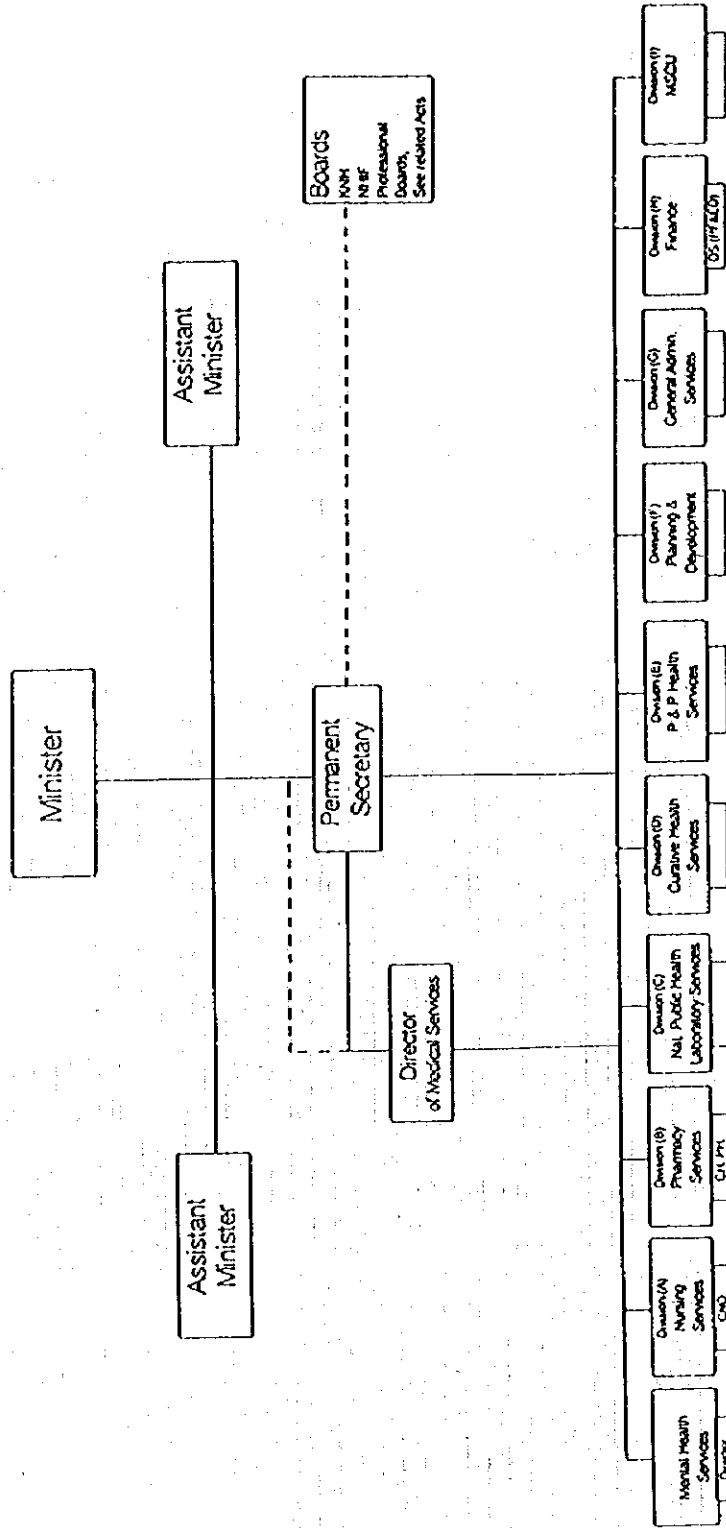

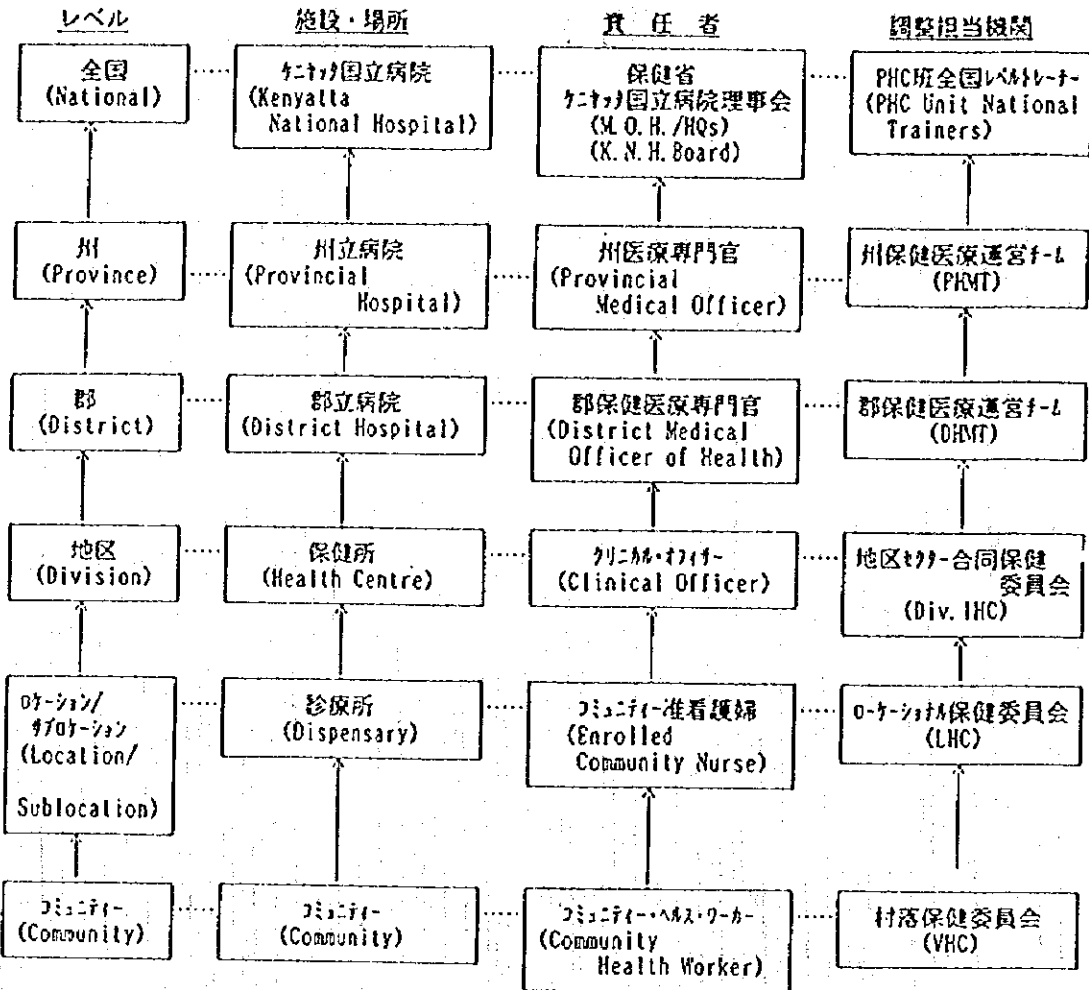
別図一 1 ケニア保健省の組織図（改訂前：1989年）

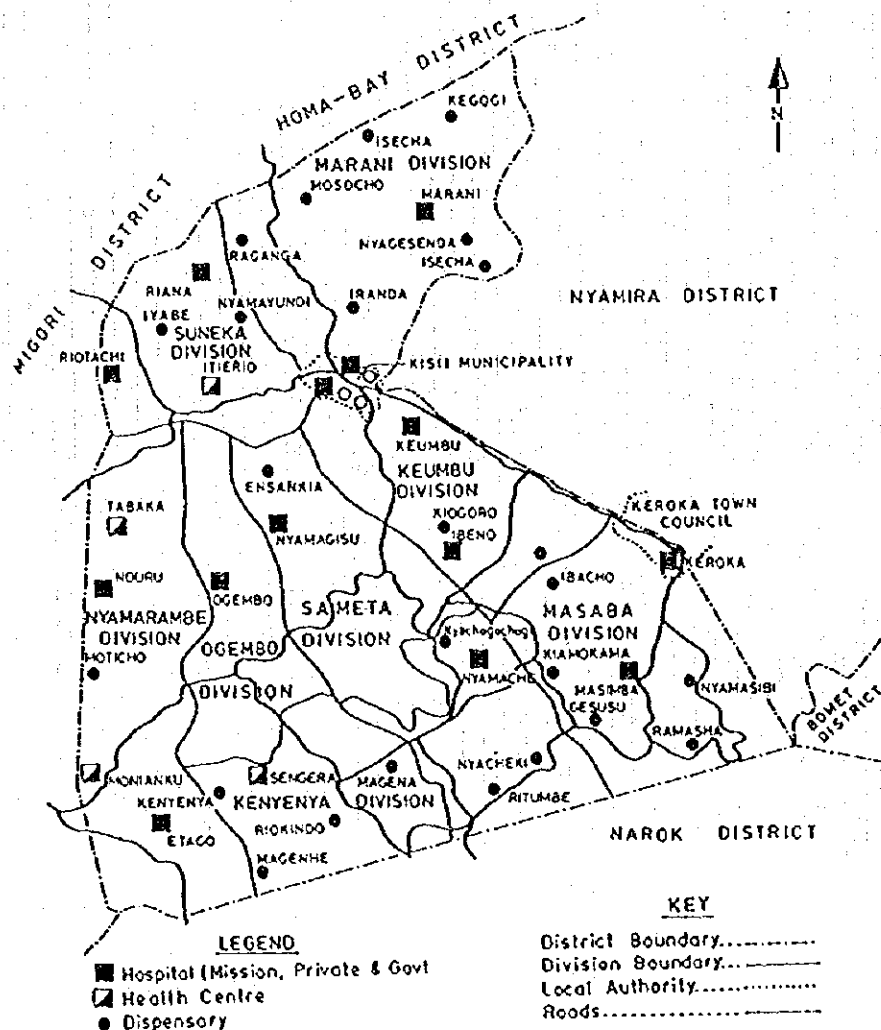

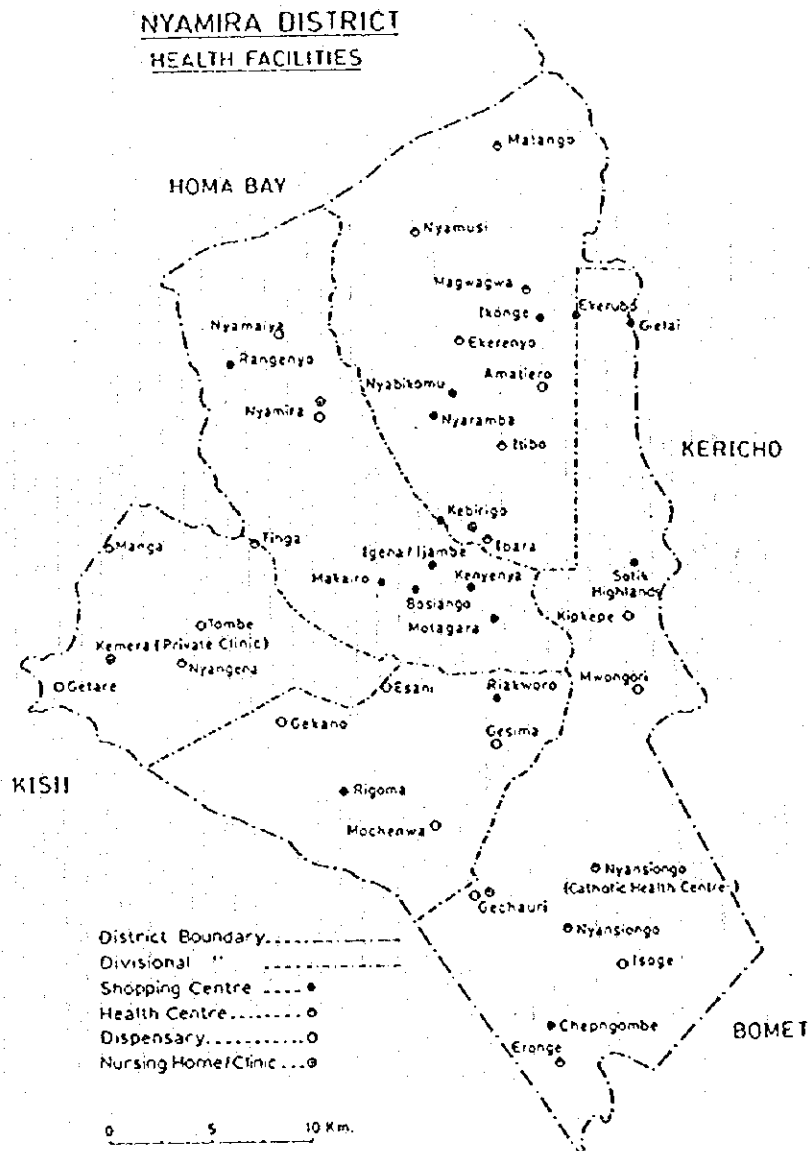

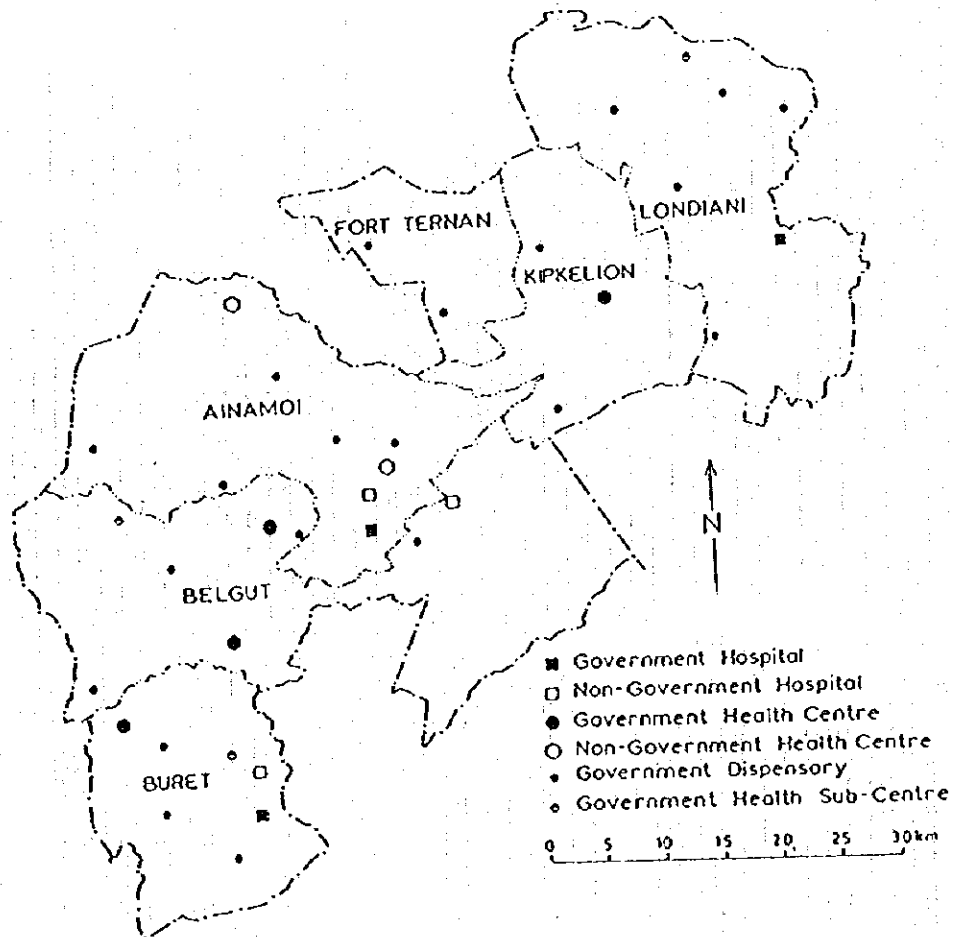


別図-5 ケリチヨ一県の保健医療施設と分布図

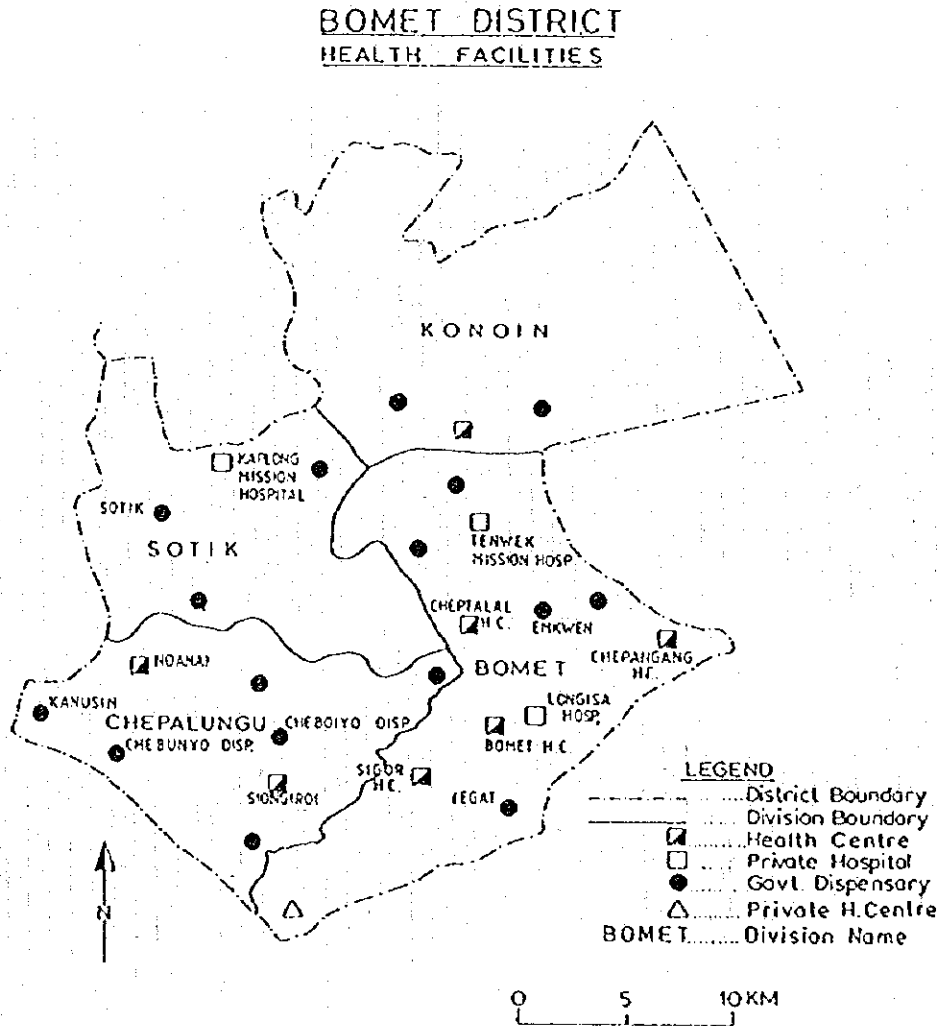
Map 4: Distribution of Health Facilities.

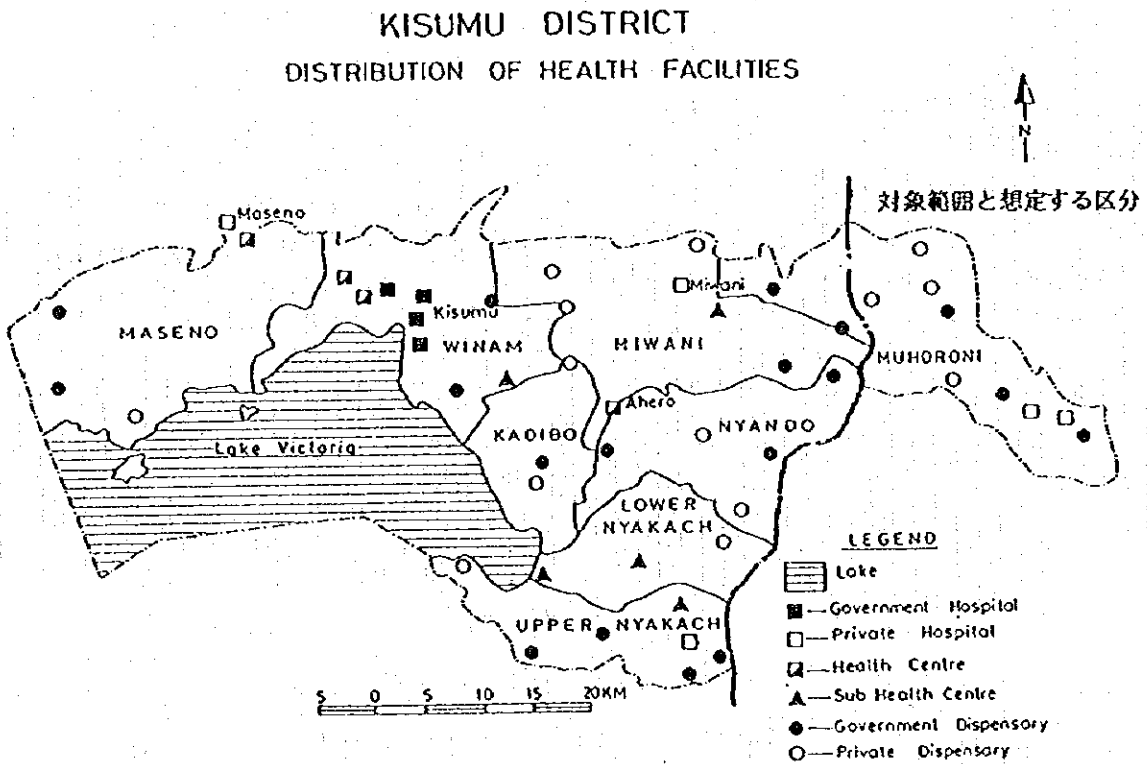

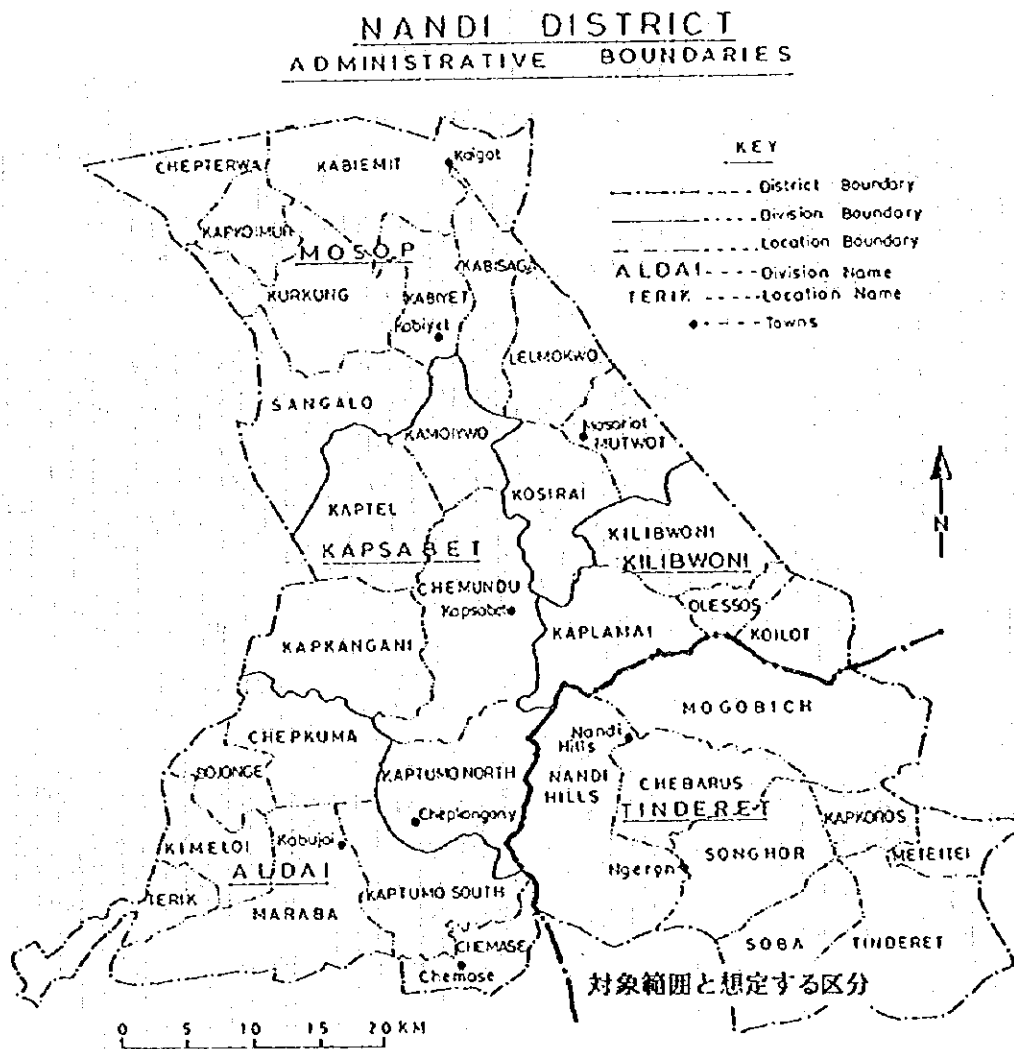

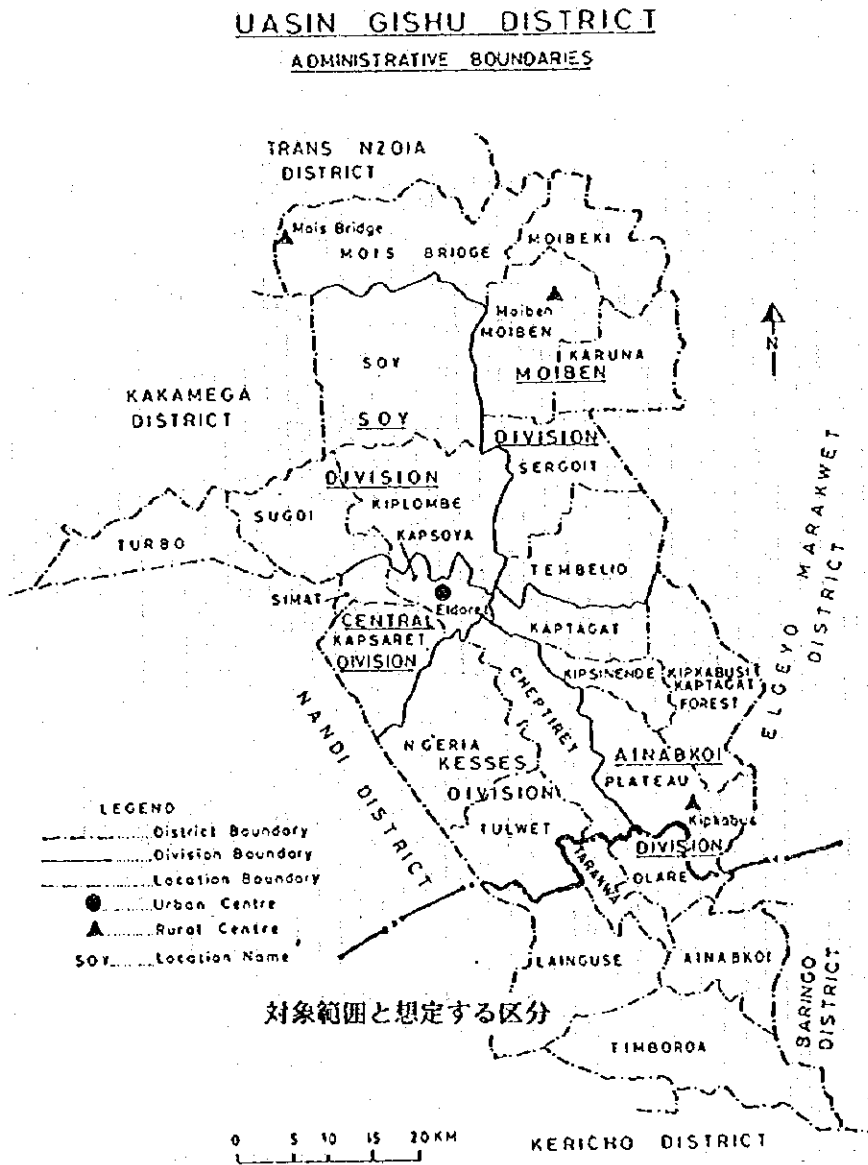

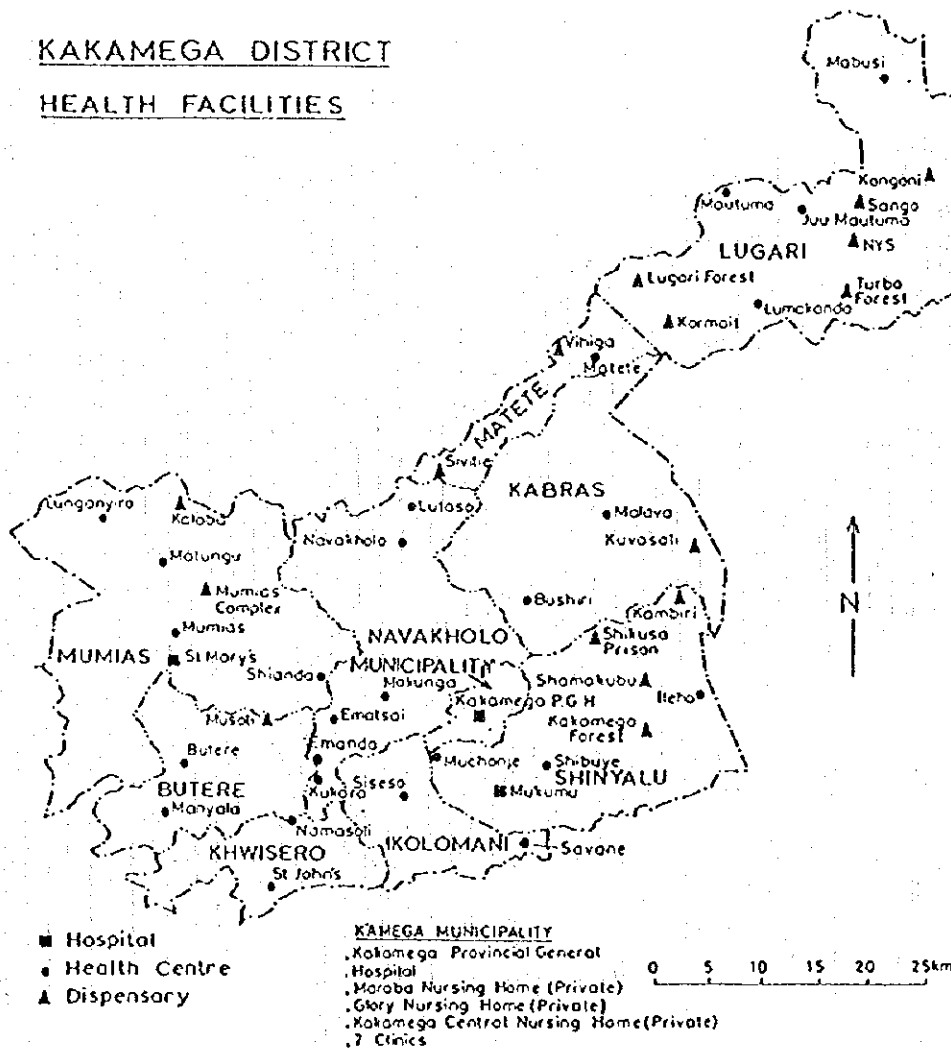

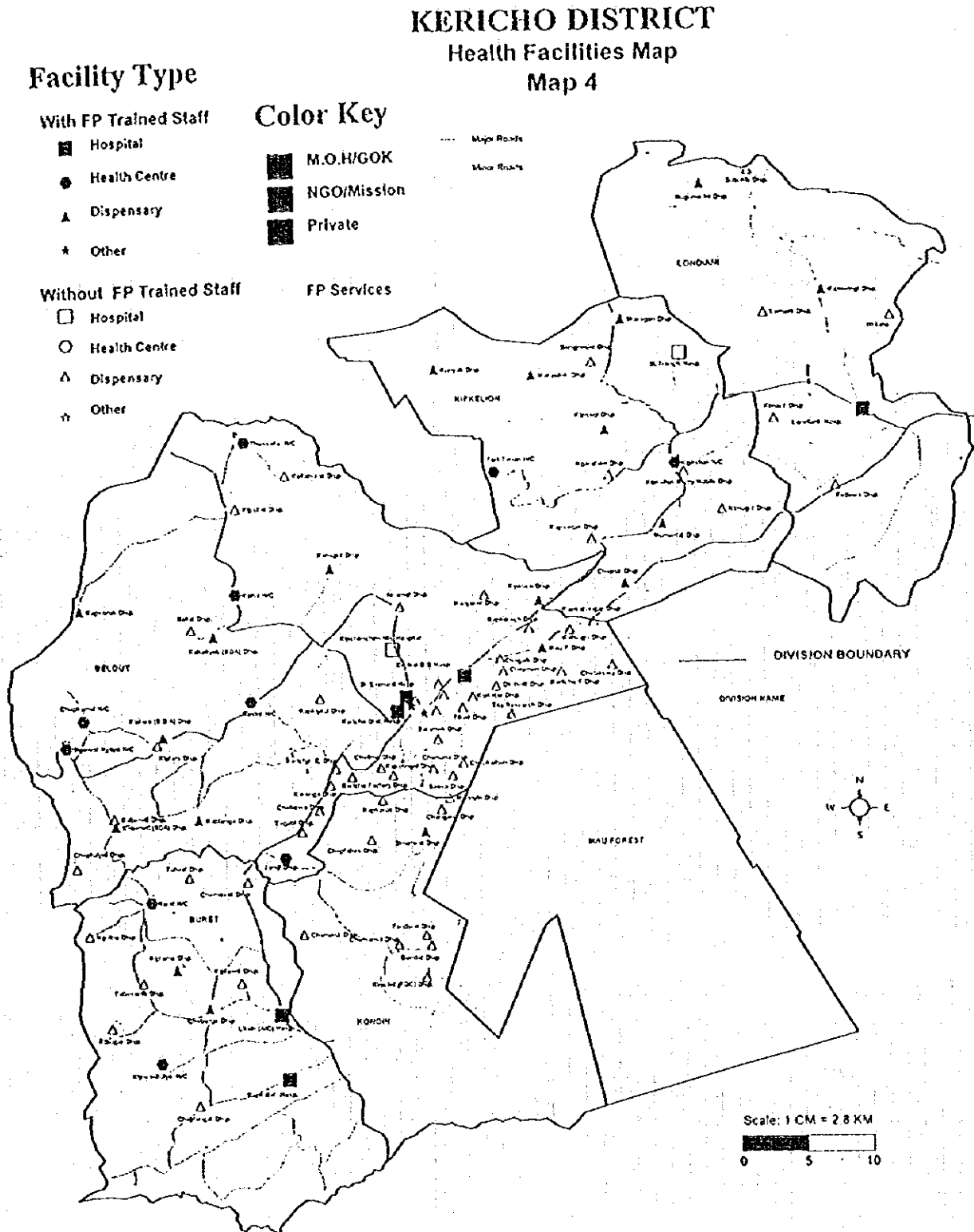
