- iii) Retrieval

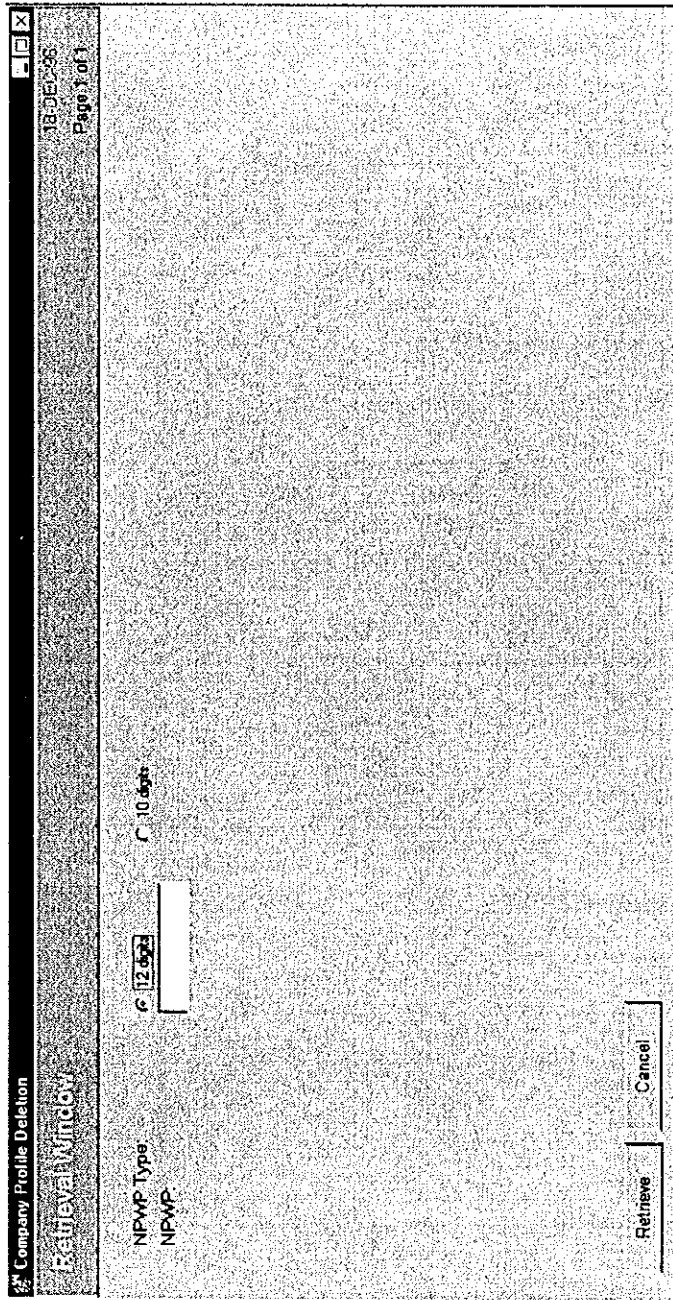


Figure 5.15-1: Window Layout for Company Profile Deletion (Retrieval Window)
