#### I. INTRODUCTION

In response to the request of the Government of The Republic of Palau (hereinafter referred to as "GOP"), the Government of Japan has decided to conduct the Development Study for Promotion of Local Economy in the Republic of Palau (hereinafter referred to as "the Study") in accordance with the relevant laws and regulations in force in Japan.

Accordingly, the Japan International Cooperation Agency (hereinafter referred to as "JICA"), the official agency responsible for the implementation of the technical cooperation programs of the Government of Japan, will undertake the Study in close cooperation with the authorities concerned of the GOP.

#### II. OBJECTIVES OF THE STUDY

The objectives of the Study are to:

- 1. formulate long-term integrated development strategies and a mid-term infrastructure improvement plan which aim to harmonize "economic development" with "environmental protection",
- 2. conduct pre-feasibility studies for priority investment projects package for priority sectors in line with the above plan, and
- 3. help to strengthen the planning capability of Palauan counterpart personnel through the implementation of the Study.

#### III. STUDY AREA

The Study area would cover the whole territory of the Republic of Palau.

#### IV. SCOPE OF THE STUDY

In order to achieve the objectives mentioned above, the Study shall cover the following items:

- 1. Analysis of current socio-economic situation
- (1) Natural conditions;
- (2) Demography and socio-cultural conditions;
- (3) Economic activities and industrial structure;
- (4) Existing infrastructure bases including the institutional set-up and budgetary system;

- (5) Land tenure system and land use;
- (6) Development policies and related plans including the "National Development Master Plan (1995-2020)";
- (7) Planned and ongoing development programs and projects proposed under the "Economic Development Plan (1995-1999)" and other relevant sector development plans;
- (8) Trend of private investments both foreign and domestic;
- (9) Roles of the government corporations;
- (10) Environmental problems and issues; and
- (11) Regulatory framework for environment protection
- 2. Identification of Development Potentials
- (1) Evaluation of natural and human resources;
- (2) Assessment of development potentials and constraints with emphasis on the sectors of tourism, agriculture and fishery; and
- (3) Demand and supply forecast
- 3. Preparation of Development Strategies up to the year 2020 for the Promotion of Palauan Local Economy
- (1) Establishment of a planning framework to the year 2020;
- (2) Formulation of fundamental development policies and objectives by taking into consideration potentials identified, assessed or forecasted above;
- (3) Preparation of altanatives for the development scenario;
- (4) Preliminary assessment of economic, social and environmental impacts of each scenario;
- (5) Selection of the most suitable development scenario; and
- (6) Elaboration of a fundamental and orderly course of development in line with the development scenario identified above
- 4. Formulation of a Infrastructure Improvement Plan up to the year 2009
- (1) Elaboration of a socio-economic perspective to the year 2009;
- (2) Elaboration of a basic spatial planning framework in line with long-term strategies as well as investment programs scrutinized from financial standpoints up to the year 2009;
- (3) Assessment of needs for infrastructure improvement in line with the socio-economic perspective to the year 2009;
- (4) Evaluation of the current service levels of and planned investment projects for infrastructure development;
- (5) Formulation of the infrastructure improvement plan to the year 2009 for the priority sectors with cost implication;
- (6) Identification and outlining of appropriate priority infrastructure investment projects

- 5. Pre-Feasibility Study for Priority Projects
- (1) Selection of high priority infrastructure investment projects;
- (2) Initial environmental evaluation of the projects;
- (3) Preliminary assessment in economic and financial viability;
- (4) Recommendation for institutional arrangements and funding sources for the implementation, operation and management of the projects

#### V. STUDY SCHEDULE

The Study will be carried out in accordance with the attached tentative study schedule (see APPENDIX).

#### VI. REPORTS

JICA shall prepare and submit the following reports in English to the the GOP in accordance with the attached tentative work schedule.

- (1) Inception Report Thirty (30) copies at the commencement of the Study
- (2) Progress Report
  Thirty (30) copies within three (3) months after the
  commencement of the Study
- (3) Interim Report Thirty (30) copies within six (6) months after the commencement of the Study
- (4) Draft Final Report
  Thirty (30) copies within ten (10) months after

commencement of the Study.

The written comments on the Draft Final Report from the GOP shall be submitted to JICA within one (1) month after submission of the report.

Fifty (50) copies within one (1) month after the receipt of the comments on the Draft Final Report

#### VII. UNDERTAKINGS BY THE GOP

- 1. To facilitate smooth and effective execution of the Study, the GOP shall take necessary measures:
  - (1) to secure the safety of the Japanese Study Team (hereinafter referred to as "the Study Team");
  - (2) to permit the members of the Study Team to enter, leave and sojourn in the Republic of Palau for the duration of their assignment therein, and exempt them from alien registration requirements and consular fees;
  - (3) to exempt the members of the Study Team from taxes, duties and other charges on equipment, machinery and other materials brought into and out of the Republic of Palau for the conduct of the Study;
  - (4) to exempt the members of the Study Team from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Study Team for their services in connection with the implementation of the Study;
  - (5) to provide the necessary facilities to the Study Team for remittance as well as utilization of the funds introduced into the Republic of Palau from Japan in connection with the implementation of the Study;
  - (6) to secure permission for the Study Team to enter into private properties or restricted areas for the implementation of the Study;
  - (7) to secure permission for the Study Team to take all data and documents including maps, photographs, related to the Study out of the Republic of Palau to Japan; and
  - (8) to provide medical services as needed. Its expenses will be chargeable on members of the Study Team.
- 2. The GOP shall bear claims, if any arises, against the members of the Study Team resulting from, occurring in the course of, or otherwise connected with the discharge of their duties in the implementation of the Study, except when such claims arise from gross negligence or willful misconduct on the part of the members of the Study Team,
- 3. The Office of Planning and Statistics of the GOP shall act as counterpart agency to the Study Team and also as a coordinating body in relation with other governmental and non-governmental

organizations concerned for the smooth implementation of the Study.

- 4. The Office of Planning and Statistics of the GOP shall, at its own expense, provide the Study Team with the following, in cooperation with other organizations concerned:
  - available data and information related to the Study, including aerial photographs and maps;
  - (2) counterpart personnel;
  - (3) suitable office space with necessary office equipment in Koror;
  - (4) appropriate number of vehicles with drivers; and
  - (5) credentials or identification cards

#### VIII. UNDERTAKING OF JICA

For the implementation of the Study, JICA shall take the following measures:

- 1. to dispatch, at its own expense, the Study Team to the Republic of Palau, and
- 2. to pursue technology transfer to the the Palauan counterpart personnel in the course of the Study.

#### IX. CONSULTATION

JICA and the Office of Planning and Statistics in President's Office of the GOP shall consult with each other in respect of any matter that may arise from or in connection with the Study.

The Japanese Preparatory Study Team (hereinafter referred to as "the Preparatory Team", organized by Japan International Cooperation Agency (JICA) and headed by Mr. Yoichi Suzuki, visited Republic of Palau from 4th of August to 11th of August, 1999 to discuss the Scope of Work for "Development Study for Promotion of Local Economy in the Republic of Palau (hereinafter referred to as "the Study").

During its stay in Palau, a series of meetings on the Study were held between the Preparatory Team and the officials from the Government of the Republic of Palau (hereinafter referred to as "the GOP") and other organizations concerned. The attendants of the meetings are listed in Appendix.

Through these meetings, both sides agreed and signed the Scope of Work for the Study, and confirmed the following points:

#### 1.Study Area

Both sides agreed that the Study would cover the entire territory of the Republic of Palau.

#### 2.Task Force

As mentioned in the Scope of Work, the Palauan counterpart agency for the Study shall be the Office of Planning and Statistics (hereinafter referred to as "the OPS").

However, taking into consideration of manpower availability of the OPS, the Preparatory Team proposed a task force to be established in the GOP, which would be composed of appropriate officials from organizations concerned .

The GOP promised that they would designate appropriate number of the task force member and submit the member list to JICA Head Ouarter through JICA/JOCV Palau Office as soon as possible.

#### 3.Steering Committee

For the smooth implementation of the Study, the Preparatory Team stressed the importance of organizing a Steering Committee.

Both sides agreed that the GOP will establish an Intragovernmental Steering Committee for the Study under the chairmanship of the OPS. The Steering Committee would supervise the activities of the task force for the Japanese Study Team (hereinafter referred to as "the Study Team").

The Steering Committee shall consist of the following officials:

- 1) National Planner;
- 2) Minister of State;

- 3) Minister of Resources and Development;
- 4) Minister of Commerce and Trade;
- 5) Chairman of Governors Association;
- 6) National Surveyor;
- 7) Director of Treasury;
- 8) Managing Director of Palau Visitors Authority; and
- 9) Head of Environmental Quality Protection Board.

#### 4. Undertakings of the GOP

As mentioned in the Scope of Work, the OPS shall provide suitable office space with necessary office equipment in Koror, and appropriate number of vehicles with drivers.

For these arrangements, the GOP requested that it be informed of the implementation schedule and the scale of the Study Team as soon as these are determined, before the actual dispatch of the Study Team.

#### 5.Disclosure of the Final Report

Both sides agreed that the Final Report of the Study shall be open to the public.
