I. INTRODUCTION

In response to the request of the Government of the United Republic of Tanzania (hereinafter referred to as "GOT"), the Government of Japan (hereinafter referred to as "GOJ") has decided to conduct the Study on the Small Scale Horticultural Development Project for Poverty Alleviation to Farmers in Coast Region (hereinafter referred to as "the Study"), in accordance with the relevant laws and regulations in force in Japan.

Accordingly, Japan International Cooperation Agency (hereinafter referred to as "JICA"), the official agency responsible for the implementation of the technical cooperation programs of the GOJ, will undertake the Study in close cooperation with the authorities concerned of the GOT.

The present document sets forth the Scope of Work with regard to the Study.

II. OBJECTIVES OF THE STUDY

The objectives of the Study are;

- 1. to formulate a master plan on small scale horticultural development for poverty alleviation to farmers, so as to contribute to income generation, especially groups of women and youth in the categorized horticultural potential area(s) based on natural and socio-economic environment,
- 2. to conduct feasibility study on the selected priority area(s), and
- 3. to carry out, in the course of the Study, technology transfer to counterpart personnel of Tanzania.

III. STUDY AREA

The Study area shall cover the whole area of Coast Region. (See location map attached as ANNEX I)

IV. SCOPE OF THE STUDY

In order to achieve the above objectives, the Study will consist of two (2) phases and will cover the following items;

VII. UNDERTAKING OF THE GOVERNMENT OF TANZANIA

- 1. To facilitate smooth conduct of the Study, the GOT shall take necessary measures;
 - 1-1. to secure the safety of the Japanese study team,
 - 1-2. to permit the members of the Japanese study team to enter, leave and sojourn in Tanzania for the duration of their assignment therein, and exempt them from foreign registration requirements and consular fees,
 - 1-3. to exempt the members of the Japanese study team from taxes, duties, fees and any other charges on equipment, machinery and other materials brought into Tanzania for the conduct of the Study,
 - 1-4. to exempt the members of the Japanese study team from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Japanese study team for their services in connection with the implementation of the Study.
 - 1-5. to provide necessary facilities to the Japanese study team for the remittance as well as utilization of the funds introduced into Tanzania from Japan in connection with the implementation of the Study,
 - 1-6. to secure permission for entry into private properties or restricted areas for the implementation of the Study;
 - 1-7. to secure permission for the Japanese study team to take all data and documents (including photographs and maps) related to the Study out of Tanzania to Japan and
 - 1-8. to provide medical services as needed. Its expense will be chargeable on the members of the Japanese study team.

- 2. The GOT shall bear claims, if any arises, against the members of the Japanese study team resulting from, occurring in the course of, or otherwise connected with, the discharge of their duties in the implementation of the Study, except when such claims arise from gross negligence or willful misconduct on the part of the members of the Japanese study team.
- 3. Coast Regional Commissioner's Office (hereinafter referred as "CRCO") shall act as a coordinating body in relation with other governmental departments and non-governmental organizations concerned for smooth implementation of the Study. CRCO in collaboration with the Ministry of Agriculture and Cooperatives shall act as a counterpart agencies to the Japanese study team.
- 4. The GOT shall, at it's own expenses, provide the Japanese study team with the following, in cooperation with other organizations concerned;
 - 4-1. available data and information related to the Study,
 - 4-2. counterpart personnel,
 - 4-3. suitable office spaces with necessary equipment and furniture in the Study area, and
 - 4-4. credentials or identification cards

VIII. UNDERTAKING OF JICA

For the implementation of the Study, JICA shall take the following measures;

- 1. to dispatch, at its own expense, the Japanese study team to Tanzania, and
- 2. to pursue technology transfer to the Tanzanian counterpart personnel in the course of the Study.



Location Map of Study Area



The preparatory study team (hereinafter refereed to as "the Team") organized by Japan International Cooperation Agency (hereinafter referred to as "JICA"), and headed by Dr. Yoshihiko NISHIMURA, visited the United Republic of Tanzania from 6 to 16 April, 1999 for the purpose of discussing and exchanging views in relation to the Scope of Work for the Study on Small Scale Horticultural Development Project for Poverty Alleviation to Farmers in Coast Region, the United Republic of Tanzania (hereinafter referred to as "the Study") with the officials concerned of the Government of the United Republic of Tanzania (hereinafter referred to as "GOT").

As a result of the discussions, the GOT and the Team mutually agreed to the Scope of Work for the Study.

The following Minutes have been prepared to confirm the main issues discussed and matters agreed upon by both sides. The list of participants in a series of meetings is attached as ANNEX.

- 1. Both sides confirmed that Coast Regional Commissioner's Office (hereinafter referred as "CRCO") would act as a coordinating body in relation with other governmental departments and non-governmental organizations concerned for smooth implementation of the Study, and that CRCO in collaboration with the Ministry of Agriculture and Cooperatives would act as a counterpart agencies to the Japanese team to be dispatched for the Study (hereinafter referred to as "the Study Team").
- 2. Both sides confirmed that the Study would be carried out mainly aiming at small horticultural development for poverty alleviation to farmers, especially targeting the groups of women and youth.
- Both sides confirmed that the Study area should cover the whole area of Coast Region. In Phase 1, a master plan study will include categorization of the present horticulture situation in Coast Region, based on national and socio-economic environment. In Phase 2, a feasibility study will be conducted in the selected priority area(s).
- 4. Both sides confirmed that Environment Impact Assessment (EIA) should be carried out in Phase 2, if needed according to the result of Initial Environment Examination (IEE). It was noted that it would be difficult for CRCO to carry out EIA because of budgetary constraints and therefore requested the Team to make the arrangement. The Team promised to convey the request to the Government of Japan.
- 5. For the smooth and effective implementation of the Study, both sides agreed upon the need for establishment of a Steering Committee consisting of representatives from relevant

institutions before the commencement of the Study.

Basically, it is expected that this Committee will meet the Study Team when it comes to explain the reports. The Steering Committee will consist of members mainly from the following:

- · Presidents Office(Planning Commission)
- The Ministry of Agriculture and Cooperatives (Department of Agriculture and Livestock Development)
- · The Ministry of Finance (Department of External Finance)
- · Ministry of Water (Department of Hydrology)
- · Ministry of Regional Administration and Local Government (Coast Regional Commissioner's Office and District Council)
- 6. CRCO promised to assign the necessary number of counterpart personnel for each member of the Study Team from the governmental departments concerned.
- 7. CRCO expressed difficulties in providing necessary vehicle(s) with driver(s), photocopy machine, personal computer and facsimile to the Study Team and therefore requested JICA to make the arrangements. The Team promised to convey the request to the Government of Japan.
- 8. CRCO shall provide suitable office space(s) with necessary number of desks, chairs, electricity and telephone-line(s)spaces to the Study Team in the Study area.
- 9. CRCO requested the counterpart training in Japan related to the Study to promote an effective technology transfer. The Team promised to convey the request to the Government of Japan.
- CRCO agreed that the Final Report would be made available to any interested party.
- 11. Both sides agreed that the Team would inform CRCO the number of members of the Study Team and their fields two months before they are dispatched to Tanzania.

In accordance with the Scope of Work for the Study (hereinafter referred to as "S/W") on the Small Scale Horticultural Development Plan for Poverty Alleviation to Farmers in Coast Region (hereinafter referred to as "the Study"), the Government of Japan dispatched through Japan International Cooperation Agency (JICA) the study Team headed by Mr. Shiro Hirata for the implementation of the Study, to the United Republic of Tanzania. At the commencement of the Study, the Study Team submitted officially twenty (20) copies of the Inception Report and explained the basic concepts, methodology and schedule of the Study to the Coast Regional Commissioner's Office (hereinafter referred as CRCO) and Ministry of Agriculture and Cooperatives on the 5th and 9th November 1999. In the discussions on the Inception Report, the importance of Farming practices, Marketing, Agricultural Support services, Agricultural Organizations and Verification Studies was reemphasized and the following points were agreed upon by the Tanzanian and Japanese sides:


- The Tanzanian side confirmed that contents of the Inception Report were prepared in compliance with the conditions set forth in the Scope of Work and agreed to proceed to the next stage of the study in accordance with the methodology and schedule presented in the Inception Report.
- 2. The Japanese side requested the Tanzanian side to nominate at least one counterpart for each member of the Study Team in regard to the agreed time schedule of the study team; to enhance the transfer of technology during the study. The Tanzanian side basically agreed on the importance of assigning the local counterparts but raised the following pertinent issues:
 - a) Engaging fulltime local counterpart staff to match the number and different specialties of the Japanese Team of Experts necessitates moving some of the local staff from districts in the region and from other regions. Therefore, the Tanzanian Government will try its best to allocate counterpart staff with due regard to professions available and their vicinity to the RCO. As to question of remuneration, the Tanzania Government will contribute accordingly.
 - b) Some of the personnel in the Japanese Team of Experts will stay for a short period of time and the major activity will be collection and synthesis of data. It might not be necessary to assign a permanent local counterpart staff to such experts.
- 3. The Tanzanian side proposed a change of the composition of the steering committee so as to formulate a more practical and efficient Committee.
 - The Japanese side agreed with this proposal and requested the Regional Commissioner's Office Coast Region to submit the new member list of the steering committee.





Coast Region Commissioner's Office will inform the concerned parties on the composition of the membership of steering committee and the progress of the study.

- 4. During Phase I of the Study, if Verification Studies are deemed necessary, they will be initiated in Phase II of the Study and continued up to and/or after that phase, if required. In such case the study period will be prolonged.
- 5. The Tanzanian side realizes the importance of training in order to equip the Tanzanian counterpart with knowledge for proper implementation of the Project. However, the Tanzanian side is of the opinion that training should be continued throughout life of the Project in order to increase the capacity of a sufficient number of personnel in different professions. The Team agreed to convey the request to the Japanese Government.
- 6. The Japanese and Tanzanian sides agree on the importance of carrying out Environmental Impact Assessment, if the Initial Environmental Examination recommends so. In this case, the Environmental Impact Assessment will be carried out by a Tanzanian Government Agency.







At the commencement of the Phase II Study, the Team submitted officially twenty (20) copies of the Interim Report and explained the basic concepts of the master plan, methodology and schedule of the Phase II Study to the Coast Regional Commissioner's Office (hereinafter referred as CRCO) and Ministry of Agriculture and Cooperatives on the 4th April 2000. In the discussions on the Interim Report, the importance of Farming practices, Marketing, Agricultural Support services, Agricultural Organizations and Verification Studies was reemphasized and the following points were agreed upon by the Tanzanian and Japanese sides:

- The Tanzanian side confirmed that contents of the Interim Report were prepared in compliance with the conditions set forth in the Scope of Work and agreed to proceed to the next stage of the study in accordance with the methodology and schedule presented in the Interim Report
- 2. Preliminary Environmental Assessment carried out in the Phase I Study concluded that Environmental Impact Assessment (EIA) is not needed.
- 3. The Verification Study which has been judged necessary during the Phase I Study will be drawn up in the Phase II Study and carried out in the Phase III Study. The Verification Study plan will be proposed and discussed in the Progress Report II to and with Tanzanian side, however the final plan will be examined in Japan and put together in the Draft Final Report (Df/R). The introduction of the Verification Study may immoderately prolong the Study period. Even in such case, the time for Df/R will not be changed and Df/R will be submitted in August 2000.
- 4. The technical transfer seminar will be held after the completion of the Verification Study.


