1. Adoption of the Agenda

The meeting adopted the agenda with the amendment that the meeting of the Joint Steering Committee scheduled for the afternoon of 30 August 2000 be dropped from the agenda and be replaced by Item (8) "Discussion of Inception Report".

2. Purpose of the Meeting

The purpose of the meeting was to present and discuss the Inception Report.

3. Welcome Remarks by Chairperson

The Chairperson welcomed the three delegations to the meeting and introductions by delegates were made.

4. Remarks by Zambia

The leader of the Zambian delegation thanked the Government of Botswana for hosting the meeting. The meeting recognised the presence of the Permanent Secretary, Ministry of Communications and Transport from Zambia whose presence will enable the meeting to conclude some outstanding issues. He also

said Namibia had given their apologies but gave the green light and pledged their support for the Project.

5. Remarks by Zimbabwe

The leader of the Zimbabwean delegation thanked the Government of Botswana for hosting the meeting. He said Zimbabwe supports the Project because it would increase trade in the area. He also said the Bridge would assist in diverting traffic from the Southern and Western parts of Zimbabwe to Zambia instead of going through Chirundu.

6. Remarks by JICA

The leader of the JICA Study Team said they are in two delegations, namely JICA Advisory Team and JICA Study Team. He said he hoped they would have a successful outcome of the Feasibility Study.

7. Presentation of Inception Report – JICA Study Team

- 7.1 The JICA Study Team submitted fifty (50) copies of the Inception Report to the meeting for distribution and discussions. The Chairperson called upon the JICA Study Team to present the Inception Report.
- 7.2 The highlights of the presentation are as follows:
- 7.2.1 JICA sought good cooperation from the members to facilitate smooth execution of the study
- 7.2.2 Confirmation of the border points and posts was critical

- 7.2.3 Choice of bridge location is limited because of the multiple international boundaries
- 7.2.4 Between the period August 2000 to March 2001, the Study Team would submit the Interim, Draft Final and Final Reports. The following is the schedule for submission of reports:
 - Interim Report middle of October 2000
 - Draft Final Report beginning of 2001
 - Final Report middle of March 2001

8. DISCUSSION OF INCEPTION REPORT

- 8.1 The JICA Study Team Leader was requested to explain some of the terminologies used in the Inception Report which he did to the satisfaction of the meeting. Clarifications were sought as to why two traffic forecast review periods were provided for in the report namely 2010 and 2015. It was explained that these were necessary for the sake of establishing traffic growth rates and trends. The traffic forecast year would still be 2015 as provided for in the Scope of Works.
- 8.2 The JICA Study Team informed the meeting that the preliminary hydrological survey had already been conducted by a previous JICA Study Team.
- 8.3 The Joint Steering Committee meetings for Interim and Draft Final Reports would be arranged by Botswana and Zambia who would invite Namibia and Zimbabwe.
- 8.4 The basic concept of the border facilities shall be based on the SADC's guidelines if available. The border facility expert of the JICA Study Team will consider these guidelines and other related standards and regulations for establishing the control system and design.
- 8.5 The JICA Study Team confirmed that office space had been allocated to them both in Lusaka and Livingstone in Zambia.

- 8.6 Discussions were still underway between the JICA Study Team and the Department of Roads in Botswana for office to be provided to them in Gaborone and, if necessary, Kasane.
- 8.7 The JICA Study Team requested the Government of Botswana and Government of Zambia to formally communicate to them two names respectively of the counterpart personnel on the study.
- 8.8 The meeting agreed that the counterpart personnel were to undertake both field work and desk work together with the JICA Study Team throughout the course of the study. Expenses for the counterpart personnel would be borne by the respective Governments. The JICA Study Team agreed to prepare the job description for the counterpart staff.
- 8.9 The identity cards for the team were to be arranged by the respective countries
- 8.10 The representative from the JICA Advisory Team informed the meeting that a formal request for counterpart training in Japan had been conveyed to the Government of Japan. However, the meeting requested the representative to provide a formal response from the Government of Japan. He further advised that Botswana and Zambia should submit application forms for counterpart training through the JICA resident offices in Pretoria Lusaka respectively.
- 8.11 Botswana undertook to send five (5) copies of the Inception Report to Namibia.

- 8.12 The meeting wanted to know how the transfer of knowledge and technology was going to be measured. The JICA Study Team clarified that this was to be done through two methods:
 - i) Day to day collaboration between the JICA Study Team and the counterpart personnel
 - ii) Scheduled seminars
- 8.13 Concerns were raised that Item 16 Natural Conditions Survey, should be reflected prior to Item 15 Preparation, submission and discussion of the Interim Report because the selection of the optimal alternative could only be done after conducting a Geo-technical Survey. It was agreed to also reflect item 16 Natural Condition Survey under Item 6 Hydrological and Hydraulic investigation.
- 8.14 The three countries confirmed that they were still using their local standards and specifications and suggested that they be part of the study material. The countries also confirmed that they were in possession of the draft SATCC standards and specifications and these could be made available to JICA Study Team.
- 8.15 It was agreed that provisions for Axle Load Control at the project site on the Zambian side, which had been omitted in the Inception Report should be included.
- 8.16 There were discussions on the threshold values for the Economic Internal Rate of Return to be used in determining the economic viability of the project. The JICA Study Team agreed to consider using multi-criteria analysis on the study.

- 8.17 It was confirmed that the bridge could be tolled subject to the modalities of project financing.
- 8.18 A brief job description for each of the JICA Study Team members must be prepared by the JICA Study Team.
