





I. INTRODUCTION

In response to the official request of the Government of India (hereinafter referred to as "GOI"), the Government of Japan has decided to conduct The Development Study on Reproductive Health in the State of Madhya Pradesh (hereinafter referred to as "the Study") in accordance with the relevant laws and regulations in force in Japan.

Accordingly, the Japan International Cooperation Agency (hereinafter referred to as "JICA"), the official agency responsible for the implementation of the technical cooperation programmes of the Government of Japan, will undertake the Study in close cooperation with the authorities concerned of GOI and Government of Madhya Pradesh (hereinafter referred to as "GOMP").

The present document sets forth the Scope of Work with regard to the Study.

II. OBJECTIVES OF THE STUDY

The overall goal of the Study is to improve the women's health status in the project area. The specific objectives of the Study are:

- (1) to review and analyse the existing programmes which aim to improve women's reproductive health and to empower women, and to formulate Master Plans at the district level.
- (2) to conduct technical transfer to the Indian counterpart personnel throughout the Study.

III. IMPLEMENTATION OF THE STUDY


The study will promote participation of communities in the planning process through various workshops.

IV. STUDY AREA

The area of the Study will be the districts of Chhatarpur, Damoh, Panna, Sagar and Tikamgarh of Sagar Division of the state of Madhya Pradesh. (See Appendix II)

V. SCOPE OF THE STUDY

In order to achieve the objectives mentioned above, the Study will cover the following items:

Phase I. Basic Study

1. Collection and review of existing data and documents on:
 - (1) general issues including natural environmental conditions and socio-economic conditions
 - (2) health related information
 - (3) progress situation of existing programmes
 - (4) present condition of health services
 - (5) sectors and issues related to health of women

2. Recognition of other related development partners' and NGO's activities and exchange opinions.

3. Examination of current situation regarding:
 - (1) administration, organizations, laws, regulations and policies related to the Study

 - (3) main industries including agriculture and forestry
 - (4) financial conditions
 - (5) social infrastructure
 - (6) development plans and planning mechanism at the levels of the state and the districts
 - (7) health service facilities and equipment
 - (8) supply system of medical materials
 - (9) referral system including transportation
 - (10) present conditions of human resource development in health sector
 - (11) access to health services
 - (12) area specific conditions


VI. WORK SCHEDULE

GOI and GOMP will submit its comments to JICA within one (1) month after receipt of the Draft Final Report.

5. Final Report :

Fifty (50) copies within one (1) month after receipt of the comments on the Draft Final Report.


VIII. UNDERTAKING OF GOVERNMENT OF INDIA

1. To facilitate the smooth conduct of the Study, GOI will take the following necessary measures:

- (1) to secure the safety of the Japanese study team (hereinafter referred to as "the Team"),
- (2) to permit the members of the Team to enter, leave and sojourn in India for the duration of their assignment therein, and exempt them from foreign registration requirements and consular fees,
- (3) to exempt the members of the Team from taxes, duties, fees and any other charges on equipment, machinery and other materials brought into India for the conduct of the Study,
- (4) to exempt the members of the Team from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Team for their services in connection with the implementation of the Study,
- (5) to provide necessary facilities to the Team for remittance as well as utilization of the funds introduced into India from Japan in connection with the implementation of the Study,
- (6) to secure permission for the Team to enter into private properties or restricted areas for the implementation of the Study,
- (7) to secure permission for the Team to take all data and documents (including photographs and maps), other than those restricted, related to the Study out of India to Japan, and
- (8) to provide medical services as needed. Its expenses will be chargeable on the members of the Team.

2. GOI/GOMP shall bear claims, if any arise, against the members of the Team resulting from, occurring in the course of, or otherwise connected with, the discharge of their duties in the implementation of the Study, except when such claims arise from gross negligence or willful misconduct on the part of the member of the Team.

3. Public Health and Family Welfare Department, GOMP shall act as the counterpart agency to the Team and also as a coordinating body in relation with other



governmental and non-governmental organizations concerned for the smooth implementation of the Study.

4. Public Health and Family Welfare Department, GOMP shall, at its own expense, provide the Team with the following, in cooperation with other organizations concerned:

- (1) Available data and information related to the Study
- (2) Counterpart personnel
- (3) Suitable office space
- (4) Credentials or identification cards
- (5) Provision of logistics support as far as possible


IX. UNDERTAKING OF JICA

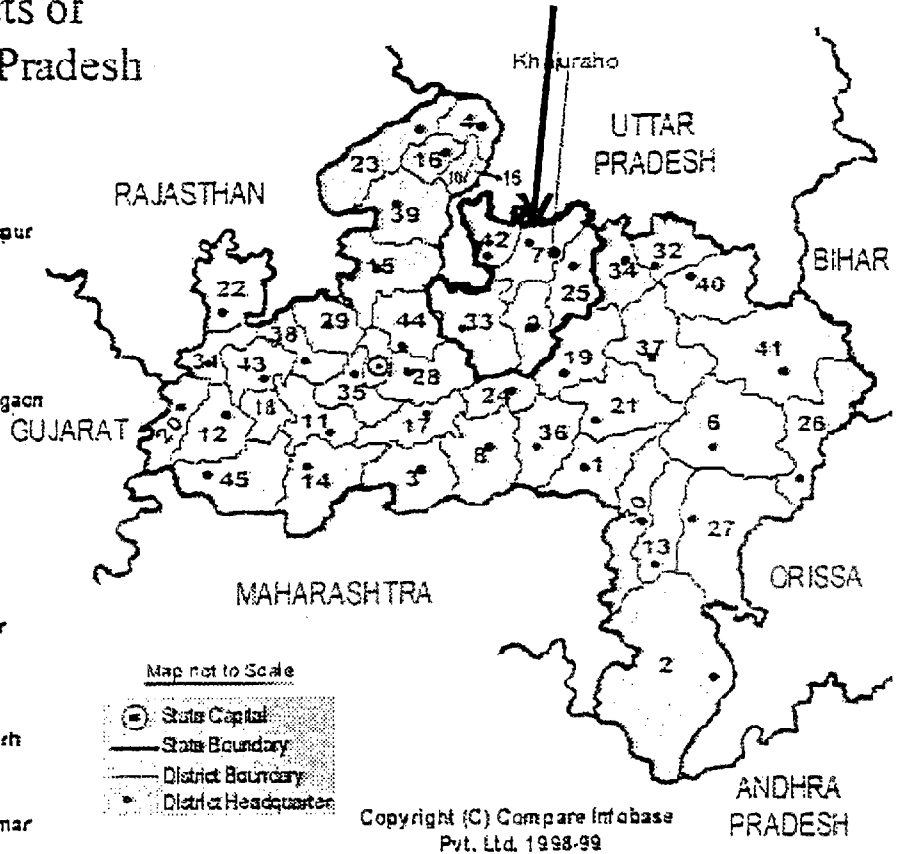



The Japanese Preparatory Study Team (hereinafter referred to as "the Team"), organized by Japan International Cooperation Agency (hereinafter referred to as "JICA") visited the state of Madhya Pradesh from 12th to 20th April 2000, during which the Team had a series of meetings with officials concerned of Government of Madhya Pradesh (hereinafter referred to as "GOMP"). The list of those who attended the meetings is shown in the Appendix I.

The Minutes of Meetings have been prepared for the better understanding of the Scope of Work agreed upon between GOMP and the Team on 20th April 2000. The main items discussed and agreed by both sides are as follows.

I. TITLE OF THE STUDY

Both sides agreed that the title of the study be changed to " The Development Study on Reproductive Health in the State of Madhya Pradesh, India" in order to clarify the object of the study.

II. STUDY AREA


1. Both sides agreed that the Study would cover Sagar Revenue Division and prioritize on Tikamgarh and Damoh districts.
2. GOMP requested the Team that Ujjain Division of the state of Madhya Pradesh (see Appendix II) should also be included in the study area since women's health status in this division showed one of the lowest figures in the state. The Team explained that this kind of request needs to be submitted to the Government of Japan through the diplomatic channel for their consideration. It would therefore not be realistic to include Ujjain Division in the Study. In the mean time, the Team assured that they should bring this request to Ministry of Foreign Affairs, Government of Japan and JICA Head Quarters.

III. TARGET YEAR

Both sides agreed that the target year of the Master Plans designed be 2010 in accordance with the National Socio-Demographic Goals for 2010.

IV. SCOPE OF THE STUDY

Both sides agreed that Full-Scale Study Team consisting of Japanese consultants



(hereinafter referred to as "the Consultants Team") should follow ICPD guidelines in the course of the Study.

V. WORK SCHEDULE

GOMP requested the team that duration of the Study should be shortened from proposed 18 months to 12 months in order to catch up with the rapid developments taking place in the State. The Team assured GOMP to consider this request.

VI. UNDERTAKING OF GOVERNMENT OF INDIA

1. As to 4. (2) of the Scope of Work, the Team requested GOMP that counterpart personnel should be identified who accompany the Consultants Team while going for field survey for ensuring better cooperation, to which GOMP agreed. A nodal officer to be nominated for this by GOMP.
2. As to 4. (3), GOMP notified the Team that office space would be provided in Health and Family Welfare Sector Reform Bureau Building in Bhopal and in the Training Center in Sagar District for the use of the Consultants Team. GOMP will provide them any further office space if requested. As for necessary equipment and furniture, GOMP requested Japan to provide the same, to which the Team agreed to consider.
3. As to 4. (5), GOMP notified the Team that GOMP shall provide the Consultants Team with support in transportation as far as possible.

VII. OTHERS

1. Both sides agreed that the Study would cover newborn baby as well as children up to five years.
2. Both sides agreed the result of the Study be open to the public.

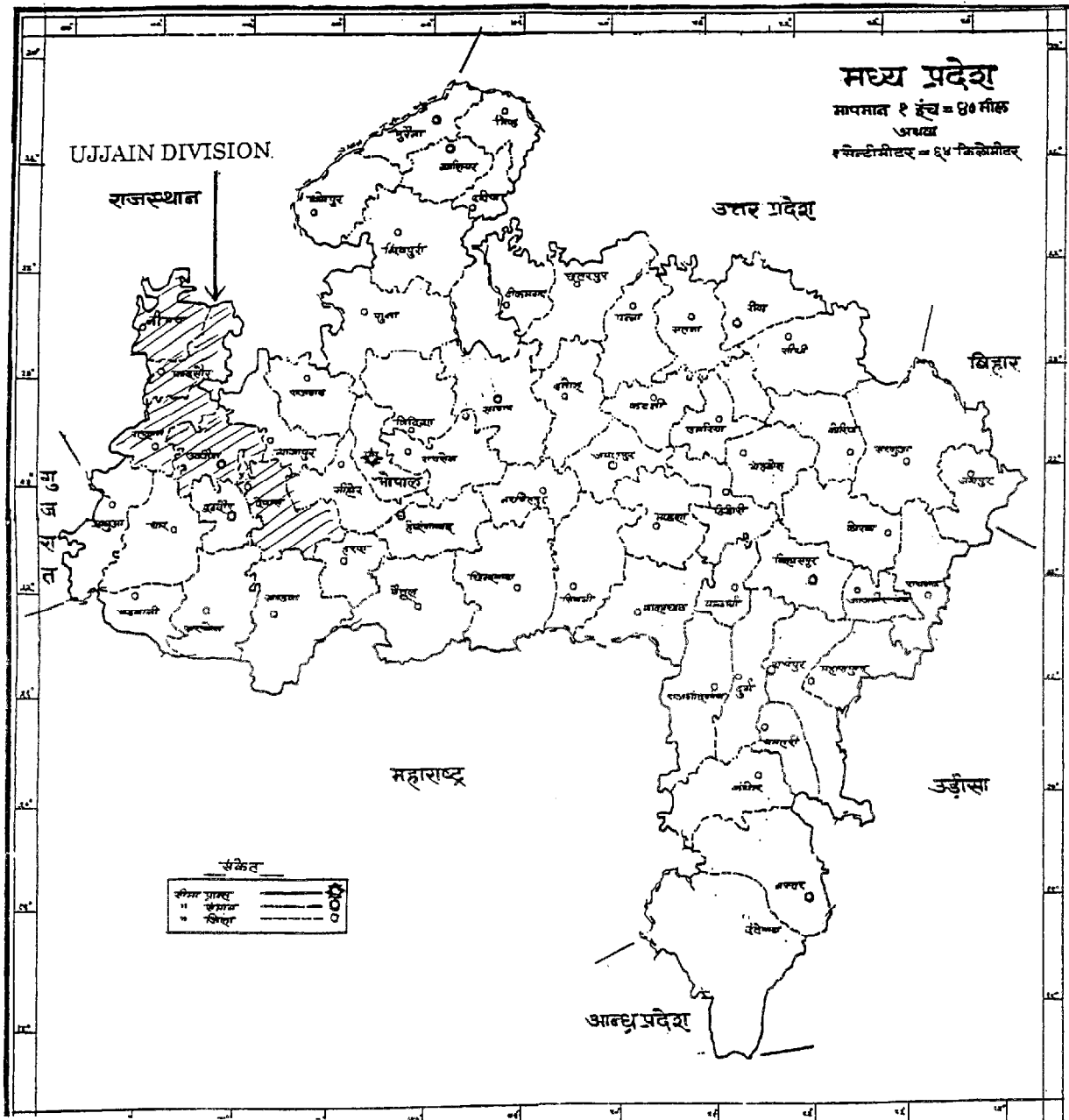
