### I. INTRODUCTION

In response to the request of the Royal Government of Cambodia (hereinafter referred to as "RGC"), the Government of Japan decided to conduct the Study on Improvement of Marketing System and Post-harvest Quality Control of Rice in Cambodia (hereinafter referred to as "the Study") in accordance with the relevant laws and regulations in force in Japan.

Accordingly, the Japan International Cooperation Agency (hereinafter referred to as "JICA"), the official agency responsible for the implementation of the technical cooperation programmes of the Government of Japan, will undertake the Study in close cooperation with the authorities concerned of RGC.

The present document sets forth the scope of works with regard to the Study.

### II. COUNTERPART AGENCY

The Ministry of Commerce (hereinafter referred to as "MOC") and the Ministry of Agriculture, Forestry and Fisheries (hereinafter referred to as "MAFF") shall act as the counterpart agencies.

# III. OBJECTIVES OF THE STUDY

The objectives of the Study are:

- (a) To conduct the Master Plan Study for the improvement of marketing system and post-harvest quality control of rice taking into account strengthening national food security.
- (b) To carry out technology transfer to Cambodian counterpart personnel through on-the-job training in the course of the Study.

# IV STUDY AREA

The Study area is covered by the provinces of Kandal, Prey Veng, Kampong Cham, Svay Rieng, Takeo, Kampong Speu, Kampong Chhnang, Battambang, Siem Reap and Phnom Penh. The location map is attached as ANNEX-1.

# V. SCOPE OF THE STUDY

The Study would consist of two phases with the contents of following study items.

PHASE-I: the Master Plan Formulation

# VIII. UNDERTAKING OF RGC

- 1. To facilitate smooth conduct of the Study, RGC shall take necessary measures:
  - (a) To secure the safety of the Japanese study team(s);
  - (b) To permit the members of the Japanese study team(s) to enter, leave and sojourn in Cambodia for the duration of their assignment therein, and exempt them from foreign registration requirements and consular fees;
  - (c) To exempt the members of the Japanese study team(s) from taxes, duties, fees and any other charges on equipments, machinery and other materials to be brought into and out of Cambodia for the conduct of the Study;
  - (d) To exempt the members of the Japanese study team(s) from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to the members of the Japanese study team for their services in connection with the implementation of the Study;
  - (e) To provide necessary facilities to the Japanese study team(s) for the remittance as well as the utilization of the funds introduced into RGC from Japan in connection with the implementation of the Study;
  - (f) To secure permission for the members of the Japanese study team(s) to enter into private properties and other areas for the implementation of the Study;
  - (g) To secure permission for the members of the Japanese study team(s) to take all data and documents related to the Study, including maps and photographs, out of Cambodia to Japan; and,
  - (h) To provide the Japanese study team(s) with medical services as needed, the expenses of which shall be chargeable to the members of the Japanese study team(s).
- 2. RGC shall bear claims, if any arises, against the members of the Japanese study team(s) resulting from, occurring in the course of, or otherwise connected with the discharge of their duties in the implementation of the Study, except when such claims arise from gross negligence or willful misconduct on the part of the members of the Japanese study team(s).
- 3. MOC and MAFF shall act as the coordinating bodies in relation with other governmental and non-governmental organizations concerned for the smooth implementation of the Study.



- 4. MOC and MAFF shall provide, at their own expense, the Japanese study team(s) with the following, in cooperation with other organizations concerned:
  - (a) available data, information and maps related to the Study;
  - (b) counterpart personnel;
  - (c) suitable office space with necessary equipment and furniture including telephone and office assistants in Phnom Penh and in the field sites;
  - (d) credentials or identification cards; and,
  - (e) additional surveys related to the Study, if necessary.





# I. INTRODUCTION

In response to the request of the Government of the Royal Government of Cambodia, the Preparatory Study Team headed by Mr. M. NAKAMURA was sent to Cambodia by the Government of Japan through the Japan International Cooperation Agency (hereinafter referred to as "JICA"), from 29th November to 10th December, 1999 for the purpose of discussing and confirming the Scope of Work for the Study on Improvement of Marketing System and Postharvest Quality Control of Rice in Cambodia (hereinafter referred to as "the Study").

The Preparatory Study Team had a series of discussions with the officials from the Ministry of Commerce (hereinafter referred to as "MOC") and the Ministry of Agriculture, Forestry and Fisheries (hereinafter referred to as "MAFF").

As a result of the discussion, the Cambodian Side and the Preparatory Study Team agreed on the Scope of Work of the Study. Important points discussed between both sides are recorded in the following section.

The list of participants is attached as ANNEX-1.

# II. RESULTS OF DISCUSSIONS

# 1. Study Area

Both sides agreed that the Study Team shall exclude a part of the study area from the Study, wherever security problems arise.

# 2. Steering Committee

For smooth and effective implementation of the Study, both sides agreed to establish the Steering Committee which shall comprise institutions concerned with the Study.

# 3. Counterpart personnel

Both sides agreed that RGC shall take responsibility for assigning enough number of qualified counterpart personnel prior to the arrival of the Study team.

# 4. Necessary Equipment and Facilities for the Study

MOC promised to provide the Study Team with desks, chairs and the exclusive use of telephone lines in suitable office space both in the Phnom Penh and in the field sites.

The Cambodian side requested that vehicles for the Study should be provided by the Government of Japan.

# 5. Interpreters for the Study

The Cambodian side requested that interpreters for Khmer-English who can conduct the Study with the Study Team should be provided by the Government of Japan.

# 6. Expense for Field Surveys

The Cambodian side requested that expenses on counterpart personnels for field trip should be provided by the Government of Japan.



# 7. Training of Counterpart Personnel

The Cambodian side requested the counterpart training in Japan for an effective technology transfer. The Study team promised to convey the request to the Government of Japan for consideration.

# 8.. Final Report

Both sides agreed that the final report of the Study would be made open and available to the public.

In accordance to the Scope of Work on the Master Plan Study on Improvement of Marketing System and Post-harvest Quality Control of Rice in Cambodia, agreed on the 9<sup>th</sup> day of December 1999, between the Ministry of Commerce (MOC) and the Ministry of Agriculture, Forestry and Fisheries (MAFF) and Japan International Cooperation Agency (JICA), JICA sent the Study Team (Team) to Cambodia on the 16<sup>th</sup> day of April 2000 to conduct the first field survey.

The Team had discussed and exchanged various views on the Inception Report and Progress Report of the Study with the members of the Steering Committee and the Task Force from MOC and MAFF (the Cambodian side). As the result, the Cambodian side accepted the contents of the Inception Report on the 20<sup>th</sup> of April and of the Progress Report on the 26<sup>th</sup> of October 2000 respectively.

In line with the schedule defined in the Inception Report, the first field survey was commenced on the 21<sup>st</sup> of April 2000 and will be terminated by the 9<sup>th</sup> of January 2001.

At the end of the first field survey, the Study Team officially submitted twenty (20) copies of the Interim Report on the 4<sup>th</sup> of January 2001 and explained its contents which contains the results of fact finding, Basic Development Concept and Strategy & Approaches to the Problems, etc. Cambodian side).

Further, the Study Team committed that the Khmer version of the Interim Report will be prepared and submitted to Cambodian side in January 2001.

As a result of explanation and exchange of opinions on the Interim Report, the following points were agreed between the Team and the Cambodian side.

- 1. The Cambodian side satisfyingly understood the outline of the Interim Report. The Cambodian side will review the details, and will send the additional comments to the Team, if any.
- 2. The Study will be continued in Japan for preparation of the Draft Final Report, which to be submitted to Cambodian side in March 2001.
- 3. Cambodian side requested that the Team should proceed to more practical steps under the second phase of the Study and include more activities on the job training to the counterparts.
- 4. Cambodian side requested opportunities to attend the Group Training Course on Post-Harvest Rice Processing in Japan would be continued for Cambodian officials. In addition to this group-training course, individual training program(s) to be arranged by JICA, relating to the Study on rice marketing and post-harvest quality control in the year of 2001 in Japan.
- 5. Both sides agreed that the Study would proceed to the next stage of the Study in accordance with the methodology and schedule.

# E MINUTES OF MEETING ON THE DRAFT FINAL REPORT FOR THE STUDY ON IMPROVEMENT FOR MARKETING SYSTEM AND POST-HARVEST QUALITY CONTROL OF RICE IN CAMBODIA

In accordance with the Scope of Work (S/W) for the Study on Improvement of Marketing System and Post-harvest Quality Control of Rice in Cambodia (hereinafter referred to as "the Study"), the government of Japan dispatched the Study Team through Japan International Cooperation Agency (hereinafter referred to as "JICA") for the implementation of the Study to the Royal Government of Cambodia.

Based on the results of field survey and home office work, the Study Team submitted twenty (20) copies of the Draft Final Report on the Study (hereinafter referred to as "the DFR") and explained its contents with an emphasis laid on the results of constrains, development concept, and development target (priority projects) to the Steering Committee represented by the Ministry of Commerce (hereinafter referred to as "MOC") and the Ministry of Agriculture, Forestry and Fisheries (hereinafter referred to as "MAFF"), on the 7<sup>th</sup> and 8<sup>th</sup> day of June 2001. The list of participants is stated in the ANNEX.

1. As a result of explanation and discussion on the DFR, both sides mutually agreed on the points as stated below:

The Cambodian side agreed on the contents of the DFR and confirmed that the contents are stated in accordance with the S/W through the Study Team explanation. The Cambodian side will make comments in English within one month, if any.

- 2. The Cambodian side and Japanese side exchanged comments for the priority projects as stated below:
  - (1) The Cambodian side expressed that all the priority projects are important to execute with athe assistance of the Japanese government.
  - (2) MAFF agreed on the importance of agricultural cooperatives, in marketing system and pointed out that development of the cooperatives should be proceeded by enacting the Royal decree concerned, then be promoted with the support of the Japanese government.
  - (3) Quality standard is surely important for Cambodia. The Study Team explained that the Cambodian side should make effort to inform the people involved in rice marketing and quality control through monitoring and dissemination practices. The Cambodian side acknowledged the difficulty in establishing quality standard and its implementation.

- (4) The Study Team pointed out that the project concerning post-harvest practice technology extension is currently implemented with the support of the Australian government. MAFF explained that there is no duplication with the priority projects of the DFR.
- (5) The open paddy market is an important project for fair transaction and incentive to improve paddy quality in Cambodia. The Administration and management of the open paddy market will be discussed among MOC, MAFF, and institutions concerned.
- (6) In order to quantify border trade more accurately, further study should cover comprehensive analysis of the legal system on paddy trade and possible enforcement mechanism.
- (7) In connection with the rice reserve at the national level, the Cambodian side understands that the project is necessary to regulate the market price. However, the Cambodian government is facing a lack of fund to re-establish the reserve system at this moment. The matters should be discussed among the ministries concerned and will be submitted for decision of the Cambodian government.
- (8) The Cambodian side will take necessary actions to realize implementation of the priority projects taking into consideration of inter-linkage the those projects as early as possible.
