MINUTES OF MEETING BETWEEN THE JAPANESE FINAL EVALUATION TEAM AND THE AUTHORITIES CONCERNED OF THE GOVERNMENT OF THE KINGDOM OF THAILAND ON THE JAPANESE TECHNICAL COOPERATION FOR THE FOLLOW-UP PROGRAM OF THE PRODUCTIVITY DEVELOPMENT PROJECT IN THE KINGDOM OF THAILAND

The Japanese Final Evaluation Team (hereinafter referred to as "the Japanese Team"), organized by the Japan International Cooperation Agency (hereinafter referred to as "JICA") and headed by Mr. Mitsuru Hagino, visited the Kingdom of Thailand from December 11 to December 23, 2000 for the purpose of joint evaluation with the Thai Evaluation Team (hereinafter referred to as "the Thai Team"), headed by Mr. Manu Leopairote, of the Follow-up Program (hereinafter referred to as "the F/U") of the Productivity Development Project (hereinafter referred to as "the Project") on the basis of Record of Discussions signed on December 28, 1998 (hereinafter referred to as "the R/D").

After the Joint Evaluation of the F/U, the Japanese Team discussed with the authorities of the government of the Kingdom of Thailand concerned (hereinafter referred to the as "the Thai side") on matters pertaining to the successful implementation of the Project.

As a result of the discussions, both sides mutually agreed upon the matters referred to in the documents attached hereto.

1 Recognition of the Joint Evaluation Report

Both sides recognized the Joint Evaluation Report for the F/U submitted as the result of the joint work by both Evaluation Teams.

Both sides agreed that the Project would be terminated on February 17, 2001 as stipulated in the R/D.

2 Further Inputs to the Project until February 17, 2001

Both sides confirmed the further inputs until the end of the Project as follows.

- 2.1 Inputs by the Japanese Side
- (1) Dispatch of Long-Term Experts

The technology transfer by three (3) long-term experts will be continued in the following fields:

- a) Chief Advisor/Coordinator
- b) Consulting Skills for Productivity Development (hereinafter referred to as "CSK")
- c) Human Resource Development and Labor-Management Relations (hereinafter referred to as "HRD/LMR")
- (2) Dispatch of Short-Term Experts

Two (2) short-term experts are scheduled to be dispatched in the following field as the speakers for the Top Management Seminar to be held on January 26, 2001.

- a) Productivity Improvement in the SMEs in Japan
- 2.2 Inputs by the Thai Side

Provision of all the necessary inputs as agreed upon in the R/D.

3. Assurance of Sustainability of the Project

As a result of the joint evaluation mentioned in 1 above, both sides reached the understanding that the Project would be successfully terminated as scheduled with a prospect for sustainability. The specific items discussed in the meeting regarding the sustainability were as follows:

3.1 Financial Aspect

The Thai side explained the Team that the ordinary budget for the

operation of Thailand Productivity Institute (hereinafter referred to as "FTPI") in Thai Fiscal Year 2001 was about 35.6 million Bahts against the original request for 278 million Bahts and that the government budget was only for the non-business activities such as administration, research, promotion and so forth. Consequently, Consulting Division and Training Division of FTPI are required to be financially self-sustainable.

In this regard, the Team expressed its concern that the mission of FTPI as the National Productivity Organization, which was to diffuse and penetrate productivity development activities to Thai enterprises, especially to small and medium enterprises, would be less active under the pressure of being self-sustaining. In response to this concern, the Thai side explained the Team that FTPI realized the importance of the mission, but on the other hand, needed to be self-sufficient. FTPI is thus planning to fulfill its mission as far as the financial and human resources permit under the new environment.

3.2 National Productivity Strategic Plan

The Thai side explained the Team that FTPI had participated in formulating National Productivity Strategic Plan which was approved by the Cabinet in September 2000 to be incorporated into the Ninth National Economic and Social Development Plan (2002-2006). In the Plan, FTPI is expected to play two different roles; one as a member of secretariat for National Productivity Committee which will be established under the Office of the Prime Minster to enhance the effective implementation of the Plan, and the other one as an implementation body of the Plan. It was explained by the Thai side to the Team that the actual role of FTPI would be determined next year.

3.3 Personnel Management System of FTPI

The Thai side explained the Team that FTPI was in process of reviewing the personnel management system to become more competitive in the changing business environment.
