

# THE RECORD OF DISCUSSIONS ON THE EXTENSION OF THE DURATION OF THE JAPANESE TECHNICAL COOPERATION FOR THE MEDICAL EDUCATION PROJECT

With regard to the extension of the duration of the Japanese technical cooperation for the Medical Education Project (hereinafter referred to as "the Project") based on the Record of Discussions signed in Kathmandu on March 22, 1989, Mr. Yasuyuki Kohori, Resident Representative of the Japan International Cooperation Agency (hereinafter referred to as "JICA") in the Kingdom of Nepal, held a series of discussions with the Nepalese authorities concerned. The discussions were in accordance with the results of the joint evaluation by the Japanese and Nepalese team conducted in Kathmandu on January 14, 1994.

As a result of the discussions, both sides agreed to recommend to their respective Governments, the implementation of the extension of duration of the Japanese technical cooperation for the Project along the lines described in the document attached hereto.

#### VII. MEASURES TO BE TAKEN BY HIS MAJESTY'S GOVERNMENT OF NEPAL

- His Majesty's Gvernment of Nepal will take necessary measures to ensure
  that the self-reliance operation of the Project will be sustained during and
  after the period of Japanese technical cooperation, through the full and
  active involvement in the Project by all related authorities, beneficiary groups
  and institutions.
- In accordance with the laws and regulations in force in Kingdom of Nepal, His Majesty's Government of Nepal will take necessary measures to meet running expenses necessary for the implementation of the Project.

#### VIII. ADMINISTRATION OF THE PROJECT

The Japanese Team Leader will provide necessary recommendations and advice to the Dean, Institute of Medicine and the Hospital Authority of Institute of Medicine on any matters pertaining to the implementation of the Project.

#### XI. TERM OF COOPERATION

The duration of the extended period of the technical cooperation for the Project under this Attached Document will be two (2) years from June 20, 1994.

#### 1. Project Purpose

In order to achieve the overall goals in "ANNEX I.1. Objectives of the Project" of the Record of Discussions signed in Kathmandu on March 22, 1989, the following purpose is set for the extended period of the Project (The purpose has been based on the Result and the Roommendation in Joint Evaluation Report signed in Kathmandu on January 14,1994):

The output obtained through the Project Activities is effectively utilized at IOM, Tribhuvan University.

- 2. Outputs and Activities of the Project
- (A) Cooperation among the departments in Tribhuvan University Teaching Hospital (hereinafter referred to as "TUTH") is promoted through the following activities:
- i. To strengthen the clinical activities in TUTH (including central departments such as Laboratory, X-ray and Operation theatre).
- To develop the curriculum of the Post-graduate Course on Internal Medicine,
   Surgery and Obstetrics & Gynecology.
- iii. To improve the administration system in TUTH.
- (B) Cooperation between TUTH and other medical institutes in Nepal:

To establish the committee between TUTH and Kanti Pediatric Hospital which holds regular meeting for effective service delivery and personnel training in pediatrics.
