

I. Introduction

- 1.1 The Study Team has submitted the Progress Report (1) (P/R(1), twenty (20) copies of English version and twenty (20) Spanish version respectively) to Municipality of Panama. Consequently a series of meetings were held from March 6th to 12th in Panama, the Republic of Panama, to discuss the contents of the P/R(1). A list of officials who attended to the above meetings is given in the appendix.

II. Issues and decisions

- 2.1. Various issues were discussed and clarifications on the P/R(1) were made. Subsequently appropriate consensus was reached during the meetings. These issues, clarification and consensus are outlined in the following paragraphs.

2.2 Comments on the P/R(1)


The Study Team explained that the P/R (1) describes the present situation of Solid Waste Management (SWM) in Panama District and the Master Plan targeting 2015 formulated based on the investigation of the present situation. The Study Team requested the Panamanian side to confirm the contents of the P/R(1). The Panamanian side agreed that they will soon confirm the contents of the P/R(1) and give final comments, if any, in writing by March 26, 2002.

The Study Team appreciated the thoughtful cooperation by the Panamanian side for the Study.

2.3 Priority Projects

Priority projects were preliminary selected from the contents of the Master Plan through discussions between the Panamanian side and the Study Team. The result of preliminary selection will be conveyed to JICA headquarters. Priority projects preliminary selected were the following.

- Final Disposal System: a **feasibility study** on facilities to ensure the final disposal by 2015 in the Cerro Patacon Final Disposal Site.
- Transfer Transport System: a **pre-feasibility study** on transfer transport system for coping with waste generated from the expanding urbanized areas towards the north and the east (Some potentially suitable sites for transfer stations were observed by both the Panamanian side and the Study Team. However, the final decision on selection of site(s) has not been made by the Panamanian side. Therefore, the Panamanian side requested the Study Team to carry out a study to obtain information that is to be helpful for the final decision.)

2.4 Pilot Projects

Pilot projects that are to be carried out during the second study in Panama were preliminary selected through discussions between the Panamanian side and the Study Team. The result of preliminary selection will be conveyed to JICA headquarters. Pilot projects preliminary selected were the following.

- Experiment of Collection Improvement
- Experiment of Separate Collection
- Experiment of Landfill Operation Improvement
- Experiment of DIMAUD's Management Improvement
- Experiment of Environmental Education
- Experiment of Public Relation Improvement

The Study Team informed that the first seminar is planned to be held in June 2002 in Panama District. Details of seminar program would like to be discussed with the Panamanian side.


2.7 Schedule

I. Introduction

- 1.1 The Study Team has submitted the Interim Report (It/R, ten (10) copies of English version and thirty (30) Spanish version respectively) to Municipality of Panama. Consequently a series of meetings were held from June 7th to 14th in Panama, the Republic of Panama, to discuss the contents of the It/R. A list of officials who attended to the above meetings is given in the appendix.

II. Issues and decisions

- 2.1. Various issues were discussed and clarifications on the It/R were made. Subsequently appropriate consensus was reached during the meetings. These issues, clarification and consensus are outlined in the following paragraphs.

2.2 Comments on the It/R

The Study Team explained that the It/R describes the present situation of Solid Waste Management (SWM) in Panama District, the Master Plan targeting 2015 and its evaluation. The Study Team requested the Panamanian side to confirm the contents of the It/R. The Panamanian side reviewed the contents of the It/R and agreed that the Study will move to the Phase II where feasibility studies and pilot projects are to be carried out based on the contents of the It/R.

2.3 Priority Projects

The Study Team informed the Panamanian side that the JICA headquarters has decided to carry out the priority projects below that were preliminary selected from the contents of the Master Plan through discussions between the Panamanian side and the Study Team.

- Final Disposal System (Cerro Patacon Landfill Project): **a feasibility study** on facilities to ensure the final disposal by 2015 at the Cerro Patacon Final Disposal Site.
- Transfer Transport System (Transfer Transport Project): **a pre-feasibility study** on transfer transport system for coping with waste generated from the expanding urbanized areas towards the north and the east.

The Panamanian side appreciated the thoughtful decision by the JICA headquarters and expressed their intention to take initiative approach to obtain fruitful outcome from the feasibility studies.

2.4 Pilot Projects

The Study Team informed the Panamanian side that the JICA headquarters has decided to carry out the pilot projects below that were preliminary selected through discussions between the Panamanian side and the Study Team.
