
Our warmest greetings to the organizers, participants and special guests of the EMPOWER Project Trade Exhibit.

I would like to welcome all the participants of the EMPOWER Exhibit on June 9 and 10, 2003.






The Environmental Management Bureau (EMB) of the Department of Environment and Natural Resources (DENR), the prevailing environmental administrative machinery, had several forerunners. Foremost of these was the National Water and Air Pollution Control Commission (NAWAPCO), which was created in 1964 by virtue of Republic Act No. 3931. It was subsequently transformed into the National Pollution Control Commission (NPCC) in 1977 through Presidential Decree No. 984. This new commission had more regulatory functions than the NAWAPCO.

In the mid-seventies, environmental problems took on a wider perspective, realizing that industrial pollution was not the country's sole environmental problem. It was recognized that practically all aspects of the environment were subjected to varying degrees of abuse and degradation. It was this perception that brought about the need to integrate the approach in confronting and solving environmental problems.

On July 6, 1976, the Inter-Agency Committee on Environmental Protection (IACEP) was created under the Department of Natural Resources to assess the environmental situation at that time, specifically on government policies and programs on environmental protection. The Committee's findings showed that there was an uncoordinated implementation of activities by at least 22 agencies with specific sectoral responsibilities on environmental protection. Furthermore, their findings also showed that the lack of adequate legislation and regulatory powers hindered the environmental efforts of the various agencies.

There was also no mechanism to assess the environmental impacts of development projects. As a result, the IACEP recommended the integration of environmental programs through inter-agency coordination and the creation of a national coordinating agency on environmental protection.

These recommendations were operationalized on April 18, 1977 when the National Environmental Protection Council (NEPC) was created by virtue of Presidential Decree No. 1121 and was placed under the Office of the President. It was tasked with the rationalization of the functions of government agencies for an effective, coordinated and integrated system of environmental protection, research and implementation of laws.

In 1986, the formation of a new government saw the abolition and reorganization of various government agencies, including the NEPC and the NPCC. These two agencies were merged on June 1987, with the creation of the DENR by virtue of Executive Order No. 192. It was in this Order that the EMB was likewise created as its staff bureau. A little more than a decade later, pursuant to the Clean Air Act or Republic Act No. 8749, the EMB has been elevated from a staff to a line bureau.

The Ecolabeling Programme of the Philippines

The continuous development of policies and systems that aim to care for the environment and the creation of effective instruments for their implementation is a major responsibility of our government. While the world does not necessarily demand compliance to environmental standards related primarily to testing and measuring pollution through ISO (International Standards Organization) 14000 series, the

Philippines has already adopted these systems to provide an option for concerned agencies to abide to sound environmental practices and procedures.

Standards of the ISO 14000 series are concerned with complex environmentally – oriented management, which includes Environmental Labeling, often called as Ecolabelling. A voluntary application with a third party certification body, the program usually identifies products that have less environmental impact, sets up environmental requirements and awards a special label to products that meet these standards. It is seen as an important market instrument used to complement mandatory laws and regulations for environmental protection set by the government.

The Green Choice Programme is the government's response on our need to change consumer preferences and practices, initiating a demand for environmental responsibility from all sectors of society.

When republic Act No. 9003, also known as the "Ecolabelling Programme (ELP) of the Philippines was given a legal basis. Article 4 of Section 27 states that "DTI shall formulate and implement a coding system for packaging materials and products to facilitate waste recycling and reuse." The Department of Trade and Industry (DTI), through its Bureau of Product Standards (BPS) and the Private Sector Participation in Managing the Environment – Environmental Management System Module (PRIME Module 3), adopted a plan for the development of the National Product Ecolabelling Program.

Clean & Green Foundation, Inc. (C&GFI) was designated Administrator of the ELP through a Memorandum of Agreement signed by the members of the ELP Board, headed by BPS-DTI and Environmental Management Bureau of the Department of Trade and Natural Resources, last 07 March 2001 at the CEO Suites, Makati City.

Noah's Paper Mills Inc. is a paper mill situated along South East Marcos Bridge Marcos Hi-way Calumpang, Marikina City. It is formerly Eastern Paper Mills own by Chiungbian Brothers. Noah's Paper Mill started its operation last quarter of 1995. It has one paper fourdrinier machine and a de-inking plant. It uses 100% secondary fiber (mixture of local and imported waste) as raw material producing white printing and writing grades, which later are then sold locally in the market.

The company is 100% Filipino own corporation with a rated machine capacity of 23,000 MT/year. The machine is equipped with a computer for process check. Due to tight business condition, the machine operates at an average of 260 working days, round the clock operation with 3 shifts. It employs a total of 80 regular employees.

The company adopts a wastewater treatment plant as a means to conform to government set standards on proper wastewater discharge. Treated water about 504 cubic meter/day is directed to Marikina River. Air emission, on the other hand are mainly derived from Bunker oil-fired Boiler, which are then controlled thru the use of cyclone filters. Power requirements for the mill are obtained from deep well. The company adopts to set benchmarking on above utilities so as to control its usage.

Solid waste disposal from the plant de-inking in the form of sludge cake which is about 40 cubic meter/day is one perennial mill problem due to lack of dumpsite. Presently the mill utilizes its vacant lot as landtill. The soil is cultivated upon mixing with mill sludge thru the used of a

Since it was established in 1992 as a non-profit organization, PBE has helped Philippine industry address its environmental concerns in several ways: It has succeeded in making environmental information resources available to industry, and acted as catalyst for sustainable development and corporate environmental action. It is credited with milestone advocacy activities such as the promotion of the Philippine Business Charter for Sustainable Development, the UNEP Declaration on Cleaner Production and the Business (Environmental) Agenda for the Industry Associations (Business Agenda 21). It is immediately associated with initiatives like the quarterly Business and Environment Magazine, still the only local magazine of its kind focused on industrial environment concerns; and the Industry Waste Exchange Program. It has also established itself as a credible partner of government, international agencies and non-government organizations. One indication of this is the number of donor – assisted programs it implemented this year alone.

The same issue chronicled the evolution of environmental management in the Philippines, described the business participation at the World Summit for Sustainable Development in Johannesburg, reflected on PBE's first ten years, and showcased ten local corporate examples of responsible environmental action.

The PBE Board also directed the Secretariat to organize a PBE Member's Brainstorming Session to review accomplishments and identify future thrusts and programs, in consideration of the changes which have occurred over the years. The Session was held back to back with the Annual Membership Meeting in November, with the assistance of a professional facilitator. A smaller group is set to develop recommendations for the PBE Board to take up in its first meeting in 2003.
