9. Materials related to foreign NGO registration

When JICA conducts a partnership program in Thailand, the implementing NGO has to obtain permission from the Ministry of Labor (formerly Ministry of Labor and Social Welfare) to operate in Thailand, in accordance with the Rules and Regulations of the Ministry of Labor and Social Welfare on the Entry of Foreign Private Organizations to Operate in Thailand B.E. 2541 (1998) and B.E.2543 (2000). These Rules and Regulations do not apply to foreign private organizations who entered Thailand to operate under the requirements of and under the agreements with the Thai Government. However, JICA's partnership program did not meet the criteria. Thus the implementing NGO of a development partnership program has to proceed through the approval process of the Ministry of Labor in accordance with the above mentioned Rules and Regulations.

(1) Procedures for foreign NGO registration

According to the Rules and Regulations of the Ministry of Labor and Social Welfare on the entry of a Foreign Private Organization to Operate in Thailand B.E. 2541 (1998) and B.E. 2543 (2000), a foreign private organization (Non Governmental Organization) has to obtain permission for entry from the Ministry. Under these rules, there is a committee to consider the operation of foreign private organizations consisting of the representatives of the relevant departments. Permission to entry is granted to a foreign NGO by this committee after investigations by relevant agencies.

The following steps must be taken to gain permission for entry:

1) NGO registration

Step 1. Submission of an application form⁴ (30 copies) to the secretariat⁵ of the Committee to consider the operation of foreign private organization, Office of Permanent Secretary, Department of Employment, Ministry of Labor.

Step 4. The Committee holds a meeting for judgment everytime they receive the application from a foreign NGO.

According to a member of the secretariat of the Committee, to obtain the permission, it takes about four months in case of the first application and one month for an extension.⁶ The permission is valid for one year for the first application and two years for an extension.

⁶ It took SAORI-HIROBA one year to obtain permission. Another Japanese NGO "Japan Alliance for Humanitarian Demining Support (JAHDS)" needed six months to get permission. A member of JAHDS who carried out NGO registration pointed out tips for accelerating application procedures for permission as follows: 1) have a good relationship with government authorities; 2) submit clear documents; 3) have notification of the organization with evidence; and 4) check the proceedings regularly.

WORKING OF ALIENS ACT,

B.E. 2521 (1978)

BHUMIBOL ADULYADEJ, REX.

Given on the 8th Day of July B.E. 2521; Being the 33rd Year of the Present Reign.

His Majesty King Bhumibol Adulyadej is graciously pleased to proclaim that:

Whereas it is expedient to revise the Law on working of aliens;

Be it, therefore, enacted by the King, by and with the solvice and consent of the National Legislative Assembly as follows:

Section 1. This Act is called the "Working of Aliens Act, B.E. 2521".

Section 2. This Act shall come into force as from the day following the date of its publication in the Government Gazette.*

Section 3. The Announcement of the National Executive Council No. 322, dated 13th December B.E. 2515 shall be repealed.

Section 4. This Act does not apply to the performance of specific duty by aliens in the Kingdom in the following capacities:

- (1) as members of a diplomatic mission;
- (2) as members of a consular mission;
- (3) as representatives of member countries and officials of the United Nations Organization and its specialized agencies;
- (4) as personal servants coming from foreign countries to work regularly for persons in (1) or (2) or (3);
- (5) as persons who perform duty of mission under an agreement concluded between the Government of Thailand and foreign Government or international organizations;
- (6) as persons who perform duty or mission for the benefit of education, culture, art, sports or other activities as may be prescribed by the Royal Decree;
- (7) as persons permitted by the Government of Theiland to enter and perform any duty or mission.

Section 5. In this Act,

"alien" means a natural person who is not of that nationality;

"work" means to engago in work by exerting energy or using

knowledge whether or not in consideration of wages or other benefit;

"permit" means a work permit;

"holder of permit" means an alien who has been granted a permit;

"Committee" means the Committee Considering Working of Aliens;

"competent official" means a person appointed by the Minister

for the execution of this Act;

"Registrar" means a porson appointed by the Minister as Registrar of working of aliens;

"Director-General" means the Director-General of the Labour Department;

"Minister" means the Miniator having charge and control of the execution of this Act.

Section 6. Subject to section 12, any work which an alien is prohibited to engage in any locality and at any particular time and whether subject to absolute or conditional prohibition. and to any extent shall be prescribed by the Royal Decree.

Section 7. Subject to section 10, an alien may engage in any work which is not prohibited by the Royal Decree issued under section 6 only upon receipt of a permit from the Director-General or official entrusted by the Director-General except an alien who is permitted to enter the Kingdom for temporary stay under the law on immigration in order to engage in the work which is of necessity and urgency for period not longer than fifteen days, but such alien may engage in the work after he has notified the Director-General or official entrusted by the Director-General in writing in the forms prescribed by the Director-General.

Section 8. Subject to the law on immigration. any person wishing to employ an alien in his business in the Kingdom may submit an application on behalf of the alien to the Director-General or official entrusted by the Director-General.

The Director-General or official entrusted by the Director-General may issue permit to an alien under paragraph one only after the entry into the Kingdom of such alien.

Section 9. In granting a permit to an alien under section 7 and section 8, the Director-General or official entrusted by the Director-General may prescribe any condition therein for the alien to comply therewith. In such case, the alien is required to give assurances that he would comply with much condition and. In the case under section 8, such alien shall give assurances prior to his entry into the Kingdom.

Section 10. An alien who has been permitted entry to work in the Kingdom under the law on investment promotion or other lass shall submit an application to the Director-General or official entrusted by the Director-General within thirty days from the date of his entry into the the Kingdom, but if such alien has been in the Kingdom, the period of thirty days shall begin as from the day he is aware that he has been granted permission to work under the law on investment promotion or other laws. Pending the issue of permit, the applicant shall be allowed to engage in such work.

Upon receipt of application, the Director-General or official entrusted by the Director-General shall issue a permit without delay.

Section 11. An alien who may apply for a permit under section 7 must possess the following qualifications:

- (1) having a place of residence in the Kingdom or having been permitted entry into the Kingdom for temporary stay under the law on immigration but not as tourist or in transit;
- (2) not being disqualified or prohibited under the conditions prescribed by the Minister as published in the Government Gazette.

Section 12. The following aliens may engage in such works as to be prescribed by the Notification of the Minister in the Government Gazette. In such Notification, the Minister may prescribe any condition as he may deem appropriate:

- (1) aliens under a deportation order under the law on deportation who have been permitted to engage in occupations at any place in lieu of deportation or while awaiting deportation;
- (2) aliens whose entries into the Kingdom have not been permitted under the law on immigration and are awaiting deportation;
- (3) aliens who were born within the Kingdom but have not sequired Thai nationality under the Announcement of the National Executive Council No. 337, dated 13th December B.E. 2515 or under other laws;

(4) aliens whose Thei nationality have been revoked by the Announcement of the National Executive Council No. 337, dated 13th December B.E. 2515 or under other laws.

An alien may engage in such works as to be prescribed by the Minister under paragraph one only upon receipt of a permit from the Director-General or official entrusted by the Director-General.

Section 13. Permits issued under this Act shall be valid for one year from the date of issue except that

- (1) the permit issued to an alien under section 10 shall be valid for a period as long as he has been permitted to work under such laws;
- (2) the permit issued to an alien under section 12 shall be valid for the period prescribed by the Director-General or official entrusted by the Director-General which must not exceed one year from the date of issue;
- (3) the permit issued to an alien who has been permitted entry into the Kingdom for temporary stay under the law on immigration shall be valid for a period as long as he has been permitted to stay in the Kingdom at the time of the issue of the permit;
- (4) the permit issued to an alien who has been permitted entry into the Kingdom for temporary stay under the law on immigration without definite period shall be valid for thirty days from the date of issue.

Section 14. In the case where a holder of permit which is issued under section 10 has received extension of working period under such laws, the holder of permit shall notify the Registrar within thirty days from the date of receiving extension and the Registrar shall record such extension in the permit.

Section 15. Before a permit is expired and the holder of permit wishes to continue working, he shall apply for a renewal of the permit to the Registrar prior to the expiration thereof. In such case, the applicant for renewal of the permit may continue working until the Registrar issues an order refusing the renewal of the permit.

Each renowal of permit shall be valid for one year, except that

- (1) the renewal of permit under section 13(3) shall be made for a period not more than the extension which the holder has been permitted to stay in the Kingdom;
- (2) the renewal of permit under section 13(4) shall be made for a period of thirty days each time except that, in the case where an alien has been permitted to stay in the Kingdom under the law on immigration for a definite period which is longer than thirty days, the renewal of permit shall be for a period as long as he has been permitted to stay in the Kingdom, but not longer than one year.

Section 16. The Minister has the power to issue Ministerial Regulations prescribing forms, rules and procedures in the following cases;

- (1) application for and issue of permit under section 7, Section 8, section 10 and section 12;
- (2) application for renewal and renewal of permit under section 15;
- (3) application for and issue of permit substitute under section 19;
- (4) application for and issue of permission to change work or locality or place of work under section 21;
 - (5) issue of identity card under section 31.

Section 17. In the case of refusing to issue a permit or not granting permission under section 7, section 8, section 10, section 12 or refusing to renew the permit under section 15 or not granting permission to change the work or locality or place of work under section 21, the applicant has the right to appeal to the Minister by submitting a written appeal to the Director-General or official entrusted by the Director-General or the Registrar, as the case may be, within thirty days from the date of the knowledge of the order of refusal. Upon receipt of the appeal, it shall be referred to the Committee within fifteen days and the Committee shall then consider and submit its opinion to the Minister within fifteen days and the Minister shall complete his consideration of the appeal within thirty days. The decision of the Minister shall be final.

In the case of an appeal against an order refusing the renewal of a permit under section 15 as mentioned in paragraph one, the appellant has the right to continue working until the Minister decides on the appeal.

Section 18. A holder of permit must keep the permit on himself or at the place of work during working hours in order that it may be readily produced to a competent official or Registrar.

Section 19. If a permit is materially damaged or lost, the holder of the permit shall apply for a permit substitute to the Registrar within fifteen days from the date of the knowledge of such damage of loss.

Section 20. In the case where an alien resigns from the work which is specified in the permit, he shall return the permit to the Registrar of Changwat where the place of work is situated within seven days from the date of his resignation.

Section 21. A holder of permit shall not engage in the work other than that which is specified in the permit or change the locality or place of work from that which is specified in the permit unless a permission is obtained from the registrar.

Section 22. No person shall employ an alien who has no permit nor employ him in the work which is of different description or conditions from that specified in the permit.

Section 23. Any person who employs an alier or transfers an alien to work in a locality other than that which is specified in the permit, or allows an alien to resign from his work, shall notify the Registrar within fifteen days from the date of employment, transfer or resignation.

The notice under paragraph one shall be in the form prescribed by the Director-General.

Section 24. There shall be a committee called the "Committee Considering Alien's Work" consisting of the Permanent Secretary of the Ministry of Interior or person entrusted by the Permanent Secretary of the Ministry of Interior as Chairman, a representative of the Ministry of Foreign Affairs, a representative of the Ministry of Industry, a representative of the Department of Local Administration, a representative of the Police Department, a representative of the Department of Public Welfare, a representative of the Department of Public Prosecution, a representative of the Department of Trade Registration, a representative of the Department of Internal Trade, a representative of the Office of the Board of Investment, a representative of the Office of the National Economic and Social Development Board, and not more than three other persons appointed by the Minister as committee members and a representative of the Labour Department as member and secretary.

Section 25. Members appointed by the Minister hold office for a term of two years and may be reappointed.

Tentative Translation

RULE OF THE MINISTRY OF LABOUR AND SOCIAL WELFARE ON THE ENTRY OF FOREIGN PRIVATE ORGANIZATIONS TO OPERATE IN THAILAND B.E. 2541 (1998)

Whereas it is expedient to revise the rule of the Ministry of Interior on the entry of foreign private organizations to operate in Thailand so as to be appropriate for and in conformity with the policy of economic and social development as well as security of the country, the Ministry of Labour and Social Welfare, with the approval of the Council of Ministers, hereby issues the Rule as follows:

Clause 1. This Rule is called the "Rule of the Ministry of Labour and Social Welfare on the Entry of Foreign Private Organizations to Operate in Thailand, B.E. 2541".

Clause 2. This Rule shall come into force as from the day following the date of its publication.

Clause 3. The Rule of the Ministry of Interior on the Entry of Foreign Private Organizations to Operate in Thailand, B.E. 2535 shall be repealed.

Clause 4. This Rule shall not apply to foreign private organizations entering to operate under the requirement of or under an agreement with the Thai Government.

Clause 5. In this Rule:

"foreign private organization" means a foreign institution, organization, society, foundation, other juristic person or group of persons which is a private organization or is supported by a foreign government;

"operation" means an application for the establishment of an office or the carrying out of any activity to provide assistance or support, whether in the form of financial support, conference, seminar or exhibition arrangement, donation, supply of inventory, equipment or endurable articles, provision of knowledge and technology, or to provide other assistance or support to a person, a group of persons or a juristic person and/or a government agency, State agency or State enterprise in Thailand or other countries in this region;

"regional office" means an office of a foreign private organization or its branch office located in Thailand which provides assistance or support to a person, a group of persons or a juristic person and/or a government agency, State agency or State enterprise in Thailand or other countries in this region;

"Committee" means a Committee considering the operation of foreign private organizations;

"permit" means a permit for an entry to operate in Thailand of a foreign private organization;

"Minister" means the Minister of Labour and Social Welfare.

Clause 6. The Permanent Secretary for Labour and Social Welfare shall have charge and control of the execution of this Rule.

Chapter 1 Committee

Clause 7. There shall be a Committee to consider the operation of foreign private organizations consisting of the Permanent Secretary for Labour and Social Welfare or the Deputy Permanent Secretary for Labour and Social Welfare entrusted by him or her as Chairman, a representative of the Department of Local Administration, a representative of the Department of Labour Protection and Welfare, a representative of the Department of Technical and Economic Cooperation, a representative of the Department of International Organizations, a representative of the National Intelligence Agency, a representative of the

Department of Public Welfare, a representative of the Religious Affairs Department, a representative of the Office of the National Security Council, a representative of the Supreme Command Headquarters, a representative of the Office of Police Immigration Commissioner, a representative of the Special Branch Bureau Commissioner and not more than four qualified persons appointed by the Minister as members, and a representative of the Department of Employment shall be a member and secretary, and the Chairman shall appoint not more than two officials of the Department of Employment as members and assistant secretaries.

- Clause 8. A qualified member appointed by the Minister shall hold office for a term of two years and may be reappointed.
- Clause 9. The Committee shall have the following powers and duties:
- (1) granting permission for an operation of a foreign private organization;
- (2) granting permission to a foreign private organization for the establishment of an office in Thailand:
- (3) granting permission to a foreign private organization for the establishment of a regional office where it is unnecessary to have a special agreement between the Thai Government and such regional office;
- (4) granting permission related to the number of positions and nature of work for the aliens who will enter to work for a foreign private organization or in the regional office:
- (5) appointing a sub-committee or a working group to carry out the activities as entrusted by the Committee;
- (6) prescribing rules, conditions or practices concerning the operation of a foreign private organization other than those specified herein.

Clause 10. In granting permission for entry of a foreign private organization to operate and/or establish a regional office, the Committee shall take into account the policy of economic and social development, national security, the good relationship between Thailand and other countries, the objectives and

operation plan of such foreign private organization as well as opinions and recommendations of the government agencies concerned.

Clause 11. At a meeting of the Committee, the presence of not less than one-half of the total number of members is required to constitute a quorum.

At a meeting of the Committee, if the Chairman does not attend or is a unable to perform his or her duty, the members present shall elect one among themselves to preside over the meeting.

The decision of the meeting shall be made by a majority of votes. Each member shall have one vote. In case of an equality of votes, the person presiding over the meeting shall have an additional vote as a casting vote.

Chapter 2 Operation of Foreign Private Organizations

Clause 12. A foreign private organization wishing to apply for an entry to operate in Thailand shall possess the following qualifications:

- (1) not having any profit-making or political purpose;
- (2) having an objective to provide assistance to or promote development for a person, a group of persons or a juristic person, and/or a government agency or a State enterprise in conformity with the development policy and security of Thailand, and also having the operation plan that is not contrary to the policy of the Thailand, Government.
- Cause 13. A foreign private organization wishing to apply for an entry to operate in Thailand shall submit an application in writing to the Chairman through the Department of Employment together with the particulars and evidence as follows:
- (1) in the case where a foreign private organization applies for the establishment of an office and/or sending the officials to serve in the office, the following particulars and evidence shall be attached:

- (a) objectives of the organization;
- (b) policy of the organization;
- (c) project or work plan and operation plan which are clear and sufficient according to the form prescribed by the Commince;
 - (d) names of members of the executive committee or the executives;
 - (e) particulars concerning budget, revenue and financial sources;
- (f) evidence or certificate of being a juristic person from the country which is the domicile of such foreign private organization or the embassy or consulate of the country which is the domicile of such foreign private organization;
- (g) in the case a foreign private organization is not a juristic person under the law, a certificate of the embassy or consulate of the country which is the domicile of such foreign private organization certifying its domicile and financial status:
- (h) letter appointing the representative plenipotentiary of such foreign private organization to co-ordinate with the Committee in the case other hacessary information or documents are required for considering the grant of permission:
- (2) in the case where a foreign private organization does not wish to operate in Thailand by itself but providing financial or other assistance instead, a person who receives such assistance may submit the application in substitution of such organization together with the following particulars and evidence:
- (a) objectives and activities of the foreign private organization which provides the assistance:
- (b) certificate of being a foreign private organization from the embassy or consulate of the country which is the domicile of such organization;
- (c) details of the project supported by such foreign private organization;
- (3) in the case where a foreign private organization wishes to enter for seminar arrangement in Thailand, the following particulars and evidence concerning the seminar shall be attached:
 - (a) objectives of the seminar;
 - (b) names of the speakers and the participants;
 - (c) topic of the seminar;

- (d) schedule of the seminar;
- (4) in the case where a foreign private organization does not arrange Seminar by itself but providing financial or other assistance for the seminar arrangement, a person who receives such assistance may submit the application in institution of such organization, provided that the application shall be submitted not less than thirty days prior to the date of the seminar.

A foreign private organization operating under the responsibility of a Maistry, Sub-Ministry, Department before this Rule comes into force shall be exempted from the submission of the application.

- Clause 14. A foreign private organization which obtains a permission for entry to operate in Thailand under this Rule shall:
- (1) comply with the rules, conditions or practices regarding the operation of foreign private organizations prescribed by the Committee;
- (2) comply with the laws, rules as well as relevant official regulations; provided that its activities shall not be contrary to morals. That custom and culture;
- (3) operate its activities in accordance with the permitted projects or work plans; and only permitted activities shall be carried out;
- (4) submit a semi-annual report on the result of operation to the Committee for information
- (5) report the matter to the Committee for information within ninety days as from the ending date of the project or work plan in the case where the term of projects or work plans permitted by the Committee comes to an end.
- Clause 15. An alice entering to work for a foreign private organization which is permitted by the Committee under Clause 13 must obtain a work permit under the law on working of aliens before commencing his of her duty.
- Clause 16. A permit for an entry to operate in Thailand shall be valid for not more than two years.
- Clause 17. A permitted foreign private organization wishing to renew the licence shall, within a period not less than ninety days prior to its

expiration, file an application for, its renewal with the Committee. When such application has been filed, such foreign private organization may continue its operation until the Committee gives an order refusing to renew the licence.

Clause 18. When the Committee grants permission to a foreign private organization for entry to operate in Thailand, the Department of Employment shall inform the agencies concerned including Changwat and Amphoe where such foreign private organization will carry out its operation.

In the case where the Committee refuses to grant permission, the Committee shall, without delay, inform the foreign private organization of such refusal in writing.

Clause 19. In the case where the Committee refuses to grant permission to a foreign private organization for entry to operate or to establish offices and/or branch offices in Thailand or to renew the licence, such foreign private organization has a right to submit an appeal in writing to the Minister within thirty days from the date of receipt of the letter notifying the refusal order of the Committee. The Minister shall complete his or her consideration of the appeal within sixty days from the date of receipt of such appeal.

The decision of the Munister shall be final.

Chapter 3 Establishment of Regional Offices and Operation in Other Countries

Clauses 20. The provisions of Chapter 2 on the operation of foreign private organizations shall apply mutatis mutandis to the establishment of regional offices and the operation of foreign private organizations in other countries where it is unnecessary to have a special agreement between the Thai Government and such regional offices.

Rule of Committee on Consideration of the Entry of Foreign Private Organization

Governing principle for consideration and instructions on the entry of foreign private organizations to operate in Thailand and the establishment of regional office in Thailand B.E. 2543

By virtue of the rule of Ministry of Labour and Social Welfare governing the entry of foreigner private organizations to operate in Thailand B.E. 2541 Clause 9(6), the committee on consideration of the entry of foreign private organization hereby issues the rules to specify principle and practices to facilitate consideration as follows:

<u>Clause 1</u> This Rule is called "Rule of Committee on Consideration of the Entry of Foreign Private Organization Governing Principle for Consideration and Instructions on the Entry of Foreign Private Organization to Operate in Thailand and the Establishment of Regional Office in Thailand B.E. 2543"

<u>Clause 2</u> This rules shall be enforced as from the day next to the date of publication in the Government Gazette.

<u>Clause 3</u> It is to repeal principles for consideration and instructions on the entry of foreign private organization to operate in Thailand and the establishment of regional office in Thailand dated 18th September 1992.

Clause 4 Under this rule



"Committee" means a Committee considering the operation of foreign private organization.

"Secretary" means secretariat of the Committee considering the operation of foreign private organization.

<u>Clause 5</u> The Permanent Secretary for Labour and Social Welfare shall have charge and control of the execution of this Rule.

Chapter 1

Foreign private organization wishing to apply for an entry to operate in Thailand and establish its regional office

Clause 6 Qualifications:

- (1) Being juristic person under law of that country, or having registered under law of domicile country.
 - (2) Not having any profit-making or political purpose.
- (3) Having the activities and proceedings which are not detrimental to stability, and not contradict to public order or good moral of the people.
- (4) Not having any record of behavior, or any activity project in Thailand which shall be detrimental to good relation between Thailand and other countries.



- (5) Having the objective to provide assistance in economic, social and academic aspects for Thailand with assistance guidelines in concert with development and stability policy of Thai government. In this regard, the assistance shall be given either to government or private sectors.
- (6) Rendering real benefit and worthiness to Thailand. In this regard, financial status must be shown stipulating budget, income and its source, inclusive of subsidy budget appropriated for operation in Thailand.
- (7) Conceding and performing according to rules and regulation of Thailand government and under Thai Law. In this regard, exploitation of various information of Thailand for foreign distribution must acquire a permission from the concerned units.

Clause 7 Length of permission for operation in Thailand shall be for 1 year for the first application. In case of the extension of proceeding, the performance from the previous year shall be considered including financial status and work plan from the head office. Extension of permission shall be granted for 2 years at a time. In case there is no application for extension prior to expiry of operation, the permission shall be terminated at the expiry of existing permit.

Clause 8 Coordination between work units:

(1) Ministry of Foreign Affairs shall be responsible in consideration of information relating to status of the foreign private organization, and foreign affairs suitability in requesting the foreign private organization to operate for assistance to Thailand.



- (2) The Office of the National Security Council shall consider internal security policy. The National Intelligence Agency, Armed Force Security Center Supreme Command Headquarters and the Special Branch Bureau Commissioner shall consider internal security and look after behavior of the foreign private organization, and aliens permitted for operation in Thailand.
- (3) Letter of certification or comment from related work units, as follows:
- (a) Work units to which the foreign private organizations stipulate to give assistance, namely, Public Welfare Department, Communicable Disease Control Department, etc., and other work units in the fields related to application for operation of such the foreign private organizations.
- (b) Work units in provincial area to which the assistance shall be given by the foreign private organization.
- (c) Work units of relating assistance rendering nature such as the foundation, association, school, bank, group of people or local people.
- <u>Clause 9</u> In applying for local operation and setting up of regional office, evidences shall be submitted together with application form as follows:
- (1) Evidence or certificate of juristic person status from that country or from embassy or consulate of that country.
- (2) Certificate from work unit or institute to which the foreign private organization applicant has plan to contribute the assistance for Thailand.

- (3) Comment Letter of work unit chief in the province in case the foreign private organization applicant has plan for a proceeding in the area of that province.
 - (4) Previous annual report for 3 years.
 - (5) Power of attorney with 30 baht duty stamp affixed.
 - (6) 2 x 2.5 inch photos of

- the applicant for 4 photos - the appointee for 4 photos - the joint operator for 2 photos

- (7) Details of project applied for operation in Thailand, operating budget as per specified documents, namely, PV 1-5, PV 8 and PV 9.
- (8) In case the foreign private organization applies for regional office establishment as well as operation in other country, project details for operation in the country receiving assistance shall be proposed, including certificate from work units given assistance and the PVR 1 - 6 form shall be submitted. In this regard, the foreign private organization must coordinate for project approval with that country, in addition, it should not exploit Thailand as the base for intervening internal affairs of the other country.
- (9) Location mapping of the foreign private organization in Thailand.
- (10) Evidences as per clause 9(1) (9) shall be made in book binding in quantity of 30 copies.



Clause 10 When period of permission has been expired and the foreign private organization requires to extend the operation period, application for operation extension shall be submitted to the secretary at least ninety days prior to the permission expiration.

- (1) The foreign private organization requiring to extend operation period in Thailand shall submit the evidences as follows:
- (a) Form reporting performance result of preceding year operation by using PV 10 Form.
- (b) Operation plan for year of extension request, by using PV 11 Form.
- (c) In case of the addition of other assistance projects, submit PV 5 Form.
- (d) Certificate from various work units receiving assistance from the foreign private organization.
- (2) The foreign private organization requiring to extend operation period in other countries shall submit the evidences as follows:
- (a) Form reporting performance result of preceding year, by using PVR 9 Form.
- (b) Operation plan for year of extension request by using PVR 10 Form.
- (c) In case the foreign private organization requests for other additional assistance projects, submit PVR 5 Form.

(d) Certificate from various work units receiving assistance from the organization.

<u>Clause 11</u> Procedure by the secretary in support of consideration by the committee in case the foreign private organization applies for operation and setting up regional office:

- (1) The secretary shall verify evidences and details of project and inform the matter to the Ministry of Foreign Affairs to consider information relating to status of the foreign private organization and foreign affairs suitability to allow operation by that foreign private organization. The matter shall be informed to the Office of the National Security Council, the National Intelligence Agency, Armed Force Security Center Supreme Command Headquarters and the Special Branch Bureau Commissioner, all to consider the internal security aspect, including making the inquiry to other work units concerning the foreign private organization.
- (2) When the Ministry of Foreign Affairs and other security work units such as the Office of the National Security Council, National Intelligence Agency, Armed Force Security Center Supreme Command Headquarters and the Special Branch Bureau Commissioner, of which more than 2 work units have proposed their opinions, the secretary shall summarize opinions of different work units for proposal to the committee.
- (3) The secretary shall visit the office of foreign private organization and/or the project operated by foreign private organization for proposal of primary judgment to the committee.



<u>Clause 12</u> Procedure by the secretary in support of consideration by the committee in case the foreign private organization asking for term extension of its operation :

- (1) Any foreign private organization requesting term extension of the operation, proceeding shall be under clause 10.
- (2) The secretary shall visit office of the foreign private organization and/or project operated by the foreign private organization for proposal of primary judgment to the committee.
- (3) Making the inquiry to the work units in the provincial area where the assistance is given by the foreign private organization, and asking for opinion from the work units concerned or related with assistance and activity of the foreign private organization.
- (4) Coordination shall be conducted with security work units such as the National Intelligence Agency, the Special Branch Bureau Commissioner and Armed Force Security Center Supreme Command Headquarters to verify the behavior of the foreign private organization and its foreign staff.
- (5) The secretary shall summarize and propose the opinion to the committee.
- <u>Clause 13</u> In consideration of representative and staff of the foreign private organization appointed for operation in Thailand, the evidences shall be submitted as follows:
- (1) Form PV.3/PVR 3, PV 4/PVR 4, PV .4.1/PVR 4.1 in quantity of 30 copies, stipulating reason and need to use foreign staff instead of Thai personnel, inclusive of stipulating the position and job description in clear details.
- (2) Location mapping of the foreign private organization office in Thailand.

- (3) Organization chart of the foreign private organization clearly specifying names and positions.
- (4) Copy of educational qualification (in case of specific profession, professional license shall be attached such as medical practitioner license, etc.)
- <u>Clause 14</u> Proceedings by the secretary for proposal to be considered by the committee are as follows:
- (1) Sending evidences in verifying the behavior of foreigners working with the foreign private organization by coordinating with security work units such as the National Intelligence Agency, the Special Branch Bureau Commissioner and Armed Force Security Center Supreme Command Headquarters to proceed with verification and reporting the result for consideration by the committee.
- (2) Summarizing evidences as per clause 13 (1) (4) to the committee for further consideration.

<u>Clause 15</u> Principles for granting permission by the committee:

- (1) Foreigner is permitted to work with the foreign private organization for one year at a time, in number suitable for the need of the project, such as project administrator, advisor, specialist suitable with budget given for assistance by foreign private organization and Thai staff, but not more than five persons.
- (2) In case the foreign private organization is able to present evidence of foreign currency being sent to the foreign private organization in Thailand for assistance project expense exceeding 50 million baht per year, the committee shall permit more than 5 foreign staff

In this regard, consideration shall be principally based on safety, security and benefit of the country both direct and indirect.

(3) The foreigner granted with permission from the committee shall proceed in getting work permit as per the Working of Aliens Act B.E. 2521 (1978)

Chapter 2

Foreign private organization giving financial or other assistance

Clause 16 Qualification of the benefactor.

- (1) Being juristic person under law of that country, or legally registered under law of the domicile country.
 - (2) Not having any profit-making, or political purpose.
- (3) Having activities and proceedings beneficial to society as a whole, which are not detrimental to stability, and not contradict to public order or good moral of the people.
- (4) Having the objective in granting assistance in the economic, social and academic aspects by giving financial and other assistance in accordance with development and stability policy of the Thai government.



(5) Rendering real benefit worthwhile to Thailand. In this regard, financial status must be shown, such as budget, income and its source, and evidence of money transfer inclusive of assistance budget appropriated for work plan or project as requested by the beneficiary.

<u>Clause 17</u> Qualification of the beneficiary:

- (1) Being Thai nationality, having domicile in Thailand, or in case of group of people, must be juristic person, or legally registered under law and regulation of Thailand.
 - (2) Not having objective in profit making, or political benefit.
- (3) Activity and proceeding must not be detrimental to security, and not contradict to public order or good moral of the people.
- (4) Having activity and proceeding in giving assistance and social development for betterment of target group in Thailand.
- (5) Money or other benefits from the assistance must be utilized direct to the objective and only under frame of work plan and project.
- <u>Clause 18</u> Permission term shall be fixed equivalent to timeframe of work plan and project for assistance, but not exceeding 2 years at a time.

Clause 19 Coordination between work units:

(1) The Ministry of Foreign Affairs shall consider information concerning status of the benefactor and foreign affairs suitability to receive assistance from that foreign private organization.

- (2) Letter of certification or comment of work units receiving assistance.
- <u>Clause 20</u> Evidences which must be submitted together with application form:
- (1) Evidence or certificate of juristic person status or correct registration from the embassy or consulate of the domicile country of that foreign private organization.
 - (2) Letter explaining reason and need of the beneficiary.
- (3) Evidence or letter certifying status of the beneficiary and certificate showing operation has been performed as requested.
- (4) Document showing financial status of the benefactor and his latest annual report.
 - (5) 2×2.5 inch photo of the beneficiary.
- (6) Details of work plan/project proposed for assistance request as approved by the benefactor.
 - (7) Location mapping of the organization acquiring the assistance.
 - (8) Form PV 21, PV 22, PV 24, PV 24.1 and PV 28

<u>Clause 21</u> In case of time extension for assistance, the beneficiary shall immediately inform the secretary upon receiving approval from the benefactor. In case of no more time extension, the beneficiary shall inform the secretary in writing for acknowledgement.

When the beneficiary has got time extension for assistance from the benefactor, the time extension shall be proceeded by submitting the evidence as follows:

- (1) Operation performance report of the preceding year, Form PV 210.
- (2) Work plan/project of the assistance for the year requesting time extension as approved by the benefactor, Form PV 211.
 - (3) Certificate from work unit or target group.

<u>Clause 22</u> Proceeding by the secretary, in case of asking for assistance and time extension of the assistance.

- (1) In case of asking for assistance.
- (a) If the foreign private organization who gives financial or other assistance does not enter into Thailand, the beneficiary shall apply on behalf with attachment of details as per clause 20.
- (b) The secretary shall verify evidence and details of work plan/project and Ministry of Foreign Affairs shall consider the status of the foreign private organization and foreign affairs suitability in receiving assistance from that foreign private organization.
- (c) The secretary shall pay a visit to the activity/project of the organization receiving the assistance.
- (d) Submitting the proposal to the committee for further consideration.
 - (2) In case of asking for time extension of assistance.
- (a) When the foreign private organization has an intention to extend the time for giving assistance, the beneficiary shall hand over evidence as specified in clause 21 paragraph two, immediately upon getting approval from the benefactor.



- (b) The secretary shall pay a visit to the project receiving the assistance.
- (c) Enquiry shall be made to the work unit in the area of the work plan / project receiving the assistance, and opinion of the target group or work unit being concerned with the assistance shall be asked.
- (d) Submitting the proposal to the committee for further consideration.
- <u>Clause 23</u> Consideration of the foreigner to work as staff in the organization receiving the assistance.

The organization receiving the assistance or foreign staff shall apply for work permit as per the Working of Aliens Act B.E. 2521 (1978) for the next step.

Chapter 3

The foreign private organization wishing to enter for seminar arrangement in Thailand

<u>Clause 24</u> Qualification:

- (1) Being juristic person, or legally registered under law of the domicile country.
 - (2) Not having any profit making, or political purpose.
- (3) Activity and proceeding shall not be detrimental to security, not contradict to public order or good moral of the people, not

intervening internal activity of other country which may affect good relation between Thailand and other country, it shall be also applied *mutatis mutandis* in case the seminar not directly arranged by the foreign private organization itself, but providing financial or other assistance for the seminar arrangement.

- <u>Clause 25</u> Evidence which must be submitted together with the application form:
- (1) Permit application, describing reason and need to arrange seminar in Thailand.
- (2) Evidence or certificate of juristic person status or correct registration from the embassy or consulate of the domicile country of that foreign private organization.
 - (3) Proposal of the seminar.
 - (4) Name list of the speakers and seminar participants.
 - (5) Meeting schedule and venue of seminar arrangement.
 - (6) Budget in seminar arrangement.

<u>Clause 26</u> Proceeding of the secretary department:

- (1) In case the foreign private organization has intended to arrange seminar in Thailand or only give financial or other assistance in the seminar, the foreign private organization or the beneficiary shall submit permit application with documentary evidence as per clause 25, in advance of the meeting date not less than 30 days.
- (2) Submitting the proposal to the committee for further consideration.



(3) Notifying result of consideration by the committee, and informing the work units concerning the entry into the kingdom for acknowledgment.
