- - During the session A of the Steering Commettee last Monday, June 20th, The Staff of Jica-experts submitted and presented us the Project's Interim Report (IR) it has established. It went further providing thorough explanation for the benefit of the Mauritanian side.
 - In light of this presentation, the Mauritanian side will provide some comments concerning the IR in this session of the Committee meeting. Thus, the two parties will have discussion and exchanging their opinions in order to improve the content of the final report (FR).

4. Comments made by the Mauritanian side

- The Mauritanian side emphasized the fact that the IR satisfactorily covered all relevant problems encountered in the Mauritanian mining sector. The Mauritanian side went further demanding that the Japanese side invest itself even more in studying these problems as indicated in the IR and to come up with appropriate solutions to be submitted in the final report (FR).
- The Mauritanian side requested additionally from the Japanese party practical recommendations likely to be useful in such a way that the Sector of Mauritanian Geology may end up having a global form locally as well as internationally.
- The Mauritanian side requested further from the Japanese side that both, information and all geological data obtained through the Supplementary Geological Study(SGS) be fixed together with related projects which, in the future, will enable Mauritanians to carry out by themselves geological studies.
- The Mauritanian side indicated that the IR was well articulated on the ground of the current Mauritanian mining sector and that modeling of deposits included in the given report were both adequate and useful. The Mauritanian side requested, thus, from the Japanese side a provision of concrete solutions in light of problems to be solved.
- The Mauritanian side requested, in addition, from the Japanese

party, supplementary efforts to improve both content and syntax of French version of documents prepared by the Jica-team of Experts, in general, and especially as far as the IR and FR are concerned.

As the Mauritanian Government is, presently, studying action plans for 2006 to 2010 within the framework of the Strategy for the Reduction of Poverty, the Mauritanian side requested from the Japanese side -1/ to conceive projects (Action Plans) for the First Step of the Strategic Plan for the Development of Mineral Resources in such a way they can positively respond to the "Strategic Framework for the Reduction of Poverty" and, -2/ to even more provide costs estimates for approximately each of the conceived Project-Action Plan

4. Conclusions by the Mauritanian Side

- The Mauritanian side approved the IR.
- The Mauritanian side also requested from the Japanese party to take following items into consideration for the Draft of the FR of the project, namely:
 - #- Conceive and provide concrete and realistic solutions;
 - #-Conceive action plans (AP) which will surely respond practically to the Strategic Framework for the Reduction of Poverty
 - #- Establish and articulate the project of the Draft of the FR based on comments submitted by the Mauritanian party;
 - #- Articulate and finalize the French Version of the IR by using a correctly written French language.

5. Miscellaneous

- (1) Organization of the Round Table in the presence of foreign companies
 - ** The Round Table shall be conveying just little bit after Ramadan in November at the initiative of the MMI.
 - ** The content of the Round Table shall be implemented concretely with the active collaboration of the Jica Study-Team of Experts.

- ** The AMA Seminar is planned to take place on November, around the 21st, 2005.
- ** The Jica-Study-Team of Experts shall coordinate preparations for the Seminar.

- Steering Committee Meeting accepts the Draft Final Report. Furthermore, it recommends the JICA team of Experts to move forward on effectively finalizing the Final Report based on comments of Steering Committee Members
