


図 8.2 (1/8) 路線毎の浸水被害の有無 (北部) (サンプル数で表示)




図 8.2 (2/8) 路線毎の浸水被害の有無 (北部) (% で表示)

how often do you have the flooding?




図 8.2 (3/8) 路線毎の浸水頻度分布 (北部) (サンプル数で表示)

how often do you have the flooding?




図 8.2 (4/8) 路線毎の浸水頻度分布 (北部) (%で表示)

how deep was the flooding?




図 8.2 (5/8) 路線毎の浸水深さの分布 (北部) (サンプル数で表示)

how deep was the flooding?




図 8.2 (6/8) 路線毎の浸水深さの分布 (北部) (%で表示)

how long was the flooding?




図 8.2 (7/8) 路線毎の浸水時間の分布 (北部) (サンプル数で表示)




図 8.2 (8/8) 路線毎の浸水時間の分布 (北部) (%で表示)

7. 案件要請の背景・経緯

1970 年代以降プノンペン市では、治水・排水施設の機能が維持、管理不足のため著しく低下しており、恒常的に洪水・内水被害が発生している。さらに急激な人口増加に伴う被害の増大が懸念されている。かかる状況のもと、1998～99 年（平成 10～11 年）に JICA によりプノンペン市及び周辺地域の総合的な治水・排水対策マスタープランが策定された。このマスタープランで提案された緊急プロジェクトに対する基本設計調査が JICA により 2001 年（平成 13 年）に実施され、2002 年（平成 14 年）の詳細設計及び事業実施の E/N 署名・交換を経て、事業実施に至ったものである。

8. 計画の概要

(1) 目的

プノンペン市における洪水に対する高い安全性の確保、並びに同市内の内水被害の軽減を目的として、市の外郭堤防の補強、排水路、ポンプ場の改修・整備を行なう。

(2) 本計画の内容

本計画では上記を目的として、メコン川及びトンレサップ川の既往最大洪水（約 30 年確率）に対して充分安全となるよう、同市南部からの外水の浸入を防ぐ外郭堤防の補強、排水樋管の改修を実施するとともに、同市南部の対象地域に降る 5 年確率の降雨を 24 時間で堤防外に排水できるよう、同市南部地域の幹線排水路改修、幹線排水路末端におけるポンプ場新設、排水樋管の改修を実施する。整備・建設する主な施設は具体的には以下のとおりである。（次頁に計画位置図を示す）

1. Tompun 外郭堤防補強（延長 4.34km、堤防嵩上げ、天端道路舗装）
2. Meanchey、Salang 幹線排水路下流改修（延長 4.54km、4 橋梁改修、5 年確率降雨を排水）
3. 新 Tompun ポンプ場建設（排水容量 15m³/s、水中ポンプ 5 台）
4. Svay Pak 排水樋管ゲートを鋼製ゲートに交換（3 ゲート）
5. Salang 排水樋管、Tum Nup Toek 排水樋管を新設

(3) 計画の効果

計画対象地域であるトンブン流域において、以前半日～1 日湛水していた地域が本計画の実施により、湛水時間が数時間程度に短縮するなど内水被害状況は劇的に改善され、地域住民から感謝状が届けられるなど市民の生活環境の改善に大きく寄与している。

(4) 施設の維持管理の現状

(a) 新 Tompun ポンプ場の運営維持管理

新 Tompun ポンプ場の運営維持管理の実態は、ポンプ場に用意されている運転維持管理記録帳(Log Sheets Book)に記録されている。年間を通し、運転開始時間/終了時間、運転時間、運転中の特記事項、部品の修理・交換等について運転員がこの記録帳に毎日記録し、監督者が確認サインを行っている。本計画実施時に作成したポンプ場の維持管理マニュアル(”Operation and Maintenance Rule for New Tompun Pumping Station”)も使用され、ほぼ月1回のモニタリングが実施されており、マニュアルにあるモニタリングシートがDPWTに保管されている。関係者間で機器実態情報を共有しており、適切な管理がなされていると判断される。

また、これらの記録帳を整理することによって、年間の各ポンプ場における総運転時間、排水量、電力消費量および料金、燃料消費量および費用等がまとめられており、次年度の運営維持管理に関する予算計画のベースとなっている。

(b) 排水路の維持管理

排水路の維持管理は、本計画実施時に作成した維持管理マニュアルに基づいて、ほぼ月1回のモニタリングが実施されており、マニュアルにあるモニタリングシートがDPWTに保管されている。これまでに実施された運営維持管理作業としては、排水路内に堆積したヘドロやごみの浚渫作業が主なものである。排水路沿いの住民参加による排水路の清掃作業も実施されており、適切な管理がなされていると判断される。

(c) Tompun 外郭堤防の維持管理

Tompun 外郭堤防は、本計画実施時に作成した維持管理マニュアルに基づいて定期的に点検している。これまでのところ、堤防に損傷箇所は認められず、補修を伴う維持管理作業は発生していない。
