#### 4. Outline of the research team

Japanese companies are known for its human resources management practices such as long time employment system, collective hiring of a group of university graduates, in house training in which jobs are design that employees may develop and nurture their own skill through their daily routine job, reward system and other welfare corporatism that become the source of high level of loyalty and commitment of its employee. Many Japanese scholars studied these phenomena since the 1980s especially when the Japanese reached its peak with its economic boom. Some compared these practices with its overseas subsidiary, some compared with other countries practices especially America.

Different with Japan, what kind of HRM practice do the Indonesian firms apply is not widely known because the research about it is still rare. This is the reason why the Indonesian HRM practice in comparison with Japan was chosen as research theme in phase two of the joint research between the Center for Japanese Studies University of Indonesia and the Institute of Social Sciences University of Tokyo.

There are many findings in the phase two research but HRM practices in Indonesian have not been clarified yet since it focused only on several Indonesian firms. In this phase we propose "The Survey on Employment Management: The Study of Human Resource Management Practice in Indonesia and Japan Focused on Service Sector" as the continuation of the theme in the previous phase but with different approach. This research will be conducted by using quantitative questioner survey of a large number of Indonesian firms and in depth interview. We will compare the findings with the HRM practices in Japan not only with its typical practices but also its changes based on the recent researches and field study in Japan.

#### 5. Needs of importantce of the research of the team:

This survey on employment management in Indonesia and comparing its result with the employment survey in Japan will be beneficial for the HRM study and for improving HRM practice in Indonesia by finding out best HRM practice that fits to Indonesia.
