

Summary of Day 1 (Preparation Day)

Group Session

Explanation

The participating countries were divided into three different groups to discuss their respective PRP processes. The discussion was to focus on their respective draft final reports and presentation slides that were prepared by each country with their Asian counterparts' inputs. The focus points were,

- Activities and Outputs
- Knowledge Co-Creation
- Difficulties and lessons learnt

Group One consisted of Kenya and its counterpart, the Department of Agricultural Extension, Thailand and Uganda and its counterpart, the Department of Agricultural Extension, Thailand.

Group Two consisted of Tanzania and its counterpart, the Ministry of Public Health, Thailand and Zimbabwe and its counterpart, the Kasetsart University, Thailand.

Group Three consisted of Senegal and its counterpart, Huai Hong Khrai Royal Development Study Centre, Thailand and South Africa and its counterpart, Huai Hong Khrai Royal Development Study Centre, Thailand.

This group session allowed each country to confirm the contents of their respective PRPs with other participants in the same group.

Country Session

Each country was given time (about two hours) to sit in a country specific group and discuss the PRP with their Asian counterpart organisation and JICA representatives in their respective countries. The purpose of this session was to "polish up" the PRP that was presented in the previous Group Session. Based on the discussions, inputs and exchanges that took place earlier in the Group Session, each country and its counterpart were expected to finalise their PRP for presentation the following day.
