### 1. IMPLEMENTATION OF THE PLAN

The governmental and private organizations means an organization with a core mission both related directly and indirectly according to the operational network of the NATIONAL PLAN FOR THE DEVELOPMENT OF THE QUALITY OF LIFE OF THE DISABLED PEOPLE NO 3 (2007-2011); and is the organization having the mechanism indispensable for operational success according to the NATIONAL PLAN FOR THE DEVELOPMENT OF THE QUALITY OF LIFE OF THE DISABLED PEOPLE NO 3 (2007-2011) which comprises:

**NETWORK** means the government and private organizations with direct mission to support the operation of the disabled people.

**PARTICIPATION** means the process which the disabled persons, their families or interested persons which provides the opportunity for them to exchange data, information, and opinion for seek alternative and various decision-makings in relation to suitable projects and which are jointly acceptable of every party concerned. It is therefore recommended that participation in this process should commence from the beginning until the stage of monitoring and evaluation for understating and recognition-learning; mutual readjustment of the projects which will be beneficial to every side.

**Independent living of the disabled** means the ability of the disabled to direct one's own living with human prestige regardless of the severity of disability, by depending on assistance as necessary. In case of severe disability and being unable to self-assistance, it is necessary to be provided with assistance from others.

Universal design means the design and creation on landscape architecture and technology so that everyone in the society can use them equally without inconsistent operation on the physical, mental, social and environmental differences (with the three major principles namely 1. No physical and mental discrimination and not discrimination between person and environment 2. No discrimination between human health and environmental health and health of social justice 3. Support the democratic concept on social equity and personal power support)

Accessible environment means architectural environment and information accessible to all kinds of the disabled.
