2. Opening of Workshop

The meeting was opened by DR. H.S Ruslan SE, (Head of BAPPEDA South Sulawesi Province).

3. Comments and Questions

- (1) From Balai Besar Makassar.
 - a. In the picture of section B, there is no long section, cross section and land use.
 - b. Suggest that the Study Team should reduce the number of intersection to Pettarani.
 - c. Suggest that Monginsidi shall be alternative for the next period in the future.

(2) Head of Mandai Sub-district

- a. Asked about the implementation of Middle Ring road and Outer Ring road; since it is related closely with land acquisition.
- b. What if there are community who do not want to release the land?
- (3) From PU Takalar raise a query and proposal regarding their proposal to the governor to conduct pre-Feasibility Study for Tanjung Bunga to Limbung and Galesong Utara.

(4) From Bina Marga

- a. Particularly for Section B of Abdullah Daeng Sirua, it should be synergized with the plan of Kota Makassar; since they already had the design for the section.
- Suggested the pipe installation as the substitute of open canal with the length of 200m.
- c. For the utilization of alternative 1 of Abdullah Daeng Sirua; it is necessary to apply traffic utilization.
- (5) From Balai Besar clarified the existence of median in study design of Abdullah Daeng Sirua and utility network along Abdullah Daeng Sirua.
- (6) From Mr. Oktavianus corrected the thickness based on the existing CBR related with financial ability.

4. Replies from Study Team

- (1) The workshop does not expose the details of longitudinal section, cross section, etc. it will be exposed in the Final Report of the Study.
- (2) The selection of intersection to Pettarani is based on our meeting previously conducted with related agency. Nonetheless, the Study Team will have further discussion and review concerning such matter.
- (3) Regarding the proposal of Takalar Government; the Study Team is difficulty to accommoDate it due to financial limit. Nonetheless, the Pemerintah Provinsi has taken that into consideration and further discuss with the Central Government and JICA Study Team.

- (4) Regarding the median in Abdullah Daeng Sirua, the Study Team will further review the design and include the median by utilize/modify the existing space for drainage and/or sidewalk. As for the utilities network installation, the Study Team will have the design on utility network after the proposal is approved.
- (5) Regarding the planned road and the synergy with related plans of Kota Makassar; the Study team will have further discussion with related agencies.

2. Opening of Meeting

The meeting was opened by Team Leader of JICA Study Team, Mr. Hiroki SHINKAI. He welcomed all the participants and extended his gratitude on behalf of JICA Study Team to the Head of Bappeda South Sulawesi province as the counterpart in organizing the workshop. In the same opportunity, Mr. SHINKAI explained that the 2nd workshop is the follow up of the 1st seminar and workshop conducted previously in Makassar on March and June this year. The participants will get further information on the progress of Feasibility Study on Arterial Roads in South Sulawesi Province; which in the phase 2 of the study

will be focused mainly on three other roads, namely Mamminasa Bypass, Abdullah Daeng Sirua Road and Hertasning Road. He expects that all invitees and participants could give inputs, suggestions and comments so that the workshop will achieve fruitful results for the improvement and betterment of Mamminasata Metropolitan area in the future.

The welcoming speech was also delivered by Mr. MINAGAWA, the representative of JICA. He welcomed all the participants and explained that JICA Makassar Field Office, established in 2005, has two major programs in its regional development approach; namely: South Sulawesi Regional Development Program covering South Sulawesi Province and North Eastern Indonesia Regional Development Program, covering 6 provinces in Sulawesi Island and 2 provinces in Maluku. The Feasibility Study itself is included in the first program that is executed by JICA, particularly in Mamminasata Metropolitan Area. Mr. MINAGAWA also expects that the workshop will run smoothly and participants can share ideas; along with the maximum effort from the Study Team to accommodate the inputs from the participants reflect in the Result of Feasibility Study on Priority Arterial Roads in South Sulawesi Province.

The next welcoming speech was delivered by Mr. Ruslan, the Head of BAPPEDA South Sulawesi Province along with the official opening of the 2nd day workshop. He welcomed all the guests and participants and expected that all participants and invitees of the workshop actively involved in discussion to share ideas and information, as well as asking queries, since it is related closely with the development of Mamminasata Metropolitan Area integrally.

After the official opening, the meeting was continued to presentation sessions and chaired by Head of Bapedalda South Sulawesi Province and Head of Public Infrastructure Agency South Sulawesi province.

3. Presentation

The presentation is divided into two sessions, session 1 explained Environmental Considerations, consist of: Stakeholder Meeting for Mamminasa Bypass, Hertasning Road and Abdullah Daeng Sirua Road (Intermediate reporting on outline of IEE and mitigation measures) based on JICA Environmental

Guideline by Mr. Rusli (EIA Consultant) and presentation on Stakeholder Meeting 2 for Outer Ring Road (Intermediate reporting on outline of IEE and mitigation measures) based on JICA Environmental Guideline by Mr. Ogawa.

Session 2 explained Preliminary Design for FS Roads, consist of; Key Issues for Preliminary Design for Mamminasa Bypass, Hertasning Road and Abdullah Daeng Sirua Road by Mr. Nagai and Rigid Pavement Design and Construction Practice by Mr. Konda.

4. Discussion

The major issues and points discussed based on the presentation are as follows:

Comments and Questions for Session 1

- (1) From Mr. Octavianus stated that the local government must prepare the compensation fund immediately; so that in the implementation phase, the project will not be hindered by the unreadiness of respective regions/city in preparing land acquisition fund. He also commented that the design of the road need to be synergized with city/region plan; taking into account Act no. 38 of 2004 concerning road which contains the right of way border is 18 m from the side ditch. In relations to that, we also need to do coordination with Land Agency.
- (2) Mr. Ilyas would like to clarify the name of Hertasning Road for new road constructed; since the new road has already got new name, whis is Aru Palaka road. It also applies to Abdullah Daeng Sirua in the section of PDAM canal is changed to Inspeksi PDAM road.
- (3) Mr. Muh. Yusran Ramli from Hasanuddin University reminded the increasing of land price in project affected areas.
- (4) From Maros raised a question why water resource in Maros Prefecture does not include in hypothetic scope; while this water resource is the biggest water supply source in Makassar and Maros.
- (5) Mr. Max from Bina Marga clarified the result of the study that accommodates the inputs from the community. What if those inputs can not be accommodated all in the result of study? What is the mechanism of JICA Study Team? What if the seminar is conducted in Jakarta in order to accommodate the aspiration of stakeholder? Who will be the representative of local stakeholder in the next meeting?


- (6) Mr. Ilyas concerning table 1.1 of air quality; it might be added by another column of air quality ambient; so that we will be able to directly identify which elements exceeding ambient quality standard. Also regarding table 1.1 for the references in point 5, shall be removed; since Decree of Governor No. 465 has been substituted by Decree of Governor of 2003.
- (7) From Mr. Sanusi (PDAM Maros), commented that in table 1.3 concerning water quality; it must include Maros River quality measurement as the biggest water supply for Makassar city. The Study Team also need to consider not merely the quality of the water but also the quantity of the water; particularly during dry season.

Replies for Session 1:

- (1) All the inputs and comments will be noted and will be utilized to consummate the compilation of Progress Report 2, as it is expected to be able to accommodate all the aspirations in the discussion.
- (2) Regarding Maros River, it will be included in the further study result.
- (3) Regarding the result of study and involvement of stakeholder, the Study Team will put maximum effort to accommodate all the aspirations and will be reflected in the next report compiled.

5. Closing



- > Head of Bontomanai Village, Gowa Regency
 - 1. The project should concern about rubbish and litter at urban areas.
 - 2. The rural areas that are passed by project routes need to be provided with drainages as irrigation channels for farmers.
 - 3. For relocation work, the buildings and structures ownership status should be handled clearly the so that it will not cause problems in future.

Nurmala (Bina Marga)

- 1. On the background, it should be conducted the early data collecting to be used for next studies.
- 2. It need to be provided reccommendations so that the roads could be implemented as national transportation facilities.

Replies for Discussion

Mr.Ogawa

- 1. The data provided on the presentation concerning the land providing is the preliminary data that will be used for policy making. While the issue of land providing will be the responsibility of P2T formed by the government and it is *not* the responsibility of JICA Study Team.
- 2. LARAP will be conducted after feasibility study.
- 3. There is no natural conservation and preservation that will be passed by this road project, however if there are protected and endangered species identified during the project implementation, they will be handled in accordance based on the existing procedures.

- 4. This project plan is appropriate with the Spatial of Mamminasata Metropolitan Area.
- 5. Global Warming Issue: this project aims to prevent traffic congestion so that it will reduce the wasted emission gas from vehicles.
- 6. This road will not pass the valuable cultural heritages, however if during the project implementation there are cultural heritages identified, the further handling will be coordinated with the related party.





Stipulate:

FIRST

: The Decree of Head of BAPEDALDA, South Sulawesi Province regarding the Approval for Documents of EIA, Environmental Management Plan, Environmental Monitoring Plan and Executive Summary on the Development Plan of Maros-Takalar Road Section, Trans-Sulawesi Mamminasata Road, South Sulawesi Province:

SECOND

- : The Decree on the Approval of Documents of EIA, Environmental Management Plan, Environmental Monitoring Plan and Executive Summary on the Development Plan of Maros-Takalar Road Section, Trans-Sulawesi Mamminasata Road, South Sulawesi Province as it is intended on the first stipulation above is considered as feasible to be proceeded by taking into account the followings:
 - Complying the suggestions/instructions from the Technical Team of Appraisal Committee for EIA, South Sulawesi Province regarding the environmental management and monitoring on the Development Plan of Maros-Takalar Road Section, Trans-Sulawesi Mamminasata Road, South Sulawesi Province;
 - 2. The environmental management and monitoring as mentioned on point 1 above shall refer to the Environmental Management Plan, Environmental Monitoring Plan and Executive Summary, and to be used as a reference on environmental management and monitoring by the Proponent and environmental monitoring by the Minister of Public Works, State Minister of Environment, BAPEDALDA Province, Provincial Bina Marga, Provincial Transportation Office, Maros Regent, Makassar Mayor, Gowa Regent and Takalar Regent, as well as to the relevant agencies;
 - 3. The Environmental Management and Monitoring of the

Construction Plan of Maros-Takalar Road Section, Trans-Sulawesi Mamminasata Road, South Sulawesi Province shall be reported, once within 6 (six) months, to the Minister of Public Works, State Minister of Environment, BAPEDALDA Province, Provincial Bina Marga, Provincial Transportation Office, Maros Regent, Makassar Mayor, Gowa Regent and Takalar Regent, as well as to the relevant agencies.

THIRD

FOURTH

HAS DECIDED TO

Stipulate:

FIRST : The Decree of Head of BAPEDALDA, South Sulawesi Province regarding the

Approval for Documents of EIA, Environmental Management Plan, Environmental Monitoring Plan and Executive Summary on the Road Development Plan in Mamminasata Metropolitan Area which consist of Mamminasa Bypass Road Section, Abdullah Daeng Sirua Road Section, and Hertasning Road Section in South Sulawesi Province;

SECOND

: The Decree on the Approval of Documents of EIA, Environmental Management Plan, Environmental Monitoring Plan and Executive Summary on the Road Development Plan in Mamminasata Metropolitan Area which consist of Mamminasa Bypass Road Section, Abdullah Daeng Sirua Road Section, and Hertasning Road Section in South Sulawesi Province as it is intended on the first stipulation above is considered as feasible to be proceeded by taking into account the followings:

- Complying the suggestions/instructions from the Technical Team of Appraisal Committee for EIA, South Sulawesi Province regarding the environmental management and monitoring on the Road Development Plan in Mamminasata Metropolitan Area, which consist of Mamminasa Bypass Road Section, Abdullah Daeng Sirua Road Section and Hertasning Road Section in South Sulawesi Province;
- 2. The environmental management and monitoring as mentioned on point 1 above shall refer to the Environmental Management Plan, Environmental Monitoring Plan and Executive Summary, and to be used as a reference on environmental management and monitoring by the Proponent and environmental monitoring by the Minister of Public Works, State Minister of Environment, BAPEDALDA Province, Provincial Bina Marga, Provincial Transportation Office, Maros Regent, Makassar Mayor, Gowa Regent and Takalar Regent, as well as to the relevant agencies;
- 3. The Environmental Management and Monitoring of the Construction Plan of Maros-Takalar Road Section, Trans-Sulawesi Mamminasata Road, South Sulawesi Province shall be reported, once within 6 (six) months, to the Minister of Public Works, State Minister of Environment, BAPEDALDA Province, Provincial Bina Marga, Provincial Transportation Office, Maros Regent, Makassar Mayor, Gowa Regent and Takalar Regent, as well as to the relevant agencies.

THIRD

: Should, in the future, there any impact occurs to the environment beyond the planning and estimation as mentioned in the approved EIA Study, RKL, RPL and ES on Road Development Plan in Mamminasata Metropolitan Area which consist of Mamminasa Bypass Road Section, Abdullah Daeng Sirua Road Section and Hertasning Road Section in South Sulawesi Province, the proponent shall soon report it to the Minister of Public Works, State Minister of Environment, BAPEDALDA Province, Provincial Bina Marga, Provincial Transportation Office, Maros Regent, Makassar Mayor, Gowa Regent and Takalar Regent, as well as to the relevant agencies.

FOURTH

: Should there any extension, removal and improvement of capacity and/or revision to the action plan that makes the approved EIA Study, RKL, RPL and ES no longer applicable for environmental management and monitoring, a new EIA study shall be made.

FIFTH

: Any mistake and/or divergence made by the Proponent in this approval, penalties

shall be imposed to them in accordance with the prevailing law and regulations.

SIXTH

: The proponent shall take into account and comply with any provisions relevant to the Law No. 23/1997 on Environmental Management, Law No. 32/2004 on Regional Government, and Government Regulation No. 27/1999 on EIA, as well as other prevailing laws and regulations.

SEVENTH: Should this Approval for EIA, RKL, RPL and ES on Construction Plan of Maros-Takalar Road Section, Trans-Sulawesi Mamminasata Road, South Sulawesi Province is not implemented within 3 (three) years since the issuance date of this approval, it shall be null and void.

EIGHTH

: This approval shall be effective as of the day of issuance, and if there any mistake found in the future, it will be reviewed.


