# **REPUBLIC ACT NO. 8294**

AN ACT AMENDING THE PROVISIONS OF PRESIDENTIAL DECREE NO. 1866, AS AMENDED, ENTITLED "CODIFYING THE LAWS ON ILLEGAL/UNLAWFUL POSSESSION, MANUFACTURE, DEALING IN, ACQUISITION OR DISPOSITION OF FIREARMS, AMMUNITION OR EXPLOSIVES OR INSTRUMENTS USED IN THE MANUFACTURE OF FIREARMS, AMMUNITION OR EXPLOSIVES, AND IMPOSING STIFFER PENALTIES FOR CERTAIN VIOLATIONS THEREOF, AND FOR RELEVANT PURPOSES"

SECTION 1. Section 1 Presidential Decree No. 1866, as amended, is hereby further amended to read as follows:

"SECTION 1. Unlawful Manufacture, Sale, Acquisition, Disposition or Possession of Firearms or Ammunition or Instruments Used or Intended to be Used in the Manufacture of Firearms or Ammunition. — The penalty of prision correccional in its maximum period and a fine of not less than Fifteen thousand pesos (P15,000) shall be imposed upon any person who shall unlawfully manufacture, deal in, acquire, dispose, or possess any low powered firearm, such as rimfire handgun, .380 or .32 and other firearm of similar firepower, part of firearm, ammunition, or machinery, tool or instrument used or intended to be used in the manufacture of any firearm or ammunition: Provided, That no other crime was committed.

"The penalty of prision mayor in its minimum period and a fine of Thirty thousand pesos (P30,000) shall be imposed if the firearm is classified as high powered firearm which includes those with bores bigger in diameter than .38 caliber and 9 millimeter such as caliber .40, .41, .44, .45 and also lesser calibered firearms but considered powerful such as caliber .357 and caliber .22 center-fire magnum and other firearms with firing capability of full automatic and by burst of two or three: Provided, however, That no other crime was committed by the person arrested.

"If homicide or murder is committed with the use of an unlicensed firearm, such use of an unlicensed firearm shall be considered as an aggravating circumstance.

"If the violation of this Section is in furtherance of or incident to, or in connection with the crime of rebellion or insurrection, sedition, or attempted coup d'etat, such violation shall be absorbed as an element of the crime of rebellion, or insurrection, sedition, or attempted coup d'etat.

"The same penalty shall be imposed upon the owner, president, manager, director or other responsible officer of any public or private firm, company, corporation or entity, who shall

willfully or knowingly allow any of the firearms owned by such firm, company, corporation or entity to be used by any person or persons found guilty of violating the provisions of the preceding paragraphs or willfully or knowingly allow any of them to use unlicensed firearms or firearms without any legal authority to be carried outside of their residence in the course of their employment.

"The penalty of arresto mayor shall be imposed upon any person who shall carry any licensed firearm outside his residence without legal authority therefor."

SECTION 2. Section 3 of Presidential Decree No. 1866, as amended, is hereby further amended to read as follows:

"SECTION 3. Unlawful Manufacture, Sale, Acquisition, Disposition or Possession of Explosives. — The penalty of prision mayor in its maximum period to reclusion temporal and a fine of not less than Fifty thousand pesos (P50,000) shall be imposed upon any person who shall unlawfully manufacture, assemble, deal in, acquire, dispose or possess hand grenade(s), rifle grenade(s), and other explosives, including but not limited to 'pillbox,' 'molotov cocktail bombs,' 'fire bombs,' or other incendiary devices capable of producing destructive effect on contiguous objects or causing injury or death to any person. cdtai

"When a person commits any of the crimes defined in the Revised Penal Code or special laws with the use of the aforementioned explosives, detonation agents or incendiary devices, which results in the death of any person or persons, the use of such explosives, detonation agents or incendiary devices shall be considered as an aggravating circumstance.

"If the violation of this Section is in furtherance of, or incident to, or in connection with the crime of rebellion, insurrection, sedition or attempted coup d'etat, such violation shall be absorbed as an element of the crimes of rebellion, insurrection, sedition or attempted coup d'etat.

"The same penalty shall be imposed upon the owner, president, manager, director or other responsible officer of any public or private firm, company, corporation or entity, who shall willfully or knowingly allow any of the explosives owned by such firm, company, corporation or entity, to be used by any person or persons found guilty of violating the provisions of the preceding paragraphs."

SECTION 3. Section 5 of Presidential Decree No. 1866, as amended, is hereby further amended to read as follows:

"SECTION 5. Tampering of Firearm's Serial Number. — The penalty of prision correctional shall be imposed upon any person who shall unlawfully tamper, change, deface or erase the serial number of any firearm."

SECTION 4. Section 6 of Presidential Decree No. 1866, as amended, is hereby further amended to read as follows:

"SECTION 6. Repacking or Altering the Composition of Lawfully Manufactured Explosives. — The penalty of prision correccional shall be imposed upon any person who

shall unlawfully repack, alter or modify the composition of any lawfully manufactured explosives."

SECTION 5. Coverage of the Term Unlicensed Firearm. — The term unlicensed firearm shall include:

- 1) firearms with expired license; or
- 2) unauthorized use of licensed firearm in the commission of the crime.

SECTION 6. Rules and Regulations. — The Department of Justice and the Department of the Interior and Local Government shall jointly issue, within ninety (90) days after the approval of this Act, the necessary rules and regulations pertaining to the administrative aspect of the provisions hereof, furnishing the Committee on Public Order and Security and the Committee on Justice and Human Rights of both Houses of Congress copies of such rules and regulations within thirty (30) days from the promulgation hereof.

SECTION 7. Separability Clause. — If, for any reason, any section or provision of this Act is declared to be unconstitutional or invalid, the other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 8. Repealing Clause. — All laws, decrees, orders, rules and regulations or parts thereof inconsistent with the provisions of this Act are hereby repealed, amended, or modified accordingly.

SECTION 9. Effectivity. — This Act shall take effect after fifteen (15) days following its publication in the Official Gazette or in two (2) newspapers of general circulation.

#### I. REFERENCES:

1. Presidential Decree No.1866 as amended by Republic Act No.8294 - Codifying the Laws on Illegal/Unlawful Possession, Manufacture, Dealing in, Acquisition, or Disposition of Firearms, Ammunition or Explosives or Instruments Used in the Manufacture of Firearms and Ammunitions.

2. Letter of Instruction 24/2000 (KATAPAT) PNP's Plan Against Possession of Loose Firearms and Carrying of Licensed Firearms without Permit to Carry Firearms Outside Residence

#### II. PURPOSE:

- 1. This LOI prescribes the operating guidelines and procedures in order to reduce, if not eradicate, the number of Illegal/Loose Firearms and Ammunition.
- 2. This LOI also gives a boost to the deployment of PNP personnel from concerned police units/offices to conduct intensive police operations against suspected crime groups, gangs, or individuals involved in the illegal manufacture, possession, acquisition, dealing, or disposition of firearms and ammunition.

# III. SITUATION:

- 1. Crime incidents involving the use of firearms cause an alarming concern to public safety. The estimate of loose firearms consisting of various calibers and make is placed at 106,000 as of the last quarter of 2005. However, this figure is a conservative estimate and may not be representing the real picture of the loose firearms situation in the country. A loose firearm is defined as a firearm that is not registered or in the possession of a person other than its registered owner, regardless of type, make or source. Loose firearms are usually in the possession not only by criminal elements but also by ordinary citizens for their personal use or protection, in violation of existing laws, rules, and regulations on firearms.
- 2. The country has been identified as among the sources of illegal firearms seized in other parts of the world particularly the neighboring countries in Asia. In some instances, the country's ports are used by illegal traders for international trafficking of illegal/lose firearms.

3. The prevailing estimate of the firearm situation and the negative public perception show a bad picture of the seeming inability of the government, particularly the PNP in addressing these illegal activities. The law enforcement actions of the police stations and concerned police units should be complemented. It is, therefore necessary to organize a dedicated police force to spearhead the conduct of intensified and extensive police operations on Anti-Illegal/Loose Firearms to be called Task Force "ARMAS".

#### IV. MISSION:

- 1. The PNP TF-"ARMAS" shall be principally tasked to conduct aggressive and sustained police operations against individuals and/or crime groups/gangs engaged in the illegal manufacture, possession, acquisition, dealing, or disposition of firearms and ammunition.
- 2. The PNP TF-"ARMAS" shall take necessary actions of information gathering to conduct intensive police operations to curb illegal transfer and international smuggling of firearms and ammunition.

# V. EXECUTION:

# 1. Concept of Operations:

- a. The Director for Operations (TDO) shall be designated as the Task Force Head, who shall be assisted by The Director for Intelligence (TDI) as Deputy Head and Deputy Director for Operations (DDO) as Executive Officer (Ex-O). The Task Force Head shall designate the Chiefs and Assistant Chiefs of the functional staff on Personnel/Administration, Intelligence, Investigation, Operations, and Public Advocacy. The members of the functional staff shall also compose the Operating Team "ARMAS" (OT "ARMAS") at the national headquarters led by the Ex-O.
- b. Task Group (TG) "ARMAS" shall be organized at Police Regional Offices (PROs). The Deputy Regional Director for Operations (DRDO) shall be designated as Commander, TG "ARMAS" of the PRO. At least one OT "ARMAS" shall be organized in every PRO and Provincial Police Office (PPO). Each OT "ARMAS" shall have at least ten (10) personnel, whose Team Leader and members shall be designated by the Regional Director (RD) of the PRO, upon recommendation by the respective Provincial Director (PD) and DRDO. Likewise, the National Capital Region Police Office (NCRPO) and its five Police Districts shall organize respective OT "ARMAS" with its Team Leader and members to be designated by the RD, NCRPO upon recommendation by the concerned District Director and DRDO.
- c. The OTs "ARMAS" shall conduct aggressive and sustained police operations to seize and confiscate all illegal/loose firearms through intensive intelligence build-up, police interdiction operations, arrest of suspects, and monitoring of cases filed in court. Inspection and monitoring of registered dealers, manufacturers, and repair shops of firearms should be conducted by OT "ARMAS" upon prior coordination with Firearms and Explosives Division, Civil Security Group (FED, CSG) or Firearms, Explosives, Security Agencies, and Guards Section (FESAGS).
- d. Seaborne patrols shall be reinforced to improve the law enforcement capability of the Maritime Group (MG) in the territorial waters of the Philippines and enhance the anti-smuggling drive in coordination with the

Bureau of Customs (BOC) and Philippine Coast Guard (PCG).

#### 2. Tasks:

- a. National Headquarters (NHQ)
  - 1) TDO Designated Head, PNP TF-"ARMAS".
    - Supervise the overall implementation of this LOI.
- Prepare and submit report to C, PNP on the results pertaining to this campaign.
- Designate the Chiefs and Assistant Chiefs of the task force functional staff at the national Headquarters.
  - Perform other tasks as directed.
  - 2) TDI Designated Deputy Head, PNP TF-"ARMAS".
    - Conduct 'intelligence monitoring and identify

holders of firearms.

- Submit assessment on loose FAs in coordination

with the FED.

- Perform other tasks as directed.
- 3) DDO Designated as Executive Officer, PNP TF "ARMAS".
  - Serve as Team Leader, OT "ARMAS" of NHQ.
- 4) TDIDM Supervise and assist in the investigation of cases involving violations of the firearms law.
- Monitor the status and disposition of all cases of violation of illegal possession of firearms and maintain inventory of the said cases.
  - Perform other tasks as directed.
  - 5) TDPRM Issue orders to all personnel involved in the TF.
    - Perform other tasks as directed
  - 6) TDL Provide logistics support to the TF.
    - Perform other tasks as directed
- 7) TDC Provide fund support for the operational requirements of the TF.
  - Perform other tasks as directed
- 8) TDPCR Orchestrate the public information drive relative to this campaign.
- 9) Secretariat, PTCFOR Provide information on persons issued with Permits to Carry Fireards Outside Residence upon request.
  - 10) Other D-Staffs Provide necessary support for the TF.

# b. National Support Units (NSU)

- 1) CSG Provide technical support to the TF through FED.
- Provide information pertaining to licensed firearms upon coordination by TF Members or formal request.
- Monitor, record and prepare statistics on loose FAs in coordination with other concerned units and submit it to TDO/Head, TF "ARMAS".
  - Perform other tasks as directed.
- 2) IG Provide list of identified personalities/groups possessing loose firearms.
- Provide list of identified personalities who carry their licensed firearms outside their residence without appropriate authority.
  - Perform other tasks as directed.
- 3) CIDG Provide appropriate support in the conduct of investigation on cases involving violations of the firearms law.
  - Perform other tasks as directed.
  - 4) CL Establish ballistics database system.
- Conduct examination and ballistics testing of evidence firearms and cross matching of bullets and cartridge cases.
  - Perform other tasks as directed.
- 5) ASG Secure all airports against firearms smugglers in coordination with airport authorities and Bureau of Customs.
- 6) MG Conduct seaborne patrols and intensify operations against gun traffickers in Philippine territorial waters and rivers.
  - 7) LS To support the DIDM's tasks.
  - 8) PCRG- To support the DPCR's tasks.
  - 9) Other NSUs Provide necessary support to the TF.
  - c. Police Regional Offices (PROs)
    - 1) DRDO Designated as Chief, TG-"ARMAS".
- Organized operating teams at the regional and provincial (district at NCRPO) levels.
  - Recommend the Team Leaders, OT-"ARMAS"
  - Perform other tasks as directed.

# VI. COORDINATING INSTRUCTION

- 1. Respect for Human Right shall be observed at all times.
- 2. Adherence to the PNP Police Operational Procedures is a must.
- 3. All apprehensions/seizues of loose firearms should be reported, to include the filing of appropriate charges against the offenders. All loose firearms surrendered and seized shall be turned over to FED, CSG except those submitted as evidence in court.
  - 4. Lateral coordination is encouraged/authorized.
- 5. All applicable provisions of existing LOI's, Memoranda, Directives or Circulars which are not in conflict or inconsistent with this plan are still in effect.

#### VII. EFFECTIVITY:

This LOI shall take effect immediately.





# I. COOPERATION BETWEEN JICA AND THE GRP

JICA will receive the Philippine personnel connected with the Project for technical training in Japan.

## III. MEASURES TO BE TAKEN BY THE GRP

- The GRP will take necessary measures to ensure that the self-reliant operation of the Project will be sustained during and after the period of Japanese technical cooperation, through full and active involvement in the Project by all related authorities, beneficiary groups and institutions.
- 2. The GRP will ensure that the technologies and knowledge acquired by the Philippine nationals as a result of Japanese technical cooperation will contribute to the economic and social development of the Philippines.
- 3. The GRP will grant in the Philippines privileges, exemptions and benefits to the Japanese experts referred to in II-1 above and their families, which are no less favorable than those accorded to experts of third countries working in the Philippines under the Colombo Plan Technical Cooperation Scheme.
- 4. The GRP will ensure that the Equipment referred to in II-2 above will be utilized effectively for the implementation of the Project in consultation with the Japanese Experts referred to in Annex II.
- 5. The GRP will take necessary measures to ensure that the knowledge and experience acquired by the Philippine personnel from technical training in Japan will be utilized effectively in the implementation of the Project.
- 6. In accordance with the laws and regulations in force in the Philippines, the GRP will take necessary measures to provide at its own expense:
  - (1) Services of the Philippine counterpart personnel and administrative personnel as listed in Annex IV;
  - (2) Buildings and facilities as listed in Annex V; and
  - (3) Supply or replacement of machinery, equipment, instruments, vehicles, tools, spare parts and any other materials necessary for the implementation of the

Project other than the Equipment provided by JICA under II-2 above.

- 7. In accordance with the laws and regulations in force in the Philippines, the GRP will take necessary measures to meet:
  - (1) Expenses necessary for transportation within the Philippines of the Equipment referred to in II-2 above as well as for the installation, operation and maintenance thereof;
  - (2) Customs duties, internal taxes and any other charges, imposed in the Philippines on the Equipment referred to in II-2 above; and
  - (3) Running expenses necessary for the implementation of the Project.

## IV. ADMINISTRATION OF THE PROJECT

- Head, ARMAS (Director, Directorate for Operations), as the Project Director, will bear overall responsibility for the administration and implementation of the Project.
- Executive Officer, ARMAS (Deputy Director, Directorate for Operations), as the Project Manager, will be responsible for the managerial and technical matters of the Project.
- Project Management Team, comprised of the representatives of ARMAS and other related units, will be formed for the smooth operation of the project activities.
- The Japanese Experts will provide necessary recommendations and advice to the Project Director and the Project Manager on any matters pertaining to the implementation of the Project.
- 5. The Japanese Experts will give necessary technical guidance and advice to the Philippine counterpart personnel on technical matters pertaining to the

implementation of the Project.

6. For the effective and successful implementation of technical cooperation for the Project, a Joint Monitoring System will be established, functions and composition of which are described in Annex VI.

# V. JOINT EVALUATION

Evaluation of the Project will be conducted jointly by JICA and the Philippine authorities concerned, during the last six months of the cooperation term in order to examine the level of achievement.

# VI. CLAIMS AGAINST JAPANESE EXPERTS

The GRP undertakes to bear claims, if any arises, against the Japanese experts engaged in technical cooperation for the Project resulting from, occurring in the course of, or otherwise connected with the discharge of their official functions in the Philippines except for those arising from the willful misconduct or gross negligence of the Japanese experts.

# VII. MUTUAL CONSULTATION

There will be mutual consultation between JICA and the GRP on any major issues arising from, or in connection with this Attached Document.

# VIII. MESURES TO PROMOTE UNDERSTANDING OF AND SUPPORT FOR THE PROJECT
