- In accordance with the Scope of the Work for the Study on Integrated Flood Management for Nyando River Basin (hereinafter referred to as "the Study") signed between the Ministry of Water and Irrigation (hereinafter referred to as "MWI"), the Water Resources Management Authority (hereinafter referred to as "WRMA") and Japan International Cooperation Agency (hereinafter referred to as "JICA"), the JICA Study team prepared the Draft Inception Report (hereinafter referred to as "DIR"). The JICA Study Team submitted twenty (20) copies of DIR on 26 July 2006 to MWI and WRMA.
- 2. A Steering Committee Meeting on DIR was held on 2 August 2006. After the chairman of the committee and the Team Leader of the JICA advisory team made opening remarks, the Team Leader of the JICA Study Team explained the outline and approach of the Study. Thereafter, a series of discussions were held by the participants. As a result of the discussions, DIR was, in principal, accepted by the committee. The main points discussed and agreed by both sides are as follows:
  - i) Implementation schedule as contained in DIR was revised as attached hereto to realize outcomes of the study as early as possible. The schedule may be revised in the study period, depending on the community consultation results and physical conditions.
  - The improvement of drainage network in low-lying areas is required to mitigate floods in addition to the rehabilitation and construction of the dike.
  - iii) The possibility of utilisation of excess water will be examined in the Study.
  - iv) Several studies on water resources development including the master plan by Italconsult (1983), the national water master plan by JICA (1992), strategy for flood management for Lake Victoria Basin (2004) etc. were conducted. Those results will be fully utilised for Study works.
  - v) There are various stakeholders related to the flood management. In addition to the involvement of those stakeholders into the Study, the coordination amongst stakeholders will be enhanced.
  - vi) The Study Team will have two offices; one in Nairobi (Maji house) and the other in Kisumu. The WRMA regional office will dispatch two counterparts for the study on full time basis at Kisumu office.

- 3. The Project Working Group (PWG) discussed DIR with the JICA Advisory Team and the Study Team on 2 August 2006. The main points discussed and agreed by both sides are as follows:
  - i) Meetings with PWG will be held on ad-hoc basis in Nairobi and bi-weekly meetings with WRMA regional office will be held in Kisumu. In addition, meetings with the PWG at site will be considered.
  - DIR was accepted by the PWG. Further comments on DIR will be submitted by the PWG ii) to the JICA Study Team before 16th August 2006, and be incorporated into the Progress Report (No.1).
- 4. The national workshop on the integrated flood management for the Nyando River Basin was jointly organized by MWI, JICA and World Meteorological Organization on 3 August 2006. Assistant Minister for Water and Irrigation, the officers of concerned organizations, and officers of development partners participated in the workshop. Integrated approach in the flood management, community participation, and coordination between concerned organizations, which are main study concepts, were widely accepted by the participants. recommendations raised in the workshop will be attached in the Progress Report (No.1).
- 5. During the field survey of 4-6 August 2006, it was confirmed that the WRMA regional office was preparing establishment of a forum for Nyando river basin water management. The first official meeting for the forum is scheduled to be held on 18 August 2006.

- In accordance with the Scope of the Work for the Study on Integrated Flood Management for Nyando River Basin (hereinafter referred to as "the Study") signed between the Ministry of Water and Irrigation (hereinafter referred to as "MWI"), the Water Resources Management Authority (hereinafter referred to as "WRMA") and Japan International Cooperation Agency (hereinafter referred to as "JICA"), the JICA Study team prepared the Progress Report No.1 (hereinafter referred to as "PR1"). The JICA Study Team submitted forty (40) copies of PR1 on 28 November 2006 to MWI and WRMA.
- 2. A Steering Committee Meeting on PR1 was held on 4 December 2006. After the chairman of the committee made opening remarks, the Team Leader of the JICA Study Team explained the outline of progress including Draft Master Plan. Thereafter, a series of discussions were held by the participants. As a result of the discussions, PR1 was accepted by the committee. The main points discussed and agreed by both sides are as follows:
  - i) Permanent Secretary of MWI (hereinafter referred to as "PS") pointed out the possibility of financial assistance for the schemes proposed in the Draft Master Plan. PS asked the Study Team whether JICA or Japanese Government can assist in funding of some of the schemes. JICA Study Team answered that the question will be conveyed to JICA Tokyo.
  - ii) Early Warning System to be prepared by Western Kenya Community Driven Development and Flood Management Project (WKCDD+FM) will be examined and considered in this Study.
  - iii) It is reported that various comments were raised by local authority and communities in the workshop on catchment management at Kisumu. Those comments were considered in the study results.
  - iv) In order to raise feeder roads as evacuation routes, authorities at the district level should take initiatives for the actual implementation.
  - v) The Study should pay attention to the existing intakes for irrigation, since those intakes should be maintained in case of development or formulation of structure measures. JICA Study Team will consider the existence of these intakes during the Initial Environmental Examination (IEE) process.

- 3. The Project Working Group (PWG) also discussed PR1 with the Study Team on 4 December 2006. The main points discussed and agreed by both sides are as follows:
  - i) One of structural measures proposed in PR1 is the raising of national road including reconstruction of bridges and culverts. These works would be done under the management of the Ministry of Public Works (MoPW). The close coordination between MWI and MoPW is inevitable for expediting the implementation as short-term measures.
  - Raising of feeder roads in flood prone areas will be necessary in addition to the raising of community roads proposed in PR1.
  - iii) Watershed management is one of important issues in the Nyando river basin, especially in the upper catchment. More detailed information for watershed management should be included in the Master Plan.
  - iv) Roof catchment is proposed for the supply of safety drinking water to the dislocated families in the evacuation centres, since the groundwater is contaminated during flood inundation period. Piped water supply from the springs of Kibos river basin might be one of alternate water sources.
  - v) The members of PWG should visit the site to familiarise with the situation of flood prone area. For this reason, some of PWG meetings will be held in the Study Area.

- In accordance with the Scope of the Work for the Study on Integrated Flood Management for Nyando River Basin (hereinafter referred to as "the Study") signed between the Ministry of Water and Irrigation (hereinafter referred to as "MWI"), the Water Resources Management Authority (hereinafter referred to as "WRMA") and Japan International Cooperation Agency (hereinafter referred to as "JICA"), the JICA Study team prepared the Interim Report (hereinafter referred to as "IT/R") (Draft). The JICA Study Team submitted twenty (20) copies of IT/R (Draft) on 26 June 2007 to MWI and WRMA.
- The project working group discussed on IT/R (Draft) on 26 June 2007. Main points discussed and agreed by participants are as follows:
  - The master plan will include the component of community driven flood management, which is the main pillar of the study concept, with the cost required.
  - ii) The status of the master plan of IT/R (Draft) is presumed as the final configurations of structural, non-structural and community-driven flood management measures. The master plan will be revised in the final report to be submitted in August 2008 after compiling lessons leant from pilot projects.
  - iii) WRMA Lake Victoria South Catchment regional office should be the member of disaster management committee at provincial and district levels to take initiative of the integrated flood management in the Nyando river basin.
  - iv) The short, medium and long term targets as shown in Table 5.9.1 of IT/R (Draft) should be clarified.
  - v) Ministry of Roads and Public Works will be invited as the member of the steering committee to discuss on road improvement proposed in IT/R (Draft).
- Nyando river basin water management forum was held on 29 June 2007. Main points discussed and agreed by the participants were as follows:
  - i) The outline of IT/R (Draft) was accepted by the forum.
  - ii) The forum plays an important role as a platform for discussing river management issues, therefore its members will be encouraged to join relevant, existing and new Water Resource Users Associations in the Nyando river basin.
  - Sustainability of pilot projects and replication from the experiences are very important. WRMA will encourage the community driven flood management organizations established in the pilot projects to be the member of Water Resource Users Associations.

- 4. IT/R (Draft) was accepted by the steering committee chaired by the permanent secretary of MWI on 2 July 2006. The main points discussed and agreed by the participants are as follows:
  - Discussion held at the project working group and Nyando river basin water management forum were confirmed.
  - ii) To take over activities of the study team, WRMA should establish a flood management unit consisting of two personnel at the Lake Victoria South Catchment regional office. In addition to the current full-time counterpart, another full-time counterpart with engineering background, should be attached to the Study Team. WRMA will notify the plan of this staff assignment to JICA before 31 July 2007.
  - IT/R (Draft) will be finalised before 31 July 2007 taking comments raised by the committee into consideration.
  - iv) WRMA will encourage and facilitate the formation of umbrella WRUA for the Nyando river basin to implement the recommendations of the master plan
  - v) WRMA will take necessary actions that WRMA Lake Victoria South Catchment regional office will become the member of disaster management committee at provincial and district levels. Joint disaster management committee meeting will be held by 31 July 2007.
  - WRMA will prepare, in collaboration with JICA, the road map which specifies necessary actions taken by the concerned organisations before 31 December 2007.
  - vii) Progress Report No. 2 will be submitted in March 2008 to include mid-term evaluation result of pilot projects.
  - viii) WRMA will encourage and facilitate WRUAs to put up water pans in Nyando river basin.
  - ix) WRMA will facilitate clearing Odesso drainage channel.

- In accordance with the Scope of the Work for the Study on Integrated Flood Management for Nyando River Basin (hereinafter referred to as "the Study") signed between the Ministry of Water and Irrigation (hereinafter referred to as "MWI"), the Water Resources Management Authority (hereinafter referred to as "WRMA") and Japan International Cooperation Agency (hereinafter referred to as "JICA"), the JICA Study team prepared the Progress Report No.2 (hereinafter referred to as "PR2"). The JICA Study Team submitted forty (40) copies of PR2 on 6th August 2008 to MWI and WRMA.
- 2. A Steering Committee Meeting on PR2 was held on 16<sup>th</sup> September 2008. After the chairman of the committee made opening remarks, the Team Leader of the JICA Study Team explained the outline of progress including Master Plan, Priority Schemes and Pilot Projects. Thereafter, a series of discussions were held by the participants. As a result of the discussions, the progress of the Study was appreciated and PR2 was accepted by the committee.
- 3. The main points discussed and agreed by both sides are as follows:
  - It was suggested that assessment of soil condition will be required, since eroded sediment triggered in upper catchment will deposit in lower catchment and decrease river flow capacity. Besides, the encroachment of agricultural activities into forest areas in upper catchment was perceived as one of the most seriously concerned issues. It was also pointed that sediment due to gully erosion causes the decrease of river flow capacity in flood prone area. It is the largest problem in lower Nyakachi. The Study Team responded that the satellite images indicated that forest areas in the upper catchment increased gradually. Therefore, soil erosion in middle catchment is getting more serious and it was accordingly proposed in the Master Plan that the sediment traps in place in middle catchment.
  - It was also suggested that dyke with specific tree planting shall be considered since tree planting will contribute to increase dyke stability.
  - iii) The Western Kenya Community-driven Development and Flood Mitigation Project under the Office of President explained their activities, and more information sharing with JICA Study was recommended. NWCPC also considers more integration to the Study, since NWCPC is constructing dyke along the Nyando River.
  - iv) The importance of flood forecasting system was emphasized. The Study Team responded that only one automatic logger at river gauging station is operational in the Nyando river basin. Prior to the establishment of flood forecasting system, hydrological monitoring network should be provided by installing automatic loggers at river gauging stations and automatic recorders at rainfall stations, which were proposed in the PR2.
  - v) The Study Team recommended that the Ministry of Public Works shall be involved in the Steering Committee, since such involvement was proposed in the previous meetings in the Steering Committee and Project Working Group. In addition, roads rehabilitation and road raising proposed as Priority Scheme are very effective measures for ensuring evacuation



- activities during flood by the local people. It was agreed that a copy of PR2 and handout of the Study will be given to the ministry for future involvement.
- vi) It was suggested that the committee member would visit the sites around Nyando River for better understanding of the Study and regional conditions. It was commented that the Stakeholders Workshop in Kisumu scheduled in December 2008 could be an opportunity for the site visit.

- In accordance with the Scope of the Work for the Study on Integrated Flood Management for Nyando River Basin (hereinafter referred to as "the Study") signed between the Ministry of Water and Irrigation (hereinafter referred to as "MWI"), the Water Resources Management Authority (hereinafter referred to as "WRMA") and Japan International Cooperation Agency (hereinafter referred to as "JICA"), the JICA Study Team prepared the Draft Final Report (hereinafter referred to as "DF/R"). The JICA Study Team submitted forty (40) copies of DF/R on 8 December 2008 to MWI and WRMA.
- A steering committee meeting on DF/R chaired by the permanent secretary of MWI was held on 8 December 2008. DF/R was basically accepted by the committee. The main points discussed and agreed by participants are as follows:
  - The comments, if any on the DF/R will be forwarded from WRMA to JICA Kenya Office by 10 January 2009.
  - ii) Three schemes are proposed for realising the Master Plan, namely 1) Implementation Plan for Yen loan, 2) JICA technical cooperation for capacity development in nationwide flood management, and 3) JICA program grant aid for environment and climate change. Of the three schemes, the program grant aid is now already under outline design stage for implementation.
  - iii) WRMA will establish a flood management and climate change adaptation unit to spread out the practices of the Study throughout the country and to promote adaptation measures.
  - iv) The established Nyando River Water Management Forum should be sustained after completion of the Study. The forum should become an umbrella body for Water Resources Users Associations (WRUAs). WRMA will support the forum to sustain activities after the Study.
  - v) WRMA Lake Victoria South Catchment regional office became the member of disaster management committee at provincial and district levels. WRMA will be expected to contribute in preventive measures such as flood forecasting and early warning.
  - vi) Further financial support by Water Services Trust Fund to communities in Nyando river basin should be considered. WRMA will coordinate continuous support to the communities through WRUAs.
- Workshop on the Study was held on 11 December 2008. MWI, WRMA, the forum members, pilot communities, and others participated in the workshop. The Master Plan and other contents of DF/R was accepted by the participants.
