PUBLIC CONSULTATION ON PROPOSED CONSTRUCTION OF SECOND BRIDGE ACROSS RIVER NILE AT JINJA

INVITATION TO PUBLIC CONSULTATION

Road transport is by far the dominant mode of transport in Uganda, catering for about 90% of passengers and freight traffic. The Northern Corridor route that runs parallel to the northern shore of Lake Victoria from the District of Kapelele to the west to the District of Busia on the Kenya border is one of Uganda's main transport arteries and is part of Uganda's strategic link to the Port of Mombasa, Kenya. In addition, it links Uganda's neighbouring countries of Rwanda, Burundi and the eastern part of the Democratic Republic of Congo to the Indian Ocean.

This main artery crosses the Nile at Jinja as a Class 1 road that was built on and as part of the construction of the Nalubaale Dam. Construction of the dam commenced in the 1940s and was completed in 1954. In addition to carrying the road, the dam houses Uganda's primary and strategic source of electricity.

With regard to the Nalubaale crossing, it has now been established that:

- Both the volumes and loadings on the bridge have increased at a faster rate than anticipated in the previous forecasts.
- The bridge/dam structural deck elements are over-stressing and piecemeal deteriorated, and
- The bridge structure and the dam, now past their design life, can no longer safely carry the prevailing load in the medium to long term considerations.

In this connection, construction of a new bridge is the only solution that would address the long term reliability and safety needs in this important transitional point of the northern corridor.

In pursuit of the above solution, the Government of Uganda has obtained assistance from the Japanese Government (through JICA) towards the feasibility study and design of a proposed second bridge across river Nile at Jinja. The study team selected by the Japanese Government (through JICA) Oriental Consultants Co. Ltd., arrived on Sunday, 2 November 2008 for the study expected to take approximately 12 months.

In accordance with the National Environment Management Act, 2003, a project of this nature has to be reviewed at a very large scale in order to determine its permissibility and the better to appropriately design suitable mitigation against any, adverse impacts.

It is for this purpose the following are invited to the first public consultative meeting which will take place on 12th December 2008 at Serena Hotel and Conference Centre. Your contribution in this process will make a difference.

Cholera kills 2 more DRC refugees

A cholera outbreak in the newly created Matanda Refugee Camp in Kibuku Sub-county, Kamungu District has killed two people and affected more than a dozen others, raising fears that it could spread to be residents.

The UNHCR spokesperson at the camp, Ms. Yumco Takahama, said they were battling the disease and had already isolated some people to curb the spread of the disease.

"We were prepared to handle this situation and we alerted our partners like the Red Cross so be on standby so that if any epidemic breaks out, we can control it," Ms. Takahama said.

Last month, two refugees died of cholera at Nakivale camp.

Meanwhile, over 700 refugees have returned to Congo in the last three days following decreased fighting.

The Kamungu District Police Commander, Mr. Nazario Mugisha, said more refugees are demanding to go back but security has been advising them to be patient.

"We have seen some refugees going back as they say

DP undecided on delegates meeting

Money to transport delegates unavailable

Conference might be held in February

Democratic Party members, who have been waiting to attend the party's national delegates conference, will have to wait due to internal problems, Daily Monitor has learnt.

The party's deputy secretary general, Dr. Lubiano Bayiga, confirmed that DP's top leadership was still undecided on when to convene the conference.

"We have postponed the conference until further notice. We are still undecided on when to convene the conference, which we have postponed since we have internal problems," he said.

In a statement during a meeting on Monday, Dr. Bayiga said the DP also needs to resolve internal problems, which he said will be done by the end of the year.

The DP conference was first scheduled for last month and later postponed to December.

However, DP President Sebasa Kintu, told journalists at a recent weekly press briefing that the conference has been rescheduled to February next year.

Dr. Bayiga, however, said some issues needed to be sorted out before a definite date could be set.

There are still internal leadership problems which we have to resolve before thinking of anything.

The meeting was to, among other things, discuss making amendments in the party constitution and devising means of mobilising funds for the party.

A senior party official who preferred anonymity because he is not the official spokesperson of the party told Daily Monitor that they need about Sh500 million to convene the conference.

Road transport is by far the dominant mode of transport in Uganda, catering for about 90% of passengers and freight traffic. - The bridge structure and the dam, now past their design life, cannot longer safely carry the prevailing load in the medium to long term considerations.

In this connection, construction of a new bridge is being planned, that would address the long term viability and safety needs in this important transportation point of the northern corridor.

In pursuit of the above solution, the Government of Uganda has obtained assistance from the Japanese Government (through JICA) towards the feasibility study and design of a proposed second bridge across river Nile at Jinja. The study team selected by the Japanese Government through JICA, Oriental Consultants Co. (OCC) arrived on Sunday 2 November 2008 for the study expected to take approximately 12 months.

In accordance with the National Environment Act, Cap 153, a project of this nature is a subject of an Environmental Impact Assessment (EIA) process for purposes of establishing the environmental feasibility of the project during the design, construction and operation phases.

1st Public Consultation Meeting for Feasibility Study on a new Bridge across River Nile at Jinja

1. Introductory Remarks

The meeting was opened at 9:30am by Eng. Kimeze Ssebugga the Director of Operations Uganda National Roads Authority (UNRA), who was representing the Executive Director of UNRA. The opening remarks from Eng. Sebanakitta were presented by Eng. Kimeze Ssebugga (Director Operations, UNRA) who started by asking the participants to introduce themselves. He apologized on behalf of the Executive Director and said he was away to North Eastern Uganda accompanying the Minister of Ministry of Works and Transport.

In the Executive Director's remarks, the participants were welcomed to the first public consultation meeting of the feasibility study of the new bridge across river Nile at Jinja. They were informed that the GOU has prioritised the construction of a new crossing over Nile at Jinja to ensure Northern corridor route which is an economic lifeline of this country and our neighbors is not threatened by closure for along time to come. This is in wake of existing Nalubale Bridge which can no longer guarantee long term service in the face of increasing trade, expanding economies and increasing vehicular travel of which are increasing the stresses on it.

They were further informed that the Government of Japan through its Japan International Cooperation Agency (JICA) has availed grant to carry out the feasibility study for the proposed new bridge and that the Consultants (Oriental Consultants Co. Ltd and Japanese Engineering Consultants Co. Ltd) commenced the study in November 2008 and are expected to complete by November 2009. More so, the Consultant has already submitted an inception report which was to form the basis of the forum's discussions

Eng. Kimeze Ssebugga's introductory remarks reiterated the Government of Uganda's prioritization of the Northern corridor route which is an economic life line of Uganda.

Eng. Ssebugga informed members that the Government of Japan through its Japan International Cooperation Agency (JICA) has availed a grant to carry out a feasibility study for the proposed new bridge, and was also ready to consider financing the detailed design and construction of the bridge suing a 30 + 10 year grace period loan from the Japan Bank for International Development (JBIC).

2. Background and Objectives of the Study

A presentation on the background and objectives of the study was made by Eng. David Luyimbazi the Director of Planning Uganda National Roads Authority. The presentation focused on the following

- Location of current Nalubale bridge
- Background to existing bridge- Dam Managed by ESKOM, bridge managed by UNRA
- Construction/maintenance history of existing bridge
- Existing Bridge Condition- Piers are in poor condition as bridge built over 50 years ago
- Axle loading- Cumulative loading has exceeded bridge design loading
- Traffic Levels- Traffic is 9500 vehicles per day, projected to rise to 11,500 by 2010
- Strategic concerns- Considered risky to have only one crossing for River Nile
- Strategic Plans- Emergency repairs to bridge in FY 2008/9 to give addition 5 to 10 year service life and construct new bridge to guarantee unrestricted traffic movement of goods and people on Northern corridor route.
- Justification for 2nd Bridge- New bridge cost is far less than economic consequence of closure of current bridge.

The expected output of the study is a recommendation to the Government of Uganda on viability, alignment, cost and implementation modalities' for a new bridge. Feasibility Study is scheduled for completion by September 2009, Detailed Design is scheduled for completion by September 2010, and construction is expected to commence in February 2011 and completion is February 2015.

3. The Feasibility Study Presentation

The presentation of the feasibility study was undertaken by Dr Masaaki Tatsumi, the Deputy Team Leader. The presentation focused on the following

- Objectives of the study- To conduct feasibility study on construction of new bridge across the River Nile, and to transfer relevant skills to Ugandans involved in the study.
- JICA Study Team- Some of the team members are already in Uganda and the rest are still in Japan. There are 18 members on the team and 12 are already in Uganda.

- Study Area- is the direct influence area of the proposed bridge in Jinja and also as whole Uganda and its neighboring countries.
- Basic Technical Approach:
 - (i) A Traffic demand forecasting considered routes in Kenya and Tanzania. A 24 hour traffic survey is also scheduled for Monday 15 December 2008 survey in Jinja to provide information on traffic levels and volumes at various points leading to the proposed bridge sites.
 - (ii) Study of alternative bridge locations and structure types. This would also involve the timing of public consultations and the next consultation on optimal location is scheduled for March 2009.
 - (iii) Bridge Locations- 3 locations have been considered namely Location A, B and C. Locations A and B were identified during a World Bank funded prefeasibility study in 2005 whilst Location C was identified by the Infrastructure Development Institute of Japan. At each of the locations, various key control points were considered including hotels, airport, and military installations.
 - (iv) Comparison of Alternative Bridge Types- 3 bridge types were considered.
 - (v) Assessment of Project Feasibility considering regional social economic impacts, covered 3 regions, i.e. Northern Corridor, Uganda, and surrounding areas of the new Nile bridge.
 - (vi) Early realization of the project- This covered funding methods (ODA loan from Japan Government), Public Private Partnerships, Toll Collections and operation and maintenance plan.
 - (vii) Assistance for information disclosure- This covered participation of various stakeholders to reach basic agreement on an optimum bridge plan. JICA would support UNRA in encouraging support of stakeholders. JICA guidelines for Environmental and Social Considerations to be considered.
 - (viii) Technical Transfer- On the job training for bridge planning and environmental/social considerations.
 - (ix) Workschedule of the study- Study to run from November 2008 to October 2009.

4. Workshop Break

Following completion of the various presentations, the moderator Eng. Ssebugga called for a 20 minute tea break. Members were asked to reconvene at 11am in readiness for the Question and Answer (Q&A) session. The workshop reconvened at 11am and Eng. Ssebugga informed members that Eng. David Luyimbazi had to attend another important meeting in Entebbe and could not be part of the session. At this point Eng Geroge Bwanga (Project Manager UNRA) and Mr Jonathan Tugume (Monitoring & Evaluation Officer UNRA) were requested to join the moderator's table and take part in providing responses to questions from the floor.

5. Question and Answer Session

Stake Holder Name: Brigadier Arch T Sabiti (Commander Engineering Brigade)

Organization- MOD/UPDF

Comments

- Extended vote of thanks for the invitation
- Jinja is a good location and has the best planned town in Uganda. The bridge will increase on the beauty. As the new bridge would enhance industrialization, so will the population and congestion in Jinja also increase in future.
- Specific comments on each of the proposed bridge location as follows
 - Location A
 - (i) Appears to be shortest but bridge design is not cheap.
 - (ii) Socially it will not distract many people.
 - Location B
 - (i) Appears rather complicated with sharp bends at western end not too comfortable
 - (ii) Big gradients and escarpments so it would be expensive to construct the roads
 - (iii) Alignment leads to further congestion particularly as it crosses the railway bridges twice
 - (iv) Current Railway Bridge is old and due for overhaul with many collapsing components. Invariably the new bridge crossing would require provision of similarly new railway crossing bridges.
 - (v) Oil pipe line would cross the alignment
 - (vi) Social amenities like the Golf course would be affected, along with local
 - Location C
 - (i) Cheapest option however the spans look bigger
 - (ii) Simple design passing near Nile Resort Hotel and also brings traffic to the Resort Hotel.
 - (iii) Compensation to nationals to alleviate poverty

- (iv) Open up Jinja more and divert traffic from the main centre to the North of Jinja.
- (v) Passes near Kimaka military Academy (Being developed into Strategic Planning University)
- (vi) Military establishment would need noise barriers on Western side of Kimaka.
- (vii) Can the project consider the construction of a foot bridge linking the Western and Eastern campus.
- (viii) On the whole this is the best location.
- Individual proposal as follows:
 - (i) The proposal to build a new bridge crossing has been long overdue as the current bridge is exhibiting cracks and its design life is nearing exhaustion
 - (ii) Not a good idea to locate 2 strategic bridges in one area, as war, terrorism or other acts could easily destroy both bridges.
 - (iii) There are many rapids Northwards and other bridge crossing could be considered in places like Bulamuti to Kayunga. This could potentially reduce travel time and enable traffic avoid Jinja, thereby allowing Jinja to develop freely, and also open up other parts of the country under Poverty Alleviation Action Plan (PEAP).
 - (iv) Project team to involve more of Uganda professionals, Strategic Planners and Military personnel in the location selection and designs of the new bridge.

Response by Eng. Ssebugga

- Eng. Ssebugga thanked Brig Sabiti for his comments and requested that these comments are provided in writing, as they provide deep insight into the locations and planning stages for the new bridge.
- Further considerations to be made by the Study Team in light of observations on the merits of each route

Comments

- Noted that pedestrians and cyclist have had many accidents at the old bridge and the new bridge design should prioritize safety for pedestrians and cyclists.
- Project team to provide plans for accident reduction eg dual carriageway, wide single carriageways etc.
- Economic benefits of the identified locations needs to be assessed along with other constraints e.g. transport costs
- Put consideration for guard rails to safe guards vehicles from plunging into the river
- Have various political parties been involved?

Response by Eng. Ssebugga

- Eng. Ssebugga requested that the study team consider these proposals in the project preparation and design.
 - The bridge will be a dual carriageway in line with the development plan for the Northern Corridor.
 - More consultations to be held in the Project area, Jinja.

Comments

- Still very early to go into the details of the design.
- Proposal to look into Kayunga is not an alternative as Jinja needs to be looked at in its own right.
- Brig. Sabiti's consultations should cover wider colleagues the military establishment so that a single position is obtained from the military
- Compensation and disruption should be limited as much as possible
- Timing of consultations is not appropriate as the second consultation is proposed for March/April 2009, by which time the selection of alternative locations has taken place. As such there will be no public input into the selection process.
- Study team to coordinate with Land use planners nationally and also Jinja Municipal Council particularly on their physical plan. The Jinja Physical Plan will be presented to Jinja Municipal Planners on 16 December 2008.

- Eng. Ssebugga requested that the study team consider these proposals in the project preparation and design, and also the 2nd consultation should be held before the selection of the optimal location of the new bridge.
- Consultations between all stakeholders should be undertaken.

Response by Brig. Sabiti

- The meeting is to give guidance and thereof members are free to air proposals.

Comments

- Need to agree on problem definition ie is a new bridge needed, should the bridge be in Jinja, what are the benefits of improving traffic flow and road condition on Northern Corridor Route.
- Need to establish if aesthetic appearance of the bridge or technical performance of the bridge takes precedence. In Uganda basic requirement is for the bridge to carry traffic and loads safely, and aesthetic appearance is a secondary benefit
- Need maintenance regime and plan in place.
- Project management, sponsoring teams, counterpart staff have not been clearly defined.
- The JICA team need to follow the regulation regarding practicing engineering in Uganda and need to be registered by Engineers Registration Board.
- Wanted clarification on why members have been invited to this meeting
- What was the actual traffic composition crossing the bridge? Is all the traffic Jinja bound, and what improvements to other road sections are needed to handle the generated traffic volumes

Response by Eng. Ssebugga

- Eng. Ssebugga requested that the study team work hand in hand with the relevant authorities in Uganda to ensure that the points above are addressed.
- The maintenance plan to be included in the final study report.
- Eng. Ssebugga pointed out that the meeting was called for consultations and exchange of ideas and opinions in relation to the bridge crossing.
- Consultations have just begin and other consultations are expected as the project progresses.

Comments

- The Government of Uganda (GOU) input to the project needs to be clearly defined.
- This project is essentially a bypass around Jinja and it would be a topical issue in light of the current issues concerning bypasses in Uganda.
- There is a good road net work in Jinja and areas like Bukedi, Teso and evidence needs to be provided that existing road ways have been explored
- Government of Uganda is planning to dual various roads like Kampala- Entebbe, Kampala-Jinja. To what extents are the plans for the new bridge synchronized with the proposed dualling of various roads.
- Have access roads, residential estates, airfields and military installations been studied to assess how they impact on the bridge proposals
- UNRA to give opinions on the road connections
- Jinja Municipal Council has not been involved in this consultative meeting and yet many roads within Jinja may need re designing as a result of these proposals

- Eng. Ssebugga agreed that bypasses can actually lead to road safety issues as a result of people migrating from towns to come and conduct businesses along bypasses. Need due protection from local authorities to avert this problem.
 - The consultant reiterated that road approaches are part of the project scope

- The old bridge is not planned to be closed, as it still serves as a Hydro Electric Power dam
- Members are free to request for information on this project from UNRA.

6. Response from JICA Team to points raised:

- (i) Some of the issues that have been identified by the stakeholders cannot be solved within the scope of the project. However discussions will be on going with UNRA to see how best to address the issues identified.
- (ii) On the issue of the 4th route proposal (Kayunga- Bulamuti) crossing, it will be difficult to consider this under the scope of the current study. At this point Eng Ssebuuga reiterated that it be put on record that participants consider that a new bridge crossing be funded under using other sources not necessarily JICA.

7. Response from Eng George Bwanga to points raised:

- (i) On the 4th route issue, UNRA is taking this seriously and this could be covered under different arrangements. The current project came up as a result of discussions with Government of Uganda, Government of Japan and other donors. Government of Japan showed commitment to funding the study and UNRA prepared the Terms of Reference and scope of works which were bilaterally agreed. Having come this far, it would now be difficult to amend the terms of reference as new issues could arise.
- (ii) On the steering committee membership members have been drawn from UNRA, Jinja Municipal Council, NEMA, Ministry of Lands and Urban Development, Ministry of Water and Environment, JICA (Uganda Team). Project workplan, deliverables are discussed at the meetings and comments and suggestions on improvements are made at the steering committee meetings.
- (iii) Choice of options for bridge location would depend on economic and technical appraisals.

- (iv) Local Ugandan consultants have been involved in various aspects of the project, eg M&E Associates, KAGGA and Partners .Local consultants are being procured to carry out the Environmental Impact Assessments, and Resettlement Action Plans.
- (v) On the issue of noise barriers and over head footbridges, the Environmental Impact Assessment team will be moving from house to house to establish the environmental needs and devise mitigation measures
- (vi) On the issue of accidents, the designs will incorporate the highest international safety standards
- (vii) On the issue of practicing licenses, the JICA team will be asked to adhere to the Uganda Engineer's Registration Board regulations.
- (viii) On other planned developments in Jinja, the Mott MacDonald prefeasibility study report of 2005 recommended the setting on an inland port at Jinja to be developed by private financiers.
- (ix) On the issue of road tolling, it should be noted that tolling is one of the funding mechanisms identified. Other funding routes are also to be assessed.
- (x) On the issue of academic institutions being omitted, the stake holder list will be reviewed and invitation extended accordingly.
- (xi) On the statement made by one of the stake holders that the current bridge is "risky", this statement is not correct and can cause panic within the general public. It should be noted that the bridge has exceeded its design life, but still has a residual life.
- (xii) On the issue of fast tracking construction, it should be noted that Government of Uganda discussed with Government of Japan and drew up a schedule for key milestones and procurement of works. It will be difficult for these milestones to change. A construction completion of 2015 would also be highly optimistic.

Concluding Remarks

Eng Ssebuuga thanks members for coming to share views and provide opinions at the^{1st} Public Consultation Meeting for Feasibility Study on a new Bridge across River Nile at Jinja. He informed them that UNRA is available for onward transmission of any more information to the Study team towards a successful feasibility study. He recognized that all the participants had showed need for the new bridge. He promised that the Study team would avail soft copies of the presentation to those who needed the detailed proposals.

The Northern Corridor route that runs parallel to the northern shore of Lake Victoria from the District of Kabale in the west to the District of Busia on the Kenya border is one of Uganda's main transport arteries and is part of Uganda's strategic link to the Port of Mombasa, Kenya. In addition, it links Uganda's neighbouring countries of Rwanda, Burundi and the eastern part of the Democratic Republic of Congo to the Indian Ocean.

This main artery crosses the Nile at Jinja as a Class 1 Road that was built on and as part of the construction of the Nalubaale Dam (formerly Owen Falls Dam). Construction of the Owen Falls Dam commenced in the 1940s and was commissioned in 1954. In addition to carrying the road, the dam houses Uganda's primary and strategic source of electricity.

With regard to the Nalubaale crossing, it has now been established that:

- Both the volumes and loadings on the bridge have increased at a faster rate than anticipated in the previous forecasts.
- The bridge/dam structural deck elements are over-stressed and piers show significant scouring; and
- The bridge structure and the dam, now past their design life, can no longer safely carry the prevailing load in the medium to long term considerations.

In this connection, construction of a new bridge is the only solution that would address the long term transportation needs of the country and its neighbouring regions.

In pursuit of the above solution, the Government of Uganda has obtained assistance from the Japanese Government (through JICA) towards the feasibility study and design of a proposed second bridge across River Nile at Jinja. It is for this purpose that the following are invited to the first Focus Group Discussion meeting which will take place on Friday, 6th March 2009 at Crested Crane Hotel, Jinja.
