Focus Group Discussion for Feasibility Study on a new Bridge across River Nile at Jinja

1. **Opening Prayer:** Opening prayer by Ayebale Pamela Land Acquisition Specialist Uganda National Roads authority (UNRA)

2. **Introductory Remarks**

The meeting was opened at 10:30am by Eng. A.D. Mugisa the Commissioner for Roads Ministry of Works and Transport (MOWT). In his remarks, the participants were welcomed to the Focus Group Discussion for the Feasibility Study of the new Bridge across river Nile at Jinja.

They were informed that about the JICA Guidelines for Environmental and Social Considerations which emphasize Democratic decision-making as an essential requirement. The Participants were informed that Stakeholder participation, Information Transparency, Accountability and Efficiency and Respect for human rights were critical for such decision-making process. He informed the participants that Information disclosure through public consultations is one of the integral parts of the basic principle of the Guidelines and the Bridge would be planned, designed and constructed such that it is not a source of inconvenience to inhabitants hence the need to take account of inputs from public consultations.

Eng Mugisa informed members that more than 90 people attended the 1st public consultation held in Kampala on December 12, 2008 whose Major objectives were: To introduce outline of the Project and the Study, to explain schedule of the JICA Study and the public consultations, to share all related information with stakeholders.

He said the 2nd public consultation would be held on April 3rd 2009 after Optimum Alternative Bridge Location has been selected which Results would be explained at this public consultation. There will then be an exchange of opinions which will enable the basic agreement on the optimum route for the bridge. The 3rd public consultation will be held at end of July to disclose information on the results of the Feasibility Study.

He informed the members that the objective of the Focus Group Discussion was purposely for the local stakeholders that might potentially be affected by the Project especially those that did not attend the 1st public consultation, The Focus Group Discussion was intended to inform such local stakeholders

about progress of the preliminary study and share information with them before the 2nd public consultation in which the basic agreement on the optimum route for the bridge would be established.

3. The Preliminary Study Results Presentation by JICA Study Team Explanation of Alternative Alignments by Route (A, B & C)

The presentation of the feasibility study was undertaken by Dr Masaaki Tatsumi, the Deputy Team Leader. The presentation focused on the following

- Background and Policy on New – Design life for the existing Nalubaale Dam Bridge has expired, Traffic demand is increasing, Urgent necessity to construct a New Nile bridge was widely agreed as the government policy and in response to the request of Government of Uganda, Government of Japan through JICA dispatched the Study Team to conduct the Feasibility Study in November 2008.
- Objectives of the study - To conduct feasibility study on construction of new bridge across the River Nile and to Transfer relevant skills to Ugandans involved in the study.
- Basic Plan of Bridge Locations with Proposed Three (3) Routes, Work Schedule of the Study and Projected increasing Traffic were Presented. The Study Team suggested the following: All motorized vehicles should use the new bridge but not use the existing dam bridge, Bicycles are allowed to pass the existing bridge in order to avoid the mixed use of motorized and non-motorized traffic on the new bridge, and Pedestrians are allowed to pass either the new or existing bridge. Pedestrian facility should be provided on the new bridge.
- Explanation of the Alternative Routes

The Preliminary Comparison of Alternative Routes was presented based on the following: Local Development Issues, Accessibility (between Jinja and Njeru), Involuntary Resettlement, Roadside Environment, Natural Environment and Construction cost (including maintenance cost)

- Characteristics of the alternative routes based on future development potential were presented by Mr. Yasukawa, the member of JICA team.

4. Environmental & Social Considerations for the Project by UNRA

The presentation of the Environmental and Social Impact Assessment (ESIA) for the Feasibility for Constructing the Second Bridge at the Nile in Jinja was undertaken by Patrick Kamanda, the Environment Specialist Uganda National Roads Authority (UNRA). The presentation focused on the following:

Mr. Patrick Kamanda the Environment Specialist Uganda National Roads Authority (UNRA) informed the Participants that the Requirement for Environmental Impact Assessment (EIA) all major Road developments such as the proposed bridge construction across the River Nile at Jinja is listed in the

Third Schedule as required to undergo the EIA process under Section 19 of the National Environment Act Cap 153.

He further informed members that the GOU is responsible for the preparation of the environmental and social impact process including constituting the ESIA study team and obtaining approval of the environmental aspects of the bridge project.

Mr. Patrick Kamanda went ahead to explain what the Environmental and Social Impact Assessment (ESIA) means and the Purpose of ESIA for the Nile Bridge Works which include: Inform the selection of optimum alignment by route, Examine in details the environmental feasibility of the selected optimum solution for the project, Inform implementation of construction activities to ensure short and long-term environmental sustainability.

He also informed the members about the Technical Transfer for the Project with a counterpart EIA consultancy team already having been constituted to work with JICA Study Team. He informed the members that in the process of undertaking the EIA, JICA would transfer relevant skills to personnel in the counterpart Study team to up lift the standard of ESIA's. Technologies/ equipment used during the study i.e. for air quality analysis, noise/ vibrations and global warming studies would also be retained by UNRA. JICA has procured the noise survey equipment and Plans are underway for JICA to undertake a series of technical transfer training sessions on noise determination and analysis to the ESIA team and selected lead agencies.

Mr. Patrick Kamanda further informed the members that ESIA would be conducted in line with the Guidelines for EIA in Uganda and JICA Environmental and Social considerations.

He stated that the Process for Conduct of the EIA will be carried out through Public Consultations of which the 1st Public Consultation (P/C) was conducted in Kampala involving stakeholders and the 2nd Public Consultation which was happening that day on the 6th March 2009 at the project site was to obtain input leading to the selection of the optimum solution out of the three alternative routes. Based on the selected optimum solution, a detailed ESIA will be conducted. Upon Conclusion of the ESIA, a final Public Consultation will be undertaken in Jinja. The Purpose of Public Consultation therefore was to obtain as much information as possible and comments leading to select the optimum solution which should be studied in details to develop ESIS that reflects input of stakeholders.

The Environmental and Social Impact Statement (ESIS) would include following;

- Baseline environmental and social economics information, Valuations and determination of the least cost option environmentally, Selection of optimum solution, detailed environmental, social and economic assessment, Proposal of mitigation measures, Environmental and Social Management Plan, Costing of the Management and Monitoring Plan.

The Study Team comprises of the following;

- ESIA Specialist – Team Leader, Plant Ecologist, Zoologist, Sociologist, Geologist/Hydrologist, Aquatic/Fisheries Specialist, Environmental Economist

5. Land Acquisition and Compensation System applied for the Project by UNRA

The presentation of the Land Acquisition Process and Compensation System for the Feasibility for Constructing the Second Bridge at the Nile in Jinja was undertaken by Ayebare Pamela the Land Acquisition Specialist Uganda National Roads Authority (UNRA). The presentation focused on the following:

Legal framework – Ms Pamela Ayebare the Land Acquisition Specialist Uganda National Roads Authority (UNRA) informed the members about the laws that govern land Acquisition in Uganda which included the Constitution of Uganda 1995, the Land Act CAP 227, 1998, the Land Acquisition Act CAP 226,1965, the Registration of Titles Act CAP 230, 1924 and the Roads Act 358,1949.

Procedures – She further informed the participants of the procedures of land acquisition in Uganda as follows; Initial Assessment, Valuation, Compensation Payment and Expropriation of land.

Compensation entitlements – Ms Pamela informed the participants that the Non-permanent assets would be compensated based on district rates, land would be valued at local market prices, Buildings would be valued at depreciated market prices and a Disturbance allowance would be paid as percentage of total compensation for those given a notice to vacate the property as follows; 15% if less than 6 months notice and 30% if less than 3 months notice. She informed members that the government Chief Valuer is in charge of approving the rates used and compensation to owners and / or occupiers depends on tenure system. Payment of compensation fees requires evidence of eligibility for example Land title, Leasehold Contract, Certificate of Ownership/Occupancy etc

Community consultations – she informed the participants that during Initial assessment notice will be given on intent to access land for survey and intent to acquire land, Village level meetings will be held to raise awareness, explain the procedures in detail and also to discuss the compensation strategy as well as allow communities raise any concerns relating to land acquisition. She also stated that interaction between surveyors and land owners/occupiers would be encouraged to identify land and assets likely to be affected. There will also be meetings with Local governments to assess the current market prices. During valuation Ms Pamela Ayebare the Land Acquisition Specialist Uganda National Roads Authority (UNRA) stated surveyors would be consulted to ensure accurate recording of land and assets description. She further stated that Village meetings would have a formal Valuation assessment and Formal inquiry into claims and objections, Grievances and Appeals should be submitted within 60days of the Valuation assessment.

Status of this Project - she concluded by saying there was still need to decide on the preferred location of the bridge and that the preliminary assessment of land acquisition would be used to help decide on the bridge location, once the bridge location and approach road alignment was known, initial assessment would be started, and promised that all compensation payments for planned land acquisition would be made before construction works start (in phases if appropriate)

6. Tea Break

Following completion of the various presentations, the moderator Eng. A.O. Mugisa called for a 20 minute tea break. Members were asked to reconvene at 12am in readiness for the Questionnaires on Evaluation Method session as well as Question and Answer (Q&A) session. The workshop reconvened at 12am and Eng. Mugisa informed members of the arrival of for Minister of Energy and now NRM Chief Whip Hon. Daudi Megereko. At this point Eng Mugisa invited every body to introduce themselves as courtesy requires after which he invited the JICA Study Team for the Questionnaires on Evaluation Method session.

7. Questionnaires on Evaluation Method

Questionnaires were then handed to the participants to fill in. After which the questionnaires were handed back to the JICA Study team, the results of the scoring was to be used as a reference to realize the stakeholders' priority in selecting alternatives.

8. Question and Answer Session

At this point Eng George Bwanga (Project Manager UNRA), Mr. Patrick Kamanda (Environment Specialist UNRA), Ms Pamela Ayebare (Land Acquisition Specialist UNRA) and Dr Masakai Tatsumi, (Deputy Team Leader JICA) were requested to join the moderator's table and take part in providing responses to questions from the floor.

9. Response from JICA Team to points raised:

- (i) On the concern about the effect of Construction works on the raw water source and the Levels of water at the Nalubale dam, the Deputy Leader of the study team assured Participants that there would be no effect since the water source is up stream and the water flows downstream stream.

10. Response from Eng George Bwanga to points raised:

- a) On how soon the construction of the bridge would start, Eng Bwanga explained that the Feasibility study was expected to end by October 2009, after which the Detailed Engineering Design would start in December 2009 to April 2010 and if funds are availed in time Construction works would commence by 2011 to 2014 for the simplest design of the bridge.
- b) On the whether the bridge would be single or Dual carriage way, Eng Bwanga pointed out that the bridge was planned to be a dual carriageway.

11. Response from Pamela Ayebale to points raised:

- a) On the issue of planned investments and Electricity Transmission lines along Route C, Pamela Ayebare informed the Participants that the reason they were invited was to make contributions that would lead to the final selection of the optimum Route, therefore their concerns would be taken into account during that process.
- b) On the concern about how much compensation would be received by Nytil/picfare, she reassured them that Nytil would not be Over compensated nor would it be under compensated, in the event that the final route selection affected their property then they would be dually compensated before construction of the Bridge kicked off.

12. Response from Patrick Kamanda to points raised:

- a) On the concern about the long term effects on constructing a bridge on Route C, Mr. Patrick Kamanda informed the participants that before selection of the final optimum route Detailed Environmental and Social Impact assessment had to be carried out whose findings would help guide the team in the final route selection, therefore those fears should be put to rest.
- b) He also informed the stakeholders that more consultations were to continue on the local and Village levels i.e. with District environmental officers e.t.c in order to make sure that all issues from the stakeholders are covered.

- c) Mr. Kamanda also assured members that construction the contractor would be checked on to make sure that Environmental and Social Issues are dealt with thoroughly this calmed the fears raised that during the Construction some of the Environmental and Social concerns would be neglected by the contractor.

- d) He then thanked all participants for their contributions and was glad that all pertinent issues had come out in this focus group discussion this therefore had armed him to take on the consultants.


Concluding Remarks

Eng Bwanga thanked members for coming to share views and provide opinions at the focus Group Meeting for the Feasibility Study on a new Bridge across River Nile at Jinja and was glad that the Discussion had achieved its objectives. He informed the participants that their contributions were of great importance and would be considered in the final Route selected. He then wished them a safe journey to their various Destinations.

The meeting was brought to a close at 1:30pm, upon which members were invited for lunch.

2nd Public Consultation for the Feasibility Study on a New Bridge across River Nile at Jinja

1. Introductory Remarks

After a short prayer, the Chairman the Steering Committee Dr. A O Mugisa requested all the participants to introduce themselves after which he called the meeting to order.

In his remarks, the participants were welcomed to the 2nd Public Consultation for the Feasibility Study of the new Bridge across river Nile at Sheraton Hotel Kampala.

He then highlighted the objectives, significance and the benefits of the Public Consultations, the role of the Steering Committee, the Focus Group Discussion and the Environment Impact Assessment to both The Government of Uganda and The Government of Japan, as further elaborated in the presentation handout attached herewith **(Annex-2)**

2. Remarks by the chief Representative JICA Uganda

The Chief Representative of JICA Uganda Office Mr. Tetsuo SEKI thanked the Government of Uganda represented by UNRA for the Cooperation and assistance accorded to the eighteen (18) Japanese Consultants who constitute the Study Team. He was optimistic that the Study which started in November 2008 will be completed on schedule in October 2009. He informed the meeting that the Government of Japan made a strong commitment towards infrastructure development in Africa.

He underscored the importance of the bridge towards the social economic development of Uganda and her neighboring landlocked countries.

He informed the meeting that the Study was at a critical point and the results of the Consultations would go along way to the commencement of the Preliminary Design.

He said JICA was waiting for the results of the Study Team for further discussions.

He was optimistic that the Government of Japan would finance the bridge.

He finally wished participants fruitful deliberations.

3. Environmental & Social Considerations for the Project by UNRA and COWI Uganda

The presentation of the Environmental and Social Impact Assessment (ESIA) for the Feasibility for Constructing the Second Bridge at the Nile in Jinja was undertaken by Patrick Kamanda, the Environment Specialist Uganda National Roads Authority (UNRA).

Mr. Kamanda informed Participants that it is a legal requirement by the Government of Uganda and a prerequisite by the Government of Japan to have an ESIA due to the size of the project (Bridge). He also thanked the Study Team for the ongoing Transfer of Technical Skills and was optimistic that an ESIA Statement would be ready in time. He made further clarifications as indicated in his presentation herewith attached (**Annex 3**).

4. Land Acquisition and Compensation System applied for the Project by UNRA

The presentation of the Land Acquisition Process and Compensation System for the Feasibility for Constructing the Second Bridge at the Nile in Jinja was undertaken by Ayebare Pamela the Land Acquisition Specialist Uganda National Roads Authority (UNRA). Ms Pamela Ayebare informed Participants that for whichever Alignment chosen, there will be need to relocate some properties in the process of acquiring land for the approach roads. She then made the presentation covering the Legal, procedural, entitlements and consultations on land acquisition as reflected in **Annex- 4** herewith attached.

5. Selection of Optimum Solution to Cross River Nile at Jinja by JICA Study Team

The team leader Mr. Isamu Gunji gave a brief history of the feasibility study. He informed the meeting that the study was formulated by the IDI of Japan in 1992 and in 1999 when it identified the current route c as shown in the presentation (Annex 5). This was later followed by another study by the World Bank in 2005 which identified the current proposed routes A and B.

The two pre-investment studies form the basis of the current feasibility study financed by the government of Japan whose findings so far are reflected in the attached presentation **Annex- 5**.

6. Tea Break

Following completion of the various presentations, the moderator Eng. A.O. Mugisa called for a 20 minute tea break. Members were asked to reconvene at 11:30 in readiness for the Question and Answer

(Q&A) session. The workshop reconvened at 11:35 and at this point Eng Mugisa invited questions from the Participants.

7. Question and Answer Session

Stake Holder Name: Brigadier Timothy Sabiiti – Engineer Brigade Commander

Organization: Ministry of Defence/UPDF

Comments

- He thanked the Government of Japan for having considered construction of a new bridge across R. Nile as early as 17 years ago.
- He wanted to know why the alignment A2 had been recommended by the Study Team.
- He advised that while much of the land along route C belonged to the Military, choosing that route would also enable the developments by the Military.
- He said that route A would increase congestion in Jinja.
- He requested for mitigation measures on noise to the school when route C is chosen.

Response by JICA Team Leader Mr. Isamu Gunji

- Alignment A2 was recommended because of the advantage of utilizing the island on the western bank while A1 was dropped because of the need to construct two piers in the water to support the longer bridge.
- While the development of the Airstrip which will necessitate expansion of the aerodrome by 1000 meters would require the relocation of the approach road along route C. This was also constrained by the hilly terrain along this route which would further increase construction costs.

- Valuation is a process which must be done carefully and this usually takes time but nevertheless effort will be taken to expedite this process. In the unlikely event, it is common practice for Government to have an updated valuation if it has taken a long time.
- The significance of the local leaders is to help in identifying the bonafide owners and in the event a property has squatters on it, they will take 30% of the value and the land title owner takes 70%.
- On the speculative property buyers, members were informed that there will be a General Government Order immediately the Optimum Alignment is approved. The local leadership is requested to be vigilant.

- The old bridge has a life time of five more years and if the construction is delayed, won't there be a big problem.

Response by Eng. Ssebugga Kimeze, Director Operations UNRA

- No one has confirmed the residual life of the bridge as five years. Emergency repairs are starting soon and there should not be so much fears. Nevertheless, efforts will be made to construct the bridge in time to avoid such a mishap.

8. Concluding Remarks

The Director Of Operations in UNRA Eng Ssebugga B. Kimezze informed the participants that the Executive Director was in Western Uganda with the Minister of Works and Transport on routine work. He was optimistic that the big number of participants that attended the first and this second Public Consultation who all supported having a new bridge across R. Nile was a sign that the need was real and urgent.

He informed the meeting that the Government of Uganda had prioritized the New Bridge to relieve the existing one of the increased traffic volumes. He said that a new bridge would enhance reliability of the Northern Corridor which serves landlocked countries of Uganda, Sudan, Rwanda, Burundi and Eastern Democratic Republic of Congo.

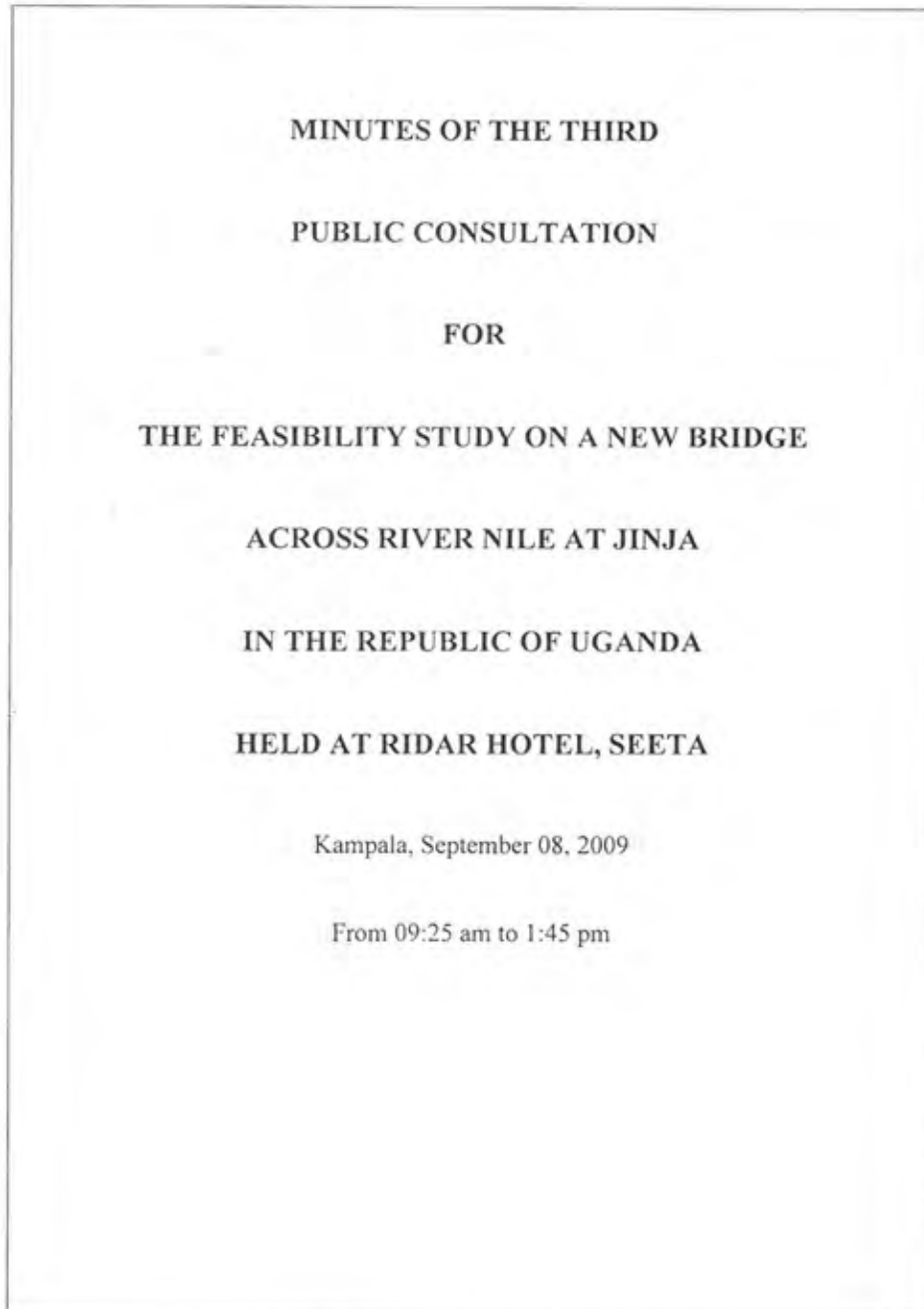
He reiterated that the project of this magnitude (more than \$50 million warrants wide and sufficient consultations, the reason why several have been planned and are being executed.

MINUTE 1 COMMUNICATION FROM THE CHAIR

After a self introduction by all participants, Eng Orach A Aloysius informed the meeting that Dr A O Mugisa was away on official duty and that he had been delegated to preside over the Public Consultation. He reminded the participants that Public Consultations were a very integral part of the Project and that the views presented in the earlier Consultations had been captured in the Draft Final Report. He assured the participants that any pending issues and those raised in this meeting will be captured in the Final Report or resolved during the Detailed Design. He then invited the JICA Study Team to present their findings.

MINUTE 2; PRESENTATION BY THE JICA STUDY TEAM

The Team Leader Mr. Gunji Isamu made the presentation to the meeting with illustrations herewith attached as Annexure 2.

MINUTE 3: PRESENTATION BY COWI ON ESIA/RAP

Mr. N Omagor, the COWI Team Leader jointly with Mr. B Ochola and Mr. Mungati made the presentation on the ESIA and the RAP with illustrations attached herewith as annexure 3.

4.1 QUESTION AND ANSWER SESSION

Item 4.11 Eng A Orach of Ministry of Works and Transport requested COWI to provide handouts of their presentation

Item 4.12 Mr. S Kagiri of Bugiri community Development Youth project asked about the procedure of compensation of the land owners who do not have titles.

Response: Mr. Paul Mungati of COWI informed the meeting that there was no Kibanja owner along the project road. All persons have land titles

Item 4.13 Mr. E Kamugisha of Naminya, Njeru asked whether compensation for the Psycho-social effects has been planned. **Mr. A Yussuf, the Director of IGAR** petrol station also wondered when compensation of the loss in their sales would be considered.

Response: Mr. P Mungati of COWI informed the meeting that if a person is injuriously affected then the psycho-social support would be considered. This would also be the case with IGAR when the access to the petrol station is closed. He advised that injurious compensation is considered only when the injury has occurred. This would only occur after the project is completed and proof is ascertainable.

Item 4.14 Mr. Jossy Nuwabaine from the Media, OKLAMS Co. Ltd, wanted to know why route C had not been chosen. **Mr. Ochola**, an exporter was concerned that route C would decrease traffic congestion in Jinja.

Response: Mr. I Gunji, Mr. N Omagor and Eng R Taitika informed the meeting that the choice of route A had been substantially discussed and agreed in both the Steering and Technical Committees of the Project. The factors discussed included the constraints raised with the expansion of the Jinja airfield, the length of the approach roads, the Kimaka forest reserve, the location of the military facilities among others. All these were not in favor of Route C. Further illustrations with the presentation materials were referred to which justified Route A to be the optimum solution.

Item 4.15 Mr. A Bisiika of Uganda Media Centre was concerned about the effects of the bridge construction on the climate

Response: Mr. Isamu GUNJI, the Team Leader informed the meeting that with the dual carriage way at the new bridge, traffic congestion will be greatly reduced which will result in decreased carbon dioxide emission at the bridge.

Item 4.16 Mr. Ngomtek Linos, a media activist asked if the traditional healers had been consulted during the ESIA.

Response: Mr. B Ochola of COWI informed the meeting that sufficient search for the traditional healers had been carried out but none was identified.

Item 4.17 Mr. Okiror Iporotum, the Chief Administrative officer of Jinja was worried about the delay in compensating the property owners rendering a loss in value for the money that is finally given to them. This was also shared by **Mr. M Mukuru** of UETCL and the **Mr. A Yussuf** of IGAR petrol station.

Response: Ms Pamela, the Land Acquisition Specialist at UNRA assured the meeting that preliminary work on compensation had started with valuation of the affected properties. The report would then be submitted to the Chief Government valuer for approval and consideration in the national budget for next financial year. Mr. P Mungati also indicated that the usual practice is that if the value has been overtaken by time, there can be a revaluation. Eng A Orach of Ministry of Works and Transport further informed the meeting that this issue had been discussed exhaustively in the Steering Committee of which the Ministry of Finance is a member, with a view of a timely and fair compensation.

Item 4.18 Ms H S Meeme, the Physical Planner for Njeru Town Council was concerned about the omission of complimentary projects for Njeru while several had been listed for Jinja. She proposed a road side fish market in Njeru. **Mr. I Okiror**, the CAO for Jinja also highlighted that Jinja referral hospital had been omitted from the list of the health facilities.

Response: Mr. B Ochola and Mr. N Omagor of COWI informed the meeting that complimentary initiatives should be requested for in writing and that the Town Council community in consultation with UNRA should also prepare to make some contribution.

COWI promised to include the referral hospital in the final report.

Item 4.19 Mr. A Yussuf of IGAR petrol station and Mr. Odeeba, a Secretary for works in Njeru Town Council were concerned about utilization of residual land.

Response: Mr. P Mungati of COWI informed the meeting that the utilization of the residual land / property is usually assessed on a case by case basis and full compensation considered when the portion can not be meaningfully utilized.
