It is an honour for me to have the opportunity to address Laos-ASEAN-Japan International Cooperation Agency (JICA) Inception Workshop today which is jointly organized by the Ministry of Foreign Affairs of the Lao PDR, ASEAN Secretariat and JICA.

On behalf of the Lao Government, I would like to extend my warmest welcome to all of you present here, and, in particular, the representatives of the ASEAN Secretariat and JICA to this workshop and to Vientiane.

The Lao PDR is the landlocked and less developed country in Southeast Asia which is a bottleneck to hindering the economic and social development of the country to a great extent and given that ASEAN has committed to establishing an ASEAN Community by 2015 which is about 5 years from now, the Lao PDR is faced with a huge challenge. This challenge unless addressed in a timely manner will further widen the development gap among ASEAN Member States

which, in turn, will continue to be the main obstacle to the realization to ASEAN's efforts to establish an ASEAN Community in 2015. But with the country's strategic location in the Mekong Sub-Region, the Lao Government has adopted a policy to turn the disadvantageous landlocked into a land-linked country to connect with our immediate neighbouring countries of which the implementation of this project requires huge amount of resources. With limited resources at its disposal, it will be extremely difficult for the Lao PDR to realize the objective of turning the Lao PDR into a land-linked country. It is, therefore, timely that JICA and the ASEAN Secretariat have lent their helping hands to support and assist the Lao PDR in its endeavour to integrate itself into the region by choosing the Lao PDR as a Pilot Program under the tripartite cooperation framework between the Lao PDR, ASEAN Secretariat and JICA.

With the concept of "Laos, the Cleanest Country in the world", this pilot program will be unique in nature since there was no program of this nature was implemented before, and if successfully implemented, it will, no doubt, contribute to promote sustainable while economic development preserving and protecting the environment. It will also further enhance trade and investment cooperation between Japan and Laos, in particular, and Japan and ASEAN in general. In this context, the Government of the Lao PDR attaches importance to the Pilot Program. It is expected that the success of the program will, to a some extent, help to make the Lao PDR a land-linked country, thereby, supporting and facilitating the ASEAN Free Trade Area (AFTA) and the ASEAN Single Market and also help to bridge the development gap and allow the Lao PDR to

participate effectively in the ASEAN activities and as a result, gaining benefits from its membership in ASEAN.

Ladies and Gentlemen,

We are now witnessing yet another rapid changes taking place in the world which include the global financial and economic crisis of an unprecedented magnitude and scale, natural disasters, the outbreak of infectious diseases, and so forth. These have considerable negative impacts on the economic growth and development of developing and developed countries alike. These challenges continue to impede efforts by developing countries to attain greater economic development and social progress.

ASEAN is now trying to establish its community by the year 2015. One of the greatest challenges to ASEAN community building is the necessity to "Narrow the Development Gap" between old and new ASEAN Member States. The acceleration of ASEAN Community building by 2015 and the challenges development have posed difficulties to ASEAN, especially new Member States to overcome all challenges and fulfill their objectives of integrating with other ASEAN Member States and the region in the short period of about 5 years. Therefore, it is in this context that Japan's role in supporting and assisting the Lao PDR and ASEAN in sub-regional, bilateral as well as tripartite frameworks is of great importance.

The Inception Workshop today is timely and significant as it will provide an opportunity for us to discuss and identify what areas of development cooperation. I have been informed that the Workshop will also discuss the vision, basic concept, strategic study, methods and schedule of the Laos Pilot Program, while stressing that the program should not duplicate the existing projects between Lao PDR and JICA and reflects the real needs of the Lao PDR. In addition, I would like to suggest that the "Strategy for Narrowing the Development Gap in the Context of the Lao PDR" is one of the components of the Laos Pilot Program which should be carried out in parallel with the implementation of the other projects under the Pilot Program.

On behalf of the Lao Government, I would like to reiterate our firm commitment and readiness to cooperate with JICA and ASEAN Secretariat to fulfill the objectives and implement the program successfully. I hope that this Pilot Program will help Lao PDR to overcome challenges as well as to accelerate the integration of Lao PDR into ASEAN.

In conclusion, I would like to take this opportunity to express my sincere thanks to the Government of Japan and ASEAN Secretariat for supporting this program and I am confident that with active participation from all of you, the workshop will be crowned with success and may I now declare the workshop officially opened.


