

- The number of members decreased due to personal reasons (illness of the member her/himself and/or family members, have to take care of grandchildren, etc.) and the production capacity became lower.

- The present members may be possible to continue their activities; however, the number of the CBO is too small to continue and expand their activities.
- AO was cooperative and attended number of events, where could learn about OVOP Movement principles and concept. Then, AO invited the CBO twice for fairs in Karakol. ©©

- The CBO made a presentation in the village to share their experiences to increase the number of members, inviting villagers and AO (Mar 2010). Though nobody have joined the CBO activities so far yet, this action proves the wishes and intention of the CBO to expand their activities.
- Utilizing the savings gained from sales of products, the CBO started informal micro credit to lend money to the villagers who do not have access to credit with lower interests than ordinal credit agency.





3. EVALUATION

Organizational Development:

- ➤ Organization of the CBO has been fragile due to lack of management skill and passive attitude of members. Income was shared when they had enough sales to share, however, the explanation on payment was not clear sometimes and anxiety and distrust came up from the members.
- Accounting record was kept with instruction from J-CEP, but still not accurate enough to run the business.

Capacity Development regarding Production and Sales

- ➤ Considering the failure of marketing of dry apples, the CBO is trying to improve their products in a way of changing packages, making different products such as apricot pastila and dry fruits tea and so on. ③⑤⑤
- ➤ Quality control should be paid attention more carefully; especially the timing and the way of packaging, considering the fact that quite a few defects were found. ②③③
- ➤ The CBO understands the importance of planning. However, the CBO plans without taking account of their marketing experiences in the previous season, which may cause business risks. ⊗⊗⊗
- The CBO is making efforts to develop markets by themselves such as negotiating with Rayon for possibility of sales at Rayon resort area and Kumtor mining company, however, PR and finding connection with the markets where tourists visit is not yet possible. ③⑤

Sustainability

- The CBO learned the importance of producing the products matching to the market needs, which can be a foundation of running business. On the other hand, planning, quality control and financial management should be further improved.
- ➤ In order to expand the production, it is necessary to increase the number of members. ⊗⊗
- AO attended number of events, where could learn about OVOP Movement principles and concept. ©

- Particular impact has not been observed so far yet.
- The leader plays several important roles in the village, such as representative of health committee. It is expected that she can be the core person to enlighten the villagers with the OVOP Movement, sharing their experiences.





The extraordinary session of the Joint Steering Committee for the JICA supported Community Empowerment Project in the Issyk-Kul Oblast has been held to discuss on the Inception Report and other issues at the outset of the Project operations in Issyk-Kul. The member representing the Issyk-Kul Development Forum has not been nominated yet, and the discussions have been made among the participants from the Oblast State Administration, Project Implementation Unit (PIU), Rayon representatives, and JICA representatives.

Major point of the discussions and resolutions are summarized in the following.

- 1. At the opening of the JSC, Governor, Mr. Isaev emphasized the importance of the activization at the community level to attain the development strategies of the Oblast, and expressed his hopes that the PIU and JICA Expert Team would jointly work for successful implementation of the Project and that the cooperation would last for a long period. JICA Resident Representative appreciated the cooperation of the Oblast and emphasized the point that the Project should be implemented at the initiative of the Oblast Administration and the PIU.
- 2. The PIU Project Manager outlined the program envisaged for the execution of the Project during Phases 1 and 2. He noted that the Phase 2 operations would be subject to the successful consolidation of the operational systems and the PIU during the Phase 1. JICA Expert Team Leader outlined the Inception Report, with

particular attention to the alternative approaches to the Community Empowerment Project and the suggested approach with the "One Village One Product" (OVOP) together with the social/livelihood improvement programs at the villages selected for the OVOP operation.

- 3. Through discussion among the participants, it has been basically agreed that the suggested approach with the OVOP and social/livelihood improvement is acceptable to the Joint Steering Committee (JSC). It has also been agreed that the applicability of this approach would be jointly reviewed at the time of the JSC scheduled towards the end of the Phase 1 operation or in October 2007.
- 4. The programs for the Pre-Pilot Project to be executed during the Phase 1 have also been reviewed. The JSC members agreed to the suggested programs with the herb cultivation and processing, as well as with the social/livelihood improvement. The PIU and JICA Expert Team will immediately proceed to the selection of villages and formulation of the programs for execution.
- 5. The JICA Team requested Tup and Ak-Suu Rayon Administration to recommend the villages appropriate for the pre-pilot project operations by the end of this month so that one village in each Rayon could be selected.
- 6. The PIU Project Manager explained the status of PIU members and requested JICA for support in the assignment of Coordinator and Assistants for the execution of the Pre-Pilot Project during the Phase 1. The JICA side took note of this request, expressing that JICA would arrange for it as the Kyrgyz budget for 2007 had already been prepared and the additional budgetary arrangement might be difficult.
- 7. The PIU Project Manager also requested JICA for support in the market survey of the potential products to be taken up under the OVOP operations. The JICA side took note of this request, expressing that JICA would additionally earmark a small fund for the requested market survey. The survey would first be made on herb, and it would be expanded to other products identified in the later part of the Phase 1.
- 8. The PIU requested JICA for training in Japan as stipulated in the Record of Discussions (R/D) in August 2006. The JICA Team noted that the Governor's initiative to the OVOP and activation of communities would be of prime importance,

and that the Team would convey the request to JICA Headquarters so that the training program would be realized in or around May 2007.

- 9. The Governor reiterated that, though it is a hard task to obtain a budget for the Project operations in 2008 and 2009, he would try his best to earmark the budget either from the central government or from the Oblast budget.
- 10. Although it has been scheduled that the next session of the JSC will be held in or around October 2007 to review the achievements during the Phase 1 and to decide whether the Project would proceed to the Phase 2, the Governor requested the JICA Team to convene more frequently and discuss on the progress and issues of the Project. The JICA Team welcomed the Governor's proposal to meet and discuss more often.

2-2-2 Implementation of Pre-pilot Project

Pre-pilot Projects promoting herb productions are implemented in two communities, Shaty village and Sary-Dobo village. The major activities undertaken until the end of August 2007 were 1) selection of pre-pilot villages, 2) herb market research, 3) baseline survey, 4) organizing the calendula producers group, 5) herb seeds arrangement and distribution, 6)technical and marketing guidance, 7) trial of solar drying facility, 8) training/workshop for community empowerment, 9) trial of new herb species. Details are shown in the Progress Report (No.1).

2-2-3 Review of results of Pre-pilot Project and strengthening the implementation system

Although the Pre-pilot Projects have not been completed yet, PIU and JICA Experts reviewed the current conditions around the Project, and has considered measures for strengthening the implementation system.

2-2-4 Preparation of the OVOP Potential Map

The OVOP Potential Map has been prepared in the Project frame in order to grasp information on locally available products and resources which have potentials for processing at the village level to increase their value and competitiveness in both domestic and external markets.

Although it was not considered at the existing PDM, in the process of the Phase I, this activity has been added to the Project, based on the suggestion made by JICA Experts.

According to the Oblast State Administration, it was difficult to assign a full-time counterpart mainly due to the change in budgetary system of the government.

(c) Allocation of necessary budget by the Issyk-Kul Oblast State Administration

The budget for the implementation of the Project has not been arranged yet. The Issyk-Kul Oblast State Administration is seriously trying to cope with this problem, e.g., they sent a request letter to the Ministry of Finance to allocate to the Project a small amount of the counterpart fund of the Japanese Grants.

(d) Frequency of various meetings such as Steering Committee, Development Forum, etc.

The extraordinary session of JSC was held on January 24, 2007. Four participants from the Issyk-Kul Oblast State Administration including the Governor and five from the Japanese side including the Resident Representative of the JICA Kyrgyz Republic Office attended the session.

Regarding the Issyk-Kul Development Forum, its consolidation was withheld and networking of the stakeholders was mainly undertaken.

The PIU Weekly Meeting was commenced at the end of March, 2007 as the place to discuss the progress and problems of the Pre-pilot Project. The meeting has been held 20 times as of September10.

4. Evaluation Result of Phase I

With the effort by the PIU and JICA Experts, the concept of the Project and its method based on the OVOP Movement is shared and understood widely, not only among stakeholders in the Issyk-Kul Oblast but in central authorities. The OVOP Potential Map developed during the Phase I shows that the Issyk-Kul Oblast has large potential for the promotion of the OVOP Movement. Although it is not adequate to demonstrate the effectiveness of the OVOP Movement only by the result of 6-month Pre-pilot Project, the community empowerment through the OVOP Movement seems to have enough possibilities to be applicable to the Kyrgyz Republic.

On the other hand, in the changing process of local governmental and financial system, it is becoming more difficult to strengthen the implementation system for the Project only by the Issyk-Kul Oblast State Administration itself, concerning budget and personnel. To improve the sustainability of the Project, the support from central ministries would be highly necessary.

5. Conclusion based on the evaluation of Phase I

The concept of the Project, community empowerment with the OVOP Movement, is becoming shared and understood by stakeholders not only in the Issyk-Kul Oblast but in central authorities. Although we need further examination on effectiveness and applicability of the OVOP Movement, it can be concluded that the Project may proceed to the Phase II, executing the pilot projects in the Issyk-Kul Oblast.

To proceed to the Phase II, however, the implementation system needs to be more strengthened and be more supported by the central authorities. The Team suggests the Kyrgyz side making further efforts to strengthen the institutional setting and financial support as suggested in the following section 6.

6. Measures for Phase II

The implementation system for the Project has not been totally strengthened as expected during the Phase I period, mainly due to changing process of local governmental and financial system. To implement the Phase II successively, some countermeasures for strengthening the implementation system is indispensable with supports from central authorities, especially from the MoEDT.

JICA suggested the Kyrgyz side to take following measures:

- (1) Measures to be taken by the Issyk-Kul Oblast State Administration
- a) Assignment of PIU members

One of the PIU members would be a full-time counterpart for the Project.

b) Budget arrangement for pilot projects

The Issyk-Kul Oblast State Administration will take actions to request central authorities for necessary budget for pilot projects.

(2) Measures to be requested to the MoEDT and other ministries

c) Supporting system to the OVOP Movement by the MoEDT

The MoEDT will be requested to assign an appropriate person as the member of the JSC for the Project (See Annex 1).

d) Budgetary support to the OVOP Movement

Arrangement of budget for implementation of pilot projects during Phase II will be requested to ministries concerned to the OVOP Movement.

Issyk-Kul Oblast State Administration requested JICA to take following measures:

,(1) Assighment of the Coordinator

Due to the administrative and financial changes in the government structure, Issyk-Kul Oblast State Administration had some difficulties in assignment of full-time PIU members, and requested JICA to assign additional Coordinator in JICA Expert Team for smooth coordination between Issyk-Kul Oblast State Administration and JICA Expert Team.

(2) Additional Training Course

Considering the successful results of the "One Village One Product" training course in Japan, the Issyk-Kul Oblast State Administration requested JICA to arrange additional training courses for other administrative staffs at the oblast and rayon levels in Japan or other countries which are implementing the OVOP Movement successfully.

7. Revision of PDM

Through the discussions of the Inception Report, both the Kyrgyz side and the Japanese side decided to initiate the OVOP Movement as the main tool for community empowerment.

Strong support from central authorities is indispensable for successive implementation of the Phase II under the circumstances of the reform of local governmental and financial system.

Considering above mentioned points, both sides tentatively agreed to revise the original PDM (PDM Ver.1) as shown in Annex 1 into as the PDM Ver.2 shown in Annex 2. Major changes of the narrative summary are shown in the table below. The details of the objectively verifiable indicators, means of verification and important assumptions for the revised PDM would be further defined at the beginning of the Phase II.

Major points of the discussions and resolutions are summarized as follows:

- 1) JSC was opened with the opening remarks by Mr. Alyshbaev, the Project Director on behalf of the Governor, Mr. Isaev. He stated his confidence in achieving the above mentioned goals during discussion.
- 2) A message from the Resident Representative of JICA Kyrgyz Republic Office was presented by Ms. Niidome to the participants. It contained (i) J-CEP aims not only to income generation but also to develop capacity of people to be able to live with local potentials, (ii) in course of promotion of OVOP Movement under J-CEP activities, JICA office also makes efforts to assist it by suggesting necessary support for opening small business to related government agencies, and (iii) the model of business based on community would be a good precedent for challenges which are undertaken by central government and would streamline the process of adoption of new laws and regulations.
- 3) After JICA Expert Team Leader outlined the strategy for J-CEP, overall pilot project plan and progress of pilot project, it was requested to pay attention to the strategy on distributing the result of research on required procedures for starting community based business, which require long process, time and costs. The strategy of J-CEP was generally agreed by the participants, and especially heads of Local Self Government agreed with the strategy to disseminate the lessons learned regarding technical barriers to opening community-based business which directly connected with the challenges of central government.
- 4) Further, JICA Expert Team Leader expressed his gratitude toward Issyk-Kul Oblast State Administration (OSA)'s efforts on organizing Karakol Student Research Center (KSRC) in collaboration with Institute of Economy and Management of the Issyk-Kul University. It was confirmed that the KSRC will play one of the important roles at operation of the Pilot Project. Regarding Bishkek Antenna Shop, Mr. Alyshbaev mentioned that OSA in the name of Governor will request Bishkek Mayor Office to provide a premise or land plot in Bishkek. In connection with this, he addressed to representative of JICA in KR, MoEDT branch and J-CEP to achieve this goal under collaboration of four sides.
- 5) The revision of Project Design Matrix (PDM) was explained by JICA Expert Team member, and it was agreed by the participants (refer to the attachment). The major modification is to add the activities regarding opening Karakol Student Research Shop and Bishkek Antenna Shop, which were not included in the PDM (ver.2). To the question of the head of Oktyabrskoe Aiyl Okmotu on possibility to provide necessary equipment, Ms. Okata explained J-CEP's strategy for provision of the inputs to pilot villages.
- 6) The Project Director mentioned about Micro Credit Agency under OSA, which will support pilot communities by giving a credit under simplified conditions. The head of Keregetashskiy AO also pointed out that they are ready to provide resource which AO has for communities in demand. In addition, JICA Expert Team Leader evaluated, especially, support of Saruu AO head in providing premise, although jamaat decided to use their own detached house for dry fruits production at the end.

- 7) JICA Expert Team Leader confirmed the changes of PIU members after November 2007. According to mutual decision of PIU and JICA Expert Team, Mr. Ibraev B. was appointed as a PM in view of resigning of Mr. Imanaliev A.; and Mr. Kalchaev A. as one of PIU member. Other members and the Project Director are remained without changes.

The Progress Report (No.3) which presents the above issues was submitted to the Issyk-Kul Oblast State Administration by the JICA Expert Team before opening the Joint Steering Committee, and it was accepted and agreed by all JSC members by the end of meeting.

Major points of the discussions and resolutions are summarized as follows:

- 1) JSC was opened with the opening remarks by Mr. Alyshbaev, the Project Director, on behalf of the Governor, Mr. Isaev. He expressed his appreciation for the cooperation of local self governments, which contributed to lead the great achievement of the pilot villages /communities in the first year.
- 2) Mr. Haraguchi gave a speech on behalf of the Resident Representative of JICA Kyrgyz Republic Office. He stated that the achievement so far was highly appreciated and active discussion on any concerns for project implementation is expected during the JSC meeting.
- 3) After JICA Expert Team Leader outlined the progress of pilot project, a sustainable implementation system for Community Empowerment with OVOP Movement, which includes the idea of opening new department for community empowerment, was proposed and the discussion was opened.
- 4) The Project Director stated that the proposed system for community empowerment with OVOP Movement, which includes the idea of opening a new department consisting of various specialists, is manageable under OSA utilizing existing human resource. Marketing issue will be a little challenging under OSA, however, it could be solved by establishing relationships with concerning agencies.
- 5) JICA Expert Team confirmed the availability of a particular section or department which deals with community empowerment with OVOP Movement in Rayon and AO. It was explained by the Project Director that AO has an economy department, which is responsible for these issues. In addition, it was explained that in both Rayon and AO, it is possible to organize PIU kind of unites appointing various specialists from concerning departments or sections including the department that deals with social mobilization.
- 6) The Project Director mentioned that he would request to JICA for further cooperation to develop OVOP Movement especially on the budget issue for sustainability when mid-term evaluation mission comes in June.
- 7) Importance of marketing was remarked by Jeti-Oguz Rayon First vice Akim and several AO heads. The Project Director and Jeti-Oguz Rayon First vice Akim commented that the market should not be limited to tourist or wealthy population, but rather consider targeting local residents as well to enlarge market. Increasing the variety of products must be also helpful for expanding their sales activities.
- 8) Some AO heads explained the constrains on low productivity of pilot communities, giving examples such as limited number of members in CBO, hard work for collecting berries, and so forth.
- 9) Jeti-Oguz Rayon First vice Akim raised the issue how the concerning government agencies together with JICA can continuously assist communities in order to keep their motivation for the work, by pointing out the current situation of limited volume of production and sales of pilot communities which may decrease their incentive.

- 10) It was explained by JICA Expert Team that pilot communities and J-CEP is aware of the issue of marketing, and accordingly, the action plans for the second year have been improved considering the lessons learned. Although the amount of sales seem not huge, pilot CBOs have expressed that they are satisfied with the results in general, which still keeps them continuing their work for the second year.
- 11) The Project Director thanked JICA in arranging the study tours to Japan. He mentioned the possibility for AO heads to participate in the tour organized this year, in case if productive support for OVOP Movement is confirmed. It would be valuable for the AO heads who are directly involved in the Movement to learn more about OVOP Movement in order to expand the Movement in the Issyk-Kul region.

 - J-CEP will request Kyrgyz side to introduce and/or provide places where OVOP products will be displayed and sold on trial.
 - J-CEP will request Kyrgyz side to make an official request to Issyk-Kul State University to continuously assist the OVOP Movement including KSRS.
- 4) All the participants basically understood the proposed measures of the JICA Consultation Survey Mission, although the Project Director commented that further discussion among the Kyrgyz side would be necessary for establishment of the system for approval of Issyk-Kul brand products.

- 3) Mr. Haraguchi also emphasized the importance of utilization of the guideline which will be finalized by the JICA Expert Team by the end of July 2010. He expected that the Issyk-Kul Oblast will be a leading Oblast of the OVOP Movement in Kyrgyzstan. The final version of the guideline should be distributed to wider population so as to expand the Movement.
- 4) Following the speech made by Mr. Haraguchi, JICA Expert Team Leader, Mr. Ishizuka outlined the contents of Progress Report (No. 4) including (i) progress of pilot projects, (ii) recommendation of the JICA consultation survey held in August 2009, (iii) creation of Issyk-Kul Brand, (iv) KSRS activities, and (v) the concept of the OVOP Movement for further expansion toward community empowerment and regional development. Regarding the above (ii), Mr. Ishizuka emphasized that a revision of PDM (Project Design Matrix) is under consideration, and the result of revision will be explained to Kyrgyz side. In his presentation, Mr. Ishizuka requested Kyrgyz side (i) to appoint one PIU member for the vacant position, and (ii) to share the updated information on government structure reform.
- 5) Explanation on the contents of Draft Guideline was continued by Mr. Ishizuka. After the explanation, he requested the participants to give comments on Draft Guideline until the end of January 2010. He added that given comments will be examined thoroughly together with the PIU members and reflected in the final version.
- 6) Mr. Alyshbaev appreciated the work of JICA Expert Team, which is not only about assistance to the pilot CBOs, but also making the practical guideline which is useful for the stakeholders for the OVOP Movement promotion as well as for learning how to open community based business. He strongly recommended for the participants to read through Draft Guideline and give comments so as to make it as much as useful.
- 7) Mr. Akyshbaev also appreciated the JICA's technical cooperation for biogas facility installation which is undertaken in the Issyk-Kul region.

During official closing of JSC, the Project Director expressed his gratitude to the representative from JICA Kyrgyz Office and participants, and requested to collaborate for successful implementation till the end of the project, and to further discuss what we should do for the

OVOP Movement promotion toward regional development in the Joint Seminar to be held on December 4th.
