The minutes of meeting have been prepared to confirm the points agreed upon between the authorities concerned of the Government of the Republic of Kenya and Japan International Cooperation Agency, in order to change the Scope of Work of the Preparatory Survey for Integrated Solid Waste Management in Nairobi City in the Republic of Kenya (hereinafter referred to as "the Survey") agreed on 6<sup>th</sup> August 2009.

## 1. Original of Scope of Work in Terms of Survey Area

Both sides confirmed the survey area in the original Scope of Work agreed on 6<sup>th</sup> August 2009 as "The Survey will cover the whole area of Nairobi City as shown in the attached Annex 1."

#### 2. New Scope of Work in Terms of Survey Area

Both sides agreed that the survey area in the original Scope of Work agreed on 6<sup>th</sup> August 2009 was changed to "The Survey will cover the whole area of Nairobi City as shown in the attached Annex 2 which includes six (6) landfill candidate sites outside of Nairobi City."

#### 3. Reason of the Necessity of Defining the New Scope of Work

Both sides confirmed the reason of the necessity of defining the new Scope of Work as follows:

3-1. Necessity to consider two options regarding construction of final disposal sites We should consider two options in terms of construction of final disposal sites as follows in order to attain high feasibility of Master Plan.

Option1: Landfill site at Ruai

Option2: Landfill sites at Ruai and the other candidate site

3-2. Necessity to consider the possibility of candidate sites outside Nairobi City

As a result of the screening in the course of the Survey so far, it is obviously realized that there are no suitable landfill sites in Nairobi City except Ruai. Therefore, it is required to consider the other alternative sites outside of Nairobi City additionally in order to secure technical viability.

#### 4. Detailed Survey Items under the New Scope of Work

Both sides confirmed that the following detailed survey items should be added after screening the candidate sites showing Annex 2 under the new Scope of Work:

#### 4-1. Site Reconnaissance

The site reconnaissance will be carried out to examine natural and social environmental conditions of the site.

#### 4-2. Site Screening

The candidate sites will be screened in terms of the following criteria:

- Authenticity regarding reserve areas or national parks
- Jurisdiction of military authorities
- · Status of land tenure or land ownership
- Volume of candidate site as final disposal
- Geological and hydrological situation
- · Historical land use and future land use plan

· Accessibility to existing transportation and future transportation plan

#### 4-3. Initial Environmental Examination

The Initial Environmental Examination for the candidate sites after the above screening will be carried out in accordance with JICA guidelines for environmental and social considerations.

## 4-4. Project Cost Estimation

Project cost will be estimated in consideration of the additional candidate sites after screening for the purpose of master plan formulation.

## 4-5. Evaluation of Technical Alternatives

Technical alternatives including the additional candidate sites will be evaluated and compared in terms of technical, financial, environmental and socioeconomic points of view.



Annex 1: Location of the Original Survey Area Annex 2: Location of the New Survey Area



Map of the Survey area




Floore 3.1: Land you map of Mairob

#### 1. INTRODUCTION

In accordance with Scope of Work for the Preparatory Survey for Integrated Solid Waste Management in Nairobi City in the Republic of Kenya (hereinafter referred to as "the Survey") agreed upon between the Office of the Deputy Prime Minister and Ministry of Local Government and Japan International Cooperation Agency (hereinafter referred to as "JICA") on 6 August, 2009, JICA dispatched a Preparatory Survey Team to Nairobi. The JICA Survey Team, headed by Mr. Masakazu Maeda, and composed of members from CTI Engineering International Co., Ltd. and NJS Consultants Co., Ltd., has carried out the Survey in Nairobi and Japan since November 2009.

The JICA Survey Team has prepared a Draft Final Report that presents all the results of the Survey and analysis conducted during the Survey.

The JICA Survey Team submitted twenty (20) copies of the Draft Final Report to the Department of Environment, the City Council of Nairobi on 13 July 2010. The meeting on the Draft Final Report was held on the 23 July 2010 at the conference room of Cianda House, Ministry of Local Government. The participants are listed in Annex-I.

The meeting was chaired by Mr. Victor Ogutu, Assistant Director of Urban Development Department, the Office of the Deputy Prime Minister and the Ministry of Local Government, who welcomed the members of the Steering Committee and the JICA Survey Team and all the other participants. A brief self-introduction was conducted at first.

#### 4. BRIEFING ON THE CONTENTS OF THE DRAFT FINAL REPORT

The Draft Final Reports have been distributed to the Kenyan side and the JICA Survey Team would like to have comments on the reports. The major points of the discussions on the Draft Final Report are summarised below while the contents of the reports were accepted in principle.

#### i Kayole site

It was confirmed that Kayole site is illegal dumpsite and should not be used any more.

#### ii. Comments in the Seminar

It was agreed that all comments in the Seminar held on 14<sup>th</sup> of July 2010 should be incorporated into the Final Report.

## iii. Medical Waste

Mr. Longolomoi of the Ministry of Public Health and Sanitation (MoPHS) mentioned that the technical working group of medical waste is being facilitated by the MoPHS, and centralised disposal of the medical waste is considered. It was confirmed, however, that the JICA Survey did not formulate the master plan of medical waste management because that it was not in their scope of work.

## iv. Reports to be Open to the Public

It was confirmed that the Kenyan side agreed to make the reports open to the public in order to achieve maximum use of the Survey results.

## v. Comments on the Draft Final Report

It was agreed that Mr. Muraya of the City Council of Nairobi will receive comments on the Draft Final Report from the other members and send the comments to Mr. Ogutu, Chairperson of the Steering Committee, and Mr. Maeda of the JICA Survey Team by 31 July 2010 after compilation of all comments by the other related agencies.

# 5. PREPARATORY ACTION FOR THE IMPLEMENTATION OF THE MASTER PLAN

Mr. Maeda explained the preparatory actions for implementation of the master plan (see Annex-3), and the following issues were discussed and confirmed.

i Commitment by the Kenyan Government

It was confirmed that JICA headquarters felt that a strong commitment by the Government of Kenya on establishment of Solid Waste Management Public Cooperation (SWMPC) was required for the next stage of implementation at least.

Mr. Muraya mentioned that the Department of Environment has reported officially the progress and outputs of the Survey results including the establishment of SWMPC so far and the Council has already approved the Survey.

It was agreed that commitment by CCN should be made first and the Minister of Local Government would be endorsed it accordingly.

ii. Priority 1: Setting Up Preparatory Unit for SWMPC in the Department of Environment

It was agreed that all actions under the Priority 1 should be carried out.

iii. Priority 2: Preparation of Construction of New Sanitary Landfill Site and Closure of Dandora Dumpsite

Ms. Wamai of the Ministry of Environment and Mineral Resources reported that the budget of the implementation of these two EIAs was already secured under the Nairobi River Basin Rehabilitation Programme.

It was confirmed that CCN should initiate the preparation of the implementation in consultation of the Ministry of Environment and Mineral Resources and NEMA. It was also confirmed that the TOR of EIAs was included in the Section G of Data Book in the Draft Final Report, and Mr. Maeda would send the soft copy of the TOR to CCN, the Ministry of Environment and Mineral Resources and the Chairperson of the Steering Committee.

iv. Priority 3: Preparation for Creation of SWM Special Account

It was agreed that PA-3-1 should be deleted because that this action was duplicated in the Priority 1.

It was agreed that PA-3-4 and PA-3-5 should be deleted because that there was no need to transfer the current SWM budget to the Special account and legalisation of the SWM special account.

v. Priority 4: Preparation for Drafting the By-law for the Establishment of SWMPC

It was agreed that the Office of the Deputy Prime Minister and the Ministry of Local Government should carry out this action.

It was agreed that "drafting the By-law" should be replaced to "drafting the Act".

It was agreed that "reviewing Water Act 2002" should be replaced to "reviewing EMCA 1999".

Mr. Ngugi of JICA Kenya Office mentioned that the Seminar on 14<sup>th</sup> of July was successfully done with many stakeholders.

# **Preparatory Actions for Implementation of the Master Plan** by Middle of 2011 to be Completed by the Department of Environment

## Priority 1: Setting up Preparatory Unit (PU) for SWM Public Corporation (SWMPC) in the Department of Environment (DoE): S-4-1

- + SWMPC should be established by the beginning of 2015 for starting the operation from the beginning of 2016. One-year preparation period will be required for the tendering process by SWMPC after its establishment. The Preparatory Unit for SWMPC should be urgently established inside the DoE.
- + The detailed concept for the organisational structure for the Preparatory Unit is recommended in the Section B of the Supporting Report of the JICA Master Plan Final Report.
- + The preparatory unit will be the target of the proposed Comprehensive Capacity Development Programme (CCDP).
- + To initiate the CCDP, the following actions are required to be carried out:
  - ▶ PA-1-1: Selection of 3 Unit Managers and 13 Sub-Unit Chiefs in accordance with the JICA Master Plan Final Report
  - ▶ PA-1-2: Selection of Staff of Each Unit
  - ▶ PA-1-3: Setting up the office (The Office for the JICA Survey Team is recommend to be utilised for the office of the Preparatory Unit.)
  - ▶ PA-1-4: Official Declaration of Setting-up the Preparatory Unit
  - ▶ PA-1-5: Formulation of the Detailed Job Description of Staff of the Preparatory Unit in accordance with the Recommendations by the JICA Master Plan Final Report
  - ▶ PA-1-6: Preparation of Provision of Incentives for Additional Tasks for the Selected Unit Managers, Chiefs and Staff
  - ▶ PA-1-7: Application of the Budget of the Preparatory Unit for the Financial Year 2012
