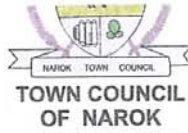

SPECIAL CONDITIONS:

1. No building shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by Local Authority (Council). The Local Authority shall not give approval unless it is satisfied that the proposals are as such to develop the land adequately and satisfactorily.
2. The lessee shall maintain good substantial repair and condition all the buildings at any time erected on the land.
3. The building shall not cover more than _____ per centum of the area of the land or lesser area as may be laid down by the Local Authority in its by-laws.
4. The land shall not be used for the purpose of any trade, business, which the Local Authority considers to be dangerous or offensive.
5. The lessee shall not sub-divide the land without prior consent in writing of the Town Council, the Director of physical planning and the commissioner of Lands.
6. The lessee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof or any building thereon except with prior consent in writing of the Town Council. No application for such consent (except in respect of the loan required for building purposes) will be considered until special conditions No.2 has been performed.

Members agreed that the Town Treasurer to check Council Accounts and pay staff before going for Christmas.


It was agreed that in the previous meeting that Kshs. 50,000/= from ward projects votes be used to pay loan deductions for the Councillors.




