Supplementary Training on Education:

Africans Learn Japanese - Method "Lesson Study" from Indonesian Schools

UPI is a national university focusing on the education of candidate teachers and educators. Its Mathematics and Science Faculty building was developed through Japan's Grant Aid, while two JICA Technical Cooperation Projects (TCPs) were implemented by UPI to help improve the particular school-subject in the junior secondary level. It has been hosting supplementary training for JICA's trainings on lesson-study in Japan.



Around 100 countries of the world affirmed their commitment to achieving "Education for All (EFA) by the year 2015" during the "World Education Forum" held in Dakar (Senegal) in 2000. In order to achieve that, effective and viable education policies are indispensable for developing

education in each of the countries. However, the access and quality of education in the African region has been especially lagging compared with other regions; mostly due to the weak capacities in terms of, among others, policy making and education planning. Therefore, improvement of education administration system has been an urgent issue for Africa. Yet, cooperation with higher education institutions is still rare, whereas it is important to get input from researchers for such improvement of education policies.

As a means to support basic education development in Africa, JICA has been providing a training course in Japan focused on research-based policy formulation in the education sector. The purpose of the training course is to study and share the approaches taken through the implementation of feasible researches and making of action plans. It utilizes the government-university network built through the previous training course, which was more focused on the promotion of independent researches and dialogues between Ministries of Education and universities in Africa.

One of the expected outputs of the trainings - held in cooperation with the Center for the Study of International Cooperation in Education (CICE), Hiroshima University (Japan) - was the increase of understanding of the African participants by learning from Asian country(s)'s experiences and knowledge. The Asian country selected to host the supplementary trainings was Indonesia, as it has a long history of cooperation with Japan (JICA) for the improvement of education, especially Science and Math at the junior secondary level through Technical Cooperation Projects (TCP) of "IMSTEP" (1998-2005) and "SISSTEMS" (2006-2008).

The two TCPs, implemented by the Indonesia University of Education (UPI) with the supervision of the Ministry of National

UPI's sustainability in developing the "Lesson Study" outside the initial pilot project site in Sumedang Regency (West Java) is the main reason it was chosen to host the supplementary trainings. If initially it involved four junior high schools and dozens of teachers (Science and Math), now "Lesson Study" has been developed in five other municipalities/regencies, involving hundreds of schools and thousands of teachers (Science and Math, Indonesian Language, and English).

to formulize final revisions and shared with other teachers.

It is interesting to note that UPI has also been independently collaborating with the Hiroshima University as well as other 26 universities from 18 African and Asian countries through the "Africa-Asia University Dialogue for Educational Development." The forum acts as a means for sharing and learning experiences in developing education.

Personnel from three countries, i.e. Ethiopia, Burkina Faso, and Botswana, have participated in the two supplementary trainings. The participants are mostly senior staffs or researchers involved in education policy making and education planning. During the supplementary trainings - held before the main trainings in Japan - UPI facilitated their dialogues with Indonesia's central and local government officials as well as UPI's lecturers and students, conducting observation of "Lesson Study" implementation in several regencies. The participants also found through the trainings that UPI facilitates nearly a hundred of its lecturers to collaborate with teachers in Sumedang. The supplementary training impressed them with Indonesia's endeavor to high-quality education, gave them new ideas on their curriculum development, and inspired them to include "Lesson Study" in education policy making of their respective countries.

Supplementary Training on Climate Change:

Learning Forest Management in the Middle of Borneo





Carbon emission reduction has been one of the key issues of countries around the world to address climate change. To reduce carbon emission, one must first have adequate capacity in forest management. As a mean to increase

the capacity of developing countries, including in conducting their own researches and obtaining respective data, JICA in cooperation with the Ehime University (Japan) and the Center for International Cooperation in Management of Tropical Peatland (CIMTROP) of the Palangkaraya University (Indonesia) implemented a training course in mid 2010. The course was held both in Japan and Indonesia to learn about Japan's technology, experience, and knowledge as well as experiencing Indonesia's real forest conditions, and gain practical skills on forest carbon counting and reforestation. As many as 8 people with backgrounds of researchers, policy makers related to forest resources management from 5 countries (Kenya, Laos, Papua New Guinea, Paraguay, and Vietnam) joined the course. The training agenda in Indonesia included the practice and observation of reforestation efforts and tree volume measurement method of peat swamp forest in Central Kalimantan Province on the island of Borneo (Kalimantan). Moreover, the participants had the chance to present their own country's forest status and efforts at an international seminar on "Sustainable Bio-Resources for Global Welfare" in Bali as a means to enhance their communication skill and networking.
