TYPICAL DESIGN SECTION -ROAD 3.0m

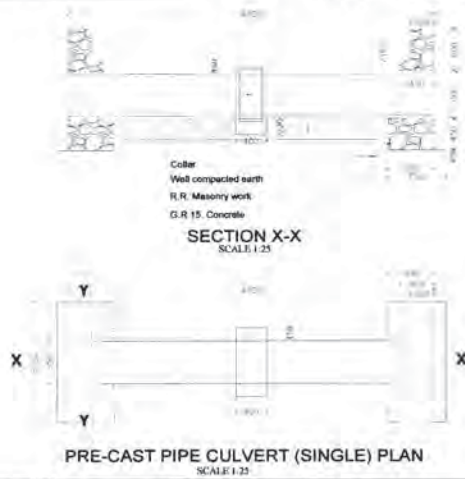
