1. Purpose

The purpose of this program funded and supported by JICA is to disseminate the effectiveness of preventive medical care system through medical checkup in Myanmar by Sanshikai, the experienced Japanese hospitals and medical checkup clinics. Periodical medical checkup will contribute to reducing risks of diseases, especially the serious cases, and the substantial medical expenses.

2. <u>Activities</u>

This program consists of two components;

- 1) Seminars in Myanmar
 - a) Participants
 - i) Officials of Ministry of Health (MOH)
 - ii) Medical professionals such as doctors, nurses and paramedics
 - iii) Company owners
 - b) Main contents
 - i) The importance of preventive medical care system
 - ii) Benefits of preventive medical care system through periodical medical checkup especially for company owners and their employees.
 - iii) Outline of Japan's preventive medical care system, medical care insurance system and their historical background

Notes:

The reasons for including company owners in manufacturing sectors are 1) the companies' responsibilities and benefits for keeping their workers healthy, 2) to reach out mass population for efficient promotion of preventive medical care system, and because 3) for Sanshikai to consider them as potential clients for its medical checkup clinic.

5 Seminar

Sanshikai held the seminars disseminating the importance of preventive medical care system and benefits of it through periodical medical checkup for the staff of Ministry of Health, doctors and nurses of General Hospitals of Nay Pyi Taw, Mandalay and Yangon in January and March 2015.

- 7. Achievement of this program and future plan
- (1) Dissemination of preventive medical system through seminars Our seminars made it clear that early finding of lifestyle diseases including diabetes make the duration and costs of treatments much shorter and cheaper. This is the good

example showing how preventive medical system is effective and crucial. The majority of the professional staffs of Yangon and Mandalay General Hospital already seemed to understand this notion. However, some of the seminar participants of MOH questioned the example of effectiveness of preventive medical system. Even a medical doctor working in the private sector confessed that he thought "medical checkup" was only done when he became sick. Both of them did experience periodical medical checkup. This JICA program is just the beginning to start to disseminate the notion of preventive medical system to the public and even some of the local medical professionals.

(2) Feasibility study to establish medical checkup clinic in Yangon for the corporate executives and the employees

① Japanese firms

Japanese firms in Yangon already understand the importance and obligation to execute the annual periodical medical checkup. Once Sanshikai opens the medical checkup clinic they at least pick up our medical checkup center as their choices for their employees

② Local executives

Many Myanmar executives go to Bangkok and Singapore for both sightseeing and periodical medical checkup. However, company owners including chairman and the top executives of Myanmar Industry Association of UMFCCI will prefer local medical checkup clinic to going to hospitals in Bangkok and Singapore. Sanshikan thinks that there are certain demands by ① and ② in order to maintain the management of the clinic.

③ Employees of local firms

Sanshikai cautiously selected around 15 local firms to visit and explain the plan to open the clinic based on the business connection with Japanese firms including Daiwa Institute of Research Ltd, our project coordinator and the published list made by SME Agency of Japan for business matching between Japanese firms and Myanmar firms.

They welcomed us and understand the effectiveness of periodical medical checkup with their own expense and agree to consult the tariff structure. They are commonly positive to offer the welfare benefits to their employees. Only one firm currently executes the periodical medical checkup. Food manufacturers including this firm with more than 1,000 employees fully understand that periodical medical checkup is crucial to maintain the quality of their product from the hygienic point of view.

However, these local firms are considered to be minority. Some of the firms declined to meet us. The reason seems to be that medical checkup simply pushes up their operation al costs without the visible short term return.

Sanshikai considers that the mandatory periodical medical checkup for larger firms will be the first step to promulgate periodical medical checkup. Meanwhile, as the top executives of Myanmar Industry Association and Myanmar Pharmaceutical & Medical Equipment Entrepreneurs' Association express their support to open the clinic, Sanshikai will continue to visit the local firms to disseminate preventive medical system and our plan to open the clinic

(3) Training program for the professional staff of Ministry of Health at Sanshikai

The three staff of MOH effectively went through our training program to put emphasis on hospital management of each ward and area including actual operation of medical checkup with tariff setting, and pubic medical insurance and checkup programs. Sanshikai assumes that they will be the core persons of promulgate preventive medical system and cooperate to with them in the future.

Besides the official JICA program, Dr.Myint Han, director, department of medical services of MOH and Dr. Moe Khine of the same department visited Sanshikai personally during their official trip to Japan in April 2015 and met Mr.Naka, chairman of Sanshikai and Dr. Nomura vice chairman and discussed the future plan by Sanshikai in Myanmar.

- (4) Others
- ① Agreement to form joint venture

Sanshikai agree to set up joint venture medical firm with Success Language Academy (Managing director and principal Mr. Sayar Arthur). Mr. Auther understands the ultimate purpose of this firm will be social contribution not profit taking. The details of the firm including percentage of investment and schedule to set up the firms are to be decided later. Kenko Kagaku, manufacturer of health equipment and Happy Field, a trader of medical equipment will join to invest in this firm.

② Social Security Fund (SSF)

Both almost all of the Japanese and the local firms expressed the strong dissatisfaction about low level of medical services offered by Social Security Fund (SSF) which is mandatory for all firms registered in Myanmar. Medical checkup with limited inspection items is complimentary at SSF designated labor hospitals and more items are to be offered if the employee would like to at General hospitals on a-pay-first-and-refunded basis. However, the results of the checkup are not trustworthy at all according to the hearing with local and Japanese firms. At this moment the utilization rate of labor hospital and other SSF-designated hospitals seems to be low due to their poor reputation. There is paradox that once the medical services of these hospitals will be improved, SSF might turn to the deficit once due to the increased utilization rate. In order to avoid this paradox it is highly recommended to introduce mandatory periodical medical checkup gradually from the large firms (2,347 firms in Yangon according to the ministry of industry) to SMEs at the nominal charges. This will cut the medical expense publicly and personally.
